I. General1. Scope of work

Furnish all equipment, materials and labor to remove three (3) existing above ground heating fuel tanks and one (1) existing masonry berm, and install three (3) new above ground storage tanks as specified at the Merrimack River Basin and Everett Project Office, and Everett Gatehouse.

2. Location

The Merrimack River Basin Office is located at 2097 Maple Street Contoocook, NH. The Everett Lake Project Office and Gatehouse is located 395 Clough Park Rd Weare, NH.

3. Site Visit

Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for the project is Bradley Clark 603-746-3601 ext 342 or Bradley.J.Clark@usace.army.mil.

4. Schedule

The period of performance shall be 45 days. The project area will be open to the contractor Monday through Friday 8:00 AM to 4:00 PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or government holidays.

5. Safety

The contractor will comply with all pertinent provisions of the latest edition of the *U.S. Army Corps of Engineers Safety and Health Requirements* COE EM 385-1-1. A copy of COE EM 385-1-1 is available for reference at the project office or the manual may be viewed at the following link

http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf.

The contractor shall also comply with all OSHA work safety standards. The project staff can and will order the cessation of work at any time should the safety of employees and visitors become jeopardized.

6. Preconstruction Conference

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Preconstruction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Preconstruction conference the contractor shall provide to the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Preconstruction Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors
- ii. Contractor's Safety Program (including sub-contractors)
- iii. Activity Hazard Analysis (Submitted & accepted prior to start of work on site)
- iv. Weekly Safety Meetings (Documented on NED Form 251)
- v. Accident Reporting (ENG Form 3394)
- vi. Safety Data Sheet (SDS) requirements
- vii. Correspondence, Communication, Security and Administrative Procedures
- viii. Invoice and payment

7. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract. This shall include any local building and mechanical permits. The Technical Point of Contact shall be informed of scheduled inspections by the local Building Inspector or Fire Marshall during and after removal and installation of the storage tanks.

8. Security

The contractor will comply with all established security policies at Hopkinton Lake and Merrimack River Basin Office. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least 24 hour notice of any such closure.

9. Environmental Protection

Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis. No burning is permissible. Water, air and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met

10. Contractor Conduct

Alcohol and firearms are prohibited on project grounds. Contractor must comply with CFR 36 Rules and Regulations.

11. Payment

Payment shall be made on a per job basis. After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. For jobs greater than 30 days the contractor may request progress payment.

II. Technical Requirements:

Part 1 General:

Existing Conditions:

The existing aboveground storage tanks at all of the locations are steel, single walled tanks with no known leaks or failures. Each tank is surrounded by a masonry containment berm that measures approximately 80" by 48" by 29" tall.

1. Merrimack River Basin Office

- a. Basement of office
 - i. 275 gallon
 - ii. Tank services existing heating system.
 - iii. Access to area is through a bulkhead entrance next to the existing fuel tank.
 - iv. Informational photo number 1.

2. Everett Lake

- a. Project Office
 - i. 275 gallon
 - ii. Tank services existing heating system.
 - iii. Access to area is through a standard residential garage bay door to the existing fuel tank.
 - iv. Informational photo number 2.
- b. Gatehouse

- i. 275 gallon (Informational photo number 3)
- ii. Tank services existing heating system and emergency generator.
- iii. Access to the existing fuel tank and masonry berm location is via an access bridge to the gatehouse.
 1. The bridge is approximately 10' wide by 135' long. (Informational photo number 4).
 2. Access into the Gatehouse is through two large steel doors at the Gatehouse entrance approximately 9' tall by 10' wide when both doors are open (Informational photo number 5).
 3. There is a stairway leading down one story from the entrance level floor to the fuel tank floor.
 4. There is also a covered floor hatchway on the entrance level floor that measures approximately 7'4" by 4' for which the covers may be removed and safety railings installed for access.
- iv. Informational drawing number 1.

Submittals:

Although the Government technically reviews submissions required by this scope of work, it is emphasized that the Contractor's work must be prosecuted using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted to the Technical Point of Contact for review and accepted by the government prior to the commencement of any field activities.

- Contractor's Qualifications
- Manufacturer Warranty
- Modified Accident Prevention Plan (APP) & Activity Hazard Analysis (AHA) (Prior to start of field work). If applicable all safety, inspections, and equipment certifications must be supplied for any hoisting and rigging equipment along with certificates for those individuals operating the hoist and / or rigging the loads in accordance with 29 CFR 1926.
- Product specification sheets for the replacement tanks, including the following:
 - Double walled above ground storage tanks
 - Audible Vent Whistle Alarm
 - Visual Tank Fuel Level Indicator
 - Automatic Level Alarm System
 - Fuel Filter
- Provide written documentation of proper disposal of each fuel tank.
- Tank Manufacturer Testing Compliance and Certification
- Manufacturer Warranty
- Operations and Maintenance Manuals

Clean Up:

The Contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area the contractor shall remove any tools, equipment, and materials that are not the property of the government. Upon completion of work, the Contractor shall clean up the job site to the satisfaction of the Government.

Government Resources:

The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources. The overhead crane in the Everett Gatehouse is not available for the contractor's use. The contractor may use the restroom facilities at the Merrimack River Basin Office and the Everett Project Office.

Omissions:

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

Quality Assurance:

The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract at all times and at all places during the term of the contract.

Receiving and Storing Materials:

The contractor is responsible for protecting any stored material until it is placed in service. The contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the contractor and will not be responsible for damage to contractor equipment or material.

Part 2 Products:

- 1) **One (1) 275 gal. Double Walled Aboveground Storage Tank, Everett Gatehouse** - The secondary containment reservoir shall be the factory fabricated, steel type or fiberglass/plastic composite that fully encloses the primary storage tank. The storage tank shall conform to NFPA 31 and UL 142.
 - a. **Aboveground Tank Emergency Vent**- Vent shall conform with NFPA 31.
 - b. **Audible Vent Whistle Alarm**- Alarm shall conform with NFPA 31.
 - c. **Visual Tank Fuel Level Indicator**- The indicator shall be installed on each tank in accordance with NFPA 31.
 - d. **Automatic Tank Fuel Level Alarm**- The alarm shall meet NFPA 31 regulations.
 - e. **Note** – Granby Tank Model 30119232 satisfies the above requirements.

- 2) **Two (2) 275 gal. Double Walled Aboveground Storage Tank, Everett & Merrimack River Basin Office** - The double walled tank shall be a factory fabricated tank and shall be installed to conform with NFPA 31. The storage tank shall conform to NFPA 31 and to standards in UL Subject 2258 for Nonmetallic Tank for Oil Burner Fuels.
 - a. Designed to fit within masonry containment berm that measures approximately 80” by 48” by 29” tall.
 - b. **Audible Vent Whistle Alarm**- Alarm shall conform to NFPA 31.
 - c. Note – Roth Tank Model DWT 1000L satisfies the above requirements.
- 3) **Three (3) Filters** - Filters shall be completely compatible with each system.

Part 3 Execution:

1) General:

The Contractor shall take appropriate actions to prevent spills or leaks during all aspects of the contract. It should be noted that any leak or spill has the ability to rapidly reach the surface water associated with the dam and the downstream river.

- a) The contractor will exercise due caution to prevent spills / leaks of fuel into the environment.
- b) The contractor shall keep on site the means to respond to a potential spill during all phases of this contract.
- c) If there is a fuel spill, it is the responsibility of the Contractor to clean up the spill.
- d) All spills shall be immediately reported to the Technical Point of Contact.
- e) No smoking is permitted in and around any Corps of Engineers buildings or structures.

The Contractor may provide their own certified and inspected hoisting and rigging equipment for use at the Everett Dam Gatehouse for the removal and installation of equipment and materials. All safety requirements for such equipment and operation must conform to the U.S. Army Corps of Engineers Safety Manual EM 385-1-1 as indicated in Part 1 Section 5.

2) AST Removal:

a) General Requirements

- i) Furnish labor, materials, necessary permits, and equipment to remove and dispose of the above ground storage tanks listed in the existing condition of this section.
- ii) Dispose of the tanks and any associated piping in accordance with applicable local, state, and federal rules and regulations.

b) Masonry Containment Berm, Everett Gatehouse

- i) Furnish labor, materials, necessary permits, and equipment to remove and dispose of the masonry containment berm listed in the existing condition of this section.
- ii) Dispose of any debris and demolition material in accordance with applicable local, state, and federal rules and regulations.
- iii) The masonry areas shall be free of any remnant mortar, block, and brick material to leave a smooth concrete surface area that will not compromise the tanks or secondary containment or create a tripping hazard.

c) **Tank Cleaning and Disposal**

- i) Fuel removal: All reusable heating fuel will be double filtered and will be transferred from existing tank to new tank. Any oil, sludge, scale, water, etc. in the tank shall be disposed of properly.
- ii) If combustible vapors are detected prior to cleaning, purge the tank before cleaning.
- iii) Remove existing heating fuel storage tank. The existing fuel lines and filter system are to be reused.
- iv) Make tank unusable for future use and transport and dispose of tank in accordance with applicable local, state, and federal rules and regulations.
- v) Provide written documentation of proper disposal.

3) **AST Installation:**

a) **General Requirement**

- i) Install work so that parts requiring periodic inspection, operation, maintenance, and repair are readily accessible.
- ii) Handle any storage tanks with extreme care to prevent damage during placement and install in accordance with the manufacturer's installation instructions, NFPA 31 and the New Hampshire's Building code.
- iii) Inspect the exterior surface of each tank for obvious visual damage to the storage tank according to manufacturer's requirements before proceeding with the systems installation.
- iv) Provide the termination of fill lines within a tank with anti-splash deflector.
- v) Provide nylon dielectric bushings on the pipe connections to the tank.

b) **System Layout**

- i) All three AST will be located in the existing fuel tank locations (see informational photos 1-3).

(1) Merrimack River Basin

- (a) Basement of office
 - (i) 275 gallon double wall tank
 - (ii) Placed within existing masonry berm
 - (iii) Audible Vent Whistle Alarm

(2) Everett Lake

- (a) Project Office
 - (i) 275 gallon double wall tank
 - (ii) Placed within existing masonry berm
 - (iii) Audible Vent Whistle Alarm
- (b) Gatehouse
 - (i) 275 gallon double walled tank
 - (ii) Automatic tank fuel level alarm
 - (iii) Audible Vent Whistle Alarm
- ii) Vent and fill pipes shall remain as close to existing configurations as possible.
- iii) Reconnect existing fuel lines and filter system. A new filter shall be installed for each tank system.

c) **System Test**

- i) The contractor shall perform a leak test and system check prior to placing the system back in service.
- ii) The contractor shall perform a system test for proper operation with existing boiler for a minimum of 30 minutes.

All contractor and all associated sub-contractors employees shall comply with applicable installation, facility and area commander installation/facility access and local security policies and procedures (provided by government representative). The contractor shall also provide all information required for background checks or background investigation and to meet installation/facility access requirements to be accomplished by installation Provost, Marshal Officer, Director of Emergency Services or Security Office. Contractor workforce must comply with all personal identity verification requirements as directed by DoD, HQDA and/or local policy. In addition to the changes otherwise authorized by the changes clause of this contract, should the Force Protection Condition (FPCON) at any installation or facility change, the Government may require changes in contractor security matters or processes.

The contractor and all associated sub-contractors shall receive a brief/training (provided by the RA) on the local suspicious activity reporting program. This locally developed training will be used to inform employees of the types of behavior to watch for and instruct employees to report suspicious activity to the project manager, security representative or law enforcement entity. A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

(b) Allowable cost for construction and marine plant and equipment in sound workable condition owned or controlled and furnished by a contractor or subcontractor at any tier shall be based on actual cost data for each piece of equipment or groups of similar serial and series for which the Government can determine both ownership and operating costs from the contractor's accounting records. When both ownership and operating costs cannot be determined for any piece of equipment or groups of similar serial or series equipment from the contractor's accounting records, costs for that equipment shall be based upon the applicable provisions of [EP 1110-1-8, Construction Equipment Ownership and Operating Expense Schedule, Region I](#). Working conditions shall be considered to be average for determining equipment rates using the schedule unless specified otherwise by the contracting officer. For equipment not included in the schedule, rates for comparable pieces of equipment may be used or a rate may be developed using the formula provided in the schedule. For forward pricing, the schedule in effect at the time of negotiations shall apply. For retroactive pricing, the schedule in effect at the time the work was performed shall apply.

(c) Equipment rental costs are allowable, subject to the provisions of [FAR 31.105\(d\)\(ii\)](#) and [FAR 31.205-36, Rental Costs](#). Rates for equipment rented from an organization under common control, lease-purchase arrangements, and sale-leaseback arrangements, will be determined using the schedule, except that actual rates will be used for equipment leased from an organization under common control that has an established practice of leasing the same or similar equipment to unaffiliated lessees.

(d) When actual equipment costs are proposed and the total amount of the pricing action exceeds the SAT, the contracting officer shall request the contractor to submit either certified cost or pricing data, or partial/limited data, as appropriate. The data shall be submitted on Standard Form 1411, Contract Pricing Proposal Cover Sheet.

(i) Competitively within a time frame providing for compliance with the contract performance schedule;

52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (MAY 2014)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

(1) Means any item of supply (including construction material) that is--

(i) A commercial item (as defined in paragraph (1) of the definition at FAR 2.101);

(ii) Sold in substantial quantities in the commercial marketplace; and

(iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and

(2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency

lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

(1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or

(2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

(1) An unmanufactured construction material mined or produced in the United States;

(2) A construction material manufactured in the United States, if--

(i) The cost of its components mined, produced, or manufactured in the United States exceeds 50 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic; or

(ii) The construction material is a COTS item.

Foreign construction material means a construction material other than a domestic construction material.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
