A. General

1. **Scope** – Purchase Order request for laboratory services that provide both potable water and non-potable (beach) analyses of samples collected from Corps of Engineers reservoirs and facilities throughout Connecticut and Massachusetts. Laboratory analysis must meet State and Federal regulations for each State the samples are collected from to protect public health as described below. Services include provision of appropriate sampling containers and analysis of water samples.
2. **Sample Location** – Samples will be collected from Corps of Engineers reservoirs and projects throughout Connecticut and Massachusetts as described below under Technical Requirements Section B.10.
3. **Laboratory Location** – The laboratory must be located in Central or Western Massachusetts in order to meet the turnaround requirements and logistical limitations for both the Connecticut and Massachusetts collection locations. To ensure that the most accurate data are generated, all *E. coli* and Total coliform samples should always be analyzed as soon as possible. Per EPA 5.11 Fecal Bacteria, “Samples for bacteria must be analyzed within 6 hours of collection. Keep the samples on ice and take them to the lab or drop-off point as soon as possible”.
4. **Certifications** – State of Connecticut and State of Massachusetts Certification for the specific method/analysis per Safe Water Drinking Act. The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal,

State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

5. **Payment** – Payment shall be made on a per job basis. After laboratory services and analytical results submitted as described below under Technical Requirements, the Contractor must submit an invoice to the Program Manager, Heather Rausch, within 30 days of sample acceptance. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item.

B. Technical Requirements:
General Requirement

1. **Summary** – Purchase Order request for laboratory services that provide both potable water and non-potable (beach) water analyses at designated Corps owned reservoirs and facilities within Connecticut and Massachusetts for parameters noted below under Section B.10, “Service Requirements”. Services include provision of appropriate sampling containers and analysis of water samples.
2. **Government Resources** – The contractor is responsible for providing all laboratory equipment. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.
3. **Omissions** – This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
4. **Quality Assurance** – The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
5. **Workmanship** – The contractor shall establish and maintain a quality control system to assure compliance with the contract requirements.
6. **Receiving and Storing Samples** – The contractor is responsible for protecting any stored samples within the EPA holding times. Government employees will not receive material for supplies for the contractor and will not be responsible for damage to the contractor’s equipment or materials.

8. **Submittals Part 1** –The laboratory must notify the Corps of Engineers Water Quality Technical Point of Contact, Nancy McNally, by phone (978) 508-9247, with coliform and E Coli results as soon as they become available; no later than noon the day following sample collection to meet the State and Federal notification timeframe. Failure to comply with the Submittal Part 1 reporting timeframe as stated will result in contract termination.
9. **Submittals Part 2** - Written submittals shall be made on a per job basis within 30 days of sample acceptance. The written submittal shall include the data type, sample location, initial of analyst, reviewer signature, sample date and time, acceptance date and time,

analytical method utilized, quantities, unit of measure, contract number, dates of service, and description of work, as applicable and required by State and EPA guidelines.

10. Service Requirements:

A. Description: Purchase Order request for laboratory services that provide both potable water and non-potable (beach) water analyses at designated Corps owned reservoirs and facilities within Connecticut and Massachusetts that meet State and Federal regulations for each state the samples are collected from to protect public health.

1. Certifications:

- State of Connecticut Certification for the specific method/analysis per Safe Water Drinking Act.
- State of Massachusetts Certification for the specific method/analysis per Safe Water Drinking Act.

2. Sample acceptance, Monday - Thursday, occasionally on Friday.

3. Notify the COE Water Quality Program representative (Nancy McNally) with coliform and E Coli results as soon as they become available; NLT noon the following day to meet the beach notification timeframe.

4. Potable Water Samples:

Potable water samples will be collected and hand-delivered to the lab year round. Laboratory analysis of potable water samples will be performed in accordance with State approved analytical methods. Samples will come from Massachusetts and Connecticut on as-need basis. Bacterial samples are to be analyzed as soon as is possible. Maximum sample holding times must be met (6-hrs for source samples). Most Probable Number (MPN) Colony counts must be reported to the Water Quality Program representative (Nancy McNally) as soon as they become available; no later than noon the day following collection. This reporting time is essential to optimal public safety and allows for timely management of postings, closures and reopening of systems and to meet State reporting requirements (notification must be received before the end of their workday). In order to achieve this, samples must be received by the lab no later than 2:00pm of the day sampled since the bacteriological tests take 18-hours plus setup beforehand and reading the results afterwards. State mandated data reporting requirements for all public water systems must be adhered to. Written reports and invoices will be provided to the Water

Quality Program representative within 30 days of sample collection. Bacteriological work must be performed on the premises.

Routine analytes include Total Coliform, Escherichia coli (E. Coli), Nitrates and Nitrites. Occasional analytes could additionally include, but are not limited to, arsenic, sodium, iron, lead, manganese and uranium. Presence/Absence coliform methods are unacceptable.

5. Non-Potable (Beach) Samples

Laboratory analyses of surface waters for E. Coli must be performed in accordance with State approved methods. Holding times must be met. Samples will primarily come from Massachusetts on as-need basis. Results for all bacteriological samples must be reported to the Water Quality Program representative (Nancy McNally) as soon as they become available; no later than noon the day following collection. This reporting time is essential to optimal public safety and allows for timely management of postings, closures and reopening of beaches. Samples must be received by the lab no later than 2:00pm of the day sampled since bacteriological tests take 18-hours plus set-up beforehand and reading results afterwards. Written reports and invoices will be provided to the Water Quality Program representative within 30 days of sample collection. Bacteriological work may not be subcontracted. Routine Beach monitoring is performed from mid-May through mid-September. Samples are generally collected weekly and hand delivered to the lab.

CLAUSES INCORPORATED BY FULL TEXT

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (JUL 2016)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (r) of this provision.

(a) Definitions. As used in this provision --

“Economically disadvantaged women-owned small business (EDWOSB) Concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service-

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

Inverted domestic corporation means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

Manufactured end product means any end product in product and service codes (PSCs) 1000-9999, except--

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

For items that are serialized within the part, lot, or batch number within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Enterprise means the entity (e.g., a manufacturer or vendor) responsible for assigning unique item identifiers to items.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

- (2) Embedded items shall be reported by one of the following methods--

(a) The Contractor is not required to flow down the terms of any Defense Federal Acquisition Regulation Supplement (DFARS) clause in subcontracts for commercial items at any tier under this contract, unless so specified in the particular clause.
