- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: The three potential wetlands appear to be isolated, man-made, excavated depressions used as ornamental ponds to display waterfowl at the former Norton Bird Garden. Currently, Wetland E would be classed as a non-wetland. Wetland A would be classed as an abandoned ornamental pond with clear evidence that it was artificially created. Wetland D would be classed as an isolated, intrastate wetland with no nexus to interstate commerce.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. **Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.**

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

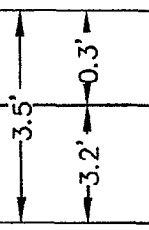

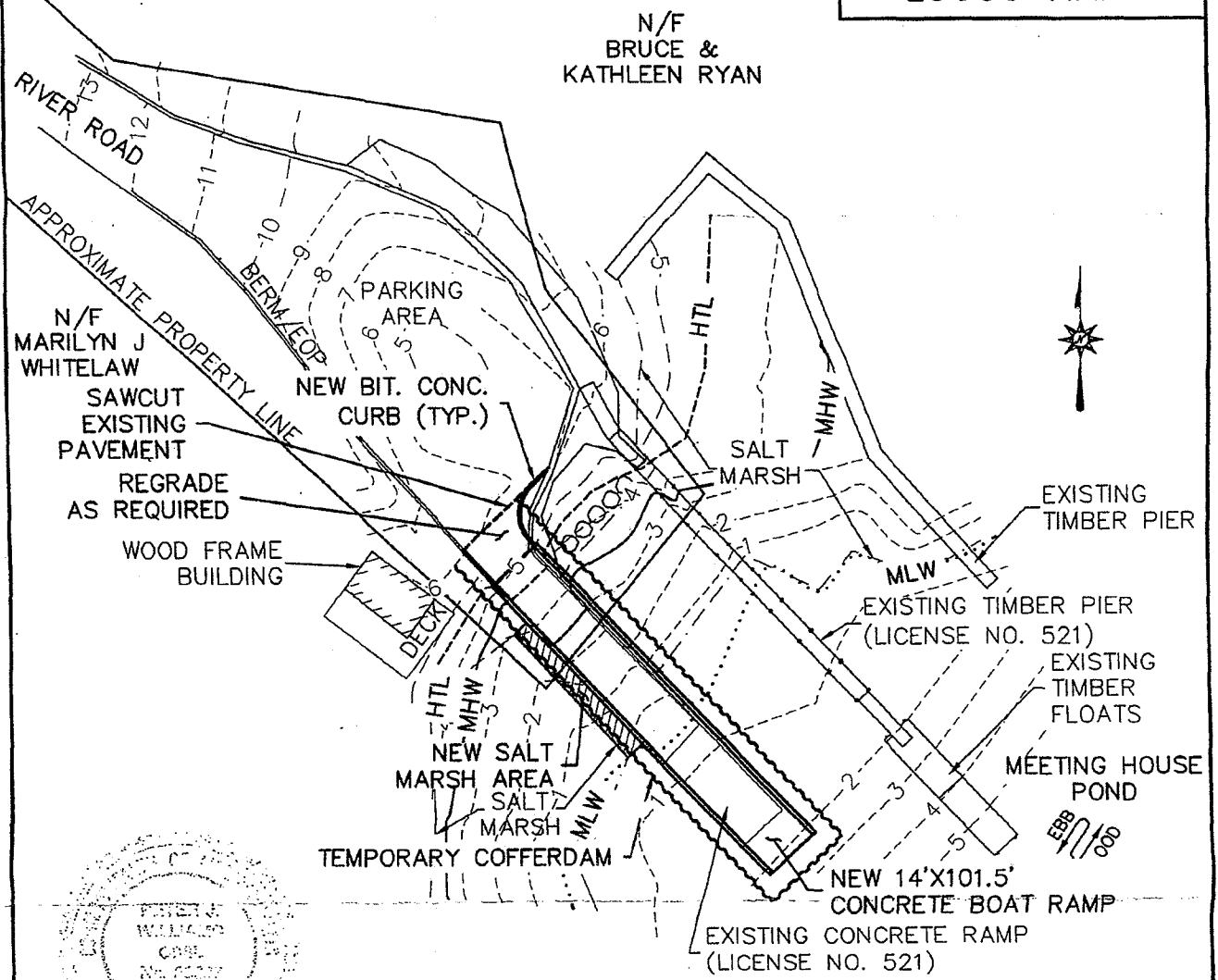

This letter responds to a request submitted on your behalf by Jacobs Engineering Group, Inc., for a determination of jurisdiction for wetlands areas located on an approximately 2.93-acre parcel bounded by Turnpike Road and Authority Drive near Princeton Street (MA Rte 31), Fitchburg, Massachusetts.

Alan Anacheka-Nasemann of our Regulatory Division conducted a field inspection of the site on May 26, 2011. During this inspection, areas labeled on the enclosed plans as Wetlands A, B and C were reviewed for potential federal jurisdiction. We have determined that Wetlands A, B, and C are not waters of the United States.

The Corps of Engineers has implemented an administrative appeals process for jurisdictional determinations, permit denials, and proffered permits for which you object to the terms and conditions. A combined Notification of Administrative Appeal Options and Process (NAP) and Request for Appeal (RFA) form and flow charts explaining the appeals process and your options are enclosed with this letter. However, in order to retain your right to appeal, you must submit the enclosed NAP form within 60 days of this letter's date.

For appeals of approved jurisdictional determinations, you must complete Section II of the NAP form ("Request for Appeal") and submit it along with any supporting or clarifying information to Michael G. In order for a Request for Appeal (RFA) to be accepted by the Corps, the Corps must determine that it is complete, that it meets the criteria for appeal under 33 CFR Part 331.5, and that it has been received by the Division Office within 60 days of the date of the NAP. Should you decide to submit an RFA form, it must be received at the above address by **January 17, 2012**. It is not necessary to submit an RFA form to the Division Office if you do not object to

the jurisdictional decision in this letter.

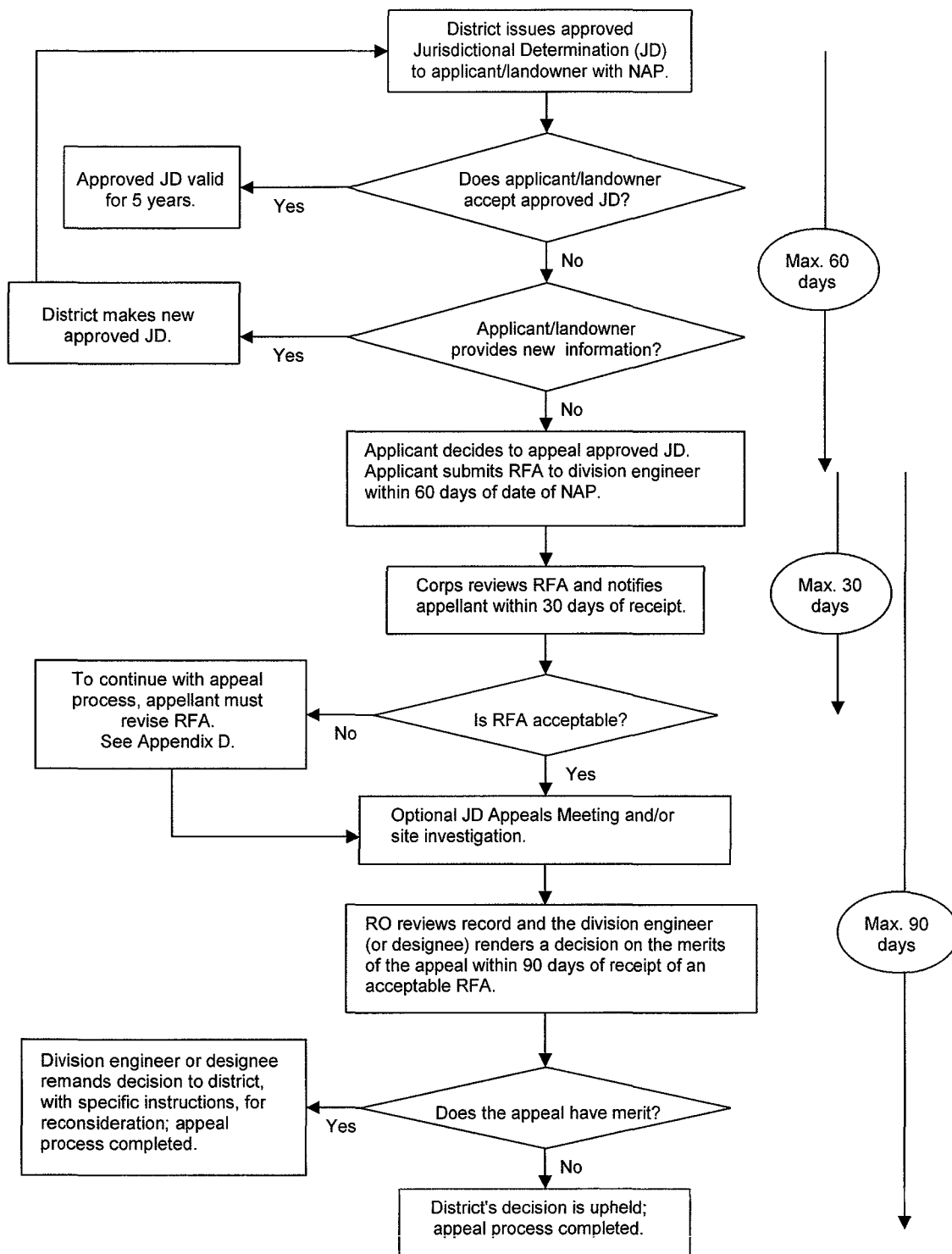

C. SIGNIFICANT NEXUS DETERMINATION
