This area, hereinafter referred to as Wetland A, is delineated by flags A01 through A23 on the attached plan entitled "Existing Conditions", dated "April 24, 2018". This wetland is intrastate and has no inlets, outlets, or hydrologic connections to any other waters of the United States. There are no adjacent jurisdictional surface waters in proximity to Wetland A. The nearest waterway, an unnamed tributary to the Connecticut River, is approximately 650 feet to the east of Wetland A. Wetland A has no apparent**

The use, degradation, or loss of Wetland A is expected to have no effect on other waters of the United States or interstate or foreign commerce. Wetland A was therefore determined to be a non-jurisdictional, isolated, vegetated wetland with no connection to interstate or foreign commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
