**I. GENERAL**

**1. Scope**

The scope of this contract includes the daily operation, on Sundays and Mondays of every week during the season and all three (3) Federal Holidays, of a park fee entrance station building for fee collection and park restrooms at Buffumville Park. The services to be accomplished under this contract will be performed by a two-person team.

**2. Locations**

Buffumville Park is located at 229 Oxford Road, Charlton, Massachusetts 01507.  
Buffumville Project Office is located at 48 Old Oxford Road, Charlton, Massachusetts, 01507.

Buffumville Park is a day-use park with parking for approximately 300 vehicles. Public camping is not permitted in the park. The main portion of the park has a swim beach, picnic tables and grills, two picnic shelters, a volleyball court and horseshoe pits, both of which may be reserved for a fee. There is a water-borne restroom and drinking water at the beach. Most facilities are handicap accessible. A lakeshore trail passes through the park. A boat launching area is located across the road from the park entrance. A Romtec single vault toilet is at the back of the boat ramp.

**4. Schedule**

The period of performance will be from the 3<sup>rd</sup> Friday in May to the 2<sup>nd</sup> Sunday in September. The specified services for the period of performance will be conducted 2 days per week, Sunday and Monday (8 am to 8 pm) most weeks. Also, Attendant #1 will work all three Federal Holidays (Memorial Day, 4<sup>th</sup> of July and Labor Day). In addition, there will be one Park Attendant training day on the 3<sup>rd</sup> Friday in May and Orientation on a date (Wednesday) in late May or early June.

**5. Safety**

The contractor will comply with all pertinent provisions of the latest edition of the *U.S. Army Corps of Engineers Safety and Health Requirements* COE EM 385-1-1, 2014 Edition. **6. Pre-Work Conference**

The Contractor will be required to attend a pre-work orientation to be conducted by the Technical Point of Contact at Buffumville Lake Project Office. This meeting will be for the purpose of discussing the policies outlined in the Scope of Work. The Contractor will also be instructed in User Fee collection procedures. The meeting will be held at the Buffumville Lake office on the (Friday) first day of the contract. The Contractor will bring the following documents to the pre-work conference: the bond, valid state driver's license, vehicle registration.

**7. Security**

The contractor will comply with all established security policies at Buffumville Lake. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least 24 hour notice of any such closure.

**8. Contractor Conduct**

Firearms are prohibited on project grounds. The attendants will not engage in any type of sales or commercial activity on Government property. Contractor and employees must comply with CFR 36 Rules and Regulations.

**9. Payment**

The contractor shall furnish the Technical Point of Contact with one invoice per month, identifying the contract number, stating the amount of services completed during the month, identified by Item Number and quantity. Payment shall be made monthly for the actual services performed at the applicable contract unit price. Reductions in payment will be made on a per diem basis on the prorated amount of the total cost of services. Short periods of emergency absence may be approved on an individual basis, based on need and workload at the discretion of the Technical Point of Contact. No payment will be made for service not completed.

## **II. Technical**

### **1. General**

#### **1.1. Background Check**

Park Attendant contractors will be subject to background security checks by USACE. Contract award is contingent upon a successful background check. The apparent low bidder will be required to complete the attached form entitled "Questionnaire for Public Trust Positions" SF85P. Failure to complete the form and complete the finger printing process within 5 business days of notification that you are the apparent low bidder will be considered a declination of the contract.

#### **1.2. Bonding**

The attendants are required AT THEIR OWN EXPENSE to furnish a bond to the government in the amount of \$1,000. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

#### **1.3. Inspection and Contract Performance**

The services performed by the attendants under the provision of this contract shall be subject to evaluation by the Contracting Officer or designated representative to insure strict compliance with the terms of this contract. The contractors will be advised as soon as possible of any deficiency in work. Upon advisory, the attendants shall take immediate action to correct such deficiency and to insure that the deficiency does not recur.

#### **1.4. Government Property**

The contractors will be required to return all Government property on the last day of the contract, unless prior agreement with Corps personnel is made. This includes keys, and all items listed under this contract regarding fee collection, supplies and equipment.

#### **1.5. Park Attendant Contractors**

There will be 2 other Contracted Park Attendants living in the park. Attendants #2 work Tuesdays-Thursdays and #3 work Fridays and Saturdays.

#### **1.6. Termination**

Failure to comply with the terms of the contract may result in termination.

### **2. Use Fee Operations**

#### **2.1. Park Entrance Gate Operation**



The attendants will unlock the entrance gate by 8:00 A.M. each morning (after the entrance station building, cash register, etc. are ready for business) and lock the entrance gate at 8:00 P.M. each night after ensuring that all visitors have left the park.

## **2.2. Entrance Station Building**

The contractor will maintain the Entrance Station Building in a clean, orderly and sanitary condition at all times. Smoking will not be permitted in the registration building. Only service animals will be allowed in the building. All non-authorized personnel are to remain outside the entrance station.

## **2.3. Fee Entrance Station Supplies and Equipment**

All administration equipment and supplies will be provided by the Government. Items may include: the cash register, telephone, 2-two way radios, office furniture, office supplies, log book, brochures, fan, heater, fire extinguisher, first aid kit and light maintenance tools and supplies, etc.

## **2.4. Fee Collection**

The attendants will collect fees for day use permits at Buffumville Park in accordance with established policies and procedures. The contractor will operate a cash register and be responsible for all fees collected and monies in the honor vault on their shift. The cash register will be shared with two other fee attendant contractor(s). Each contractor will be responsible for their own set of cash register keys, codes and cash drawer (provided). When checks are received, the contractor will insure that the driver's license number, current address, and phone number are written on the check by utilizing the individual's driver's license for cross reference. Collected fees will be deposited in a government provided safe daily. After every shift, the park attendant will prepare a Bill for Collection (BFC) for funds transfer to the Technical Point of Contact before they leave the premises, for their days off. Cash will be converted to a bank check or money order. **THE CONTRACT ATTENDANT WILL BE REQUIRED TO PAY FOR THE PURCHASE OF THE MONEY ORDERS.** Remittance of these checks, money orders and associated paperwork, will be covered at an orientation on the first (Friday) day of the contract. A change fund of at least fifty dollars or more will be provided by and maintained by the contractors for their exclusive use.

## **2.5. Other Duties**

- 2.5.1. The attendants will explain the carry-in/carry-out litter policy to each visitor and shall furnish a litterbag (supplied by the Government), only as needed, to any patron who may need it for purposes of carrying out their garbage when they leave the park.
- 2.5.2. The attendants will assist other personnel when the parking lot(s) become full by monitoring parking, directing overflow, etc.
- 2.5.3. The attendants will keep a supply of brochures and trail maps at the entrance station for distribution and will acquaint themselves with the area and US Army Corps of Engineers facilities in order to answer the public's questions.

**2.6. Special Use Permits**

The National Recreation Reservation Service (NRRS) handles rental of the two picnic shelters at the park. Contract attendants will be responsible for issuing temporary handicap and/or drive down permits. Rental for other items such as sports equipment and use of the courts (volleyball and horseshoes) will be the responsibility of the contract attendants on the day of the request. Attendants will be given updates to use fee reservations and be familiar with the latest schedule. They will also be responsible for posting reservations daily.

**2.7. Uniform Dress, Personal Appearance and Demeanor**

The attendants will promote and maintain a favorable image of the US Army Corps of Engineers through their personal appearance and actions. An attendant will at all times, conduct himself/herself in such a manner as to insure personal safety and the safety of Corps employees, the visiting public and others. Each contractor on duty will maintain a fully clothed, neat, well-groomed appearance. The Corps of Engineers identification in the form of a shirt provided by the Corps will be worn while on duty at all times- jacket and cap are optional. A supplied nametag will be worn in addition to the Corps identification. Appropriate closed-toe footwear, furnished by the attendants, will be worn at all times.

**2.8. Visitor Comments and Daily Log**

The contractors will record in as much detail as possible a written daily log of all complaints, comments, suggestions, accidents/incidents, violations/disturbances, contractor entrance/exit times and safety hazards followed by a detailed written description of how the situation was resolved. Safety hazards should be visibly marked and reported immediately. The log will be reviewed and discussed by the Technical Point of Contact at frequent intervals during the term of the contract. Park Attendant Contractors may have weekly meetings with the Technical Point of Contact.

**2.9. Disturbances**

The contractors will promptly report (while on duty or off, if on site) all accidents, incidents, violations of the law, disturbances and situations that may affect the health and safety of visitors to the Park Manager or Park Ranger(s). In the event the attendants are unable to communicate with the Park Manager or Park Ranger, they should contact local law enforcement officials as soon as practical. All communication with local law enforcement officials will be reported to the Technical Point of Contact no later than the next day. Under no circumstance are the attendants to enforce Title 36 Rules and Regulations or any Federal, State, or local laws. Serious incidents such as motor vehicle accidents, serious injury or fatality will be reported immediately.

**2.10. Lost and Found**

The attendants will hold all lost and found articles in the entrance station building or other designated area (storage barn) and turn all items over to the Technical Point of Contact with all pertinent information as soon as possible.

### **3. Grounds And Restroom Cleaning**

#### **3.1. Supplies and Equipment**

All cleaning materials to be used will be government furnished warehouse-type items. Items may include: brooms, mops, squeegee, dust broom and pan, trash cans, commercial disinfectant, floor cleaner, bleach, wet-wipes, non-latex gloves, wire brushes, ash bucket and scoop, toilet paper, etc.

#### **3.2. Park Restrooms**

The attendant couple will be the primary janitorial team on Sundays and Mondays and will clean/disinfect and maintain the whole restroom facility, inside and out (which includes no more than 7 toilets, 3 urinals, 5 sinks, doors, stall partitions, baby changing stations/baby seats, interior walls and floors) to the satisfaction of the Technical Point of Contact throughout the course of the 12 hour shift. The restrooms must be checked hourly and cleaned as needed. This includes cleaning and disinfection of all surfaces, sweeping, mopping (streak-free and no standing water), litter pickup, replenishing toilet tissue and light bulbs as necessary and checking at least once a day to insure all exhaust fans, hand dryers, GFI outlets, and bathroom water holding tank are operating properly. The cleaning will be completed causing the least inconvenience and disturbance to park users. Trash emptied and removed will be taken to the Buffumville Dam site dumpster. Daily sign-in logs will be initialed for each cleaning or sanitary check (inside closet doors). Bathrooms must be clean for the park opening, each day.

#### **3.3. Romtec (vault Toilet) Restroom Cleaning**

The Romtec is located across the street from the park, at the back of the boat ramp. It must be cleaned once daily. This one room restroom has one toilet. The floors must be swept during each cleaning and mopped as necessary. There will be no streaks or standing water on any surfaces or fixtures upon completion. Toilet paper will be replenished as needed.

#### **3.4. Park Litter Pick up**

All litter (to include wrappers, paper, cigarette butts, etc.) will be picked up throughout the entire Buffumville Lake Park area. This area includes; parking lots, picnic areas to include picnic shelters, stairs and walkways and across the street at the boat ramp and parking area. These areas should be raked if necessary to remove broken glass or other debris. The contractor will be responsible for disposing all litter and refuse collected during the contract days into the dumpster located at the office at Buffumville Lake.

#### **3.5. Park Features**

Buffumville Park has a volleyball court, horseshoe pit and a pirate ship. The horseshoe pits will be raked, all litter removed and any sand outside of the sandbox/horseshoe pits will be refurbished.

#### **4. Contractor Camp Site**

##### **4.1. Temporary Living Quarters**

- 4.1.1. The park attendant contractor(s) are required to live on site, while on their duty days in a designated site at the park. The couple must provide their own fully operable “self-contained” RV or other self-contained camper unit. Maximum length of the camper/trailer cannot exceed 45'. Pickup (shell-type) campers, pop-up tent trailers, tents, mobile homes, converted school buses, or other type of recreational vehicle which does not meet general “self-contained” classification will not be acceptable. The campsite can be described as partial sun/shade, level, and is in view of the entrance station building and visitor parking lot. Designated site utilities and other amenities include electric (50 amp, 120 v), water, and sewer hookups, telephone service (phone to be provided by the contractor; phone number 508-248-3775 or 508-248-7906), storage barn (to be shared), picnic table and fire ring and/or grill.
- 4.1.2. The dumpster/recycling bins are located at the Buffumville Lake Office, less than 2 miles away.
- 4.1.3. The attendants will maintain the campsite in a clean and sanitary condition at all times. No animal pens, fences, cages or similar facilities for pets or raising animals will be allowed. All pets will be contained in the attendants living quarters. Problematic pets may be removed at the Technical Point of Contact’s discretion. No excessive personal items such as washers, dryers, freezers, or other such items will be permitted outside the living quarters. While on duty, relatives and friends are welcome to stay with attendants, but the team’s motor home will be the sole (vehicle) occupants of their site.
- 4.1.4. Contractors may arrive as early as 10 day before the park opens. Contractors may stay at their site up to 10 days after the park closes for the season unless other arraignments have been made.

##### **4.2. Contractor Vehicle**

The attendants will provide and maintain a fully operable vehicle, which can be operated independently of the RV, for purposes of personal or contract related transportation. Contractors must supply their own transportation to, from, within, and around the day use park. The attendants vehicle must be registered and in compliance with all state and local laws. All motor vehicle operators must possess a valid state driver’s license and comply with state and local vehicle regulations. The attendants may have the use of a Corps of Engineers golf cart, if applicable and following any necessary driver training.

1) COMPUTER EMPLOYEES: Under the SCA at section 8(b), this wage determination does not apply to any employee who individually qualifies as a bona fide executive, administrative, or professional employee as defined in 29 C.F.R. Part 541. Because most Computer System Analysts and Computer Programmers who are compensated at a rate not less than \$27.63 (or on a salary or fee basis at a rate not less than \$455 per week) an hour would likely qualify as exempt computer professionals, (29 C.F.R. 541.400) wage rates may not be listed on this wage determination for all occupations within those job families. In addition, because this wage determination may not list a wage rate for some or all occupations within those job families if the survey data indicates that the prevailing wage rate for the occupation equals or exceeds \$27.63 per hour conformances may be necessary for certain nonexempt employees. For example, if an individual employee is nonexempt but nevertheless performs duties within the scope of one of the Computer Systems Analyst or Computer Programmer occupations for which this wage determination does not specify an SCA wage rate, then the wage rate for that employee must be conformed in accordance with the conformance procedures described in the conformance note included on this wage determination.

Additionally, because job titles vary widely and change quickly in the computer industry, job titles are not determinative of the application of the computer professional exemption. Therefore, the exemption applies only to computer employees who satisfy the compensation requirements and whose primary duty consists of:

- (1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;
- (2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;
- (3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

HAZARDOUS PAY DIFFERENTIAL: An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordinance, explosives, and incendiary materials. This includes work such as screening, blending, dying, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving regrading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the

like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

\*\* UNIFORM ALLOWANCE \*\*

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of "wash and wear" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

The duties of employees under job titles listed are those described in the "Service Contract Act Directory of Occupations", Fifth Edition, April 2006, unless otherwise indicated. Copies of the Directory are available on the Internet. A links to the Directory may be found on the WHD home page at <http://www.dol.gov/esa/whd/> or through the Wage Determinations On-Line (WDOL) Web site at <http://wdol.gov/>.

REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE {Standard Form 1444 (SF 1444)}

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination. Such conformed classes of employees shall be paid the monetary wages and furnished the fringe benefits as are determined. Such conforming process shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees. The conformed classification, wage rate, and/or fringe benefits shall be retroactive to the commencement date of the contract. {See Section 4.6 (C)(vi)} When multiple wage determinations are included in a contract, a separate SF 1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage

rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.

3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor, for review. (See section 4.6(b)(2) of Regulations 29 CFR Part 4).

4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.

5) The contracting officer transmits the Wage and Hour decision to the contractor.

6) The contractor informs the affected employees.

Information required by the Regulations must be submitted on SF 1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" (the Directory) should be used to compare job definitions to insure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination.

#### CLAUSES INCORPORATED BY FULL TEXT

#### 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (DEC 2016)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (t) of this provision.

(a) Definitions. As used in this provision --

“Administrative merits determination” means certain notices or findings of labor law violations issued by an enforcement agency following an investigation. An administrative merits determination may be final or be subject to appeal or further review. To determine whether a particular notice or finding is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

“Arbitral award or decision” means an arbitrator or arbitral panel determination that a labor law violation occurred, or that enjoined or restrained a violation of labor law. It includes an award or decision that is not final or is subject to being confirmed, modified, or vacated by a court, and includes an award or decision resulting from private or confidential proceedings. To determine whether a particular award or decision is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

“Civil judgment” means—

(1) In paragraph (h) of this provision: A judgment or finding of a civil offense by any court of competent jurisdiction.

(2) In paragraph (s) of this provision: Any judgment or order entered by any Federal or State court in which the court determined that a labor law violation occurred, or enjoined or restrained a violation of labor law. It includes a judgment or order that is not final or is subject to appeal. To determine whether a particular judgment or order is covered by this definition, it is necessary to consult section II.B. in the DOL Guidance.

“DOL Guidance” means the Department of Labor (DOL) Guidance entitled: “Guidance for Executive Order 13673, ‘Fair Pay and Safe Workplaces’”. The DOL Guidance, dated August 25, 2016, can be obtained from [www.dol.gov/fairpayandsafeworkplaces](http://www.dol.gov/fairpayandsafeworkplaces).

“Economically disadvantaged women-owned small business (EDWOSB) Concern” means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

“Enforcement agency” means any agency granted authority to enforce the Federal labor laws. It includes the enforcement components of DOL (Wage and Hour Division, Office of Federal Contract Compliance

Programs, and Occupational Safety and Health Administration), the Equal Employment Opportunity Commission, the Occupational Safety and Health Review Commission, and the National Labor Relations Board. It also means a State agency designated to administer an OSHA-approved State Plan, but only to the extent that the State agency is acting in its capacity as administrator of such plan. It does not include other Federal agencies which, in their capacity as contracting agencies, conduct investigations of potential labor law violations. The enforcement agencies associated with each labor law under E.O. 13673 are--

(1) Department of Labor Wage and Hour Division (WHD) for--

(i) The Fair Labor Standards Act;

(ii) The Migrant and Seasonal Agricultural Worker Protection Act;

(iii) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act;

(iv) 41 U.S.C. chapter 67, formerly known as the Service Contract Act;

(v) The Family and Medical Leave Act; and

(vi) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors);

(2) Department of Labor Occupational Safety and Health Administration (OSHA) for--

(i) The Occupational Safety and Health Act of 1970; and

(ii) OSHA-approved State Plans;

(3) Department of Labor Office of Federal Contract Compliance Programs (OFCCP) for--

(i) Section 503 of the Rehabilitation Act of 1973;

(ii) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974; and

(iii) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity);

(4) National Labor Relations Board (NLRB) for the National Labor Relations Act; and

(5) Equal Employment Opportunity Commission (EEOC) for--

(i) Title VII of the Civil Rights Act of 1964;

(ii) The Americans with Disabilities Act of 1990;

(iii) The Age Discrimination in Employment Act of 1967; and

(iv) Section 6(d) of the Fair Labor Standards Act (Equal Pay Act).

"Forced or indentured child labor" means all work or service-

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

“Highest-level owner” means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

- (4) The National Labor Relations Act.
- (5) 40 U.S.C. chapter 31, subchapter IV, formerly known as the Davis-Bacon Act.
- (6) 41 U.S.C. chapter 67, formerly known as the Service Contract Act.
- (7) E.O. 11246 of September 24, 1965 (Equal Employment Opportunity).
- (8) Section 503 of the Rehabilitation Act of 1973.
- (9) The Vietnam Era Veterans' Readjustment Assistance Act of 1972 and the Vietnam Era Veterans' Readjustment Assistance Act of 1974.
- (10) The Family and Medical Leave Act.
- (11) Title VII of the Civil Rights Act of 1964.
- (12) The Americans with Disabilities Act of 1990.
- (13) The Age Discrimination in Employment Act of 1967.
- (14) E.O. 13658 of February 12, 2014 (Establishing a Minimum Wage for Contractors).
- (15) Equivalent State laws as defined in the DOL Guidance. (The only equivalent State laws implemented in the FAR are OSHA-approved State Plans, which can be found at [www.osha.gov/dcsp/osp/approved\\_state\\_plans.html](http://www.osha.gov/dcsp/osp/approved_state_plans.html)).

“Labor law decision” means an administrative merits determination, arbitral award or decision, or civil judgment, which resulted from a violation of one or more of the laws listed in the definition of “labor laws”.

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except--

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

Sensitive technology--

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically--

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern--

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern" means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

"Small disadvantaged business concern", consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that--

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by--

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

"Successor" means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term

“successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

“Veteran-owned small business concern” means a small business concern--

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127)”, means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.

The enjoined definitions will become effective immediately if the court terminates the injunction. At that time, DoD, GSA, and NASA will publish a document in the Federal Register advising the public of the termination of the injunction.

These amended representation(s) and/or certification(s) are also incorporated in this offer and are current, accurate, and complete as of the date of this offer. 252.211-7003 ITEM UNIQUE IDENTIFICATION AND VALUATION (MAR 2016)

(a) Definitions. As used in this clause-

Automatic identification device means a device, such as a reader or interrogator, used to retrieve data encoded on machine-readable media.

Concatenated unique item identifier means--

(1) For items that are serialized within the enterprise identifier, the linking together of the unique identifier data elements in order of the issuing agency code, enterprise identifier, and unique serial number within the enterprise identifier; or

(2) For items that are serialized within the original part, lot, or batch number, the linking together of the unique identifier data elements in order of the issuing agency code; enterprise identifier; original part, lot, or batch number; and serial number within the original part, lot, or batch number.

Data Matrix means a two-dimensional matrix symbology, which is made up of square or, in some cases, round modules arranged within a perimeter finder pattern and uses the Error Checking and Correction 200 (ECC200) specification found within International Standards Organization (ISO)/International Electrotechnical Commission (IEC) 16022.

Data qualifier means a specified character (or string of characters) that immediately precedes a data field that defines the general category or intended use of the data that follows.

DoD recognized unique identification equivalent means a unique identification method that is in commercial use and has been recognized by DoD. All DoD recognized unique identification equivalents are listed at [http://www.acq.osd.mil/dpap/pdi/uid/iuid\\_equivalents.html](http://www.acq.osd.mil/dpap/pdi/uid/iuid_equivalents.html).

DoD item unique identification means a system of marking items delivered to DoD with unique item identifiers that have machine-readable data elements to distinguish an item from all other like and unlike items. For items that are serialized within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier and a unique serial number. For items that are serialized within the part, lot, or batch number within the



enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Enterprise means the entity (e.g., a manufacturer or vendor) responsible for assigning unique item identifiers to items.

Enterprise identifier means a code that is uniquely assigned to an enterprise by an issuing agency.

Government's unit acquisition cost means--

(1) For fixed-price type line, subline, or exhibit line items, the unit price identified in the contract at the time of delivery;

(2) For cost-type or undefinitized line, subline, or exhibit line items, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery; and

(3) For items produced under a time-and-materials contract, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery.

Issuing agency means an organization responsible for assigning a globally unique identifier to an enterprise, as indicated in the Register of Issuing Agency Codes for ISO/IEC 15459, located at [http://www.aimglobal.org/?Reg\\_Authority15459](http://www.aimglobal.org/?Reg_Authority15459).

Issuing agency code means a code that designates the registration (or controlling) authority for the enterprise identifier.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

Parent item means the item assembly, intermediate component, or subassembly that has an embedded item with a unique item identifier or DoD recognized unique identification equivalent.

Serial number within the enterprise identifier means a combination of numbers, letters, or symbols assigned by the enterprise to an item that provides for the differentiation of that item from any other like and unlike item and is never used again within the enterprise.

Serial number within the part, lot, or batch number means a combination of numbers or letters assigned by the enterprise to an item that provides for the differentiation of that item from any other like item within a part, lot, or batch number assignment.

Serialization within the enterprise identifier means each item produced is assigned a serial number that is unique among all the tangible items produced by the enterprise and is never used again. The enterprise is responsible for ensuring unique serialization within the enterprise identifier.

Serialization within the part, lot, or batch number means each item of a particular part, lot, or batch number is assigned a unique serial number within that part, lot, or batch number assignment. The enterprise is responsible for ensuring unique serialization within the part, lot, or batch number within the enterprise identifier.

Type designation means a combination of letters and numerals assigned by the Government to a major end item, assembly or subassembly, as appropriate, to provide a convenient means of differentiating between items having the same basic name and to indicate modifications and changes thereto.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

Unique item identifier type means a designator to indicate which method of uniquely identifying a part has been used. The current list of accepted unique item identifier types is maintained at [http://www.acq.osd.mil/dpap/pdi/uid/uii\\_types.html](http://www.acq.osd.mil/dpap/pdi/uid/uii_types.html).

(b) The Contractor shall deliver all items under a contract line, subline, or exhibit line item.

(c) Unique item identifier. (1) The Contractor shall provide a unique item identifier for the following:

(i) Delivered items for which the Government's unit acquisition cost is \$5,000 or more, except for the following line items:

(iv) Any item of special tooling or special test equipment as defined in FAR 2.101 that have been designated for preservation and storage for a Major Defense Acquisition Program as specified in Attachment Number ----.

(v) Any item not included in paragraphs (c)(1)(i), (ii), (iii), or

(iv) of this clause for which the contractor creates and marks a unique item identifier for traceability.

(2) The unique item identifier assignment and its component data element combination shall not be duplicated on any other item marked or registered in the DoD Item Unique Identification Registry by the contractor.

(3) The unique item identifier component data elements shall be marked on an item using two dimensional data matrix symbology that complies with ISO/IEC International Standard 16022, Information technology--International symbology specification--Data matrix; ECC200 data matrix specification.

(4) Data syntax and semantics of unique item identifiers. The Contractor shall ensure that--

(i) The data elements (except issuing agency code) of the unique item identifier are encoded within the data matrix symbol that is marked on the item using one of the following three types of data qualifiers, as determined by the Contractor:

(A) Application Identifiers (AIs) (Format Indicator 05 of ISO/IEC International Standard 15434), in accordance with ISO/IEC International Standard 15418, Information Technology--EAN/UCC Application Identifiers and Fact Data Identifiers and Maintenance and ANSI MH 10.8.2 Data Identifier and Application Identifier Standard.

(B) Data Identifiers (DIs) (Format Indicator 06 of ISO/IEC International Standard 15434), in accordance with ISO/IEC International Standard 15418, Information Technology--EAN/UCC Application Identifiers and Fact Data Identifiers and Maintenance and ANSI MH 10.8.2 Data Identifier and Application Identifier Standard.

(C) Text Element Identifiers (TEIs) (Format Indicator 12 of ISO/IEC International Standard 15434), in accordance with the Air Transport Association Common Support Data Dictionary; and

(ii) The encoded data elements of the unique item identifier conform to the transfer structure, syntax, and coding of messages and data formats specified for Format Indicators 05, 06, and 12 in ISO/IEC International Standard 15434, Information Technology-Transfer Syntax for High Capacity Automatic Data Capture Media.

(5) Unique item identifier.

(i) The Contractor shall--

(A) Determine whether to--

(1) Serialize within the enterprise identifier;

(2) Serialize within the part, lot, or batch number; or

(3) Use a DoD recognized unique identification equivalent (e.g. Vehicle Identification Number); and

(B) Place the data elements of the unique item identifier (enterprise identifier; serial number; DoD recognized unique identification equivalent; and for serialization within the part, lot, or batch number only: Original part, lot, or batch number) on items requiring marking by paragraph (c)(1) of this clause, based on the criteria provided in MIL-STD-130, Identification Marking of U.S. Military Property, latest version;

(C) Label shipments, storage containers and packages that contain uniquely identified items in accordance with the requirements of MIL-STD-129, Military Marking for Shipment and Storage, latest version; and

(D) Verify that the marks on items and labels on shipments, storage containers, and packages are machine readable and conform to the applicable standards. The contractor shall use an automatic identification technology device for this verification that has been programmed to the requirements of Appendix A, MIL-STD-130, latest version.

(ii) The issuing agency code--

(A) Shall not be placed on the item; and

(B) Shall be derived from the data qualifier for the enterprise identifier.
