

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. B. ADDITIONAL COMMENTS TO SUPPORT JD: The pond is an abandoned man-made settling basin that was created in uplands during the late 1950's or early 1960's. It was formerly used and its sole purpose was to serve as a settling basin to capture, contain, and recycle washwater as part of a fine and coarse aggregate washplant operation.

The washplant operation was a closed loop system with no inlet or outlet. The washplant use apparently ceased in the early 1980's. The settling basin has never had any surface water connection while in use or since the washplant operation was abandoned, i.e. there is and never has been any point source surface inflow or outflow to this basin, either natural or man-made.

Since the washplant ceased operations, the site has been dormant and only a portion of the antiquated washplant structure remains. Sporadically, the importation of construction demolition material has occurred and, over the years, some of this imported material has sloughed into the settling basin. The parcel is hydrologically downgradient of and is impacted by a groundwater leachate plume emanating from the City of Torrington's former landfill. A groundwater monitoring well was installed in the southwest corner of this parcel by the City's consultant as part of an on-going monitoring program required by the Connecticut DEEP.

A site visit was conducted to verify the settling basin is entirely surrounded by uplands. The settling basin does not receive or convey surface water flows from or to a waters of the U.S. The settling basin is within the mapped 100-year floodplain. However, data from nearest stream gauge, "USGS 01206900 Naugatuck River at Thomaston, CT." suggests this area is inundated by the Naugatuck River on a very infrequent basis. Furthermore, Naugatuck River flows are regulated by several upstream dams located approximately 2.6 and 7.8 miles upstream from the site.
