NOTES of special concern:

- 1) Applications must be submitted at least 30 days prior to the event but not postmarked before Jan 2 of the calendar year of the event.
- 2) An event may consist of CONSECUTIVE dates; however a separate application form needs to be submitted for additional events. Fees listed are per day, per one location.
- 3) A copy of liability insurance for each shooting event will be enclosed with application.
- 4) Permittee is required to obtain ALL state and local permits and to have permits available during the event for inspection by the on duty park ranger; to have ALL signs posted at designated locations prior to the use of any firearms, whether blank or live. Access gate is to be closed after each entering and exiting vehicle.
- 5) Permittee does not have exclusive use of the grounds.
