The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: This system contains wetlands that are adjacent to an RPW which flows directly into a TNW. The wetlands provide attenuation of agricultural pollutants such as herbicides, pesticides, fertilizers in addition to roadway runoff pollutants and sediments. The wetlands function as groundwater discharge, flow, flow storage, and alteration as it captures snow melt and storm events. It functions as wildlife habitat due to its relatively undisturbed nature and adjacency to larger undisturbed habitat and amount of food bearing vegetation.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Summarize overall biological, chemical and physical functions being performed: Emergent meadow provides for agricultural pollutant attenuation prior to flowing thru larger wetland complex which further flows into the TNW. The wetlands function as groundwater discharge, flow flow storage and alteration as it captures snow melt and storm events. Due to it's proximity to Route 161, it will capture sediments, nutrients and pollutants from the highway. It functions as wildlife habitat due to it's relatively undisturbed nature and adjacency to larger undisturbed habitat and amount of food bearing vegetation.

Summarize overall biological, chemical and physical functions being performed: This wetland system contains wetlands that are adjacent to an RPW. The wetlands function as ground water discharge, flow, flow storage and alteration as they capture snow melt, hillside seeps and storm events. Summarize overall biological, chemical and physical functions being performed: This system contains wetlands that are adjacent to an RPW which flows directly into a TNW. The wetlands provide attenuation of agricultural pollutants such as herbicides, pesticides, fertilizers in addition to roadway runoff pollutants and sediments. The wetlands function as groundwater discharge, flow, flow storage, and alteration as it captures snow melt and storm events. It functions as wildlife habitat due to its relatively undisturbed nature and adjacency to larger undisturbed habitat and amount of food bearing vegetation. Mud Lake Stream/Cross Lake Thorofare provides for conveyance of wetland drainage from the northeast of Route 161.

C. SIGNIFICANT NEXUS DETERMINATION

Summarize overall biological, chemical and physical functions being performed: The wetland system contains wetlands adjacent to an RPW, and function as ground water discharge, flow, flow storage and alteration as they capture snow melt, hillside seeps and storm events. Due to its proximity to Route 161, it will capture not only farm field pollutants such as fertilizers and herbicides, but also sediments, nutrients and pollutants from the highway.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
