The U.S. Army Corps of Engineers is in the process of revising the Charles River Natural Valley Storage Area Master Plan. The Master Plan revision will guide the land and recreational management of the federally owned property that make up the flood storage area for the next 25 years. Management activities include protecting natural and cultural resources, providing public land and water recreation, protecting the public, and ensuring reservoir and dam operations.
