The following have been added by full text: <u>REQUEST FOR INFORMATION</u>

QUESTION 1: Can you please provide the incumbents info, if there is one along with the previously awarded contract number and the total awarded amount?

RESPONSE 1: The Government is permitted to provide only the previous contract awardee and total awarded contract amount. The previous awardee for these services was Cavossa Disposal Corp for a total contract amount of \$79,520. Interested vendors should note that service requirements may differ from previous awards.

QUESTION 2: Are there dumpsters on site that will need to be replaced?

QUESTION 5: Confirming that this contract dictates a combined total of 15 removals for the first year? Will additional removals be a possibility and if so will the TPOC notify us of that?

RESPONSE 5: The quantity of services to remove and dipose of debris will not exceed the maximum totals stated in the Bid Schedule and the Performance Work Statement.
