The delivery date of 31 December 2026 in "Continuation of Deliveries or Performance" will be updated at award to reflect contract award date through 31 December 2026 for the base year.

Question 2: The Performance Work Statement references nine (9) scheduled pickups per year (April-December). Please confirm whether the Government's intent is one scheduled pickup per month, with additional service needs addressed through the on-call pickup quantities identified in the solicitation.
