LATEST NEWS FROM FORMER FORT DEVENS

Investigation and cleanup activities continue in several locations at former Fort Devens. In this fact sheet, we review the history of former Fort Devens and highlight the Army's commitment to environmental cleanup. We also recap the community open house held in November 2024 and discuss the upcoming 2025 Five-Year Review.

COMMUNITY OPEN HOUSE

The Army and U.S. Army Corps of Engineers (USACE) hosted a community open house on November 21, 2024, in the Great Hall at Ayer Town Hall. Poster stations staffed by project team members were on display throughout the hall and covered a variety of topics including former Fort Devens history, PFAS investigation updates, Shepley's Hill Landfill, and more.

The event provided the community another opportunity to learn more about former Fort Devens environmental cleanup efforts, talk directly with representatives from Army, USACE, USEPA, Massachusetts DEP, and Mass Development, and learn how to get involved through the Restoration Advisory Board (RAB).

Representatives from Nashua River Watershed Association (NRWA), People of Ayer Concerned about the Environment (PACE), and the Town of Ayer water department were also on hand and shared their perspectives with the community.

2025 FIVE-YEAR REVIEW

The U.S. Army Base Realignment and Closure Division (BRAC) is announcing the start of the sixth Five-Year Review of remedial actions taken at the Former Fort Devens Federal Superfund site. The purpose of the Five-Year Review is to evaluate whether the cleanup methods are working as designed and continue to remain protective of human health and the environment. As part of the review process, the Army invites local communities to participate in community interviews and attend quarterly RAB meetings. The interviews are valuable because they help the Army gather community perspectives on remedy performance and overall progress during the past five years.


