STATEMENT OF WORK

BOURNE BRIDGE PAVEMENT AND JOINT REPAIR U.S. ARMY CORPS OF ENGINEERS CAPE COD CANAL FIELD OFFICE Bourne, Massachusetts

I. General

1. Scope

The contractor shall furnish all labor, equipment, materials, and transportation necessary to complete a repair to the damaged pavement and a steel joint (Photo 1) at one location on the Bourne bridge in Bourne, MA. Work includes demolition of asphalt pavement and concrete to expose the joint anchors, replacement of 10 linear feet of steel angle and installation of new elastomeric concrete (government furnished material) and bituminous pavement in accordance with the Statement of Work. The contractor shall utilize sufficient personnel and equipment to complete work within one eight-hour shift on the bridge. Contractor is responsible for all traffic control necessary for the work.

*Note: This work requires the following submittals prior to commencement of work:

- Abbreviated Accident Prevention Plan
- Activity Hazard Analysis
- 10-hr OSHA Certification
- First-Aid, CPR Certifications (If 2 or more employees on-site)
- Schedule for On-Site Work (submit to TPOC, at least 7 days prior to start date)

2. Location

The repair location is located on the north abutment of the Bourne Highway Bridge, Route 28-MA, Bourne, MA (Figures 1 and 2 show the location).

3. Site Visit

To arrange a site visit, contact the Technical Point of Contact (TPOC), Operations Specialist, David D'Angelo (978-318-8507 or david.d.d'angelo@usace.army.mil).

4. Schedule

The work shall be completed within 21 days of contract award. The work area will be open to the contractor Monday through Friday, 6:00 AM to 5:00 PM. No work shall be done on weekends or Government holidays. The contractor shall utilize sufficient personnel and equipment to complete work within one eight-hour shift on the bridge. Work shall be sequenced to minimize impacts to traffic.

5. Safety Requirements

All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety, and health requirements. A copy of EM 385-1-1 can be accessed at the project office or

electronically at Headquarters USACE website under publications using the following link:

Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

All Safety Submittals must be accepted prior to the commencement of any field work activities.

a. Abbreviated Accident Prevention Plan: The Contractor shall prepare an Abbreviated Accident Prevention Plan (AAPP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable Abbreviated APP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the Abbreviated APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

- b. Activity Hazard Analyses: An AHA shall be submitted for each major phase of work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. Work shall not proceed on a phase of work until the AHAs have been accepted. A preparatory meeting shall be conducted to discuss the AHAs with onsite employees. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.
- c. <u>Emergency Response:</u> Emergency procedures shall be documented in the Abbreviated Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.
- d. Required Personnel: The Contractor shall employ a minimum of one competent person at the project site that is responsible for safety. The safety person shall be present at the project site and be responsible for safe means and methods of construction and compliance with approved safety plans. The safety person is required to have related construction experience and have completed a 10 Hour OSHA training (or more).

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, at least two (2)

- employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.
- e. Accident Reporting: All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC immediately. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

6. Preconstruction Conference

Prior to the start of any work, the Contractor and Technical Point of Contact will schedule and conduct a "Preconstruction Conference". The Contractor's Project Manager and Quality Control Personnel will be physically present to attend this meeting. This conference will be scheduled for a time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the requirements in terms of safety, quality, submittals, communications, inspections, and payments. Storage areas for materials, equipment and dumpsters will also be coordinated at this meeting.

7. Security

The contractor will comply with all established security policies on the Project. Potential periods of heightened security measures may affect contractor access to the Project work area. During periods of heightened security, the Government reserves the right, at any time, to close the Project area and reschedule and/or cancel work. The Contractor shall be given at least a 24- hour notice of any such closure.

8. Contractor Conduct

The work area is located on Federal property. Contractor and employees must always act in a professional manner. Alcohol and firearms are prohibited on project grounds.

9. Government Resources:

The government will provide reasonable amounts of water and electricity for the contractor to accomplish the work. The contractor is responsible for providing all other resources to complete the project. The Wabo-crete raw materials will be supplied by the Government as stated in Part 2. Section 6. "New Government Furnished Wabo-crete elastomeric concrete" below. The Government will not provide any additional equipment or services.

10. Omissions:

This scope of work may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

11. Quality Control and Quality Assurance:

The Contractor is responsible for the quality control of all work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times during the term of the contract.

12. Other Contracts:

The Government may undertake or award other contracts for additional work not related to this contract, the Contractor shall fully cooperate with other Contractors and Government employees. The contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by Government employees.

13. Storage and Equipment Staging Areas:

Storage and equipment staging areas shall be coordinated with TPOC. Contractor is responsible to manage all storage of materials, dumpsters, and staging inside this work area. The contractor is responsible for receiving, unloading and movement of all materials. The contractor shall ensure that stored materials do not migrate into the waterway, roadway, or railroad track right of way. Contractor shall ensure the area adjacent the railroad track right of way is clear at all times. Any materials that migrate into the waterway, roadways, sidewalks, bike paths, or recreation areas shall be cleaned up by the contractor daily. The Government is not responsible for damage or theft of contractor equipment or materials.

14. Clean Up:

The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work, the contractor shall remove all surplus tools, equipment, and materials, etc., that are not the property of the government and shall clean up the job site to the satisfaction of the government. Contractor shall leave the entire site and areas adjacent in a neat and orderly condition. Contractor shall clean up and properly dispose of debris off-site in accordance with Federal, State and Local ordinances and regulations.

15.Payment

II. Execution and Technical Requirements

- 1. The schedule for all onsite work shall be coordinated with the TPOC prior to start. At least 7 days prior notice is required to allow the TPOC to coordinate the lane restrictions on the Bourne Bridge with local municipalities and MASSDOT. Work shall be performed in a safe manner that protects both workers and the motorists from hazards.
- 2. Contractor is responsible to provide all required traffic control devices and two police details for the work on the bridge. Contractor shall hire one State Police detail and one Bourne Police detail to assist with traffic control on the bridge. Traffic control devices, positioning and methodology should conform with the Manual on Uniform Traffic Control Devices (MUTCD) and MASSDOT Work Zone Safety Guidelines. At all times, at least one 12' wide travel lane in each direction shall remain open during construction work. The contractor shall utilize sufficient personnel and equipment to complete work within one eight-hour shift on the bridge. All traffic control devices shall be promptly removed after completion of work.
- 3. The damaged steel angle to be replaced is approximately 10' long. The existing asphalt pavement shall be saw cut approximately 24" from the damaged steel angle and removed. The existing waterproofing membrane and high strength concrete deck shall be saw cut approximately 12" from the damaged steel angle. The concrete shall be removed to expose the broken steel angle and anchors. All loose steel, asphalt, concrete and debris shall be removed prior to repair work. Demolition shall be performed carefully to protect reinforcing steel in the deck and ensure depth of demolition does not exceed 6".
- 4. New steel angle and anchors The damaged steel angle shall be removed and replaced with a new ½" x 4" x 4" x 10' steel angle. Steel shall be in accordance with ASTM A36/A36M. New steel installed to fit flush with the existing expansion joint with full penetration welds. New steel anchors at least one inch diameter and minimum length of 6 inches shall be welded to the new angle spaced every 12". The new angle shall be accurately set and securely supported at the correct grade and elevation to match the opening of the existing expansion joint.
- 5. Welding All welding shall be performed in accordance with AWS D1.1/D1.1M. All welds shall be full penetration welds with welds ground smooth in the finished installation.
- 6. New Government Furnished Wabo-crete elastomeric concrete The Wabo-crete raw materials will be supplied by the Government. Contractor shall install the material adjacent to the new angle and around the anchors. The contractor shall follow the manufacturer's instructions for the mixing, placing, and curing of the Wabo-crete material. The entire area must be clean, dry, and sound material for proper Wabo-crete adhesion. Wabo-crete material shall be formed with square edges and allow for 2" of new asphalt pavement to match the existing conditions. Government furnished supplies valued at \$1,371.00.
- 7. New Asphalt Pavement Contractor shall install new bituminous asphalt pavement material in a 2' thick layer. Pavement shall be MassDOT Class 1 Hot Asphalt Mix (HMA)

from a MassDOT approved asphalt processing plant. Pavement shall be installed by experienced installers in accordance with appropriate industry practices to produce a professional quality installation. The existing asphalt pavement to remain adjacent to new pavement shall be saw cut to provide a vertical surface and straight lines. All edges of the existing pavement shall be coated with tack coat material prior to placement of any new asphalt pavement. The finished surface of new pavement shall transition smoothly to adjacent pavement. Compaction shall not displace or extrude pavement from position. Tack material shall meet ASTM specification D977 for grade RS-1.

New pavement mix shall be completely well compacted using a mechanical tamper to achieve 95% compaction.

8. All debris from the work shall be removed from the site by the Contractor properly disposed or recycled. All debris shall be handled in accordance with Federal, State and Local ordinances and regulations.

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007

in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

52.204-27 PROHIBITION ON A BYTEDANCE COVERED APPLICATION (JUN 2023)

(a) Definitions. As used in this clause--

Covered application means the social networking service TikTok or any successor application or service developed or provided by ByteDance Limited or an entity owned by ByteDance Limited.

Information technology, as defined in 40 U.S.C. 11101(6)--

- (1) Means any equipment or interconnected system or subsystem of equipment, used in the automatic acquisition, storage, analysis, evaluation, manipulation, management, movement, control, display, switching, interchange, transmission, or reception of data or information by the executive agency, if the equipment is used by the executive agency directly or is used by a contractor under a contract with the executive agency that requires the use-
- (i) Of that equipment; or
- (ii) Of that equipment to a significant extent in the performance of a service or the furnishing of a product;
- (2) Includes computers, ancillary equipment (including imaging peripherals, input, output, and storage devices necessary for security and surveillance), peripheral equipment designed to be controlled by the central processing unit of a computer, software, firmware and similar procedures, services (including support services), and related resources; but
- (3) Does not include any equipment acquired by a Federal contractor incidental to a Federal contract.
- (b) Prohibition. Section 102 of Division R of the Consolidated Appropriations Act, 2023 (Pub. L. 117-328), the No TikTok on Government Devices Act, and its implementing guidance under Office of Management and Budget (OMB) Memorandum M-23-13, dated February 27, 2023, "No TikTok on Government Devices" Implementation

Guidance, collectively prohibit the presence or use of a covered application on executive agency information technology, including certain equipment used by Federal contractors. The Contractor is prohibited from having or using a covered application on any information technology owned or managed by the Government, or on any information technology used or provided by the Contractor under this contract, including equipment provided by the Contractor's employees; however, this prohibition does not apply if the Contracting Officer provides written notification to the Contractor that an exception has been granted in accordance with OMB Memorandum M-23-13.

(c) Subcontracts. The Contractor shall insert the substance of this clause, including this paragraph (c), in all subcontracts, including subcontracts for the acquisition of commercial products or commercial services.

Commercially available off-the-shelf (COTS) item—
(1) Means any item of supply (including construction material) that is-
(i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);
(ii) Sold in substantial quantities in the commercial marketplace; and

- (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-
- (i) An unmanufactured construction material mined or produced in the United States; or
- (ii) A construction material manufactured in the United States, if--
- (A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
- (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are

treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. - (2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine

whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.

- (3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.
- (B) For domestic construction material that is a critical item or contains critical components.
- (1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.
- (2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.
- (3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.
- (ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or
- (iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.
- (c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--
- (A) A description of the foreign and domestic construction materials;
- (B) Unit of measure;
- (C) Quantity;
- (D) Price;
- (E) Time of delivery or availability;
- (F) Location of the construction project;
- (G) Name and address of the proposed supplier; and
- (H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.
- (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.
- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.
- (3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.
