I. General:

- 1. Scope Furnish all equipment, materials, labor and transportation necessary to provide approximately twelve (12) miles of U.S. Army Corps of Engineers (USACE) Property Boundary identification, clearing, and marking at Surry Mountain Lake.
 - a. While performing boundary maintenance, the contractor will keep an ongoing written report of all findings including missing monuments, damaged monuments, monuments that couldn't be located, areas where fiberglass/carsonite posts need to be placed (or replaced), trespasses, encroachments, etc. including photographic evidence to be submitted upon completion of the contract. A photo album of every monument located will be included with the final report.

2. Location -

Daily safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

c. Activity Hazard Analysis (AHA):

An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. A DFOW is defined as any task, which is separate and distinct from other tasks, has separate control requirements, or is identified as different trades or disciplines. The Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.b.

Level 3 SSHOs must have training, knowledge, and/or experience identifying hazards and implementing controls for the work being performed.

f. Additional Personnel Requirements:

h. Employee Exposure Data:

The Contractor shall electronically report total employee work hours (including subcontractors) to the Technical Point of Contact by close of business on the 10th calendar day of the following month.

6. Contractor's Personnel -

a. Minimum Personnel Requirements - The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently

within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.

b. Employee Conduct - The Contractor shall be responsible for seeing that the firm's employees strictly comply with the Code of Federal Regulations Title 36, Chapter III, Part 327, and all, federal, state, and municipal laws. 1. Summary – Boundary lines are maintained lines of sight to ensure abutters are aware of federal boundary lines on U.S. Army Corps of Engineers property. Maintenance to clear these lines requires trimming, brush removal, tree marking, as well as providing a written report of all findings including missing monuments, monuments that couldn't be located, areas where fiberglass/carsonite posts need to be placed or replaced, trespasses,

encroachments, etc. containing photographic evidence to be submitted upon completion of the contract. A photo album of every monument located will be included in the final report.

2. Submittals – Although the Government reviews submissions required by this Performance Work Statement, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The Government reserves up to twenty one (21) days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall resubmit to the Government within fourteen (14) days of the Government's response, unless additional time is granted by the Government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and accepted by the Government.

- **a. Pre-work:** Submitted within twenty-one (21) days of contract award. Submittals must be accepted prior to the commencement of any field work activities.

 - i. A written report with photographic evidence and associated map documenting any encroachment or suspected encroachment observed. Observed encroachments are to be immediately reported to the Technical Point of Contact.
 - **ii.** A written final report of all findings including missing monuments, monuments that couldn't be located, damaged monuments, areas where fiberglass/carsonite posts need to be placed or replaced, trespasses, encroachments, maps, etc. including photographic evidence.
 - o A photo album including a picture of every boundary monument located, including broken and/or damaged monuments will be included in this report.
- **3.** Existing Conditions For all sections of boundary lines included in this contract, the contractor may anticipate overgrown brush/small trees, fallen trees, rough terrain, non-existing or faded marking paint, and broken or missing signage. Boundary monuments are assumed to be intact but may be difficult to locate.

Note: Contractor will receive detailed maps and information of service areas from the USACE upon contract award.

4. Other Contracts – The Government may undertake or award other contracts for additional work not related to this contract, and the contractor shall fully cooperate with other contractors and Government employees. The contractor shall not commit or permit any act

which will interfere with the performance of work by another contractor or by Government employees.

- 5. Clean Up and Waste Disposal The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any designated storage areas free from accumulation of waste materials. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the Government. Any and all disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the Technical Point of Contact. All waste material will be disposed of offsite in accordance with all federal, state, and local regulations.
- **6. Personal Protective Equipment** It is the contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.
- 7. Damage to Government and Private Property The contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the contractor's operation. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the contractor's operation. The contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person resulting from the contractor's operation. Trucks and/or trailers will be driven on existing roads only and not across or through park areas to facilities.
- **8. Quality Assurance** The contractor is responsible for the quality control of the contract work. The contractor shall establish and maintain a quality control system to assure compliance with the contract requirements. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
- 9. Restrictions All work will be inspected by the contractor's Quality Control Inspector as boundary line maintenance commences. The contractor shall notify Technical Point of Contact immediately upon completion of services, so that the Army Corps of Engineers may inspect the work. The contractor shall be responsible for correction of any and all deficiencies discovered by the Quality Assurance inspection. These correction(s) will be at no additional cost to the government.
- **10. Receiving and Storing Materials** The contractor is responsible for protecting any stored material until it is placed in service. The contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive materials or supplies for the contractor and will not be responsible for damage to the contractor's equipment or materials.
- 11. Omissions This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

Part 2 Products:

All products shall be new, unused and to the satisfaction of the Technical Point of Contact. Products shall be approved by the Technical Point of Contact prior to use.

1. Contractor Furnished Paint - The contractor shall furnish marking paint required to complete the performance work statement. The paint must be approved in advance by the TPOC.

2. Tree Marking Paint -

- **a.** Provide a 6-8 year permanent duration
- **b.** Applied either by brush or forestry marking spray applicator
- **c.** Orange in color
- **d.** Paint will be oil base for durability

Part 3 Equipment:

1. Condition of Equipment - All equipment used to perform work under this contract must be in good operating and mechanical condition and comply with EM 385-1-1, US Army Corps of Engineers Safety and Health Requirements.

2. Type of Equipment -

a. Chainsaws, overhead chainsaws, motorized brush cutters, metal detector, pruners and forestry paint applicator may be required throughout the execution of the contract.

Part 4 Service Requirements:

Boundary lines are maintained lines of site to ensure abutters are aware of federal boundary lines on USACE projects. Maintenance to clear these lines requires routine identification, clearing, painting, marking, reporting encroachments (documenting via photo), and reporting broken or missing monuments.

1. Identification of Boundary -

- a. Contractor will receive detailed maps and information of service areas from the USACE upon contract award. Maps will not be released to the public and must be returned after work has been accepted. Services performed under this contract are to be based on boundary surveyed data as indicated on maps furnished to the contractor by USACE.
- **b.** The detailed boundary survey maps indicate the location of project boundary monuments and the distances and bearings of the property lines.
- **c.** At the end of the contract period of performance all maps furnished to the contractor shall be returned to the USACE.
- **d.** Maps will contain locations of county, town, streets, and USACE monuments within boundary line service area.
- e. Contractor will identify the true USACE boundary prior to clearing and marking, which may require the use of temporary flagging for boundary line accuracy. Any flagging used will be removed by the contractor prior to completion of the contract.

2. Clearing of Boundary Lines -

- **a.** Contractor will clear/maintain a four-foot wide, from U.S. Government boundary, by eight feet high line of site by cutting all branches, trees three inches (3") diameter and under at breast height, and brush/fallen trees intruding into this line; stumps will be cut no higher than three inches (3") above the ground
- **b.** Branches will be cut back to the main stem of the tree/shrub.
- **c.** Clearing is not required where the bound is defined by roads, hedges, stone walls, fences, streams, or bodies of water.
- **d.** All cuttings will be disposed onto USACE property and not left hung up in trees or placed on abutters' property.

3. Marking of Boundary Line, Monument and Corner Trees, Bounds -

a. Marking Boundary Line:

- i. Marking boundary line shall be made by painting the closest tree within the four feet boundary clearing, approximately five feet above the ground, with at least a four (4") inch diameter orange paint mark.
- ii. Trees to be painted shall be greater than four inches in diameter at breast height and shall be either on the boundary line or on government property within four feet of the boundary line.
- iii. Trees shall be painted as necessary to provide marks visible from each to the next at an interval not to exceed fifty (50') feet.
- iv. In open or lightly wooded areas, where a painted mark is not possible, a fiberglass/carsonite post should mark the boundary. All areas where posts are missing (interval not to exceed 50 feet) or damaged shall be included in the final written report.

b. Marking Boundary Monument and Corner Boundaries:

- i. Marking Monument and Corner Boundaries shall be made by painting closest tree, within the four feet boundary clearing on Government property, approximately five feet above the ground, with three (3) parallel lines marked, each one at least twelve (12") inches in length. For trees less than twelve (12") inches at DBH, markings shall coincide with tree diameter at DBH.
- **c.** Boundary Monuments will receive the same orange marking if room allows.
- **d.** Type of boundary monument varies (aluminum/brass/bronze disk, drill holes, concrete marker, etc.). Boundary Monuments should have a carsonite post with a boundary and witness sticker on it. Final report shall list each monument and rather post is present or missing.
- **e.** Paint markings and stakes shall be made to be seen as entering USACE property and installed only on USACE property.
- **f.** Paint and all supplies to perform this contract will be supplied by the contractor.

4. Monument Inspection and Documentation -

- **a.** There are two hundred (200) monuments along Surry Mountain Lake's boundary that require inspection under this contract.
- **b.** Contractor shall be responsible to use a metal detector, where appropriate, to locate monuments that may not be immediately visible.
- c. ALL monuments will be painted with ORANGE colored tree marking paint.

d. Contractor will provide the Technical Point of Contact documented conditions of all monuments on site with notes and photos of each monument. Contractor shall make note of any missing, damaged or incorrect monument identification on provided maps and whether a post with a witness sticker is present at each monument.

5. Encroachment Reporting -

- **a.** Contractor will provide a photo album with pictures of possible encroachment and indicate where the encroachment is on provided maps with a brief description of each encroachment and include this information in the final report.
- **b.** Discovery of encroachments and suspected encroachments are to be immediately reported to the Technical Point of Contact throughout the course of the contract.
- **c.** The contractor SHALL NOT attempt to resolve any encroachments.

ALL OCCUPATIONS LISTED ABOVE RECEIVE THE FOLLOWING BENEFITS:

HEALTH & WELFARE: \$5.36 per hour, up to 40 hours per week, or \$214.40 per week or \$929.07 per month

HEALTH & WELFARE EO 13706: \$4.93 per hour, up to 40 hours per week, or \$197.20 per week, or \$854.53 per month*

*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706, Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 1 week paid vacation after 1 year of service with a contractor or successor; 2 weeks after 2 years; and 3 weeks after 10 years. Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of eleven paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Juneteenth National Independence Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: This wage determination does not apply to any individual employed in a bona fide executive, administrative, or professional capacity, as defined in 29 C.F.R. Part 541. (See 41 C.F.R. 6701(3)). Because most Computer Systems Analysts and Computer Programmers who are paid at least \$27.63 per hour (or at least \$684 per week if paid on a salary or fee basis) likely qualify as exempt computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 213(a)(17), this wage determination may not include wage rates for all occupations within those job families. In such instances, a conformance will be necessary if there are nonexempt employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industry, and are not determinative of whether an employee is an exempt computer professional. To be exempt, computer employees who satisfy the compensation requirements must also have a primary duty that consists of:

- (1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;
- (2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;
- (3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation requirements and the above duties test qualifies as an exempt computer professional under both section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (Field Assistance Bulletin No. 2006-3 (Dec. 14, 2006)). Accordingly, this wage determination will not apply to any exempt computer employee regardless of which of these two exemptions is utilized.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you

work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

** HAZARDOUS PAY DIFFERENTIAL **

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, dying, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that

represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

** UNIFORM ALLOWANCE **

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of ""wash and wear"" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

** SERVICE CONTRACT ACT DIRECTORY OF OCCUPATIONS **

The duties of employees under job titles listed are those described in the ""Service Contract Act Directory of Occupations"", Fifth Edition (Revision 1), dated September 2015, unless otherwise indicated.

** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE, Standard
Form 1444 (SF-1444) **

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the ""Service Contract Act Directory of Occupations"" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1)).
