BID SCHEDULES:

1. If a Bid Schedule is included in the solicitation, vendors shall complete the bid schedule in its entirety (all tasks, all years).
2. Failure to complete the Bid Schedule in its entirety and return same with a quote will result in quotes being deemed non-responsive.

SITE VISITS:

1. If dates/times for site visits are included in the solicitation, then interested vendors will be permitted to visit the site during those dates/times. No other dates/times will be permitted for site visits.

SUBMITTALS:

1. Submittals (Accident Prevention Plan, Activity Hazard Analyses, Products, etc.) and Certifications/Licenses (10-hour OSHA, 30-hour OSHA, Competent Person in Fall Protection, Electrician's License, etc.) that are specified in the scope as required by this solicitation are not to be submitted with a quote. BASIS OF AWARD:

1. Potential vendors are notified that the basis on which award will be made is price alone.
2. All responsible sources may submit a quote which, if timely received, must be considered by the Agency.

SECURITY REQUIREMENTS

General security requirements and guidance: The security requirements described below apply to all contract personnel (including employees of the prime Contractor ("Contractor") and all subcontractor employees) supporting the performance requirements of this contract. The Contractor is responsible for compliance with these security requirements. Questions regarding security matters shall be addressed to the designated Government representative (eg., Contracting Officer Representative (COR), Requiring Activity (RA) representative, or Contracting Officer (if a COR or other RA representative is not appointed)). Contract personnel are critical to the overall security and safety of US Army Corps of Engineers (USACE) installations, facilities and activities, and security awareness training contributes to those efforts. The Department of Defense (DoD) and Army security training requirements specified below, if applicable, are performance requirements; all applicable contract personnel shall complete initial training within 30 days of contract award or the date new contract personnel begin performance on the contract. Within five business days from the completion of training, the Contractor shall provide written documentation (e.g., email or memorandum) to the Government representative. The documentation shall include the names of contract personnel trained and which training they completed; the Contractor shall maintain training records as part of their contract files and be prepared to provide copies of training certificates to the Government representative. Contractor personnel and vehicles are subject to search when entering federal installations. Additionally, all contract personnel shall comply with Force Protection Condition (FPCON) measures, Random Antiterrorism Measures (commonly referred to as "RAMs"), and Health Protection Condition (HPCON) measures. The Contractor is responsible for meeting performance requirements during elevated FPCON and/or HPCON levels in accordance with applicable RA plans and procedures –this includes identifying mission essential and non-mission essential personnel. In addition to the changes otherwise authorized by the changes clauses of this contract, should FPCON or HPCON levels at any individual facility or installation change, the Government may implement security changes that affect contract personnel. The Contractor shall ensure all contract personnel are aware of their security responsibilities, including any site-specific requirements identified in local policies or procedures.

Suspicious Activity Reporting training (e.g. iWATCH, CorpsWatch, or See Something, Say Something):

All contract personnel shall receive initial and annual refresher training from the RA representative on the local suspicious activity reporting program. This locally developed training provides contract personnel with general information on suspicious behavior, and guidance on reporting suspicious activity to the project manager, security representative or law enforcement entity.

Performance Work Statement

Part A

1. GENERAL

New England District Safety and Occupational Health Office (SOHO) oversees the use of Automated External Defibrillators (AED) throughout the District. It is the SOHO's responsibility to develop and implement a formal AED Program. This program requires medical direction and program management be provided by an outside source. The contractor shall furnish all labor and equipment needed to perform the duties detailed below for all AEDs within the New England District:

- Develop site-specific AED protocols
- Maintain current registration of AED with local EMS and 911 call centers
- Provide online maintenance tracking/notification system
- Provide AED evaluation post event

2. Locations

The U.S. Army Corps of Engineers, New England District (NAE) currently has 55 AEDs deployed throughout the New England states. The location and number of AED units at each location are detailed in Attachment 1.

3. Schedule

The period of performance is one year from 20 September 2024 to 19 September 2025 with two, one-year options. The period of performance for option year 1 is 20 September 2025 to 19 September 2026. The period of performance for option year 2 is 20 September 2026 to 19 September 2027.

4. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification necessary for the performance of this contract. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

5. Payment

The contractor shall furnish the USACE Technical Point of Contact (TPOC) with one invoice per quarter, identifying the contract number, dates of service to which invoice applies, and stating the services completed during the quarter. Payment shall be made quarterly for the actual services performed at the applicable contract unit price. The invoice can be mailed or emailed to the USACE TPOC using the following contact information:

Part B

1. Technical Items

The vendor will ensure that all AEDs are kept serviceable and in compliance with all governing AED laws, regulations, and best practices. Any deficiencies noted will be reported to the USACE TPOC. The contractor must provide the following services:

- a. Medical Direction and Program Management
 - Complete registration/application process for new or replacement AEDs, as required by state or local law.
 - Provide medical direction and oversight utilizing a Licensed Physician.
 - Provide the USACE TPOC with manufacturer recall information for the AEDs under this contract.
 - Provide a Point of Contact (POC) to answer questions and address programmatic issues.
- b. Site-Specific AED Protocols
 - Develop site-specific AED protocols and procedures.
 - Conduct annual review and update of AED protocols and procedures, providing written documentation of review to the USACE TPOC.
- c. AED Registration with Local EMS and 911 Call Centers
 - Maintain AED Registration with local EMS and 911 call centers.
 - Register newly acquired AED units with local EMS and 911 call centers.
- d. Online Maintenance Tracking and Notifications
 - Provide an electronic online system capable of providing the program POC with the following information:
 - i. State of readiness and compliance for each AED in the program
 - ii. Site-specific AED administrator and AED unit information (make/model/serial number)
 - iii. Equipment expiration dates
 - iv. Personnel training records
 - v. Electronic notifications/alerts for upcoming actions.

NOTE: Data obtained for this contract shall not be used to create databases or any other product not intended for use specifically for this contract. All data containing personal identifiers shall be handled in accordance with the Privacy Act of 1974 (Public Law 93-579). No data is to be released to anyone without the specific approval of the Contracting Officer.

e. Post Event Procedures

- Maintain the ability to collect data from all the AEDs in the program.
- Offer an online event reporting system.
- Provide loaner equipment if an AED must be sent offsite for data collection after an event.
- **The contractor is required to provide the following services post use:**
 - i. Provide a means to notify and record the event with the contractor.
 - ii. If a loaner AED is required, contractor will overnight a loaner AED unit to the location from which the AED was used. Replace items if used and return original AED to location from which it came. Return original AED to the location that experienced the event after everything is complete. Provide a shipping box and pre-paid mailing label to the USACE NAE location that received loaner AED so USACE NAE can return loaner AED to contractor.
 - iii. If AED utilizes a data card, provide instructions for shipping the event data card to the contractor. Contractor is to overnight a new data card to the location so AED is usable post event.
 - iv. Contractor will download the AED data and have the physician interpret the data to determine if the AED correctly analyzed the rhythm and recommended a shock if determined by the cardiac rhythm.
 - v. Contractor will compile all of the data into a report and submit the report to USACE TPOC and any additional state agencies that require the report.
 - vi. Communicate with the manufacturer, if necessary, on our behalf.

f. Additional Information

- If a current AED is determined to be irreparable or obsolete, USACE will purchase a new AED or replace a current AED. The Contractor will be responsible to develop (if new AED) or update (if replacing an AED) the AED site-specific program and add the AED to the electronic portal so the New England District AED Coordinators can track inspections and maintenance. The awarded Contractor is responsible only for the requirements described above, not the purchase of the AED themselves. The addition of AEDs to the program will require a modification to the contract at an agreed upon price with the Contractor. The Contractor shall not perform any work outside of the awarded Performance Work Statement until a modification signed by the Contracting Officer is issued.
- Contractor is only responsible for the site-specific protocols that are required to be updated annually.
- There are no requirements for training/education/classroom instruction.
- Site-specific AED protocols have been developed and will be provided to the AED oversight contractor. However, it is the contractor's responsibility to determine if these protocols comply with the "Guidelines for Public Access Defibrillation Programs in Federal Facilities" published in the Federal Register in August 2009. If protocols are not in compliance, the oversight contractor will be responsible for the update of the protocols and dissemination to the USACE TPOC.
- The awarded Contractor will be required to maintain training records in their electronic portal. Training records will be provided to the awarded Contractor by the USACE TPOC.

3. Administrative

- a. Government Resources: The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.
- b. Omissions: This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
- c. Quality Assurance: The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

CLAUSES INCORPORATED BY FULL TEXT

52.204-26 COVERED TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (OCT 2020)

(a) Definitions. As used in this provision, “covered telecommunications equipment or services” and “reasonable inquiry” have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

(c) Representations.

(1) The Offeror represents that it [____] does, [____] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(2) After conducting a reasonable inquiry for purposes of this representation, the offeror represents that it [____] does, [____] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

(End of provision)

52.204-27 PROHIBITION ON A BYTEDANCE COVERED APPLICATION (JUN 2023)

(a) Definitions. As used in this clause--

Covered application means the social networking service TikTok or any successor application or service developed or provided by ByteDance Limited or an entity owned by ByteDance Limited.

Information technology, as defined in 40 U.S.C. 11101(6)--

(1) Means any equipment or interconnected system or subsystem of equipment, used in the automatic acquisition, storage, analysis, evaluation, manipulation, management, movement, control, display, switching, interchange, transmission, or reception of data or information by the executive agency, if the equipment is used by the executive agency directly or is used by a contractor under a contract with the executive agency that requires the use-

(i) Of that equipment; or

(ii) Of that equipment to a significant extent in the performance of a service or the furnishing of a product;

(2) Includes computers, ancillary equipment (including imaging peripherals, input, output, and storage devices necessary for security and surveillance), peripheral equipment designed to be controlled by the central processing unit of a computer, software, firmware and similar procedures, services (including support services), and related resources; but

(3) Does not include any equipment acquired by a Federal contractor incidental to a Federal contract.

(b) Prohibition. Section 102 of Division R of the Consolidated Appropriations Act, 2023 (Pub. L. 117-328), the No TikTok on Government Devices Act, and its implementing guidance under Office of Management and Budget (OMB) Memorandum M-23-13, dated February 27, 2023, "No TikTok on Government Devices" Implementation Guidance, collectively prohibit the presence or use of a covered application on executive agency information technology, including certain equipment used by Federal contractors.
