# SEPTIC SYSTEM PUMP & FLOAT REPLACEMENT U.S. ARMY CORPS OF ENGINEERS BUFFUMVILLE LAKE, CHARLTON, MA STATEMENT OF WORK

#### I. GENERAL

#### 1. Summary:

Provide all labor, materials, equipment, and transportation necessary to remove and replace two septic tank pumps, associated electric lines, and four floats located within Buffumville Lake Park. There is an option to replace the existing stainless-steel guide rails within the tank if they are not sufficient to support the new septic pumps. All work shall be completed in accordance with the following Statement of Work.

#### 2. Location:

Buffumville Lake Park is located at 229 Oxford Road in Charlton, MA 01507. See the attached informational maps for more detailed location information.

#### 3. Site Visits and Requests for Information:

Site visits are strongly recommended to gauge the full scope of work and provide an accurate quote. No extra payment will be considered for perceived additional work caused by unfamiliarity with the site conditions and requirements. Contact the Technical Point of Contact (TPOC) to arrange a site visit. #### 4. Schedule:

The period of performance will be 120 days from contract award. Work shall be performed Monday through Friday between the hours of 7:00 AM and 3:30 PM unless otherwise approved by the TPOC. Any proposed changes to an approved schedule must be submitted to the TPOC in writing and are not finalized until approved. No work shall be done on weekends or Government holidays.

All pre-construction submittals shall be submitted within 21 days of contract award. The Government reserves up to 21 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall be resubmitted to the Government in an acceptable form within 14 days of the Government's response, unless additional time is granted by the Government in writing. No field work may proceed prior to the acceptance of pre-construction submittals.

# 5. <u>Safety Requirements:</u>

a. General: All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Occupational Health Requirements (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety and health requirements. Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

b. Accident Prevention Plan: The Contractor shall prepare a site-specific Accident Prevention Plan. The APP must be written by a Competent Person (CP) and document the specific work processes, equipment,

materials to be used, hazards and applicable control measures.

The mandatory ENG Form 6293 (Accident Prevention Plan Worksheet) must be submitted and accepted prior to beginning on site work:

A preparatory meeting shall be conducted by the Prime Contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing the subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Daily safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

c. Activity Hazard Analysis: An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. A DFOW is defined as any task, which is separate and distinct from other tasks, has separate control requirements, or is identified as different trades or disciplines. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

d. Site Safety and Health Officer (SSHO) Requirements: Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.b.

Level 3 SSHOs must have training, knowledge, and/or experience identifying hazards and implementing controls for the work being performed.

The SSHO shall be present at the project site and be responsible for overseeing the implementation of the Prime Contractor's SOH program. Contractor shall designate all SSHOs on a mandatory ENG Form 6282 (Site Safety and Health Officer Designation Letter): https://www.publications.usace.army.mil/Portals/76/Eng Form 6282 2023Aug28.pdf

- e. First-Aid and CPR Personnel Requirements: For shifts with multiple employees, provide at least two employees that are certified to administer First Aid and CPR. When employees work alone, they must be certified in First Aid and be provided an effective means of communication to call for assistance in the event of an emergency. Minimum First Aid and CPR qualifications are outlined in EM 385-1-1, Chapter 3-3.
- f. Additional Personnel Requirements: Other Competent Person (CP) or Qualified Persons (QP) may be required per EM 385-1-1 and/or other sections of this Scope of Work, based on the definable features of work for this project.
- g. Accident Reporting: All accidents and near misses shall be investigated by the Contractor and reported to the TPOC in accordance with EM 385-1-1, Table 2-1.

h. Employee Exposure Data: The Contractor shall electronically report total employee work hours

(including subcontractors) to the TPOC by close of business on the  $10^{th}$  calendar day of the following month.

#### 6. Electrical:

- a. General: All electrical work shall comply All electrical work shall comply with EM 385-1-1 (Sections 11 & 12) and applicable National Electrical Safety Code (NESC), National Electric Code (NEC), National Fire Protection Association (NFPA), OSHA and USCG regulations. In the circumstance there is a discrepancy between the codes and regulations listed above, the most stringent shall apply.
- b. <u>Qualified Person</u>: Electrical work shall be performed by a Qualified Person (QP) with verifiable credentials who are familiar with applicable code requirements. Verifiable credentials consist of State, National and/or Local Certifications or Licenses that a Master or Journeyman Electrician may hold, depending on the work being performed, and should be identified in the appropriate AHA. Journeyman/Apprentice ration shall be in accordance with State, Local and Federal requirements applicable to where the work is being performed.
- c. All electrical wiring and equipment shall be a type listed by a nationally recognized testing laboratory for the specific application for which it is to be used. Appropriate PPE will be worn and/or utilized at all times and adequately match the level of associated risk.
- d. Emergency Procedures and Training: Employees exposed to shock hazard and those employees responsible for taking action in case of emergency shall be trained in accordance with EM 385-1-1 Section 03.A, OSHA 29 CFR 1910.151, and NEPA 70E 110.2c. The training shall include methods to release of victims from contact with exposed energized electrical conductors or circuit parts. Employees shall be regularly instructed in methods of first aid and emergency procedures, such as approved methods of resuscitation.
- e. All equipment and circuits to be worked on shall be de-energized before work is started. Personnel shall be protected by a Hazardous Energy Control Program (HECP) and procedures in accordance with EM 385-1-1, Section 12. Positive means shall be provided for rendering controls or devices inoperative while repairs or adjustments are being made to the machines they control.
- f. If work MUST be performed on an energized system, then the employer must first demonstrate that deenergizing introduces additional or increased hazards or is infeasible due to equipment design or operational limitations (i.e., testing, troubleshooting, etc.).
- g. Energized work may never be performed without prior authorization. Once it has been determined that equipment must be worked on in an energized condition, an energized work permit shall be submitted to the Technical Point of Contact for acceptance. > See NFPA 70E and EM 385-1-1, Section 11.A.02.c for permit requirements

#### 7. Confined Spaces

## a. Permit Required Confined Space

i. General: The following requirements apply to all confined space work, except tunneling. Contractor is responsible for establishing, implementing, and managing a confined space program in accordance with EM 385-1-1 Chapter 34, ANSI/ASSE A10.43, ANSI Z117.1, and 29 CFR 1910.146.

If the confined space contains a flammable gas or vapor at 10% or higher than the LEL for the gas, then the space will be labeled "Not Safe for Workers – Not Safe for Hot Work."

If the confined space contains an atmosphere that is toxic, corrosive, or irritants that exceed the OEL, then the space will be labeled as "Not Safe for Workers."

#### ii. Submittals:

- 1) Prior to the beginning of any Permit Required Confined Space (PRCS) work, the Entry Supervisor must develop and submit written Site-Specific Confined Space Plan to the Technical Point of Contact for acceptance. This plan will include at least the following:
  - 1) Detailed description of the activity being performed.
  - 2) Confined Space Permit process that identifies hazards or concerns and the control measures that will be implemented to control to an acceptable level.
  - 3) Assignment of personnel and their roles and responsibilities. Include necessary information/documentation to support qualification/training of such persons.
  - 4) Inspection and oversight methods to ensure adherence to the plan.
  - 5) Equipment required for each entry.
  - 6) Procedures for conducting atmospheric monitoring.
  - 7) Communication methods used.
  - 8) Confined Space Inventory.
  - 9) Labeling procedures.
  - 10) Rescue Plan to include anticipated hazard levels.
- iii. If any of the following conditions or events occur, stop all confined space work:
  - 1) Additional hazards are identified.
  - 2) There is a change in the configuration, conditions, contents, or operation of the space.
  - 3) There is a change in assigned duties.
  - 4) Entrants must evacuate, or if there are changes in the overall use of the space that may increase the hazards to the Entrant.
  - 5) A new confined space is discovered or created due to construction or demolition activity.
  - 6) An accident or near miss occurs.

Entry Supervisor must update the Site-Specific Confined Space Plan and resubmit it for acceptance prior to resuming entry. (34-7.c)

#### iv. Roles and Responsibilities:

- 1) Owner/Operator will ensure contractor(s) are aware of potential or known confined space hazards where work will be performed and provide any other necessary information.
- 2) Qualified Person (QP): must identify and label Permit Required Confined Spaces (PRCS) to prevent unauthorized entry, and develop confined space programs for USACE operations.
- 3) Entry Supervisor: must develop site-specific Confined Space Plans and oversee and direct all PRCS entry operations. Additionally, the Entry Supervisor must fulfill all duties as subscribed in EM385-1-1, Ch. 34-4, to include but not limited to:
  - a) Remain onsite at all times during PRCS entries.
  - b) Verify all applicable procedures (for example, ventilation, fall protection) are in place prior to confined space entry.
  - Ensure all energy sources, mechanical hazards, and equipment is controlled, disconnected, or isolated prior to issuing an entry permit (see para 12-8.a).
  - d) Complete and sign the entry permit. See non-mandatory ENG Form 6208 (Permit-Required Confined Space Entry) https://www.publications.usace.army.mil/Portals/76/Eng Form 6208 2023Jun1.pdf
  - e) Ensure pre-entry testing and continuous monitoring of the confined space atmosphere is
    - conducted. See non-mandatory ENG Form 6205 (Atmospheric Testing) <a href="https://www.publications.usace.army.mil/Portals/76/Eng\_Form\_6205\_2023May25.pdf">https://www.publications.usace.army.mil/Portals/76/Eng\_Form\_6205\_2023May25.pdf</a>
  - f) Ensure Attendant(s) can execute the emergency response and rescue plan.
  - g) Coordinate with rescue services to ensure they are aware of the confined space entry and are capable of supporting according to the identified hazard level (see para 34-8.h).
- 4) Entrant: authorized Entrant must fulfill all duties as subscribed in EM385-1-1, Ch. 34-4, to include but not limited to:

- a) Understand the potential hazards of the confined space.
- b) Review and sign the entry permit when a permit is required.
- c) Enter the confined space only when directed by the Entry Supervisor or after the completion of a pre-entry evaluation.
- d) Notify the Attendant and exit the confined space immediately if symptoms, warning signs, or unacceptable conditions occur or when directed to do so by the Attendant or Entry Supervisor.

Note: The Entry Supervisor can also serve as an Entrant if so trained and qualified.

- 5) Attendant: must fulfill all duties as subscribed in EM385-1-1, Ch. 34-4, to include but not limited to:
  - a) Understand the hazards of the confined space.
  - b) Review and sign the entry permit.
  - Remain outside the assigned PRCS during entry operations until relieved by another Attendant or all Authorized Entrants have left the space and the permit is canceled.
  - d) Maintain a count of Entrants. See non-mandatory ENG Form 6207 (Confined Space Entrant Log) https://www.publications.usace.army.mil/Portals/76/Eng Form 6207 2023May31.pdf
  - e) Order the evacuation of the confined space upon identification of a hazardous condition inside or outside of the confined space.
  - f) Summon rescue or emergency services and/or perform non-entry rescue, as required.

Note: The Entry Supervisor can also serve as an Attendant if so trained and qualified.

- 6) Rescue Personnel: The role of a confined space rescue service, whether in house or outside rescue service, is to enter a space and perform a rescue. The rescue service must:
  - a) Respond in a timely manner, based on the hazards and conditions of the space.
  - b) Provide a team of sufficient size and technical training to perform the rescue.
  - c) Have the proper equipment and retrieval devices.
  - d) Provide basic first aid and CPR response.
- v. Entry Permits: The Entry Supervisor shall complete and sign a PRCS permit, and shall be responsible for enforcing the use of permits for entry into all PRCSs at the facility/site.
- vi. Confined Space Rescue: Base the confined space rescue plan on the hazard level. Until a confined space can be proven to have no potential for hazards and no potential difficulty associated with the rescue of Entrants, the rescue service must be able to meet the requirements of the following hazard levels:
  - 1) Hazard Level 1:
    - A confined space that does not contain any potential or recognized Hazards, but could require technical rescue due to its configuration that would prohibit Entrants from being easily removed should a worker become incapacitated. A fully trained rescue team must be available to respond within five minutes to the site and is capable of setup and rescue entry within 15 minutes of arrival onsite.
  - 2) Hazard Level 2:
    - A confined space that does not contain life-threatening or other potentially IDLH hazards, but does contain potential or recognized hazards that could incapacitate Entrants or prevent them from exiting the space without assistance. A fully trained rescue team must be onsite, equipped, and capable of setup for safe entry for rescue within 12 to 15 minutes of incident occurrence.
  - 3) Hazard Level 3:
    - A confined space that contains life-threatening hazards requiring immediate intervention (that is, IDLH atmosphere). A fully trained rescue team must be onsite and standing by in the immediate area throughout the entire entry. The rescue team must be dedicated to a single entry with no other responsibilities and will be completely set up and capable of rescue entry within two minutes of incident occurrence.

- vii. Personnel Required Qualification/Training: All personnel working in or around a confined space must receive training in accordance with EM385-1-1, Chapter 34-3. Some requirements include training:
  - a) Before assigned confined space duties, or when there is a change in assigned confined space duties. Whenever there is a change in confined space operations that presents a hazard, or the employer has reason to believe there are deviations from the confined space entry procedures or there are inadequacies in the individual's knowledge or use of the entry procedures.
  - b) If none of the above conditions exist, retraining must be conducted at least annually.
  - c) Initial training must meet requirements outlined in EM385-1-1, Ch. 34-3.b, most notably:
    - a) How to understand and recognize the characteristics of a confined space.
    - b) How to understand and recognize the hazards, signals, or warnings that require immediate evacuation.
    - c) Rescue exercise(s) applicable to the space(s) on the site.
    - d) Hands-on exercise on the use, calibration, and maintenance of monitoring equipment, communication equipment, and retrieval equipment.
    - e) Instruction on the use and donning of appropriate PPE needed for safe entry and exit.
  - d) Refresher Training must be completed at least annually by all Entrants, Attendants, Entry Supervisors, and Rescue Personnel. Training must meet requirements outlined in EM385-1-1, Ch. 34-3.c, most notably:
    - a) Review of entry procedures.
    - b) Rescue exercise.
    - c) The use of air monitoring, PPE, and retrieval equipment.

#### 8. Pre-Construction Conference:

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Pre-Construction Conference". The Contractor's Project Manager and Quality Control Personnel will be physically present to attend this meeting. The Contractor shall directly oversee all work on the project and the Project Manager and Quality Control Personnel shall have the authority to act for on behalf of the Contractor. This conference will be held at the time and location agreeable to the Government and Contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-Construction Conference the Contractor shall provide the name of the project superintendent with a telephone number for project coordination.

For the duration of the contract, the Contractor will be provided keys to the Buffumville Lake Park gate and pump house. The keys are to be used only for contract purposes. The keys will not be utilized to provide access for any individuals not performing contract specific work. During the contract period, the Contractor is assumed responsible for the keys. At the completion of work, the key must be returned to the TPOC.

The following is a general list of items for discussion during this pre-construction conference:

- Authority of the Technical Point of Contact
- Contractor's Safety Program (including sub-contractors)
- Accident Prevention Plan and Activity Hazard Analysis
- Daily Safety Meetings (Documented on NED Form 251)
- Accident Reporting (ENG Form 3394)

- Accident Prevention Plan (APP)
- Activity Hazard Analysis (AHA)
- Correspondence, Communication and Administrative Procedures
- Invoice and payment

#### 9. Permits:

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable federal, state, county, and municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

#### 10. Security:

The Contractor will comply with all established security policies at the project. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent work in an area. The Contractor shall be given at least 24-hour notice of any such closure.

#### 11. Payment:

After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. The invoice must also include the company letterhead, and this must match the data that is registered in the System for Award Management (SAM) registry. For jobs greater than 30 days the Contractor may request multiple payments.

## II. TECHNICAL

# 1. Submittals:

Although the Government reviews submissions required by this statement of work, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The Government reserves up to 21 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall resubmit to the Government in acceptable form within 14 days of the Government's response, unless additional time is granted by the Government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and accepted by the Government.

Pre-construction Submittals: Submitted within 21 days of contract award. Submittals must be accepted before the commencement of any field work.

Post-construction Submittals: Submitted at completion of field work and prior to final payment.

- Operation manuals for both effluent pumps

#### 2. Clean Up:

The Contractor shall practice good housekeeping to maintain a safe job site. The Contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area each day, the Contractor shall remove any tools, equipment, and materials that are not the property of the Government. Upon completion of work, the Contractor shall clean up the job site to the satisfaction of the Government.

## 3. Government Resources:

The Contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.

## 4. <u>Damage to Government and Private Property:</u>

The Contractor shall be responsible for restoring any Government facilities or structures damaged as a result of the Contractor's operation. The Contractor shall also be responsible for any damage to private property or injury to any person as a result of the Contractor's operations. The Contractor shall notify the TPOC immediately of damage to Government and private property and injury to any person resulting from the Contractor's operation.

#### 5. Omissions:

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

## 6. Quality Assurance:

The Contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

#### 7. Other Contracts:

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and Government employees. The Contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by Government employees.

#### 8. Environmental Protection:

Containers for excess and/or waste materials, rubbish, etc. shall be provided by the Contractor at the site, and the site will be inspected/cleaned each workday. No burning is permissible.

Water, air, and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met and maintained.

#### 9. Sustainability:

All products provided by the Contractor must meet the recycled content requirements set forth by the Environmental Protection Agency. Under the Comprehensive Procurement Guidelines (CPG) program, the Environmental Protection Agency (EPA) designates products that are or can be made with recovered materials and recommends practices for buying these products. Any designated product that is being offered

or supplied under this contract shall meet the minimum recommended content levels as identified under the CPG program. Any designated product that is being offered or supplied under this contract shall meet USDA BioPreferred's minimum bio-based content level. #### 10. Receiving and Storing Materials:

The Contractor is responsible for protecting any stored material until it is placed in service. The Contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the Contractor and will not be responsible for damage or theft of Contractor equipment or material.

## 11. Existing Conditions:

Buffumville Lake Park is a seasonal recreation area. The park's amenities include a swim beach, picnic tables and grills, restroom facility, and a picnic shelter. Hours of operation for the park are 8:00AM to 8:00PM every day from the third Saturday of May to the second Sunday of September, including federal holidays. The restroom facility is located in the lower portion of the park. Waste from the restroom is diverted into two tanks in series: a solids tank and a grey water tank. The existing pumps were installed in 2009.

#### a. Solids Septic Tank

- i. Wastewater is fed into the septic tank from the neighboring restroom facility.
- ii. 2' diameter metal cap, buried approximately 6" below grade.

## b. Grey Water Septic Tank

- i. The septic tank has a storage capacity of 4,000 gallons.
- ii. 2' diameter metal cap, buried approximately 10" below grade.
- iii. Wastewater is fed into the septic tank by a 4" pipe.
- iv. Two (2) Goulds WE1512H 1-1/2 horsepower cast iron effluent pumps.
- v. The pumps sit atop stainless-steel guide rails with 2" diameter pipe.
- vi. The electrical junction for the pumps is located approximately 10' from the tank in an electrical junction box.
- vii. The pump control panel is located approximately 250' from the electrical junction.
- viii. Three floats are currently installed.

#### c. Pump Control Panel

- i. Goulds D10020N1 single-phase duplex pump control panel mounted to a wooden structure.
- ii. Visual and auditory "HIGH" capacity alarm with alarm reset.
- iii. The pump control panel is located approximately 250' from the septic tank, adjacent to the picnic shelter.
- iv. The pump control panel's wiring allows for both 3-float and 4-float systems.
- v. See the informational attachments for the manufacturer's panel installation, operation, panel layout, dimensions, and float wiring instructions.

#### 12. Products:

#### a. Floats

- i. Four (4) tether float switches
- ii. Switches shall have a mechanical mechanism that is not liquid mercury.
- iii. The lowest float shall shut off all pumps when the septic tank is near-empty.
- iv. The second lowest float shall turn on the first lead pump as the septic tank is filled.
- v. The third lowest float shall turn on the second lag pump.
- vi. The highest float shall signal a high-level audible or light alarm within the pump control panel as

the septic tank nears capacity.

# b. Pumps

- i. Two (2) single-phase effluent pumps
- ii. The pumps shall be rated for 2 horsepower each.
- iii. 60Hz
- iv. 230 volts
- v. Up to 140 Gallons Per Minute (GPM)
- vi. Up to 128' Total Dynamic Head (TDH)
- vii. 3450 RPM
- viii. One pump shall serve as the lead pump.
- ix. One pump shall serve as the lag pump.

#### c. Electrical

 All electrical conduits, fittings, and extensions shall comply with National Electric Code (NEC) 230.24. All wire, conduit, cable, enclosures, and electrical fittings shall be weatherproof and rust resistant.

#### d. High-Level Alarms

- i. Visual alarm: SAE J845 Class 1 amber LED strobe light with IP67 rating for water and dust resistance.
- ii. Audible alarm: Outdoor continuous horn alarm with NEMA rating of 3R or higher and not to exceed 85 decibels.

## e. Septic Cover Risers

- i. Two (2) precast concrete septic risers with 24" diameter cast iron manhole covers.
- ii. Minimum concrete strength of 4,000 PSI with wire mesh reinforcement
- iii. Manhole covers must be labeled "SEPTIC"
- iv. The septic cover risers shall be made flush and level with soil grade

#### III. EXECUTION:

- 1. The Contractor shall pump the tank contents and properly dispose of the contents off-site in accordance with all local, state, and federal regulations. At the end of each workday the septic tank cover shall be replaced. Secure the work area around the tanks each night with safety fencing or caution tape.
- 2. The Contractor shall lock-out/tag-out the pump control panel in accordance with EM 385-1-1. Existing pumps and floats will be disconnected from the control panel. The pumps, floats, and all associated wiring will be removed and disposed of off-site by the Contractor.
- 3. Replace the electrical wiring needed for the new equipment, from the pump control panel to the septic tank through existing underground conduit and junction boxes.
- 4. Four (4) new floats will be installed in the septic tank and connected to the pump control panel. The four pumps shall serve the following purposes: shut-off of all pumps, activation of lead pump, activation of lagpump, and high-level alarm.
- 5. External high-level alarm components are to be installed and wired to the pump control panel. The visual alarm will be installed in a location on the wooden kiosk that is visible from the ADA parking spots adjacent to the shelter. The audible alarm will be installed on the face of the wooden kiosk closest to the shelter. All wires to the high-level alarms will be encased in conduit.
- 6. Two (2) new effluent pumps will be installed in the septic tank and connected to the pump control panel. One pump shall serve as the lead pump and the other shall serve as the lag pump within the system.
  - a. <u>OPTION:</u> If the existing stainless-steel guide rails are not sufficient to support the new effluent pumps, then the Contractor shall notify the TPOC in writing. The Government may choose to execute an option to fully replace the stainless-steel guide rails with an adequate support system.

- 7. Install two septic tank cover risers in accordance with all federal, state, and local regulations. One riser will be installed over the 2' diameter metal cap of the solids tank. The other riser will be installed over the 2' diameter metal cap of the grey water tank. Both risers shall extend to a height flush with grade.
- 8. After installation of the new floats and pumps, the Contractor shall restore electrical power to the panel by removing all lock-out/tag-out measures. All floats shall be tested by hand. During testing, the pumps shall be submerged in water so as not to run dry.

All soil disturbed through work performed under this contract will be graded, restored to the original state. Damage to the landscape such as stone dust walkways or turf will be restored to original state.

# 52.204-27 PROHIBITION ON A BYTEDANCE COVERED APPLICATION (JUN 2023)

(a) Definitions. As used in this clause--

Covered application means the social networking service TikTok or any successor application or service developed or provided by ByteDance Limited or an entity owned by ByteDance Limited.

Information technology, as defined in 40 U.S.C. 11101(6)--

- (1) Means any equipment or interconnected system or subsystem of equipment, used in the automatic acquisition, storage, analysis, evaluation, manipulation, management, movement, control, display, switching, interchange, transmission, or reception of data or information by the executive agency, if the equipment is used by the executive agency directly or is used by a contractor under a contract with the executive agency that requires the use-
- (i) Of that equipment; or
- (ii) Of that equipment to a significant extent in the performance of a service or the furnishing of a product;
- (2) Includes computers, ancillary equipment (including imaging peripherals, input, output, and storage devices necessary for security and surveillance), peripheral equipment designed to be controlled by the central processing unit of a computer, software, firmware and similar procedures, services (including support services), and related resources; but
- (3) Does not include any equipment acquired by a Federal contractor incidental to a Federal contract.
- (b) Prohibition. Section 102 of Division R of the Consolidated Appropriations Act, 2023 (Pub. L. 117-328), the No TikTok on Government Devices Act, and its implementing guidance under Office of Management and Budget (OMB) Memorandum M-23-13, dated February 27, 2023, "No TikTok on Government Devices" Implementation Guidance, collectively prohibit the presence or use of a covered application on executive agency information technology, including certain equipment used by Federal contractors. The Contractor is prohibited from having or using a covered application on any information technology owned or managed by the Government, or on any

information technology used or provided by the Contractor under this contract, including equipment provided by the Contractor's employees; however, this prohibition does not apply if the Contracting Officer provides written notification to the Contractor that an exception has been granted in accordance with OMB Memorandum M-23-13.

(c) Subcontracts. The Contractor shall insert the substance of this clause, including this paragraph (c), in all subcontracts, including subcontracts for the acquisition of commercial products or commercial services.

The term includes, with respect to forestry materials, forest products that meet biobased content requirements, notwithstanding the market share the product holds, the age of the product, or whether the market for the product is new or emerging. (7 U.S.C. 8101) (7 CFR 3201.2).

USDA-designated product category means a generic grouping of products that are or can be made with biobased materials--

- (1) That are listed by USDA in a procurement guideline (7 CFR part 3201, subpart B); and
- (2) For which USDA has provided purchasing recommendations (available at <a href="https://www.biopreferred.gov">https://www.biopreferred.gov</a>).
- (b) The Contractor shall report to <a href="https://www.sam.gov">https://www.sam.gov</a>, with a copy to the Contracting Officer, on the product types and dollar value of any biobased products in USDA-designated product categories purchased by the Contractor during the previous Government fiscal year, between October 1 and September 30; and
- (c) Submit this report no later than--
- (1) October 31 of each year during contract performance; and
- (2) At the end of contract performance.

(End of clause)

# 52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (OCT 2022)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

- (1) Means any item of supply (including construction material) that is-
- (i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);
- (ii) Sold in substantial quantities in the commercial marketplace; and
- (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency

lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-
- (i) An unmanufactured construction material mined or produced in the United States; or
- (ii) A construction material manufactured in the United States, if--
- (A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
- (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial

melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.
- (2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

- (3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that
- (i) The cost of domestic construction material would be unreasonable.
- (A) For domestic construction material that is not a critical item or does not contain critical components.
- (1) The cost of a particular domestic construction material subject to the requirements of the Buy American statute is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;
- (2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.
- (3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.
- (B) For domestic construction material that is a critical item or contains critical components.
- (1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.

- (2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.
- (3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.
- (ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or
- (iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.
- (c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--
- (A) A description of the foreign and domestic construction materials;
- (B) Unit of measure;
- (C) Quantity;
- (D) Price;
- (E) Time of delivery or availability;
- (F) Location of the construction project;
- (G) Name and address of the proposed supplier; and
- (H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.
- (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.
- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).
- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

- (3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.
- (d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
