# I. General

- 1. Scope of Work The Contractor shall provide all equipment, materials, labor, and transportation necessary to provide and service dumpsters for both construction debris and metal at the Cape Cod Canal. Services are to be provided in accordance with the following scope of work and schedule. All labor, equipment and transportation shall conform to Federal, State, and local laws and regulations. All work shall be performed in accordance with the following Performance Work Statement.

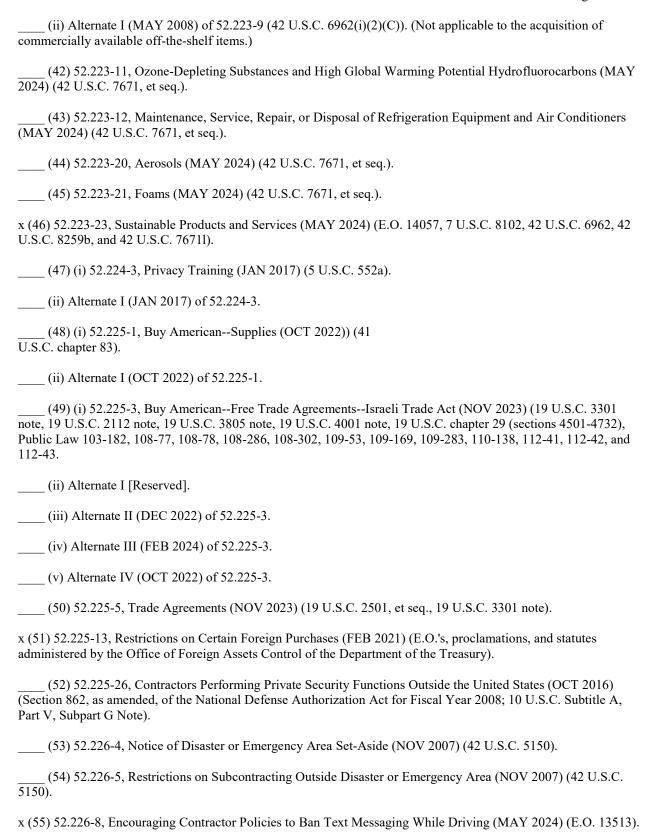
