1. Submittals (Accident Prevention Plan, Activity Hazard Analyses, Products, etc.) and Certifications/Licenses (10-hour OSHA, 30-hour OSHA, Competent Person in Fall Protection, Electrician's License, etc.) that are specified in the scope as required by this solicitation are **not** to be submitted with a quote. **SECURITY REQUIREMENTS**

**General security requirements and guidance:** The security requirements described below apply to all contract personnel (including employees of the prime Contractor ("Contractor") and all subcontractor employees) supporting the performance requirements of this contract. The Contractor is responsible for compliance with these security requirements. Questions regarding security matters shall be addressed to the designated Government representative (eg., Contracting Officer Representative (COR), Requiring Activity (RA) representative, or Contracting Officer (if a COR or other RA representative is not appointed)). Contract personnel are critical to the overall security and safety of US Army Corps of Engineers (USACE) installations, facilities and activities, and security awareness training contributes to those efforts. The Department of Defense (DoD) and Army security training requirements specified below, if applicable, are performance requirements; all applicable contract personnel shall complete initial training within 30 days of contract award or the date new contract personnel begin performance on the contract. **I. General**

1. **Scope of Work** – The Contractor shall provide all equipment, materials, labor, and transportation necessary to provide and service dumpsters for both construction debris and metal at the Cape Cod Canal. Services are to be provided in accordance with the following scope of work and schedule. All labor, equipment and transportation shall conform to Federal, State, and local laws and regulations. All work shall be performed in accordance with the following Performance Work Statement.
2. **Location** – The Cape Cod Canal Field Office is located at 40 Academy Dr. Buzzards Bay, Massachusetts.
3. **Site Visit**- To arrange a site visit, contact the Technical Point of Contact (TPOC), Park Ranger, William Butler (978)-318-8565 or email [William.B.Butler@usace.army.mil](mailto:William.B.Butler@usace.army.mil)
4. **Contract Term** – The period of performance for this contract is from date of Contract Award to 31 January 2026. In addition, the Government may exercise two (2) optional years with the same scope of services. Option year one would include a period of performance is from 1 February 2026 to 31 January 2027 and option year 2 would have a contract period of performance from 1 February 2027 to 31 January 2028.
5. **Pre-Work Conference** - Prior to the start of any work, the TPOC will conduct a pre-work conference within 7 days of contract award. This conference will be held at the time and location agreeable to the Government and Contractor. No work may be performed prior to this conference. The following is a general list of items for discussion during the pre-work conference:
  - a. Authority of the Technical Point of Contact and quality assurance inspectors.
  - b. Contractor's safety program (including sub-contractors).
  - c. Contractor's equipment.
  - d. Correspondence, communication, security, and administrative procedures.
  - e. Invoice and payment.
6. **Safety Requirements**-
  - a. General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Occupational Health Requirements (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety and health requirements. Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.
  - b. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor and immediately reported to the Technical Point of Contact.



7. **Permits-** The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.
8. **Security** – The Contractor will comply with all established security policies at the Cape Cod Canal Field Office. Due to periods of heightened security that may affect the access to the areas covered under this contract, the Government reserves the right to close any property or portion of property and reschedule and/or cancel any subsequent service. The Contractor shall be given at least 24-hour notice of any such closure.
9. **Environmental Protection** - The Contractor shall prevent pollution or damage to the environment resulting from work performed during this contract. The Contractor will receive no additional payment for environmental protection work. Prevention of pollution and environmental damage is a Contractor obligation under current State and Federal laws and regulations. Assurance of compliance with this section by sub-contractors shall be the responsibility of the Contractor. All spills/damage shall be immediately reported to the TPOC.
10. **Damage to Government and Private Property** - The Contractor shall be responsible for restoring all Government facilities or structures damaged due to Contractor's operations. The Contractor shall also be responsible for any damage to private property or injury to any person because of the Contractor's operations. The Contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person.
11. **Payment** – The Contractor shall furnish the Technical Point of Contact with one invoice per month. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, and total amount due per line item. The invoice must also include the company letterhead, and this must match the data that is registered in the System for Award Management (SAM) registry. Payment shall be made monthly for the actual services performed at the applicable contract unit price.

## **II. Technical Requirements**

- 1. Schedule** - Work is to be performed Mondays through Fridays between the hours of 7:00a.m. and 3:00p.m. Dumpster rentals and services are to be performed from Contract Award through 31 January 2026 during the base year. The Government reserves the right to exercise up to two (2) option years for similar services and quantities stated in this contract. Option year one would include a period of performance is from 1 February 2026 to 31 January 2027 and option year 2 would have a contract period of performance from 1 February 2027 to 31 January 2028.
- 2. Service Location, Description and Frequency –**
  - a. Cape Cod Canal Field Office, located at 40 Academy Drive in Buzzards Bay MA 02532:
    - i. One 15-cubic yard metal-only dumpster, emptied up to five (5) times per year (base year, option year 1, option year 2).
    - ii. One 30-cubic yard Construction and Demolition debris dumpster, emptied up to ten (10) times per year (base year, option year 1, option year 2).
- 3. Construction and Demolition Dumpster Service Requirement** - The Contractor will furnish all labor and equipment necessary to provide containment and removal service at the specified location and frequency. The servicing includes emptying and removal of all dumpster contents from Government property and proper disposal in accordance with all Federal, State, and local laws and regulations.
- 4. Metal Only Dumpster Service Requirements** - The Contractor will furnish all labor and equipment necessary to provide containment and removal service at the specified location and frequency. The servicing includes emptying and removal of all dumpster contents from Government property and proper disposal or recycling in accordance with all Federal, State, and local laws and regulation.
- 5. General Service Requirements –**
  - a. The Contractor shall coordinate delivery and removal dates with the Technical Point of Contact.
  - b. The Contractor is responsible for repairing or replacing any containers deemed unusable by the TPOC.
  - c. Dumpsters will be located in a secure compound only accessible between the hours of 7:00a.m and 3: 00p.m Monday through Friday.
  - d. If the Contractor cannot meet a scheduled service for an unforeseen event, such as equipment breakdown, weather event, or other circumstance outside of the control of the Contractor, the TPOC shall be notified as soon as possible.

(a) Definitions. As used in this provision, “covered telecommunications equipment or services” and “reasonable inquiry” have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

(c) Representations.

Information technology, as defined in 40 U.S.C. 11101(6)--

(2) Includes computers, ancillary equipment (including imaging peripherals, input, output, and storage devices necessary for security and surveillance), peripheral equipment designed to be controlled by the central processing unit of a computer, software, firmware and similar procedures, services (including support services), and related resources; but

(3) Does not include any equipment acquired by a Federal contractor incidental to a Federal contract.

(b) Prohibition. Section 102 of Division R of the Consolidated Appropriations Act, 2023 (Pub. L. 117-328), the No TikTok on Government Devices Act, and its implementing guidance under Office of Management and Budget (OMB) Memorandum M-23-13, dated February 27, 2023, “No TikTok on Government Devices” Implementation

Guidance, collectively prohibit the presence or use of a covered application on executive agency information technology, including certain equipment used by Federal contractors. The Contractor is prohibited from having or using a covered application on any information technology owned or managed by the Government, or on any information technology used or provided by the Contractor under this contract, including equipment provided by the Contractor's employees; however, this prohibition does not apply if the Contracting Officer provides written notification to the Contractor that an exception has been granted in accordance with OMB Memorandum M-23-13.

(c) Subcontracts. The Contractor shall insert the substance of this clause, including this paragraph (c), in all subcontracts, including subcontracts for the acquisition of commercial products or commercial services.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204–25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
