STATEMENT OF WORK

I. General

1. Scope - Furnish all labor, materials, and equipment necessary to assemble and install one (1) new, US Government furnished Elkay model LK4420BF1UDBFRK drinking fountain at the Franklin Falls Dam to include installation of an ADA compliant concrete walkway to access all features of the fountain. All work shall be completed in accordance with the following Statement of Work.

NOTE: This work requires the following submittals prior to commencement of work (Refer to Section II. Technical Requirements for a full list of submittals):

Product Data Sheet(s) - Prior to ordering.

Any required permits

Valid New Hampshire Plumber's License.

2. Location(s) - The Franklin Falls Dam Project Office is located at 46 Granite Drive, Franklin, NH 03235.

3. Technical Point of Contact - After Contract Award, contact the Technical Point of Contact (TPOC) to begin coordination. The TPOC for this Contract is Natural Resource Specialist, Kevin Norton (978-318-8841 or kevin.j.norton@usace.army.mil).

4. Site Visits - Site visits are strongly recommended to gauge the full scope of work and provide an accurate quote.

Scheduled site visits for interested vendors will be listed in the Solicitation. Interested vendors should attend a site visit to confirm understanding of the scope, inspect field conditions, access, and existing utilities prior to bidding. No extra payment will be allowed for perceived additional work caused by unfamiliarity with site conditions and requirements.

Please Note - Site visits outside of these specific dates and times are not permitted unless additional site visit dates/times are publicized in an amendment. All questions during site visits will be sent to the Contract Specialist as indicated in the Instructions to Vendors and responses will be provided in an amendment. Information incorporated into the solicitation via amendment will become binding.

5. Schedule - The period of performance shall be 90 days from Contract Award. Work shall be performed Monday through Friday from 7:00 AM to 3:30 PM unless otherwise approved in advance by the TPOC. No work shall be done on weekends or Government holidays, unless otherwise approved in advance by the TPOC. The Pre-Construction Conference shall be completed within 21 days from Contract Award.

All Pre-Construction submittals shall be submitted within 21 days of Contract Award. The Government reserves up to 14 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall be resubmitted to the Government in an acceptable form within 7 days of the Government's response, unless additional time is granted by the Government in writing. No field work may proceed prior to the acceptance of Pre-Construction submittals.

6. Safety Requirements

a. General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Occupational Health Requirements (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), Federal, State, and local safety and health requirements. A copy of EM 385-1-1 can be accessed electronically at the following link: https://www.publications.usace.army.mil/Portals/76/EM%20385-1-1%20_EFFECTIVE%2015March2024.pdf

Project staff reserves the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

b. Accident Prevention Plan (APP):

The Contractor shall prepare a site-specific Accident Prevention Plan. The APP must be written by a Competent Person (CP) and document the specific work processes, equipment, materials to be used, hazards and applicable control measures.

The mandatory ENG Form 6293 (Accident Prevention Plan Worksheet) must be submitted and accepted prior to beginning on site work: https://www.publications.usace.army.mil/Portals/76/Eng_Form_6293_Aug%202024%20-%20FINAL.pdf

A preparatory meeting shall be conducted by the Prime Contractor to discuss the APP contents with all affected onsite employees. The Prime Contractor is responsible for informing the subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Daily safety meetings shall be held and documented. Records shall be available to the TPOC upon request.

c. Activity Hazard Analysis (AHA):

An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. A DFOW is defined as any task, which is separate and distinct from other tasks, has separate control requirements, or is identified as different trades or disciplines. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

d. Site Safety and Health Officer (SSHO) Requirements:

The Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or

Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.

The SSHO shall be present at the project site and be responsible for overseeing the implementation of the Prime Contractor's SOH program. e. First-Aid and CPR Personnel Requirements:

For shifts with multiple employees, provide at least two employees that are certified to administer First Aid and CPR. When employees work alone, they must be certified in First Aid and be provided an effective means of communication to call for assistance in the event of an emergency. Minimum First Aid and CPR qualifications are outlined in EM 385-1-1, Chapter 3-3.

f. Additional Personnel Requirements:

Other Competent or Qualified Persons may be required per EM 385-1-1 and/or other sections of this Statement of Work, based on the definable features of work for this project.

g. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor and reported to the TPOC in accordance with EM 385-1-1, Table 2-1.

h. Employee Exposure Data:

The Contractor shall electronically report total employee work hours (including subcontractors) to the TPOC by close of business on the 10th calendar day of the following month.

7. Specific Safety Section - Excavation and Trenching:

a. General: All excavating and trenching activities are required to be completed in accordance with EM 385-1-1, Chapter 25.

b. Submittals:

i. Activity Hazard Analysis (AHA) is required to be developed by a Competent Person (CP) for all work in excavations and trenches.

ii. For excavations or trenches 5 feet (1.5m) or more in depth, an Excavation and Trenching Plan is required. The plan must be developed by a CP, submitted, and approved by the USACE supervisor or accepted by the TPOC prior to beginning work. The plan must meet minimum plan requirements outlined in EM 385-1-1, Chapter 25-7.

c. Required Personnel:

i. Competent Person (CP): All projects that involve excavation and trenching activities are required to have a Competent Person (CP) who has training, knowledge, and experience in excavation and trenching soil analysis, use of protective systems, and the requirements of EM 385-1-1 Chapter 25 and 29 CFR 1926 Subpart P.

ii. Rescue Personnel: Must be trained on rescue procedures identified in Excavation and Trenching Plan.

8. Pre-Construction Conference - Prior to the start of any work, the TPOC will schedule and conduct a "Pre-Construction Conference". The Contractor's Project Manager and Quality Control Personnel shall be physically present at this meeting. The Contractor shall directly oversee all work on the project, and the Project Manager and Quality Control Personnel shall have the authority to act on behalf of the Contractor. This conference will be held at the time and location agreeable to the Government and Contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the TPOC to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-Construction Conference the Contractor shall provide the name of the Project Superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Pre-Construction Conference:

i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.

ii. Contractor's Safety Program (including sub-contractors).

iii. Accident Prevention Plan and Activity Hazard Analysis

iv. Documented Safety Meetings

v. Accident Reporting (ENG Form 3394)

vi. Safety Data Sheet (SDS) requirements

vii. Contractor's Equipment

viii. Correspondence, Communication, Security and Administrative Procedures.

ix. Invoice and payment.

9. Permits - The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, county, and municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

10. Security - The Contractor will comply with all established security policies at the USACE project. Due to periods of heightened security that may affect the access to the areas covered under this contract, the Government reserves the right to close any property or portion of property and reschedule and/or cancel any subsequent work. The Contractor shall be given at least 24-hour notice of any such closure.

11. Payment - After final inspection and acceptance by the Government, the Contractor must submit an invoice to the TPOC. The invoice shall include the invoice date, contract number, dates of work, description of work, quantities, labor hours, and total amount due per line item. The invoice must also include the company letterhead, and this must match the data that is registered in the System for Award Management (SAM) registry. For jobs greater than 30 days the Contractor may request multiple payments.

II. Technical Requirements:

Part 1 General:

1. Summary - Furnish all labor, materials, and equipment necessary to assemble and install one (1) new, US Government furnished Elkay model LK4420BF1UDBFRK drinking fountain in accordance with Elkay Model LK4420BF1UDBFRK assembly and installation instructions (Please reference Appendix B for instructions). Install an ADA compliant walkway that connects to the existing walkway and allows access to all features of the fountain. Refer to informational photos in Appendix A for more information. All work shall be completed in accordance with the following Statement of Work.

2. Submittals - Although the Government reviews submissions required by this Statement of Work, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The Government reserves up to 14 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall resubmit to the Government in an acceptable form within 7 days of the Government's response, unless additional time is granted by the Government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and must be accepted by the Government.

a. Pre-Construction Submittals: Submitted within 21 days of Contract Award. Submittals must be accepted prior to the commencement of any field work.

4. Existing Conditions:
- a. Site Access:
 - i. The work site is located within the Franklin Falls Dam recreation area at 46 Granite Drive in Franklin, NH which is approximately .25 miles from the intersection with NH Route 127 in Franklin, NH. (See Informational Maps 1 and 2).
 - b. General Conditions:
 - i. The drinking fountain is currently stored onsite in the same condition that it was shipped from the manufacturer and has not been exposed to natural weather elements.
 - ii. The drinking fountain shall be installed adjacent to the east side of an existing restroom building. The restroom building is a plumbed restroom with water and sewage lines in place.
 - iii. The main water supply shut off to the restroom building is located in the Activity Center building, immediately to the West of the restroom building. The shut-off valve is located in the basement of the Activity Center and is shown in Informational Photo 8.
 - iv. The restroom building is a ROMTEC manufactured concrete and masonry building. For general design plans of this restroom building please see Informational Drawings 1, 2, 3, and 4 in Appendix A.
 - v. The existing water supply line in the restroom building is 1/2" PEX-A type water supply line as shown in Informational Photos 4 through 7.
 - vi. The drinking fountain shall not block the current restroom vent located on the east wall of the existing restroom building. See Informational Photo 2.

vii. The ground conditions in the area for this work are mostly flat bare ground with grass covering. A small section of 3/4 inch quarry pack is present adjacent to the existing walkway (See Informational Photos 2 and 3).

viii. There is an existing concrete walkway leading to the front of the plumbed restroom building to include the entry area for each of the restroom access doors. (See Informational Photos 1, 2 and 3). The existing walkway in front of the restroom doors is 5 inches thick and 60 inches wide.

ix. The ADA compliant concrete walkway to be installed shall connect to the easternmost section of existing walkway and connect to the concrete mounting pad with enough ADA compliant walkway to access all features of the drinking fountain. See Informational Drawing 5 in Appendix A for general layout and dimensions.

x. There is only a general understanding of underground utilities in this area. The Contractor shall coordinate with Dig-Safe prior to starting any excavation.

NOTE: For all Informational Photos please reference attached Appendix A. For the drinking fountain owner's manual (assembly and installation instructions) and specifications, please reference attached Appendix B.

5. Other Contracts - The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and Government employees. The Contractor shall not commit or permit any act which will interfere with the performance of work by another contractor or by Government employees.

6. Clean Up and Waste Disposal - The Contractor shall practice good housekeeping to maintain a safe job site. The Contractor shall keep the work area, including any designated storage areas, free from accumulation of waste materials. Upon completing work in an area, the Contractor shall remove any tools, equipment, and materials that are not the property of the Government. Any and all disturbed areas resulting from Contractor activities shall be restored by the Contractor to the satisfaction of the TPOC. All waste materials will be disposed of offsite in accordance with all Federal, State, and local regulations.

7. Environmental Protection - Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the Contractor at the site, and the site will be inspected/cleaned on a daily basis when working onsite. Water, air, and land resources shall not be adversely impacted during the course of the work. The Contractor will take necessary steps to ensure all Federal, State, and local environmental regulatory requirements are met at no additional cost to the Government. Assurance of compliance with this section by subcontractors shall be the responsibility of the Contractor.

8. Sustainability & Environmentally Preferred Products - Under the Comprehensive Procurement Guidelines (CPG) program, the Environmental Protection Agency (EPA) designates products that are or can be made with recovered materials and recommends practices for buying these products. Any designated product that is being offered or supplied under this contract shall meet the minimum recommended content levels as identified under the CPG program. Visit <https://www>.

epa.gov/smm/comprehensive-procurement-guideline-cpg-program for a complete list of designated products and the associated recommended contents levels. Offerors must be able to demonstrate that each offered product meets minimum content levels upon request.

Furthermore, the contractor should also meet the BioPreferred Program requirements. The United States Department of Agriculture (USDA) designates certain bio-based products for federal procurement and specifies minimum bio-based content levels for those products. Any designated product that is being offered or supplied under this contract shall meet USDA BioPreferred's minimum bio-based content level. 9. Personal Protective Equipment - It is the Contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.

10. Government Resources - The Contractor shall supply his own means of communication (telephone) and electricity. The Contractor may use the restroom facilities and access to water which are both located in the restroom building mentioned in this Statement of Work. However, when the Contractor shuts water off to this facility to connect to plumbing for the required work, the Contractor shall supply restroom and potable water access at the site or have an acceptable plan for such resources for the Contractor's employees. The Contractor is not required to supply restroom facilities or potable water access for the public during the restroom closure.

11. Damage to Government and Private Property - The Contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the Contractor's operation. The Contractor shall also be responsible for any damage to private property or injury to any person as a result of the Contractor's operation. The Contractor shall notify the TPOC immediately of damage to Government and private property and injury to any person resulting from the Contractor's operation. Also, the Contractor shall notify the TPOC of damage to Government facilities due to vandalism or other causes on the day such damage is first noticed. Trucks and/or trailers will be driven on existing roads only and not across or through park areas to facilities. The Contractor shall also restore landscape features (shrubs, flowers, grasses, etc.), which are damaged or destroyed by the Contractor's operation. Damaged or destroyed grass areas shall be re-planted as directed by the TPOC, and shrubs and flowers which are damaged or destroyed shall be replaced from nursery stock of like size and kind.

12. Contractor's Personnel -

a. Minimum Personnel Requirements - The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.

Note: At least one (1) of the Contractor employees on site shall be able to communicate effectively and efficiently with project staff.

b. Employee Conduct - The Contractor shall be responsible for seeing that the Contractor's employees strictly comply with Code of Federal Regulations Title 36, Chapter III, Part 327, and all Federal, State, and municipal laws. Any personnel activity, which, in the opinion of the Government, is deemed detrimental to the performance of the contract may result in the removal of Contractor employee(s).

Examples of unbecoming actions or conduct include but are not limited to the following:

- i. Cursing, harassment, or discrimination of and/or unwarranted physical contact with visitors, USACE personnel, or other Contractors.
- ii. Recurring written and/or verbal complaints from visitors, USACE personnel, or other Contractors.
- iii. Unsafe operation of vehicles while on USACE property.

c. Removal of Contractor's Employees - The TPOC may require the Contractor to immediately remove from the work site any employee of the Contractor or subcontractor, who, in the opinion of the TPOC, endangers persons or property, or whose physical or mental condition is such that it would impair the employee's ability to satisfactorily perform assigned work. Notification to the Contractor shall be promptly made in writing if time and circumstances permit. Otherwise, notification shall be verbal or by telephone and shall be confirmed in writing as soon as possible. No such removal, however, will reduce the Contractor's obligation to perform all work required under this contract, and immediate replacement will be made as required. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.

13. Quality Assurance - The Contractor is responsible for the quality control of the contract work. The Contractor shall establish and maintain a quality control system to assure compliance with the contract requirements. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

14. Inspections -

a. Contractor Quality Control - The Contractor is responsible for establishing and maintaining an adequate quality control system to satisfactorily inspect and ensure that all work performed by the Contractor's organization in each separate service is in full compliance with this contract and the instructions, provisions, specifications, drawings, and maps herein.

b. General Inspection - Upon the completion of each requirement, the Contractor will perform an inspection of all areas under this contract to ensure compliance with the Statement of Work. The Contractor or their representative must be able to commit personnel, equipment, and resources to correct deficiencies. A Government representative may accompany the Contractor on an inspection of completed work and will identify any contract deficiencies. Any deficiencies noted will be corrected within original contract time frames or appropriate deductions in payment will be made.

c. Equipment/Supplies Inspections - The TPOC may inspect required equipment and, supplies at any time when in use on Government property. Any equipment found deficient shall be removed from service immediately until faulty conditions have been corrected and passed by the TPOC. No such removal will reduce the Contractor's obligation to perform all work required within the time scheduled under this contract. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.

d. Government Inspections - The Government will monitor the Contractor's work and make deductions accordingly for work not corrected with the time permitted.

15. Receiving and Storing Materials - The Contractor is responsible for receiving and unloading of delivered goods. The Contractor is responsible for protecting any stored material until it is placed in service. Government employees will not receive materials or supplies for the Contractor and will not be responsible for damage to the Contractor's equipment or materials.

16. Omissions - This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, State, or Federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

Part 2 Equipment:

1. Condition of Equipment - All equipment used to perform work under this contract must be in good operating and mechanical condition and comply with EM 385-1-1, Army Corps of Engineers Safety and Occupational Health Requirements. A regular schedule of preventive maintenance must be followed on all equipment. All vehicles utilized under this contract will be presentable, serviceable, and shall comply with safety standards.

2. Type(s) of Equipment -

a. The Contractor shall provide the appropriate equipment and tools of the trade to execute the requirements of the Statement of Work.

b. Type(s) of equipment for this work may include but not be limited to various hand and power tools, portable generator, extension cords, excavation equipment, vibratory plate compactor, concrete forms, cement mixer or cement truck, dump truck, plumbing tools, Personal Protective Equipment.

3. Equipment Storage - Various equipment and supplies may be secured and stored onsite within the work area. NOTE: The Government does not assume security for any lost or damaged equipment or materials stored on-site.

Part 3 Products:

All products shall be new, unused and to the satisfaction of the TPOC. The Contractor shall provide product data sheets to the TPOC for all products and materials being used. Products shall

be accepted by the TPOC prior to ordering and installation. Products shall have the following specifications.

1. Provided by the Government:

- a. One (1), new, Elkay model LK4420BF1UDBFRK drinking fountain.
- b. NOTE: New, US Government furnished drinking fountain, valued at \$9,196.54.

2. Provided by the Contractor:

- a. PVC pipe and fittings as required by the manufacturer installation specifications for the vertical column structure and the drainpipe as per Appendix B.
- b. 1/2" PEX-A water supply line for the drinking fountain.
- c. Shut off valve for water supply connection in the restroom to the drinking fountain.
- d. Concrete:
 - i. High strength (minimum 3000 PSI) mix capable of supporting the drinking fountain with a 300 lb. load on the fountain when cured.
 - ii. The drinking fountain mounting slab shall be minimum of 5" thick throughout.
 - iii. The new walkway shall be a minimum of 5" thick throughout.
 - iv. Light to medium brush finish in compliance with ADA standards.
- e. Sand, drainage stone and gravel to meet New Hampshire Building Code requirements for backfill of plumbing.
- f. Concrete sand compactible bedding material meeting ASTM C33 for subbase under the new concrete structures.
- g. Mineral wool or polyester blanket type insulation material cut to fit to meet requirements for insulating the vertical column.
- h. 3/8" minimum fasteners to mount the drinking fountain to the finished concrete mounting pad.
- i. Any other products necessary to install the drinking fountain per manufacturer's specifications and to install an ADA compliant walkway.

NOTE:

1. The Contractor provided materials and supplies listed above may not include all miscellaneous items needed for a sound and professional installation. It is the responsibility of the Contractor to provide any omitted items to complete the required work.
2. All Contractor supplied materials to be used shall be reviewed and accepted in advance by the TPOC.
3. The Contractor shall submit one copy of the manufacturer's Safety Data Sheet for each chemical proposed for use prior to using the chemicals on-site.

Part 4 Execution:

1. General:

- a. The Contractor shall assemble and install one (1) new, US Government furnished Elkay model LK4420BF1UDBFRK drinking fountain in the designated location. The Contractor shall also install an ADA compliant concrete walkway to connect to the current walkway and to provide access to all features of the fountain. All work shall be completed in accordance with the following Statement of Work.
 - b. It is the Contractor's responsibility to coordinate with Dig-Safe for any and all areas requiring earthwork, including the trench area.
 - c. It is the Contractor's responsibility to take all field measurements to ensure proper ordering and installation of the correct products for a fully functional fit and finish that meets the manufacturer's installation requirements and all of the Federal, State regulations.
 - d. It is the Contractor's responsibility to properly dispose of or salvage all materials or waste designated for removal or produced by the Contractor while performing the requirements of this Statement of Work in accordance with all applicable Federal, State, and local regulations.
 - e. The Contractor shall coordinate the placement of any excess excavated or removed soil to a nearby location designated by the TPOC.
 - f. The Government will be responsible for final landscaping around new concrete structures after the Contractor has fully cleaned up the area of any trash, debris, gravel, sand, excess excavated soil, and the area has been accepted by the TPOC.
 - g. For all Informational Photos please reference attached Appendix A. For the drinking fountain owner's manual (assembly and installation instructions) and specifications, please reference attached Appendix B.
2. Safety Equipment: It is the Contractor's responsibility to furnish and supply personnel with the proper personal protective equipment (Hardhats, Hand Protection, Hearing Protection, Eye Protection, etc.) when and where necessary.

3. Contractor's Qualifications:

- a. The Contractor shall have a minimum of five (5) years of experience with work of this nature.
- b. All work requiring a License shall be performed by a licensed and qualified worker with certified credentials for such work.

4. Drinking Fountain Assembly:

- a. The drinking fountain shall be assembled according to the specific manufacturer's instructions and specifications found in Appendix B.
- b. NOTE: Based on the manufacturer's instructions, there are specific stages of assembly required during installation, the entire drinking fountain is not fully assembled prior to mounting on the concrete slab.

5. Drinking Fountain Installation:

- a. The Contractor shall employ protective measures to ensure the safe removal, handling, and preparation of all Government-owned property.
- b. The drinking fountain shall be installed according to the specific manufacturer's instructions and specifications found in Appendix B. The manufacturer also indicates that installation shall comply with local regulations and codes.
- c. The vertical PVC column shall be set and installed prior to pouring the concrete mounting pad as detailed in Appendix B.
- d. The Contractor shall provide coverings for any open excavations within the work area during non-work hours in accordance with EM 385-1-1, Chapter 25.
- e. The Contractor shall ensure the orientation of the concrete mounting pad and drinking fountain will allow for proper clearance from the drip edge of the restroom building when considering rain and snow load fall area.
- f. The general layout for the concrete mounting pad and drinking fountain orientation with approximate dimensions can be seen on Informational Drawing 5 in Appendix A. The PVC column and fountain mounting location shall still be in close proximity as shown in Appendix B, however the drinking fountain is oriented in a manner to allow for ADA accessibility to all features of the drinking fountain. The access cover to the PVC column shall remain accessible and not enveloped by concrete (slab or walkway).
- g. Prior to commencing work, the Contractor shall verify the routing of the existing potable water lines. The Contractor shall connect the drinking fountain supply line to the existing restroom water system at a location coordinated with and approved by the TPOC. The baseline location for this connection is under the sink in the easternmost restroom, unless an alternate connection point is determined to be more advantageous and is accepted by the TPOC. The Contractor shall connect

the new drinking fountain to the existing restroom building water supply. The Contractor shall drill through the concrete floor under the sink in the easternmost restroom, route the new water supply line through the penetration, and install the line into the trench designated for the vertical PVC column. The Contractor shall seal and waterproof the floor penetration around the new pipe. The Contractor shall install an isolation shut-off valve inside the restroom building for the drinking fountain water supply line. The Contractor shall coordinate and obtain TPOC approval for both the valve location and the floor penetration (drilling) location prior to commencing any drilling or installation work.

h. The Contractor shall backfill the trench created for the water supply line, vertical PVC column, and drinking fountain drain according to the manufacturer's instructions. The top finish grade of the trench shall be finished with any excess excavated loam material from the trench and shall be flush with the surrounding ground surface grade.

i. The Contractor shall level and prepare the area for the concrete mounting pad by removing the topsoil and any roots. The subgrade shall then be dampened and compacted with a vibratory plate compactor until the surface is firm and unyielding.

j. The mounting pad subbase shall be brought up to the required elevation for the concrete mounting pad by placing uniform lifts of concrete sand meeting ASTM C33. Each lift shall not exceed 4 inches in loose depth. Each lift shall be dampened and compacted with a vibratory plate compactor until the surface is firm and unyielding

k. Once the subbase elevation is achieved, concrete forms shall be placed, and concrete can be poured. The concrete shall be poured in in a single batch. Multiple batch pours will not be permitted.

l. The Contractor shall ensure that the area for the concrete mounting pad is prepared in a manner that creates an ADA compliant transition from the new walkway.

m. The concrete mounting pad shall be 5 inches thick to match the thickness of the existing and new walkways.

n. The Contractor shall ensure that expansion joints and / or saw cuts are created for this installation per American Concrete Institute guidelines.

o. It is the Contractor's responsibility to properly provide temporary barriers and signage to protect the work site.

p. The Contractor may shut off water to the adjacent restroom building during work. If the water has to remain off during non-work hours, the Contractor shall inform the TPOC so the restrooms can be secured and temporary closure signs posted.

7. Concrete Walkway

a. Proper protective procedures shall be incorporated for the safe removal and preparation of all products designated for such requirements per this Statement of Work.

- b. Construction shall be in accordance with the dimensions included in Informational Drawing 5, and the Contractor shall verify that all dimensions are in compliance with all ADA requirements.
- c. The Contractor shall level and prepare the area for the walkway by removing the topsoil and any roots. The subgrade shall then be dampened and compacted with a vibratory plate compactor until the surface is firm and unyielding.
- d. The walkway subbase shall be brought up to the required elevation for the concrete walkway by placing uniform lifts of concrete sand meeting ASTM C33. Each lift shall not exceed 4 inches in loose depth. Each lift shall be dampened and compacted with a vibratory plate compactor until the surface is firm and unyielding.
- e. Once the subbase elevation is achieved, concrete forms shall be placed, and concrete can be poured. The concrete shall be poured in a single batch per section of walkway. Multiple batch pours in any one section of walkway will not be permitted.
- f. The Contractor shall ensure that the area is prepared in a manner that creates an ADA compliant transition from the existing walkway to the new walkway.
- g. The walkway shall connect to the current walkway in front of the existing restroom building.
- h. The new walkway shall be 5 inches thick to match the thickness of the existing walkway.
- i. The Contractor shall ensure that expansion joints are created for this installation per American Concrete Institute guidelines.
- j. The walkway shall be ADA compliant to include a light to medium brush finish.
- k. The walkway shall allow ADA compliant access to all features of the drinking fountain.
- l. It is the Contractor's responsibility to properly provide temporary barriers and signage to protect the work site.

8. Final Inspection and Acceptance:

- a. A full cleanup of the work area shall be performed to remove any accumulation of trash or debris caused during assembly and installation phases of this contract.
- b. The Contractor shall coordinate a walk-through with the TPOC to ensure all components, hardware and elements are installed as intended, that all components function as designed by the manufacturer, and to ensure completion of all work required by this Statement of Work.

(f) If the Contractor represented that it was other than a small business concern prior to award of this contract, the Contractor may, but is not required to, take the actions required by paragraphs (e) or (g) of this clause.

Buy American-Construction Materials (Feb 2026) (Deviation 2026-O0038)

(a) *Definitions.* As used in this clause-

Commercially available off-the-shelf (COTS) item-

(1) Means any item of supply (including construction material) that is-

(i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);

(ii) Sold in substantial quantities in the commercial marketplace; and

(iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and

(2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4), such as agricultural products and petroleum products.

"Construction material" means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means-

(1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or

(2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means-

(1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-

(i) An unmanufactured construction material mined or produced in the United States; or

(ii) A construction material manufactured in the United States, if-

(A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or

(B) The construction material is a COTS item; or

(2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

"United States" means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction

materials, excluding COTS fasteners. The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

NONE

(3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that-

(i) The cost of domestic construction material would be unreasonable.

(A) For domestic construction material that is not a critical item or does not contain critical components.

(1) The cost of a particular domestic construction material subject to the requirements of the Buy American statute is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;

(2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.

(B) For domestic construction material that is a critical item or contains critical components.

(1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.

(2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether

the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.

(ii) The application of the restriction of the Buy American statute to a particular construction material would be impracticable or inconsistent with the public interest; or

(iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.

(c) Request for determination of inapplicability of the Buy American statute.

(1)

(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including-

(A) A description of the foreign and domestic construction materials;

(B) Unit of measure;

(C) Quantity;

(D) Price;

(E) Time of delivery or availability;

(F) Location of the construction project;

(G) Name and address of the proposed supplier; and

(H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute or Balance of Payments Program.

(d) *Data.* To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:

(a) Payment of price. The Government shall pay the Contractor the contract price as provided in this contract.

(b) Progress payments. The Government shall make progress payments monthly as the work proceeds, or at more frequent intervals as determined by the Contracting Officer, on estimates of work accomplished which meets the standards of quality established under the contract, as approved by the Contracting Officer.

(1) The Contractor's request for progress payments shall include the following substantiation:

(i) An itemization of the amounts requested, related to the various elements of work required by the contract covered by the payment requested.

(ii) A listing of the amount included for work performed by each subcontractor under the contract.

(iii) A listing of the total amount of each subcontract under the contract.

(iv) A listing of the amounts previously paid to each such subcontractor under the contract.

(v) Additional supporting data in a form and detail required by the Contracting Officer.

(2) In the preparation of estimates, the Contracting Officer may authorize material delivered on the site and preparatory work done to be taken into consideration. Material delivered to the Contractor at locations other than the site also may be taken into consideration if-

(i) Consideration is specifically authorized by this contract; and

(ii) The Contractor furnishes satisfactory evidence that it has acquired title to such material and that the material will be used to perform this contract.

(c) Contractor certification. Along with each request for progress payments, the Contractor shall furnish the following certification, or payment shall not be made: (However, if the Contractor elects to delete paragraph (c)(4) from the certification, the certification is still acceptable.)

I hereby certify, to the best of my knowledge and belief, that-

(1) The amounts requested are only for performance in accordance with the specifications, terms, and conditions of the contract;

(2) All payments due to subcontractors and suppliers from previous payments received under the contract have been made, and timely payments will be made from the proceeds of the payment covered by this certification, in accordance with subcontract agreements and the requirements of Chapter 39 of Title 31, United States Code;

(3) This request for progress payments does not include any amounts which the prime contractor intends to withhold or retain from a subcontractor or supplier in accordance with the terms and conditions of the subcontract; and

(4) This certification is not to be construed as final acceptance of a subcontractor's performance.

(d) Refund of unearned amounts. If the Contractor, after making a certified request for progress payments, discovers that a portion or all of such request constitutes a payment for performance by the Contractor that fails to conform to the specifications, terms, and conditions of this

contract (hereinafter referred to as the "unearned amount"), the Contractor shall-

(1) Notify the Contracting Officer of such performance deficiency; and

(2) Be obligated to pay the Government an amount (computed by the Contracting Officer in the manner provided in paragraph (j) of this clause) equal to interest on the unearned amount from the 8th day after the date of receipt of the unearned amount until-

(i) The date the Contractor notifies the Contracting Officer that the performance deficiency has been corrected; or

(ii) The date the Contractor reduces the amount of any subsequent certified request for progress payments by an amount equal to the unearned amount.

(e) Retainage. If the Contracting Officer finds that satisfactory progress was achieved during any period for which a progress payment is to be made, the Contracting Officer shall authorize payment to be made in full. However, if satisfactory progress has not been made, the Contracting Officer may retain a maximum of 10 percent of the amount of the payment until satisfactory progress is achieved. When the work is substantially complete, the Contracting Officer may retain from previously withheld funds and future progress payments that amount the Contracting Officer considers adequate for protection of the Government and shall release to the Contractor all the remaining withheld funds. Also, on completion and acceptance of each separate building, public work, or other division of the contract, for which the price is stated separately in the contract, payment shall be made for the completed work without retention of a percentage.

(f) Title, liability, and reservation of rights. All material and work covered by progress payments made shall, at the time of payment, become the sole property of the Government, but this shall not be construed as-

(1) Relieving the Contractor from the sole responsibility for all material and work upon which payments have been made or the restoration of any damaged work; or

(2) Waiving the right of the Government to require the fulfillment of all of the terms of the contract.

(g) Reimbursement for bond premiums. In making these progress payments, the Government shall, upon request, reimburse the Contractor for the amount of premiums paid for performance and payment bonds (including coinsurance and reinsurance agreements, when applicable) after

the Contractor has furnished evidence of full payment to the surety. The retainage provisions in paragraph (e) of this clause shall not apply to that portion of progress payments attributable to bond premiums.

(h) Final payment. The Government shall pay the amount due the Contractor under this contract after-

(1) Completion and acceptance of all work;
