I. General

1. Scope

Furnish all equipment, labor, materials, and transportation, for the repair of the Mill River Levee in accordance with the following Statement of Work.

*Note: This work requires the following submittals prior to the commencement of work:

- ENG Form 6293 (Accident Prevention Plan Worksheet)
- Activity Hazard Analysis (AHA)
- ENG Form 6282 (Site Safety and Health Officer Designation Letter)
- First Aid/CPR Certifications
- Product specification sheets for all materials

2. Location

All equipment and materials shall be delivered and unloaded at the following location: Woonsocket Flood Risk Reduction, Mill River Levee, REAR 292 E School St, Woonsocket, RI. 02895

3. Project Coordination

4. Schedule

The work specified in these requirements shall be completed no later than **40 days after contract award**. All work shall be performed Monday through Friday between the hours of 7:00 AM and 3:30 PM unless otherwise approved by the TPOC. Any proposed changes to an approved schedule must be submitted to the TPOC in writing and are not finalized until approved. No work shall be done on weekends or government holidays. Field work will commence within 7 days number of days of the acceptance of preconstruction submittals.

All preconstruction submittals shall be submitted within 14 days of contract award. The Government reserves up to 7 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall be resubmitted to the Government in an acceptable form within 5 days of the Government's response, unless additional time is

b. Accident Prevention Plan (APP):

The Contractor shall prepare a site-specific Accident Prevention Plan. The APP must be written by a Competent Person (CP) and document the specific work processes, equipment, materials to be used, hazards and applicable control measures.

Daily safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

c. Activity Hazard Analysis (AHA):

An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. The Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.b.

Level 3 SSHOs must have training, knowledge, and/or experience identifying hazards and implementing controls for the work being performed.

II. Technical

1. Summary

Furnish all equipment, labor, materials, and transportation for the repair of the Mill River Levee in accordance with the following requirements and schedule. This work consists of providing placed riprap on prepared surfaces of the sizes and layer thicknesses at the locations indicated on the plan titled C-101, and in accordance with these Specifications.

2. Submittals

Although the Government reviews submissions required by this statement of work, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The Government reserves up to 7 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall resubmit to the Government in acceptable form within 5 days of the Government's response, unless additional time is granted by the Government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and accepted by the Government.

Preconstruction submittals: Submitted within 14 days of contract award. Submittals must be accepted prior to the commencement of any field work.

- Product specification sheets and cut sheets for materials
- Manufacturer warranty for any materials
- Accident Prevention Plan and Activity Hazard Analysis

- ENG Form 6293, Accident Prevention Plan Worksheet
- ENG Form 6282 (Site Safety and Health Officer Designation Letter)
- First Aid/CPR Certification
- 3. References- All work shall be in conformance with:
 - a. U.S. Army Corps of Engineers
 - i. EM 385-1-1 Safety and Health Requirements Manual, U.S. Army Engineering Manual; latest version
 - b. Other appropriate federal, state, and local codes

4. <u>Clean Up and Waste Disposal</u>

The Contractor shall practice good housekeeping to maintain a safe job site. The Contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area, the Contractor shall remove any tools, equipment, and materials that are not the property of the government. Portable toilets are allowed at the Contractor's expense. Upon completion of work, the Contractor shall clean up the job site to the satisfaction of the TPOC. All waste material will be disposed of offsite in accordance with all federal, state, and local regulations.

5. Environmental Protection

Contractor at the site, and the site will be inspected/cleaned daily when working onsite. Water, air, and land resources shall not be adversely impacted from work. Dumpsters are allowed at the Contractor's expense. Storage, fueling and lubrication of equipment and motor vehicles shall be conducted in a manner that affords the maximum protection against spills and evaporation. Storage and usage of lubricants and daily fueling of machinery and equipment shall occur at least 50 feet from any drainage inlets, water bodies (rivers, streams, and lakes), and environmentally sensitive areas (wetlands, vernal pools). The Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met at no additional cost to the Government. Assurance of compliance with this section by subcontractors shall be the responsibility of the Contractor.

6. Government Resources

The Contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.

7. Omissions

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

8. Quality Assurance

The Contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

9. Other Contracts

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and government employees. The Contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by government employees.

10. Traffic Control

The Contractor is responsible for safely controlling and protecting traffic in the affected parking lot during the construction period to the satisfaction of the TPOC.

11. Receiving and Storing Materials

The Contractor is responsible for protecting any stored material until it is placed in service. The Contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the Contractor and will not be responsible for damage to Contractor equipment or material.

III. Materials

1. Geotextile:

Geotextile shall meet or exceed the following specifications.

- a. Approximately 800 sq ft of area is required to be covered. <u>Final quantities and</u> measurements of material are the responsibility of the Contractor.
- a. Geotextile must be woven or nonwoven geotextile fabric meeting the Class 1 survivability requirements of AASHTO M 288-22, Standard Specification for Highway Applications.
- b. Minimum permittivity is 0.2 sec⁻¹.
- c. Maximum apparent opening size (AOS) is 0.25 mm.

The installation of geotextile shall strictly conform to the manufacturer's guidelines and as modified herein.

- a. The surface of finished ground must be smooth. All rock, dirt clods, grass clumps, trash and other obstructions which will prevent the mat from laying in direct contact with the soil surface and which may cause the geotextile to puncture, or tear must be removed, unless otherwise directed by the TPOC or designated representative.
- b. To the extent practicable, the geotextile must be placed loosely without wrinkles or folds.
- c. The geotextile must be placed in continuous sheets from the top to the bottom of the slope without seams. A minimum overlap width of two feet must be used between adjacent geotextile sheets with the upstream sheet placed on top of the downstream sheet.

- d. Anchor pins must be installed immediately after placement of each section to protect from wind uplift and to prevent the geotextile from sliding down the slope before it is covered with riprap.
- e. The geotextile must overlap the remaining stone at the toe of the slope a minimum distance of 1 foot to secure the geotextile at the toe of the slope.
- f. During riprap installation, a minimum length of 5 feet of additional geotextile must be provided at the top of the slope to allow for minor geotextile slippage during riprap installation. Any remaining excess geotextile will be trimmed after stone installation. If required, riprap stones may be placed on the excess geotextile as temporary anchors during riprap installation.

2. Riprap

Three riprap sizes will be used. Riprap shall be well graded and shall meet the quality and dimensional requirements for riprap specified in Section M 10.03 of the Rhode Island Department of Transportation Standard Specifications for Road and Bridge Construction, as amended March 2018. The riprap stone sizes shall meet the following size requirements based on screening through a sieve with square openings.

Type 3	22	34	18	

Stone for riprap shall be placed on the prepared slope or area in a manner which will produce an evenly graded mass of stone with the minimum practical percentage of voids. The entire mass of stone shall be placed to conform with the lines, grades, and thicknesses shown on the Plans. Riprap shall be placed to its full course thickness in one operation and in such a manner as to avoid displacing the underlying material. Placing of riprap methods likely to cause segregation will not be permitted. Contractor is responsible for all measurements. Final quantities and measurements of materials are the responsibility of the Contractor.

IV. Execution

1) Safety

- a. Work layout area shall be surrounded by caution tape to prevent the public from entering the area.
- b. Work area on slope will be surrounded by safety orange construction fencing, supported by metal stakes, at times while no work is being done (vacant area) and at the end of each workday.

2) Preparation

a. The Contractor shall take all appropriate measures necessary to protect the surrounding areas from damage during the execution of the work. Damage to the surrounding area will be repaired to the satisfaction of the TPOC.

b. It must be noted a 24-inch reinforced concrete pipe (RCP) storm sewer drain exists between manhole at approximately levee Sta. 0+78 past the upstream end of the repair. The pipe invert is at approximately elevation (EL.) 127.3 at the manhole and slopes upward at about 0.035 ft/ft toward the upstream end of the repair. See Informational Photo/Plan No 2. As such, riprap shall be placed in a manner to prevent damage to the underlying storm sewer drain.

c. Site work:

Areas for machinery and materials are defined in Informational Photo/Plan No. 3 and will be confirmed onsite, by the technical point of contact. This area shall be prepared without any excavation of existing slopes and areas.

d. <u>Slope Preparation and Geotextile Installation</u>
Refer to the requirements outlined in Section III of these specifications.

e. Stone Placement:

Place riprap to produce a well graded mass with the minimum practicable percentage of voids in conformance with lines and grades indicated on Informational Photo/Plan Sheet ID, C-101. Distribute larger rock fragments, with dimensions extending the full depth of the riprap stone throughout the entire mass and eliminate "pockets" of small rock fragments. Rearrange individual pieces by mechanical equipment or by hand as necessary to obtain the distribution of fragment sizes specified above.

3) Order of Installation

- a. Regrade the overhanging and near vertical slope at the top portion of the levee washout to a 0.5H:1.0V slope or otherwise approved by the TPOC or their designed representative. The top of the washout elevation ranges from approximately elevation (EL.) 135 to EL. 142 but is generally above El. 140.
- b. Install and anchor Geotextile over the existing sloped area from station (Sta.) Sta. 0+05 and Sta. 0+48 and between EL. 130 and EL. 142 as required to cover the prepared slope.
- c. Install a 12-inch layer of rip rap stone, Type 1 over the installed geotextile material.
- d. Begin placing riprap between levee Sta. 0+05 and Sta. 0+48 at the toe of the slope and base of the river channel (ranging from about El. 129 to El. 131) and proceeding up the slope taking care to avoid stretching and subsequent tearing of the geotextile. Riprap shall not be dropped onto the geotextile fabric from a height of more than 1 foot unless approved by the TPOC or designated representative. Type 1 and Type 2 riprap should be placed continuously from the bottom of the slope to the top of the slope. The Type 3 riprap can either be placed concurrently with the other riprap types or after the slope is stabilized with the Type 1 and Type 2 riprap at the Contractor's discretion.
- e. Riprap placement shall continue to the top of the prepared slope, maintaining the finished slope at approximately 1.5H:1.0V. Top of finished slope, at or below El. 140, the minimum final layered thickness of the riprap shall be 12 inches of Type 1 riprap and 24 inches of Type 2 riprap. Top of slope above EL. 140, Type 1 stone will be placed from El. 140 to the top of the slope and the Type 2 stone

- thickness below El. 140 will be adjusted accordingly to maintain the finished 1.5H:1V slope.
- f. Type 3 riprap will be placed between levee Sta. 0+05 and Sta. 0+48 from about EL.129 to EL. 132. The final thickness of the Type 3 riprap shall be 36 inches.
- g. The top/crest of the levee elevation shall remain unchanged at EL. 143.5

4) Clean up

a. Areas of work will be cleaned up. Any damaged or rough areas created by the repair work shall be returned to original grade.

C. Employees on the seniority list shall be paid a one hundred dollar (\$100.00) bonus for every four hundred (400) hours worked, up to a maximum of five hundred dollars (\$500.00)

All drivers working on a defined hazard material job site shall be paid a premium of \$2.00 per hour over applicable rate.

TRUCK DRIVER CLASSIFICATIONS

GROUP 1: Pick-up trucks, station wagons, & panel trucks

GROUP 2: Two-axle on low beds

GROUP 3: Two-axle dump truck

GROUP 4: Three-axle dump truck

GROUP 5: Four- and five-axle equipment

GROUP 6: Low-bed or boom trailer.

GROUP 7: Trailers when used on a double hook up (pulling 2 trailers)

GROUP 8: Special earth-moving equipment, under 35 tons

GROUP 9: Special earth-moving equipment, 35 tons or over

GROUP 10: Tractor trailer

WELDERS - Receive rate prescribed for craft performing operation to which welding is incidental.

The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and

the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

State Adopted Rate Identifiers

Classifications listed under the ""SA"" identifier indicate that the prevailing wage rate set by a state (or local) government was adopted under 29 C.F.R •1.3(g)-(h). Example: SAME2023-007 01/03/2024. SA reflects that the rates are state adopted. ME refers to the State of Maine. 2023 is the year during which the state completed the survey on which the listed classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 01/03/2024 reflects the date on which the classifications and rates under the ?SA? identifier took effect under state law in the state from which the rates were adopted.

(a) Definitions. As used in this clause
Commercially available off-the-shelf (COTS) item—
(1) Means any item of supply (including construction material) that is

- (i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);
- (ii) Sold in substantial quantities in the commercial marketplace; and
- (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-
- (i) An unmanufactured construction material mined or produced in the United States; or
- (ii) A construction material manufactured in the United States, if--
- (A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
- (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a

construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.
- (2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

- (3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that
- (i) The cost of domestic construction material would be unreasonable.
- (A) For domestic construction material that is not a critical item or does not contain critical components.
- (1) The cost of a particular domestic construction material subject to the requirements of the Buy American statute is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;

- (2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.
- (3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.
- (B) For domestic construction material that is a critical item or contains critical components.
- (1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.
- (2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.
- (3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.
- (ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or
- (iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.
- (c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--
- (A) A description of the foreign and domestic construction materials;
- (B) Unit of measure;
- (C) Quantity;
- (D) Price;
- (E) Time of delivery or availability;
- (F) Location of the construction project;
- (G) Name and address of the proposed supplier; and
- (H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.
- (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).
- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.
- (3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.
- (d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
