The following have been added by full text:

REQUEST FOR INFORMATION

Question 1: How much fuel is left in the tanks?

Response 1: Please refer to the Statement of Work, Part II. Technical, 10. Existing Conditions.

Question 2: How many burners do you have?

Response 2: Fuel tanks supply fuel for two (2) burners which consist of the heater and generator in gatehouse.

Question 3: What is the distance from the burner to tanks?

Response 3: The approximate distance from the tanks to the heater/burner is about six (6) feet, however, it does require penetration through the concrete containment barrier. The length of the feed and return for the system is approximately 18 feet in length, separately, however, these distances are approximate. Interested vendors are responsible for measuring distance to ensure adequate material is included in their quotes. No modifications will be considered post award for failure to verify site conditions.

Question 4: How far off the ground is the outside vent from the ground?

Response 4: Vent pipe is more than 20 ft from ground, thus it is recommended to reuse existing pipe if possible, or thread a new one out of the existing hole.

Question 5: Is the fuel refilled inside or outside?

Response 5: Fuel tanks are filled inside of the building. There is no external fill tube.

Question 6: Is this a tax exempt job?

Response 6: The Government can issue a tax exemption certificate for materials consumed during the contract.

Question 7: Is a temporary fuel source required while the tanks are being replaced?

Response 7: A temporary fuel source is not required during the performance of the Purchase Order. Temporary storage of the existing fuel in the system is required.
