I. <u>GENERAL</u>

1. Summary:

Provide all labor, materials, equipment, and transportation necessary to sample and test potable water at Buffumville Lake Park. All procedures will be in accordance with 310 CMR 22.00: The Massachusetts Drinking Water Regulations. The contractor shall be the primary communicator between the government and the Massachusetts Department of Environmental Protection (Mass DEP). The contractor shall complete and submit all required documents and forms to allow for the public water supply to operate in accordance with the Mass DEP.

2. Location:

Buffumville Lake Park is located at 229 Oxford Road in Charlton, MA 01507. See the attached informational maps for more detailed location information.

3. Site Visits and Requests for Information:

Site visits are strongly recommended to gauge the full scope of work and provide an accurate quote. No extra payment will be considered for perceived additional work caused by unfamiliarity with the site conditions and requirements. Contact the Technical Point of Contact (TPOC) to arrange a site visit. The Technical Point of Contact for this project is Park Ranger James Higgins: (978) 318-8472 (Office line) or via email at James.j.higgins@usace.army.mil.

4. Schedule:

The contract period of performance for the base year will be from contract award to March 31, 2025. In addition, the government may exercise one (1) option year with the same statement of services. Option year one (1) has a period of performance from April 1, 2025, to October 31, 2025.

The seasonal period of performance for actual water sampling is from May through September each year, while the park and well are in use.

Work shall be performed Monday through Friday between the hours of 7:00 AM and 3:30 PM unless otherwise approved by the TPOC. Any proposed changes to an approved schedule must be submitted to the TPOC in writing and are not finalized until approved. No work shall be done on weekends or government holidays.

All pre-work submittals shall be submitted within 14 days of contract award. The government reserves up to 7 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the contractor shall make such revisions and shall be resubmitted to the government in an acceptable form within 7 days of the government's response, unless additional time is granted by the government in writing. No field work may proceed prior to the acceptance of pre-work submittals.

5. Safety:

a. General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Occupational Health Requirements (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety and health requirements. Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

b. Accident Prevention Plan (APP):

The Contractor shall prepare a site-specific Accident Prevention Plan. The APP must be written by a Competent Person (CP) and document the specific work processes, equipment, materials to be used, hazards and applicable control measures.

A preparatory meeting shall be conducted by the prime contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing the subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Daily safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

c. Activity Hazard Analysis (AHA):

An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. A DFOW is defined as any task, which is separate and distinct from other tasks, has separate control requirements, or is identified as different trades or disciplines. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

The Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.b.

Level 3 SSHOs must have training, knowledge, and/or experience identifying hazards and implementing controls for the work being performed.

The SSHO shall be present at the project site and be responsible for overseeing the implementation of the prime contractor's SOH program. Contractor shall designate all SSHOs on a mandatory ENG Form 6282 (Site Safety and Health Officer Designation Letter):

For shifts with multiple employees, provide at least two employees that are certified to administer First Aid and CPR. When employes work alone, they must be certified in First Aid and be provided an effective means of communication to call for assistance in the event of an emergency. Minimum First Aid and CPR qualifications are outlined in EM 385-1-1, Chapter 3-3.

f. Additional Personnel Requirements:

Other Competent Person (CP) or Qualified Persons (QP) may be required per EM 385-1-1 and/or other sections of this Scope of Work, based on the definable features of work for this project.

g. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor and reported to the Technical Point of Contact in accordance with EM 385-1-1, Table 2-1.

h. Employee Exposure Data:

The Contractor shall electronically report total employee work hours (including subcontractors) to the Technical Point of Contact by close of business on the 10th calendar day of the following month.

6. Pre-Work Conference:

Prior to the start of any site work, the Technical Point of Contact will schedule and conduct a pre-work conference. The contractor's Project Manager and Quality Control Personnel will be physically present to attend this meeting. The Project Manager and Quality Control Personnel shall have the authority to act on the behalf of the Contractor. This conference will be held at the time and location agreeable to the government and contractor. No site work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the government in its administration of the contract, and to discuss the performance that will be expected from the contractor. This conference will allow the contractor an opportunity to ask questions about the government's administration and inspection of contract work or obtain other pertinent information that might be required. II. TECHNICAL

1. Submittals:

Although the government reviews submissions required by this performance work statement, it is emphasized that the contractor's work must be completed using proper internal controls and review procedures. The government reserves up to 7 days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the contractor shall make such revisions and shall resubmit to the government in acceptable form within 7 days of the government's response, unless additional time is granted by the government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and accepted by the government.

- a. Pre-work Submittals: Submitted within 14 days of contract award. Submittals must be accepted before the commencement of any field activities.
 - Accident Prevention Plan
 - Activity Hazard Analysis
 - First Aid and CPR Certificates
 - Appropriate licenses and certifications

b. Other Submittals:

- Written sampling plan & approval
- Written start-up procedure & acceptance (No later than May10th)
- All final lab results & acceptances (After each test)

2. Clean Up:

The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the government. Upon completion of work, the contractor shall clean up the job site to the satisfaction of the government.

3. Government Resources:

The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the government will not provide any equipment, telephone services or other resources.

4. Damage to Government and Private Property:

The contractor shall be responsible for restoring any government facilities or structures

damaged as a result of the contractor's operation. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the contractor's operations. The contractor shall notify the TPOC immediately of damage to government and private property and injury to any person resulting from the contractor's operation.

5. Omissions:

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

6. Quality Assurance:

The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

7. Other Contracts:

The government may undertake or award other contracts for additional work not related to this contract, and the contractor shall fully cooperate with other contractors and government employees. The contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by government employees.

8. Environmental Protection:

Containers for excess and/or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/cleaned each workday. No burning is permissible.

Water, air, and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met and maintained.

9. Receiving and Storing Materials:

The contractor is responsible for protecting any stored material until it is placed in service. The contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the contractor and will not be responsible for damage or theft of contractor equipment or material.

10. Existing Conditions:

Buffumville Lake Park is a seasonal recreation area. The park's amenities include a swim beach, picnic tables and grills, restroom facility, and a picnic shelter. Hours of operation for the park are 8:00AM to 8:00PM every day from the third Saturday of May to the second Sunday of September, including federal holidays. Three (3) host sites are situated adjacent to the entrance road alongside a storage barn. The park's water is sourced by Public Water Supply (PWS) 2054052.

a. PWS 2054052

- i. Seasonal system with population served of 250 in the summer and 0 in the winter.
- ii. 6" bedrock well drilled to a depth of 675' with a 2-horsepower submersible pump set at 600'.
- iii. Approved by Mass DEP for a withdrawal rate of 3,000 gallons per day.
- iv. Aboveground well components are in the pump house. See attached maps. Components include a calibrated water meter, variable frequency pump control drive, pressure tank, and filter housing unit.
- v. See included attachments for the Certificate of Registration (2024), Water Quality Report (Consumer Confidence Report, 2023), and Compliance Monitoring Schedule (2023-2025).

11. Service Locations:

Each sampling visit requires the contractor to perform testing at three (3) different sampling points within Buffunville Lake Park. Two (2) of the points are representative of water throughout the distribution system. One (1) point serves as the entry point to the distribution system.

a. Sample Point 1

i. Sample point 1 is in the pump house. See attached maps. A handwheel hose bibb is located between the pressure tank and filter housing. The handwheel hose bibb serves as the collection point for the sample.

b. Sample Point 2

i. Sample point 2 is located on the exterior of the restroom facility. Two (2) water fountains are located on the face of the building. The contractor shall select either of the two (2) fountains and remain consistent with that choice for the remainder of the contract. The fountain serves as the collection point for the sample.

c. Sample Point 3

i. Sample point 3 is in the host site closest to the park entrance, Host Site 1. A frost-proof yard hydrant is mounted to a 4"-by-4" post within the host site. The hydrant serves as the collection point for the sample.

III. EXECUTION:

- 1. The contractor shall perform potable water testing for Buffumville Lake Park. For the duration of the contract, the contractor shall perform all collections, tests, and submittals in accordance with 310 CMR 22.00: The Massachusetts Drinking Water Regulations.
- 2. The contractor shall be the primary communicator between the government and the Mass DEP. For all seasonal, routine, and repeat monitoring tests the contractor shall submit final lab results and Mass DEP communications and acceptance within 48 hours of receiving to the TPOC.
- 3. The contractor shall submit to Mass DEP a written sampling plan that identifies the

sampling sites listed in this performance work statement and a sample collection schedule in accordance with 310 CMR 22.00: The Massachusetts Drinking Water Regulations. Mass DEP communications and acceptance shall be submitted to the TPOC prior to the first test.

- 4. The contractor shall submit a written start-up procedure to the Mass DEP no later than May 1st. Proof of acceptance by the Mass DEP must be submitted to the TPOC no later May 10th.
- 5. The contractor shall perform routine tests at the intervals agreed upon by the Mass DEP in their written sampling plan. Typical testing in the past has taken place on a weekly basis, however this may not necessarily be the case every year.
- 6. Contractor shall complete and submit seasonal shut-down paperwork.
- 7. In the event any test exceeds Maximum Contaminant Levels (MCL), the contractor shall perform additional testing as required by repeat monitoring requirements and analytical requirements in 310 CMR 22.05(2). The contractor may perform up to two (2) instances of repeat testing. Contractor shall complete and submit all required paperwork with Mass DEP. The government shall only pay for services rendered.
 - a. An instance of repeat testing is defined as the first initial test exceeding MCL. All consecutive tests exceeding MCL are considered the same instance of repeat testing until proof of acceptable levels, as defined by the Mass DEP, are achieved.
- 8. The contractor shall take corrective actions in the event of a test exceeding the MCL or at the request of the Mass DEP. The contractor shall provide treatment of the PWS to bring the water quality below MCL thresholds. The contractor may perform up to four (4) instances of corrective action treatment. The government shall only pay for services rendered.





currently being enforced as to contracts or contract-like instruments entered into with the federal government in connection with seasonal recreational services or seasonal recreational equipment rental for the general public on federal lands. HEALTH & WELFARE: \$4.98 per hour, up to 40 hours per week, or \$199.20 per week or \$863.20 per month

HEALTH & WELFARE EO 13706: \$4.57 per hour, up to 40 hours per week, or \$182.80 per week, or \$792.13 per month*

*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706, Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor; 3 weeks after 8 years, 4 weeks after 15 years, and 5 weeks after 30 years. Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of eleven paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Juneteenth National Independence Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: This wage determination does not apply to any individual employed in a bona fide executive, administrative, or professional capacity, as defined in 29 C.F.R. Part 541. (See 41 C.F.R. 6701(3)). Because most Computer Systems Analysts and Computer Programmers who are paid at least \$27.63 per hour (or at least \$684 per week if paid on a salary or fee basis) likely qualify as exempt computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 213(a)(17), this wage determination may not include wage rates for all occupations within those job families. In such instances, a conformance will be necessary if there are nonexempt employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industry, and are not determinative of whether an employee is an exempt computer professional. To be exempt, computer employees who satisfy the compensation requirements must also have a primary duty that consists of:

- (1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;
- (2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;
- (3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation requirements and the above duties test qualifies as an exempt computer professional under both section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (Field Assistance Bulletin No. 2006-3 (Dec. 14, 2006)). Accordingly, this wage determination will not apply to any exempt computer employee regardless of which of these two exemptions is utilized.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you

work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

** HAZARDOUS PAY DIFFERENTIAL **

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, dying, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

** UNIFORM ALLOWANCE **

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of ""wash and wear"" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

The duties of employees under job titles listed are those described in the ""Service Contract Act Directory of Occupations"", Fifth Edition (Revision 1), dated September 2015, unless otherwise indicated.

** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE, Standard
Form 1444 (SF-1444) **

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or

notifies the contracting officer that additional time will be required to process the request.

- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the ""Service Contract Act Directory of Occupations" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1)).
