1. Quotes shall be submitted **via email** to the Contract Specialist listed above **no later than the closing date and time** identified in the solicitation or subsequent amendments.
2. The Government is under no obligation to consider any quote received after the solicitation closing date or time.

## SITE VISITS:

2. If date(s)/time(s) for site visits are included in the solicitation, then interested vendors will be permitted to visit the site during those dates/times. No other dates/times will be permitted for site visits.

## BONDING:

A Payment Bond or Irrevocable Letter of Credit is the SELECTED payment protection for the Government. The penal amount of bond shall be 100% of the original contract price. This bond shall be submitted to the Contracting Officer within 10 days after receipt of award.

A Performance Bond shall be required if the total price of the quote is \$150,000.00 or above. The penal amount of the Performance Bond shall be 100% of the original contract price. If the contract price increases, the Government will require an increase in the penal sum of the existing bond. This bond shall also be submitted to the Contracting Officer within 10 days after receipt of award.

## Section C - Descriptions and Specifications

STATEMENT OF WORK

**REPAIR COHEN ROAD AT WINHALL BROOK CAMPING AREA  
U.S. ARMY CORPS OF ENGINEERS  
BALL MOUNTAIN LAKE  
JAMAICA, VERMONT  
STATEMENT OF WORK**

**I. General**

1. **Scope** – Furnish all labor, materials, and equipment necessary to perform the following repairs to two (2) sections of Cohen Road, an emergency access and heavy equipment route for the south side of Winhall Brook Camping Area (WBCA).
  - a. Site #1 Repair a thirty foot (30') long washout.
  - b. Site #2 Reinstallation and cleaning of one (1) eighteen-inch (18") culvert and ditch.
  - c. All work shall be completed in accordance with the following Statement of Work.
2. **Location** –
  - a. The Ball Mountain Lake office is located at 88 Ball Mountain Ln., Jamaica, VT 05343.
  - b. Winhall Brook Camping Area is located at 919 Winhall Station Rd., South Londonderry, VT 05155.
  - c. Cohen Road is located two tenths of a (.2) mile from the entrance of the camping area. For the purpose of this work Cohen Road is accessed via Godaleville Road, Jamaica, VT.
3. **Site Visit** – A site visit is highly recommended. Contact the Technical Point of Contact (TPOC) to arrange a site visit. The TPOC for the project is Natural Resources Specialist, Morgan Post 978-318-8474 or [morgan.j.post@usace.army.mil](mailto:morgan.j.post@usace.army.mil).
4. **Schedule** – The work shall be completed 180 days from Contract Award. The Contractor will coordinate with the Government for the estimated start date of field work. Work shall be performed Monday through Friday 7:00 AM to 3:30 PM unless otherwise approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays. The Pre-Construction Conference shall be completed with fourteen (14) days of Contract Award.

All pre-construction submittals shall be submitted within twenty-one (21) days of Contract Award. The Government reserves up to twenty-one (21) days for review and acceptance on each submittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall be resubmitted to the Government in an acceptable form within fourteen (14) days of the Government's response, unless additional time is granted by the Government in writing. **No field work may proceed prior to the acceptance of all pre-construction submittals.**

**5. Safety Requirements-**

**a. General:**

All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Occupational Health Requirements (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), Federal, State, and local safety and health requirements. A copy of EM 385-1-1 can be accessed electronically at the following link:

Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

**b. Accident Prevention Plan (APP):**

The Contractor shall prepare a site-specific Accident Prevention Plan. The APP must be written by a Competent Person (CP) and document the specific work processes, equipment, materials to be used, hazards and applicable control measures.

The mandatory ENG Form 6293 (Accident Prevention Plan Worksheet) must be submitted and accepted prior to beginning on site work:

A preparatory meeting shall be conducted by the Prime Contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing the subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Daily safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

**c. Activity Hazard Analysis (AHA):**

An AHA shall be submitted and accepted for each definable feature of work (DFOW) in accordance with EM 385-1-1, Chapter 2-6. A DFOW is defined as any task, which is separate and distinct from other tasks, has separate control requirements, or is identified as different trades or disciplines. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

**d. Site Safety and Health Officer (SSHO) Requirements:**

The Contractor shall employ a minimum of one person to function as a Level 3, SSHO. A Level 3 SSHO is a designated Qualified Person (QP) or Competent Person (CP) with Safety and Occupational Health (SOH) responsibility that meets the requirements of EM 385-1-1, Chapter 2-3.b and 2-4.b.

Level 3 SSHOs must have training, knowledge, and/or experience identifying hazards and implementing controls for the work being performed.

The SSHO shall be present at the project site and be responsible for overseeing the implementation of the Prime Contractor's SOH program. Contractor shall designate all SSHOs on a mandatory ENG Form 6282 (Site Safety and Health Officer Designation Letter):

**e. First-Aid and CPR Personnel Requirements:**

For shifts with multiple employees, provide at least two employees that are certified to administer First Aid and CPR. When employees work alone, they must be certified in First Aid and be provided an effective means of communication to call for assistance in the event of an emergency. Minimum First Aid and CPR qualifications are outlined in EM 385-1-1, Chapter 3-3.

**f. Additional Personnel Requirements:**

Other Competent Person (CP) or Qualified Persons (QP) may be required per EM 385-1-1 and/or other sections of this Scope of Work, based on the definable features of work for this project.

**g. Accident Reporting:**

All accidents and near misses shall be investigated by the Contractor and reported to the Technical Point of Contact in accordance with EM 385-1-1, Table 2-1.

The mandatory ENG Form 3394 shall be completed and submitted to the Technical Point of Contact within seven (7) days of an incident:

**h. Employee Exposure Data:**

The Contractor shall electronically report total employee work hours (including subcontractors) to the Technical Point of Contact by close of business on the 10<sup>th</sup> calendar day of the following month.

- 6. Pre-Construction Conference** – Prior to the start of any work, the Technical Point of Contact will schedule and conduct a “Pre-Construction Conference”. The Contractor's Project Manager and Quality Control Personnel will be physically present to attend this meeting. The Contractor shall directly oversee all work on the project and the Project Manager and Quality Control Personnel shall have the authority to act on behalf of the Contractor. This conference will be held at the time and location agreeable to the Government and Contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This

conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-Construction conference the Contractor shall provide the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Pre-Construction Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.
  - ii. Contractor's Safety Program (including sub-contractors).
  - iii. Accident Prevention Plan and Activity Hazard Analysis (ENG Forms 6293 & 6206)
  - iv. Accident Reporting (ENG Form 3394)
  - v. Site Safety and Health Officer Designation Letter (ENG Form 6282)
  - vi. Safety Data Sheet (SDS) requirements
  - vii. Contractor's Equipment
  - viii. Correspondence, Communication, Security and Administrative Procedures.
  - ix. Invoice and payment.
7. **Permits** – The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, county, and municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.
8. **Security** – The Contractor will comply with all established security policies at Ball Mountain Lake. Due to periods of heightened security that may affect the access to the areas covered under this contract, the Government reserves the right to close any property or portion of property and reschedule and/or cancel any subsequent work. The Contractor shall be given at least twenty-four (24) hours' notice of any such closure.
9. **Flooding** – Ball Mountain Lake is a flood control project, and the work area outlined in this contract is subject to becoming inundated during periods of excessive rainfall. If such an event should occur, in-progress work shall immediately cease, and all equipment, materials, and personnel will be vacated from the area within twenty-four (24) hours' notice by the TPOC. When flooding ends and waters recede, the TPOC will notify the Contractor as areas reopen and work may resume.
10. **Payment** – After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of work, description of work, quantities, process, and total amount due per line item. The invoice must also include the company letterhead, and this must match the data that is registered in the System for Award Management (SAM) registry. For jobs greater than 30 days the Contractor may request multiple payments.

## **II. Technical Requirements**

### **Part 1 General**

1. **Scope** – Furnish all labor, materials, and equipment necessary to perform the following repairs to two (2) sections of Cohen Road, an emergency access and heavy equipment route for the south side of Winhall Brook Camping Area.
  - a. Site #1 Repair a thirty foot (30') long washout.
  - b. Site #2 Reinstallation and cleaning of one (1) eighteen-inch (18") culvert and ditch.
  - c. All work shall be completed in accordance with the following Statement of Work.
2. **Submittals** – Although the Government reviews submissions required by this Statement of Work, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The Government reserves up to twenty-one (21) days for review and acceptance on each submittal/resubmittal from the date of receipt. If revisions are necessary to the submittals, the Contractor shall make such revisions and shall resubmit to the Government within fourteen (14) days of the Government's response, unless additional time is granted by the Government in writing.

The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and accepted by the Government.

- a. **Pre-Construction:** Submitted within twenty-one (21) days of Contract Award.

Submittals must be accepted prior to the commencement of any field work .

  - i. Accident Prevention Plan (ENG Form 6293)
  - ii. Activity Hazard Analysis (ENG Form 6206)
  - iii. Site Safety and Health Officer Designation Letter (ENG Form 6282)
  - iv. First-Aid, CPR Certifications
  - v. Notification of Work – will provide a minimum of seven (7) days' notice prior to the start of field work.
  - vi. Commercial Driver's License (CDL) – for all operators of vehicles requiring a CDL
  - vii. Erosion and sediment control plan measures to include: dips, water bars, culverts, silt fencing, check dams, filter socks, straw rolls, etc.
  - viii. Site restoration plan to include: conservation seed mix, erosion control matting, silt fencing, mulch hay, with locations and quantities for use in conformance with contract specifications.
  - ix. Spill Prevention Plan.
  - x. Spill response plan for petroleum, oils and lubricants and other hazardous materials.
  - xi. Materials submittal to be approve by the Technical Point of Contact.
- b. **Post-work:** By the completion of work and before final payment

- i. Truck load counts including the amount of material in yards.

**3. References –**

- a. 2024 Vermont Standard Specifications for Construction sections 755.04

**4. Existing Conditions -**

- a. Cohen Road is an emergency access and heavy equipment route for the south side of the Winhall Brook Camping Area. Cohen Road can be accessed via Winhall Brook Camping Area off Winhall Station Road or from Goodaleville Road (heavy equipment access).
- b. Cohen Road is a one (1) mile-long class IV, non-maintained roadway that was washed out due to flooding and erosion. Approximately a half mile of the roadway is gated from the last residence to the camping area.
- c. Slasons Bridge is located in Winhall Brook Camping Area and measures approximately ten feet (10') wide with a load rating of sixteen (16) ton. This access can only accommodate smaller equipment.
- d. Site #1 - The washout area is a thirty-foot (30') section of road that is located three hundred (300) yards southwest of the Winhall Brook Camping Area gate (south of Slasons Bridge) and nine tenths (.9) of a mile northeast of the intersection of Goodaleville Road and Cohen Road. Multiple trees are down along the thirty-foot (30') washout area. The bottom of the lower bank up to the road surface is approximately thirty-foot feet (30') in height (Informational pictures 1-3).
- e. Site #2 - a single eighteen-inch (18") culvert that needs to be cleaned and reinstalled and is located two hundred and seventy five (275) yards southwest of site #1. A ravine is located above the roadway that washed onto the road surface and clogged the culvert serving this intermittent stream (Informational pictures 4-5).

**5. Other Contracts –** The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other Contractors and Government employees. The Contractor shall not commit or permit any act which will interfere with the performance of work by another Contractor or by Government employees.

**6. Clean Up and Waste Disposal –** The Contractor shall practice good housekeeping to maintain a safe job site. The Contractor shall keep the work area, including any designated storage areas free from accumulation of waste materials. Upon completing work in an area, the Contractor shall remove any tools, equipment, and materials that are not the property of the Government. Any and all disturbed areas resulting from Contractor activities shall be restored by the Contractor to the satisfaction of the Technical Point of Contact. All waste material will be disposed of offsite in accordance with all Federal, State, and local regulations.

**7. Environmental Protection –** Water, air, and land resources shall not be adversely impacted during the course of the work. Storage, fueling and lubrication of equipment and motor vehicles shall be conducted in a manner that affords the maximum protection against spills and evaporation. Storage and usage of lubricants and daily fueling of machinery and equipment shall occur at least fifty feet (50') from any drainage inlets, water bodies (rivers,

streams, and lakes), environmentally sensitive areas (wetlands and vernal pools). Contractor will take necessary steps to ensure all Federal, State, and local environmental regulatory requirements are met.

- 8. Sustainability & Environmentally Preferred Products** – Under the Comprehensive Procurement Guidelines (CPG) program, the Environmental Protection Agency (EPA) designates products that are or can be made with recovered materials and recommends practices for buying these products. Any designated product that is being offered or supplied under this contract shall meet the minimum recommended content levels as identified under the CPG program. Visit <https://www.epa.gov/smm/comprehensive-procurement-guideline-cpg-program> for a complete list of designated products and the associated recommended contents levels. Offerors must be able to demonstrate that each offered products meets minimum content levels upon request.

The United States Department of Agriculture (USDA) designates certain bio-based products for Federal procurement and specifies minimum bio-based content levels for those products. Any designated product that is being offered or supplied under this contract shall meet USDA BioPreferred's minimum bio-based content level. - 9. Personal Protective Equipment** – It is the Contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.
- 10. Government Resources** – The Government will supply hay for mulching purposes valued at (\$7/bale). The Contractor shall supply their own means of communication (telephone/radio). There is no restroom available or potable water at the contract site. The Contractor would have to provide these resources or have an acceptable alternative plan for these resources.
- 11. Damage to Government and Private Property** – The Contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the Contractor's operation. The Contractor shall also be responsible for any damage to private property or injury to any person as a result of the Contractor's operation. The Contractor shall notify the Project Manager immediately of damage to Government and private property and injury to any person resulting from the Contractor's operation. Also, the Contractor shall notify the Technical Point of Contact of damage to Government facilities due to vandalism or other causes on the day such damage is first noticed. Trucks and/or trailers will be driven on existing roads only and not across or through park areas to facilities. The Contractor shall also restore landscape features (shrubs, flowers, grasses, etc.), which are damaged or destroyed by the Contractor's operation. Damaged or destroyed grass areas shall be re-planted as directed by the Technical Point of Contact, and shrubs and flowers which are damaged or destroyed shall be replaced from nursery stock of like size and kind.

- 12. Contractor's Personnel** –

- a. **Minimum Personnel Requirements:** The Contractor shall provide an adequate number of fully qualified personnel to perform the specified work properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.
- b. **Employee Conduct:** The Contractor shall be responsible for seeing that the firm's employees strictly comply with the Code of Federal Regulations Title 36, Chapter III, Part 327, and all, Federal, State, and municipal laws. Any personnel activity, which, in the opinion of the Government, is deemed detrimental to the performance of the contract may result in the removal of Contractor employee/employees.

Examples of unbecoming actions or conduct include but are not limited to the following:

- i. Cursing, harassment, or discrimination of and/or unwarranted physical contact with visitors, USACE personnel, or other Contractors.
  - ii. Recurring written and/or verbal complaints from visitors, USACE personnel, or other Contractors.
  - iii. Unsafe operation of vehicles while on USACE property.
- c. **Removal of Contractor's Employees:** The Technical Point of Contact may require the Contractor to immediately remove from the work site any employee of the Contractor or subcontractor, who, in the opinion of the Technical Point of Contact, is incompetent, who endangers persons or property, or whose physical or mental condition is such that it would impair the employee's ability to satisfactorily perform assigned work. Notification to the Contractor shall be promptly made in writing if time and circumstances permit. Otherwise, notification shall be verbal or by telephone, and shall be confirmed in writing as soon as possible. No such removal, however, will reduce the Contractor's obligation to perform all work required under this contract, and immediate replacement will be made as required. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.

- 13. **Omissions** – This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, State, or Federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
- 14. **Quality Assurance** – The Contractor is responsible for the quality control of the contract work. The Contractor shall establish and maintain a quality control system to assure compliance with the contract requirements. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
- 15. **Receiving and Storing Materials** – The Contractor is responsible for protecting any stored material until it is placed in service. The Contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive materials or supplies for the Contractor and will not be responsible for damage to the Contractor's equipment or materials.

**Part 2 Materials****1. Provided by Contractor -****a. Stone Retaining Wall Material:**

- i. Three-to-five-foot (3' to 5') stone material for use in stabilizing bottom layer of roadbed and armoring the lower bank of the roadway.

**b. Road Base Material:**

- i. Five-inch (5") minus **stone** for use as a mid-layer of roadbed.

**c. Road Surface Material:**

- i. Three quarter to one and one half inch (.75" to 1.5") stone for use as surfacing material.

**d. Grass Seed:**

- i. Conservation Mix: 35% creeping red fescue, 25% tall fescue, 15% annual ryegrass, 12% perennial, 10% Kentucky bluegrass, 3% white clover.
- ii. State-approved seed of the latest season's crop shall be provided in original sealed packages bearing the producer's guaranteed analysis for percentages of mixture, purity, germination, hard seed, weed seed content, and inert material.
- iii. Substitutions will not be allowed without written request and approval from the Government.
- iv. **Quality:** Weed seed shall not exceed one (1) percent by weight of the total mixture. Wet, moldy, or otherwise damaged seed shall be rejected.

**e. Erosion Control:**

- i. Silt Fence, hay bales, silt blankets, and waddles.

**2. Provided by Government –****a. Mulching Hay:**

- i. The Government will supply hay for mulching purposes valued at seven (7) dollars per bale.

**Part 3 Equipment:**

- 1. Condition of Equipment–** All equipment used to perform work under this contract must be in good operating and mechanical condition and comply with EM 385-1-1, Army Corps of Engineers Safety and Health Requirements. A regular schedule of preventive maintenance must be followed on all equipment. All vehicles utilized under this contract will be presentable, serviceable, and shall comply with safety standards.
- 2. Mobilization, Demobilization, and Other Equipment Costs:** The scope will include mobilization and demobilization, fuel surcharge and any permits to get the equipment to Winhall Brook Camping Area and the Contractor shall quote this accordingly.

**Part 4 Execution:****1. Site Preparation -**

- a. The Contractor shall remove all debris present on roadway in the area of the washout to prepare site for repair work. Debris shall be removed off site and disposed of properly.
- b. Debris includes multiple down trees as show in the informational photos.
- c. The material that is removed may be used to build the roadbed if the material is free of organic material and falls within the products specified above. Otherwise, material will be used for widening existing roadway where appropriate.
- d. Prior to any work, erosion control measures must be taken to prevent the movement of soil and debris into Winhall Brook. The TPOC will be immediately notified if control measures fail at any point.
- e. Silt fence or other erosion control measures shall be maintained following best management practices.

**Note: The Contractor shall conduct periodic inspections of the silt fence to ensure the silt fence function and integrity is maintained during the duration of the contract. If the silt fence is damaged or breached, the Contractor shall repair, reinstall, or add addition silt fence as necessary before dumping or grading additional material.**

**2. Site #1 - Washout Repair -**

- a. The Contractor shall remove material on the uphill side of the roadway to widen roadway to a minimum width of twenty feet (20').
- b. Uphill bank shall not exceed a 2:1 slope and shall be armored with stone to prevent future erosion.
- c. A ditch at the base of the slope shall allow water to run toward the nearest culvert.
- d. Stone shall be used to stabilize the base of the roadbed. Footer rock shall be embedded and keyed into the existing ground. Footer wall shall be constructed with staggered joints between rocks on adjacent tiers.
- e. Stone shall also be used to armor the downhill bank of the roadway against future flood water encroachment along the thirty-foot (30') foot section of road.
- f. Road base material placed at a minimum depth of eighteen inches (18") to a maximum depth of twenty-four inches (24") shall be used as an intermediate substrate to fill in washout area on top of riprap footing material.
- g. Road surface material placed at a minimum for four inches (4") to six inches (6") compacted depth shall be used as a top surface of the roadway, above the road-base material.
- h. Final slope of the hill side above the road shall be seeded and dressed with stone to prevent future erosion.
- i. Seed all disturbed areas of hillside.
- j. All seeded areas with greater than or equal to a 2:1 slope, shall be covered with an approved erosion control fabric and approved silt fencing at the toe of the slopes.

**3. Site #2 - Culvert reinstallation -**

- a. Excavate and clean out the inside of existing culvert.

- b. Inspect the culvert and if damaged notify TPOC.
- c. Dig trench or cutoff and prepare the bedding. Allow for eighteen (18) inches of road base material to be placed on top of the culvert.
  - i. Location of culvert will be as close as possible to original location and coordinated with TPOC.
- d. Place the culvert into the trench.
- e. Backfill each side of the culvert with road base material.
- f. Place road base material over and around the culvert.
- g. Compact every one (1) foot in depth (1 foot lifts).
- h. Excavate the inlet of the culvert to a minimum depth of the bottom of the placed culvert.
- i. Extending a minimum distance of five (5) feet upstream, remove any material that may impede the flow water through the culvert.

**4. Seeding -**

- a. Shall meet requirements of 2024 Vermont Standard Specifications for Construction sections 755.04.
- b. Seed shall be spread uniformly at a rate of one hundred thirty pounds (130lbs) per acre minimum.
- c. Seed may be applied using a hydraulic application or by hand. If done by hand, seed will be incorporated into the top one quarter inch (1/4") inch of soil by hand raking or other approved methods.

**5. Mulching -**

- a. Coverage of mulching hay must be at least one eighth inch (1/8") thick over entire area.

**Suspicious Activity Reporting training (e.g. iWATCH, CorpsWatch, or See Something, Say Something):** All contract personnel shall receive initial and annual refresher training from the RA representative on the local suspicious activity reporting program. This locally developed training provides contract personnel with general information on suspicious behavior, and guidance on reporting suspicious activity to the project manager, security representative or law enforcement entity.

[The Contractor shall enter the name and unique entity identifier of each party to the joint venture: .]

(a) Definitions. As used in this clause--

Biobased product means a product determined by the U.S. Department of Agriculture (USDA) to be a commercial product or industrial product (other than food or feed) that is composed, in whole or in significant part, of biological products, including renewable domestic agricultural materials and forestry materials, or that is an intermediate ingredient or feedstock. The term includes, with respect to forestry materials, forest products that meet biobased content requirements, notwithstanding the market share the product holds, the age of the product, or whether the market for the product is new or emerging. (7 U.S.C. 8101) (7 CFR 3201.2).

USDA-designated product category means a generic grouping of products that are or can be made with biobased materials--

- (1) That are listed by USDA in a procurement guideline (7 CFR part 3201, subpart B); and
  - (2) For which USDA has provided purchasing recommendations (available at <https://www.biopreferred.gov>).
  - (b) The Contractor shall report to <https://www.sam.gov>, with a copy to the Contracting Officer, on the product types and dollar value of any biobased products in USDA-designated product categories purchased by the Contractor during the previous Government fiscal year, between October 1 and September 30; and
  - (c) Submit this report no later than--
    - (1) October 31 of each year during contract performance; and
    - (2) At the end of contract performance.
- (End of clause)

#### 52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (OCT 2022)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

- (1) Means any item of supply (including construction material) that is--
  - (i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);
  - (ii) Sold in substantial quantities in the commercial marketplace; and
  - (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material

regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

(1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or

(2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means--

(1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both--

(i) An unmanufactured construction material mined or produced in the United States; or

(ii) A construction material manufactured in the United States, if--

(A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or

(B) The construction material is a COTS item; or

(2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

(3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that

(i) The cost of domestic construction material would be unreasonable.

(A) For domestic construction material that is not a critical item or does not contain critical components.

(1) The cost of a particular domestic construction material subject to the requirements of the Buy American statute is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;

(2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.

(B) For domestic construction material that is a critical item or contains critical components.

(1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.

(2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic

offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.

(ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or

(iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.

(c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--

(A) A description of the foreign and domestic construction materials;

(B) Unit of measure;

(C) Quantity;

(D) Price;

(E) Time of delivery or availability;

(F) Location of the construction project;

(G) Name and address of the proposed supplier; and

(H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.

(d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
