**Performance Work Statement
October 2018**

A. GENERAL

1. **Scope**

Provide all equipment, materials, labor, and transportation necessary to perform snow removal and road and parking lot sanding services.

2. **Location**

Barre Falls Dam is located at 200 Coldbrook Road, Barre, MA 01005.

3. **Site Visit**

Contact the Technical Point of Contact, Park Ranger, Brianna Green (978-928-4712, 978-318-8263 or brianna.j.green@usace.army.mil) to arrange a site visit.

4. **Schedule**

The period of performance will start after contract award and end on 30 April 2019. In addition, the Government may exercise 1 option year with the same scope of services. Option Year 1 will have a period of performance from **1 November** 2019 through 30 April 2020.

5. **Pre-Work Conference**

The Contractor, upon award of this contract, shall contact the Technical Point of Contact to arrange a pre-work conference. At this meeting, contract requirements will be discussed and any problems resolved. The successful bidder is required to attend this pre-work conference.

The following is a general list of items for discussion during this Pre-work Conference:

- i. Authority of the Technical Point of Contact.
- ii. Contractor's Safety Program.
- iii. Activity Hazard Analysis (Submitted & accepted prior to start of work on site).
- iv. Requirements for Safety Meetings (Documented on NED Form 251).
- v. Accident Reporting (ENG Form 3394).
- vi. Accident Exposure Hours – Reporting requirements
- vii. Material Safety Data Sheet (MSDS) requirements.
- viii. Contractor's Quality Control Plan.
- ix. Communications and Correspondence Procedure.
- x. Administrative Procedures.
- xi. Invoice and payment.

6. **Permits**

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor

shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

7. **Security**

The contractor will comply with all established security policies at Barre Falls Dam. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least 24 hour notice of any such closure.

8. **Contractor Conduct**

Alcohol and firearms are prohibited on project grounds. Contractor and employees must comply with CFR 36 Rules and Regulations.

9. **Payment**

The contractor shall furnish the Technical Point of Contact with one invoice per month, identifying the contract number, stating the amount of services completed during the month, identified by Item Number and quantity. Payment shall be made monthly for the actual services performed at the applicable contract unit price.

B. Technical Service Requirements

1. Summary

Provide all equipment, materials, labor, and transportation necessary to provide snow removal and road and parking lot sanding services. The services include Snow Plowing, Sanding, and Shoveling. The services shall be performed at Barre Falls Dam project area as shown in the attached exhibits. Contractor's work and responsibility shall include, but not be limited to, all job planning, programming, scheduling, administration, inspection, personnel, equipment, vehicles, fuel, materials, supplies, supervision, and quality control necessary to perform the various services required herein.

2. Exhibits

- a. Exhibit 1: General Location Map
- b. Exhibit 2: Snow Removal & Sanding Map - Entrance Road
- c. Exhibit 3: Snow Removal & Sanding Map - Overlook Parking Area
- d. Exhibit 4: Snow Removal & Sanding Map - Office & Employee Parking
- e. Exhibit 5: Snow Removal & Sanding Map - Gate House
- f. Exhibit 6: Snow Removal & Sanding Map - Recreation Area Parking
- g. Exhibit 7: Snow Removal & Sanding Map - Route 122 Parking Area

3. Materials & Supplies

The following materials shall be provided by Contractor:

- o Sand/Salt mix (for plowed areas). Note – Mixture will have a salt content of approximately 20%.

Note: The Contractor shall submit one copy of the manufacturer's Material Safety Data Sheet for each chemical proposed for use.

4. Equipment

The contractor is required to have equipment sufficient to plow snow and to sand. The equipment should be able to handle heavy snow loads from normal falling snow, ice, and rain, to drifted snow. The equipment should be able to broadcast the snow to avoid encroaching snow banks.

The minimum equipment shall include

- o $\frac{3}{4}$ ton four wheel drive truck
- o An 8 foot plow, equipped with four way angling capabilities.
- o A powered sander with a minimum one yard capacity (Hand Sanding is not acceptable).

5. Safety Requirements

All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health requirements Manual (EM 385-1-1, most recent edition), and all applicable federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be accessed electronically at Headquarters USACE website under publications using the following link:

http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf

The contractor shall also comply with all OSHA work safety standards. The project staff can and will order the cessation of work at any time should the safety of employees and visitors become jeopardized.

6. Modified Activity Hazard Analysis:

- A Modified AHA shall be submitted and must cover all the major phases of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. Work shall not proceed on a phase of work until the AHAs have been accepted by the GDA. A preparatory meeting shall be conducted by the prime contractor to discuss the Modified AHA's contents with all effected onsite employees. The Modified AHA shall be continuously reviewed and revised to address changing site conditions as appropriate. The AHA's shall interface with the Contractor's overall safety and health program.
- Emergency Reponses Procedures shall be documented in the Modified AHA and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

7. Required Personnel:

- The Contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site and report to the contractor's upper management. The CP is required to have related construction and/or service experience.
- In addition, when emergency medical services are not accessible within 5 minutes of the work location and there are 2 or more workers onsite, at least 2 employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

8. Accident Reporting:

- All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the GDA within 4 hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the GDA. ENG Form 3394 shall be completed and submitted to the GDA within five working days of the incident.

- The Contractor shall complete the attached “USACE Contractor Monthly Summary Record of Injuries/Illness and Work Hour Exposure” (for prime and its subcontractors) and forward the completed form to the GDA no later than close of business on the 5th calendar day of the following month. The method of transmission by the prime contractor to the GDA shall be electronically.

Service Description

1. **Snow Plowing:** The following services shall be performed as part of the Snow Plowing:
 - A. Snow plowing will be required after accumulation of four (4) inches or more of snow, or upon notification by Technical Point of Contact.
 - B. The Contractor will make sure to safely push back all banks along roadways and entry points to maintain access. All access shall be a minimum of sixteen (16) feet in width. When plowing the parking lot adjacent to the Project Office, the Contractor shall not pile snow against the fence containing the waste dumpster or the fence containing the emergency generator (at the rear of the building).
 - C. The width of the access roadway and parking lots shall be plowed as shown on the Snow Plowing Map. (Approximately 1.3 miles).
 - D. Significant snow drifting may occur at the crest of the dam, so extra vigilance is required when plowing this location.
 - E. There are two speed bumps in the picnic area (one entering and one exiting) – Contractor shall take extreme caution when plowing speed bumps and shall take all cautions deemed necessary so as not to damage equipment or the speed bumps. All damages incurred by the Contractor to the speed bumps shall be repaired by the Contractor at no additional cost to the Government. Speed limit is posted at 10 mph.
 - F. Site Access
 - a. The contractor will be provided a key for access to the Barre Falls Dam Project area gates if necessary.
 - b. If the contractor is required to unlock and open a gate to plow, then the contractor will be required to secure the gate when the plowing is completed.
 - c. Upon the completion of this contract, the contractor will return the key to project staff before final payment is made.
 - G. Property Damage
 - a. In the event that property does become damaged, it is the Contractor’s responsibility to immediately notify the Technical Point of Contact to report the damage.
 - b. It will be the responsibility of the Contractor to coordinate with the Technical Point of Contact an appropriate way to repair damaged property at no cost to the Government.

2. **Sanding/Salting:** The following services shall be performed as part of the Sanding:
 - A. The contractor shall sand/salt all icy areas with the Sand/Salt mixture for plowed areas. Sand/Salt Mixture shall be spread adequately on plowed surfaces to provide traction for driving and walking
 - B. The project staff may request additional sanding and salting as conditions require.
 - C. Sanding and salting will also be performed on weekends, holidays, and after normal working hours during the week if necessary.

3. **Shoveling:** After plowing, the contractor shall shovel snow from the main doorways of the four main buildings on the project. Snow shall be cleared beyond swing of door and beyond each side of door frame.
 1. Project Office: shovel around three main entry doors – two doors in the front of the building and one in the rear by the parking lot
 2. Gate House: shovel out by doorway
 3. Old Operator's Quarters: shovel steps and doorway at the south side of building, by the garage door
 4. Back garage: shovel around both doors (on East and West sides of building)
 5. Snow may not be placed against any building or fences.

4. **Route 122 Parking Area:**

At the discretion of the Technical Point of Contact, additional plowing may be necessary in Oakham by the intersection of Coldbrook Road and Route 122 (see exhibit 4). This will only occur when requested by the Technical Point of Contact during the winter season and is not to be considered as part of the routine contract.

5. **Inspections:** Upon the completion of each service, the contractor shall inspect all areas under this contract to ensure compliance with the requirements and document the inspection on the attached Inspection Form. Any deficiencies must be corrected immediately or shall be deducted from payment.

Service Locations

1. **Barre Falls Dam Project Locations** are presented on the Snow Plowing Maps (attached exhibits). The area descriptions are presented below:
 - A. Plowing
 1. Administrative Area – includes office buildings, garages, and gate house. (Exhibits 2-6)
 2. Entrance Road – includes estimated 1.3 miles of Coldbrook Road leading into Barre Falls Dam and the Recreation Areas. (Exhibits 2-6)
 3. Parking Areas – Visitor and Employee parking lots. (Exhibits 2-7)
 4. Lower Garage – 4 bay garage located behind the project office. (Exhibit 4)

 - B. Sanding:
 1. Administrative Area – includes office buildings, garages, and gate house. (Exhibits 2-6)

2. Entrance Road – includes estimated 1.3 miles of Coldbrook Road leading into Barre Falls Dam and the Recreation Areas. (Exhibits 2-6)
3. Parking Areas – Visitor and Employee parking. (Exhibits 2-7)
4. Lower Garage – 4 bay garage located behind the project office. (Exhibit 4)

C. Schedule:

1. Weekdays: Hours of operation vary from 6:00 AM to 6:00 PM, Monday through Friday. To provide safe access for employees, service shall be completed by 6:00 am on weekdays, unless otherwise directed by the Technical Point of Contact.
2. Weekends: service shall be performed immediately upon completion of the snow storm, unless otherwise directed.

D. Service Definition:

1. A full service is defined as a single completion of all requirements for each item detailed below.
2. Larger snow storms may require more than one service at the discretion of the government.
3. The contractor may not perform more services than the government authorizes for each storm.
4. If a partial service is rendered, payment will be adjusted according to percent of area completed.
5. If snow continues to fall after completion of service and the government requires the contractor to return to plow again, that will be considered a separate service.

2. **Estimated Quantities** – The following table is an estimate for the number of required services anticipated over the course of the season:

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (AUG 2018) ALTERNATE I (OCT 2014)

The offeror shall complete only paragraphs (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal> . “Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

“Service-disabled veteran-owned small business concern”—

 - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

HEALTH & WELFARE: \$4.48 per hour or \$179.20 per week or \$776.53 per month

HEALTH & WELFARE EO 13706: \$4.18 per hour, or \$167.20 per week, or \$724.53 per month*

*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706, Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor; 3 weeks after 8 years, 4 weeks after 15 years, and 5 weeks after 30 years.

Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of ten paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: Under the SCA at section 8(b), this wage determination does not apply to any employee who individually qualifies as a bona fide executive, administrative, or professional employee as defined in 29 C.F.R. Part 541. Because most Computer System Analysts and Computer Programmers who are compensated at a rate not less than \$27.63 (or on a salary or fee basis at a rate not less than \$455 per week) an hour would likely qualify as exempt computer professionals, (29 C.F.R. 541.400) wage rates may not be listed on this wage determination for all occupations within those job families. In addition, because this wage determination may not list a wage rate for some or all occupations within those job families if the survey data indicates that the prevailing wage rate for the occupation equals or exceeds \$27.63 per hour conformances may be necessary for certain nonexempt employees. For example, if an individual employee is nonexempt but nevertheless performs duties within the scope of one of the Computer Systems Analyst or Computer Programmer occupations for which this wage determination does not specify an SCA wage rate, then the wage rate for that employee must be conformed in accordance with the conformance procedures described in the conformance note included on this wage determination.

Additionally, because job titles vary widely and change quickly in the computer industry, job titles are not determinative of the application of the computer professional exemption. Therefore, the exemption applies only to computer employees who satisfy the compensation requirements and whose primary duty consists of:

- (1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;
- (2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;
- (3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you

work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

** HAZARDOUS PAY DIFFERENTIAL **

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, dyeing, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

** UNIFORM ALLOWANCE **

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by

laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of "wash and wear" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

**** SERVICE CONTRACT ACT DIRECTORY OF OCCUPATIONS ****

The duties of employees under job titles listed are those described in the "Service Contract Act Directory of Occupations", Fifth Edition (Revision 1), dated September 2015, unless otherwise indicated.

**** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE, Standard Form 1444 (SF-1444) ****

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).

2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.

3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).

4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.

5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.

6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1)).
