STATEMENT OF WORK

EXTERIOR BUILDING PAINTING- QUECHEE GORGE VISITOR CENTER U.S. ARMY CORPS OF ENGINEERS North Hartland Lake Statement of Work

I. <u>General</u>

1. Scope of Work

Provide all materials, labor, and equipment for performing all operations necessary to paint the exterior wood walls and trim of the Quechee Gorge Visitor Center. The building is approximately 75'x41' and is a two story building.

2. Location

The North Hartland Lake Project Office is located at 112 Clay Hill Rd, North Hartland, VT 05052. The Quechee Gorge Visitor Center is located at 5966 Woodstock Road (Route 4) Quechee, VT 05059

3. Site Visit

Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for the project is Heather Morse (802-295-2855) or <u>Heather.L.Morse@usace.army.mil</u>).

4. Schedule

The work shall be completed 45 days from contract award. The project area will be open to the Contractor Monday through Friday 8:00 AM to 4:00 PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.

5. Safety

<u>a.. Accident Prevention Plan</u>: The Contractor shall prepare an Accident Prevention Plan (APP) specific to the activities being performed. It shall include an Activity Hazard Analysis (AHA) as described below. All work shall be conducted in accordance with the APP, the U.S. Army Corps of Engineers Safety and Health requirements Manual (EM 385-1-1, most recent edition), and all applicable federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be accessed electronically at Headquarters USACE website under publications using the following link:

http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf

Work shall not proceed until the APP has been reviewed by the Government Designated Authority (GDA) and deemed acceptable for use on the project. USACE will provide a non-mandatory, fillable template APP. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements listed in EM 385-1-1.

The APP shall interface with the Contractor's overall safety and health program. Any portions of the Contractor's overall safety and health program referenced in the APP shall be included in the applicable APP element and made site-specific. The Government considers the Prime Contractor to be the "controlling authority" for safety and health of the subcontractors.

The Contractor shall conduct a safety meeting at the project site on the first day of work, whenever a new activity or phase of work begins, or at least weekly during the progress of work. All safety meetings shall be documented. The attached safety meeting form or a similar contractor-prepared form shall be used. Records of the safety briefings shall be submitted to the GDA weekly.

- 1. <u>AHA:</u> An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. Work shall not proceed on a phase of work until the AHAs have been accepted by the GDA. A preparatory meeting shall be conducted by the prime contractor to discuss the AHAs contents with all effected onsite employees. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.
- 2. <u>Required Personnel</u>: The Contractor shall employ a minimum of one Competent Person (CP) at each project site to function as the Site Safety and Health Officer (SSHO). The SSHO shall be present at the project site and report to the contractor's upper management. The SSHO is required to have related construction experience and have completed a <u>10 Hour OSHA training</u> (or more).

In addition, when emergency medical services are not accessible within 5 minutes of the work location and there are 2 or more workers onsite, <u>at least 2 employees shall be</u> <u>trained in First Aid and CPR</u>. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

Note: Other Competent or Qualified Persons may be required per EM 385-1-1 and other sections of this Scope of Work, based on the characteristics of the project

b. <u>Accident Reporting:</u> All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the GDA within 4 hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the GDA. ENG Form 3394 shall be completed and submitted to the GDA within five working days of the incident.

The Contractor shall complete the attached "USACE Contractor Monthly Summary Record of Injuries/Illness and Work Hour Exposure" (for prime and its subcontractors) and forward the completed form to the GDA no later than close of business on the 5th

calendar day of the following month. The method of transmission by the prime contractor to the GDA shall be electronically.

- 6. Fall Protection Requirements
 - a. <u>General</u>: The requirements of this section are applicable to contractors when their employees are working at heights above 6 feet, exposed to fall hazards, and/or using fall protection equipment. Every Contractor is responsible for establishing, implementing and managing a fall protection program in accordance with EM 385-1-1, Section 21.
 - b. <u>Submittals</u>: A site-specific **Fall Protection and Prevention Plan** is required to be submitted and approved by the GDA prior to any work being completed at heights. USACE will provide a non-mandatory, fillable template plan. However, the contractor is permitted to submit their own plan, at a minimum it must address the items listed in EM 385-1-1, Section 21.D.01:
 - *i.* Duties and responsibilities. Identify CPs and QPs and their responsibilities and qualifications;
 - *ii.* Description of the project or task performed;
 - *iii.* Training requirements to include safe use of fall protection equipment;
 - iv. Anticipated hazards and fall hazard prevention and control;
 - v. Location of anticipated anchorages that will be installed during the project;
 - vi. Rescue plan and procedures;
 - vii. Design of anchorages/fall arrest and horizontal lifeline systems:
 - viii. Inspection, maintenance and storage of fall protection equipment;
 - *ix.* Incident investigation procedures;
 - *x.* Evaluation of program effectiveness;
 - xi. Inspection and oversight methods employed.

NOTE: It is realized that means of fall protection for the first person establishing anchorages can be difficult. In this situation, fall protection may not be required while the individual is installing the initial anchorage point. Once this is installed, fall protection is required. These activities need to be addressed in the AHA and Fall Protection and Prevention Plan.

- c. <u>Competent Person (CP)</u>: The person designated in writing by the employer to be responsible for immediate supervising, implementing and monitoring of the fall protection program, who through training, knowledge and experience in fall protection and rescue systems and equipment, is capable of identifying, evaluating and addressing existing and potential fall hazards and, who has the authority to take prompt corrective measures with regard to such hazards. *The CP shall:*
 - *i.* Be onsite at all times while work at height is being performed;
 - *ii.* Be trained in accordance with EM 385-1-1, Section 21.C.04, to include a minimum of 24 hour CP in fall protection training made up of classroom and practical hands-on components.
 - *iii.* Prepare, update, review and approve fall protection and prevention plans;
 - *iv.* Review procedures as workplace activities change to determine if additional practices, procedures or training need to be implemented;

- v. Supervise the selection, installation, use and inspection of non-certified anchorages;
- vi. Verify End Users who work at heights are trained and authorized to do so;
- *vii.* Inspect fall protection equipment at the frequency required by the manufacturer and EM 385-1-1.

NOTE: THE USE OF SCAFFOLDING OR ELEVATING AERIAL PLATFORMS (MANLIFTS) NEGATES THE NEED FOR A 24 HOUR COMPETENT PERSON IN FALL PROTECTION TRAINING IF EQUIPMENT MEETS THE REQUIREMENTS OF SECTION 22 OF EM 385-1-1 AND IS EQUIPPED WITH FACTORY INSTALLED ANCHORAGE POINTS FOR FALL PROTECTION. FALL PROTECTION MUST STILL BE USED IN ACCORDANCE WITH SECTION 21.K OF EM 385-1-1.

- d. <u>Qualified Person (QP)</u>: A person with a recognized degree, or professional certificate, with extensive knowledge, training and experience in the fall protection and rescue field who is capable of designing, analyzing, evaluating and specifying fall protection and rescue systems. *The QP shall*:
 - *i.* Be trained to the applicable level, as described in EM 385-1-1, Section 21.C.03;
- *ii.* Provide technical support for the fall protection program;
- *iii.* Have advanced understanding and knowledge of the requirements, equipment, systems, physical sciences, and engineering principles that affect fall protection and rescue systems;
- *iv.* Supervise the design, selection, installation and inspection of certified anchorages and horizontal lifelines;
- v. Be qualified to select proper fall protection and rescue equipment;
- e. <u>End User</u>: A person who has been trained and authorized by the employer on the use of assigned fall protection equipment in a typical fall hazard situation. They must have an understanding of workplace activities and follow the policy, procedures, and instructions of the Competent Person regarding the use of fall protection, rescue systems, and related equipment. *They shall:*
 - *i.* Be trained by a CP in accordance with EM 385-1-1, Section 21.C.05, to include hands-on training and practical demonstrations
- *ii.* Bring all unsafe or hazardous conditions or actions that may cause injury to them or others, to the attention of the CP;
- *iii.* Properly use, inspect, maintain, store and care for their fall protection equipment and systems;
- iv. Inspect all fall protection equipment or damage or defects, prior to each use.
- v. Understand the nature of fall hazards in the work area and how to properly mitigate them;
- vi. Calculate free fall distances and clearance requirements of fall protection systems;
- vii. Understand the site-specific rescue procedures;
- f. <u>Personal Fall Arrest System Requirements (PFAS)</u>: All PFAS shall meet the requirements contained in <u>ANSI Z359</u>, Fall Protection Code, to include fall restrain and positioning systems. A PFAS consist of a full body harness, connecting means, and an anchorage system. General this equipment is certified for users within the capacity range of 130 to 310 lbs, including the weight of the worker, equipment, and tools. A CP shall inspect the equipment at least once semi-annually and whenever the equipment is subject to a fall or impact.
- *i.* Full body harnesses shall meet the requirements of ANSI Z359 and be used in accordance with EM 385-1-1, Section 21.1.06. Body belts and full body harnesses meeting only the requirements of the ANSI A10.14 shall not be used. All full body harnesses shall be equipped with Suspension

Trauma Preventers such as stirrups, relief steps, or similar in order to provide short-term relief from the effects of orthostatic intolerance.

ii. All energy free fall energy absorbing lanyards shall meet the requirements of ANSI Z359.13 and be used in accordance with EM 385-1-1, Section 21.1.07.

NOTE: When an anchor point is below the dorsal D-ring, a free fall (FF) distance greater than 6 ft (1.8 m) is created. For these situations, a 12 ft (3.6 m) FF energy absorbing lanyard shall be used in accordance with manufacturer's instructions and recommendations. A 12 ft (3.6 m) FF energy absorbing lanyard does not refer to the lanyard length. Instead it refers to a FF that is greater than 6 ft (1.8 m) up to 12 ft which is created by the anchor point being located below the dorsal D-ring. <u>The maximum</u> length of the lanyard used shall not exceed 6 ft. (See Figure 21-4 in the EM 385-1-1)

NOTE: THE USE OF SCAFFOLDING OR ELEVATING AERIAL PLATFORMS (MANLIFTS) NEGATES THE NEED FOR A 24 HOUR COMPETENT PERSON IN FALL PROTECTION TRAINING IF EQUIPMENT MEETS THE REQUIREMENTS OF SECTION 22 OF EM 385-1-1 AND IS EQUIPPED WITH FACTORY INSTALLED ANCHORAGE POINTS FOR FALL PROTECTION. FALL PROTECTION MUST STILL BE USED IN ACCORDANCE WITH SECTION 21.K OF EM 385-1-1.

7. <u>Preconstruction Conference</u>

Prior to the start of any work, the contract awardee will schedule and conduct a "Preconstruction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This meeting may be in person or over the phone. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-work conference the contractor shall provide the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Pre-work Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.
- ii. Contractor's Safety Program (including sub-contractors).
- iii. Activity Hazard Analysis
- iv. Accident Prevention Plan
- v. Safety Meetings (Documented on NED Form 251).
- vi. Accident Reporting (ENG Form 3394).
- vii. Safety Data Sheet (SDS) requirements.

iii. Self-Retracting Devices (SRDs) shall meet the requirements of the ANSI/ASSE Z359.14 standard and be used in accordance with EM 385-1-1, Section 21.1.07.d.

viii. Correspondence, Communication and Administrative Procedures.

8. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

9. Security

The contractor will comply with all established security policies at North Hartland Lake. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least 24 hour notice of any such closure.

10. Contractor Conduct

The Contractor and Employees shall not use or be under the influence of drugs or alcohol at any time while performing the obligations under this contract or giving the public the appearance of the same. Alcohol and firearms are prohibited on project grounds. Contractor and employees must comply with CFR 36 Rules and Regulations.

11. Payment

Payment shall be made on a per job basis. After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item.

II. Technical Requirements:

Part 1 General:

1.1. **Existing Conditions**:

The wood exterior walls and trim are currently painted and stained. It was last painted and stained in 2005 and is beginning to fade. Refer to the attached informational photos.

1.2. Summary:

Furnish all labor, materials and equipment to paint the exterior of the Quechee Gorge Visitor Center.

1.3. Clean Up and Waste Disposal:

The Contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area free from accumulation of waste materials. Upon completing work in an area the contractor shall remove any tools, equipment, and materials that are not the property of the government. Any and all disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the Technical Point of Contact.

1.4. Environmental Protection:

Containers for excess and/or waste materials, rubbish, etc. shall be provided by the contractor at the site and the site will be inspected/cleaned on a daily basis. No burning is permissible. Water, air and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state and local environmental regulatory requirements are met.

1.5. Sustainability:

The contractor should meet the BioPreferred Program requirements set in place by the USDA. 1.6. Government Resources:

The contractor may use the existing restroom facilities at the Visitor Center. The government will supply any electricity necessary for the project work from points of existing outlets. The contractor shall carefully conserve the use of electricity provided. The contractor shall supply his own means of communication (telephone).

1.7. Damage to Government and Private Property:

The Contractor shall be responsible for restoring any Government facilities or structures damaged as a result of the firm's operation. The Contractor shall also be responsible for any damage to private property or injury to any person as a result of the firm's operation. The Contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person resulting from the firm's operation.

1.8. **Omissions:**

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable and functional product.

1.9. **Quality Assurance:**

The Contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract. The government may utilize sampling and unscheduled inspections. If any of the work does not conform to the contract requirements the contractor shall be required to perform the work again in conformity with the contract requirements at no expense to the government.

1.10. Other Contracts:

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and Government employees. - 2.2. **Paint Product:** Contractor shall use an exterior acrylic latex house paint flat sheen for the trim around the roof peak, eaves and fascia board along porch, that meets the following requirements:
 - 2.1.1 Resists dirt and mildew
 - 2.1.2 Includes self-priming one-coat protection
 - 2.1.3 Low VOC
 - 2.1.4 Coverage: up to 300 sqft per gallon
 - 2.1.5 Lifetime limited warranty

Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

(1) An unmanufactured construction material mined or produced in the United States;

(2) A construction material manufactured in the United States, if--

(i) The cost of its components mined, produced, or manufactured in the United States exceeds 50 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic; or

(ii) The construction material is a COTS item.

Foreign construction material means a construction material other than a domestic construction material.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the component test of the Buy American statute is waived for construction material that is a COTS item. (See FAR 12.505(a)(2)). (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.

(d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
