REQUEST FOR INFORMATION

Question 1: I am unclear on the scope of this solicitation. Is the pond 5 acres or the hand pulling area 5 acres? If not, what size area needs to be cleared and what is the water depth?

Answer: The RFQ is for 250 man-hours of crew work hand-pulling Eurasian water milfoil at Stoughton Pond. The map and reference to approximately 5 acres depicts the priority hand pulling location. If the priority location is completed in less than 250 man hours, another location will be assigned. Water depths in assigned hand pulling locations will be six feet or less.
