STATEMENT OF WORK

REPAIRS TO EXISTING PVC ROOF NEW BEDFORD HURRICANE BARRIER U.S. ARMY CORPS OF ENGINEERS New Bedford, MA Scope of Work

I. General

- 1. Scope Furnish all labor, equipment, tools, materials and services to replace a damaged section of an existing PVC roof membrane on the New Bedford Operators Building. Work includes demolition of approximately 210 square feet of the existing PVC roof membrane system and temporary patch materials. Work includes installation of new base insulation materials and new PVC membrane system and flashing materials. The completed repair shall be water tight and properly pitched to shed water from the roof. Contractor is responsible for removal and proper disposal or recycling of all debris generated. Figures, Reference Drawings, and Informational Photos show the required repair area.
- 2. **Location** The roof repair area is located on Operating House No. 1 at the Project. Access to the Project is from Gifford Street, New Bedford, MA.
- 3. **Site Visit** Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for this project is Andrew Cattano (978-318-8329) or Andrew.M.Cattano@usace.army.mil.
- 4. **Schedule** The work shall be completed no later than 120 days from Contract Award. Work shall be performed Monday through Friday 7:00 AM to 4:00 PM unless otherwise approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.

5. Safety Requirements

a. <u>General</u>: All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable OSHA, federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be accessed at the project office or electronically at the following link:

Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

b. Abbreviated Accident Prevention Plan:

The Contractor shall prepare an Abbreviated Accident Prevention Plan (APP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable Abbreviated APP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the Abbreviated APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

c. Activity Hazard Analysis (AHA):

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

d. Emergency Response:

Emergency procedures shall be documented in the Abbreviated Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

e. Required Personnel:

The Contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site. The CP is required to have related construction experience.

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, at least two (2) employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

f. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPC within four (4) hours of the incident. Serious accidents shall be immediately reported to the TPC. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

Contractors are responsible to ensure their subcontractors are in compliance with safety requirements.

As part of the APP and AHAs include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements: Procedures for periodic sanitation and disinfecting project sites in accordance with CDC guidelines. Site specific measures to practice social distancing while working on the project. Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines. A list of PPE to be used in accordance with CDC and state guidelines.

- 6. **Preconstruction Conference** –Prior to the start of any work, the Contractor and Technical Point of Contact will schedule and conduct a "Preconstruction Conference". The Contractor's staff responsible for quality and safety on the job site will attend this meeting. This conference will be scheduled for a time and location agreeable to the government and contractor. No field work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the requirements in terms of safety, quality, communications, inspections and payments. Staging and storage areas for materials, equipment and dumpsters will also be coordinated at this meeting.
- 7. **Permits** The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.
- 8. **Security** The Contractor will comply with all established security policies at the New Bedford Hurricane Barrier. Due to periods of heightened security that may affect the access to the areas covered under this contract, the Government reserves the right to close any property or portion of property and reschedule and/or cancel any subsequent work. The Contractor shall be given at least 24 hour notice of any such closure. The contractor will verify all employees working at the New Bedford Hurricane Barrier through the E-Verify website located at: http://www.uscis.gov/e-verify. The Contractor will submit verification documents to the Technical Point of Contact prior to or during the Preconstruction Conference.
- 9. Contractor Conduct Alcohol and firearms are prohibited on project grounds.

II. Technical Requirements:

Part 1 General:

- 1. Summary Furnish all labor, equipment, tools, materials and services to repair damage to an existing PVC roof membrane located on the New Bedford side Operators House. Work includes demolition of approximately 210 square feet of the existing PVC roof membrane system that is damaged and temporary patch materials. Work includes installation of new base insulation materials and new PVC membrane system that is attached to the existing PVC membrane to remain. Work includes new flashing materials for the repair area. Work includes removal and proper disposal or recycling of all debris generated. Figures and Informational Photos show the required repair area. All products shall be installed in accordance with the manufacturer's recommendations in terms of fastening and seams with the existing PVC membrane to remain. The completed roof repair shall be water tight and properly pitched to shed water from the roof.
- 2. Existing Conditions The existing PVC roofing system on the Operating House was installed in 2010. During a recent winter storm, an antennae was blown over resulting in damage to part of the roof membrane and underlying insulation near the base of the antennae. The roof was patched with temporary materials to prevent water intrusion. There are roof-mounted items and penetrations within the repair area including a new antenna concrete base, vent equipment pad, and a 5-inch exhaust pipe. The existing PVC roofing membrane is constructed of fully adhered membrane over top of rigid, tapered insulation installed over the concrete deck of the building. The existing roof system has high quality edge details to prevent air and water intrusion around the perimeter. Figures 5-10 show details of the existing roof system layout and dimensions.
- 3. Access to Work Site Access to the project site is currently available for construction traffic. The Contractor is responsible for maintaining access necessary for its equipment and material to and from the work area. Contractor can assess roof from stairs leading through Operating House control room and side door out to roof repair area. Figures 5-6 and Photo 6 show access to existing roof system.
- 4. **Clean Up and Waste Disposal** The contractor shall keep the work area free from accumulation of waste materials. Any and all disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the Technical Point of Contact.
- 5. **Environmental Protection** Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis. Water, air and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met.

6. **Sustainability** - EPA Designated: Under the Comprehensive Procurement Guidelines (CPG) program, the Environmental Protection Agency (EPA) designates products that are or can be made with recovered materials, and recommends practices for buying these products. Any designated product that is being offered or supplied under this contract shall meet the minimum recommended content levels as identified under the CPG program. - 7. **Building Protection** The building and all of its contents shall be protected from the elements during the duration of this contract. The contractor shall keep on site the means to quickly cover and protect all areas open to the elements during an unforeseen weather related event that could cause damage to the building and or any of its contents during all phases of this contract.
- 8. **Personal Protective Equipment** It is the contractor's responsibility to furnish and supply personnel with the proper personal protective equipment and fall protection necessary for performing the work.
- 9. **Government Resources** The government has 120 volt electric power for hand tools that is available to the Contractor from points of existing outlets. The contractor shall carefully conserve the use of electricity provided. The contractor may have a portable toilet delivered and placed near the work site, which may be secured by the contractor when not on site. A single bathroom in the New Bedford building is also available for Contractor use.
- 10. **Damage to Government and Private Property** The contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the firm's operation. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the firm's operation. The contractor shall notify the Project Manager immediately of damage to Government and private property and injury to any person resulting from the firm's operation.
- 11. **Omissions** This contract may not cover all specified activities, steps, and procedures required for the completed roof repair. In case of omission, the normal industry, state, or

federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

- 12. **Quality Assurance** The contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
- 13. Other Contracts The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other Contractors and Government employees. The contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor or by Government employees.
- 14. **Receiving and Storing Materials** The Corps of Engineers will provide an exterior storage area and parking for contractor personnel. The contractor is responsible for protecting any stored materials, equipment and tools during sitework. The contractor is responsible for receiving and unloading of delivered goods.
- 15. **Submittals** Although the Government technically reviews submissions required by this scope of work, it is emphasized that the Contractor's work must be prosecuted using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted for review and accepted by the Government prior to the commencement of any field activities.
 - Abbreviated Accident Prevention Plan with Activity Hazard Analysis for all work.
 - Repair Materials Provide a description of the proposed repair materials to include PVC membrane, adhesives, insulation, metal edge materials and fasteners. Submittal should describe how the new insulation will be fastened, how the new PVC membrane will be attached to the existing PVC membrane to remain and flashing and edge details.
 - Security Verification Prior to the start of field work
 - Limited Warranty- Cover any defects in the roof repair area for 2 years.

Part 2 Products:

All products shall be new and unused. Products shall be approved by the Technical Point of Contact prior to installation. The products and materials used shall be designed for use in a marine salt water environment with winds up to 100mph. Proposed materials shall be similar to the materials used in the existing PVC roof system.

- 1. PVC Membrane
 - a. Reinforced polyvinyl chloride (PVC) membrane shall comply with ASTM D 4434, Type III, or ASTM D 6754, and in all cases shall provide 0.045 inch

minimum thickness for mechanically fastened application. The new PVC membrane shall be compatible with the existing roof PVC membrane in terms of ability to have watertight seems. Dimensions shall be sufficient to minimize joints. New membrane shall match existing membrane with edge detailing to prevent air and water intrusion underneath the membrane.

- b. Shall match thickness of existing PVC membrane to remain.
- c. Fully adhered.
- d. Top color of membrane White.

2. Flashing:

a. Membrane flashing, including self-adhering membrane flashing, perimeter flashing, flashing around roof penetrations and prefabricated pipe seals, shall be minimum polymer thickness 0.045 inch reinforced PVC and shall be utilized as recommended by the membrane manufacturer.

3. Insulation and Edge Details

- a. Insulation system and fascia material shall be compatible with proposed PVC membrane and match material type and features of existing roof.
- b. Able to withstand foot traffic without crushing.
- c. Pitched to match existing drainage pattern.

4. Wood Products

a. New pressure treated wood for nailers and blocking as necessary to complete the roof repair.

Part 3 Execution:

General

- 1. The Contractor shall coordinate all activities to minimize any impact on the operations of the New Bedford Hurricane Barrier. The building and all its contents shall be protected from the elements during the duration of this contract.
- 2. Demolition and installation shall be scheduled so that weather related events will result in no damage to the building or any of its contents. The contractor shall keep on site the means to quickly cover and protect all areas open to the elements during an unforeseen weather-related event.

Demolition

- 1. Carefully remove the existing PVC membrane, insulation, patch materials, protective walk pads, flashing, pressure treated nailers, fascia and other related items from the repair area shown on Figure 4.
- 2. Existing railings shall remain in place and be protected during demolition work.
- 3. Cut flush or remove any objects, such as old fasteners, that may puncture the new roofing system. Contractor shall ensure surfaces are rigid, clean, dry, smooth, and free from cracks, holes, and sharp changes in elevation.
- 4. Collect and legally dispose of all debris generated in accordance with all federal, state and local laws and regulations.

Installation

- 1. Install new insulation, PVC membrane, wood blocking, flashing, pressure treated nailers and fascia in the repair area shown on Figure 4.
- 2. Install new insulation to provide a smooth transition with insulation to remain. New insulation shall provide base to maintain proper pitch of roof to drain water.
- 3. PVC membrane roofing utilizing mechanically fastened application method. Membrane shall be overlapped a minimum of 5.5-7 inches and minimum 4 inches at ends. Membrane joints shall be free of wrinkles and fishmouths. The entire length of hot-airwelded seams shall be probe-tested and corrected during the day of installation. Defective areas shall be re-welded. Wrinkles, fishmouths, or damaged areas shall be cut out and the area covered with a membrane using a continuous hot-air-welded seam on all sides. Hot-air-welded seams are to be accomplished in accordance with the PVC membrane roofing manufacturer's published requirements. Ensure membrane is free of wrinkles and ridges. Mechanically secure the membrane sheet with specified fasteners in the lap area. Space fasteners as required to provide wind uplift resistance specified. Check all seams and ensure full/continuous lap seal.
- 4. Mechanically secure roof membrane sheet at roof south perimeter in a manner to comply with wind resistance requirements and in accordance with membranes manufacturer's printed instructions.
- 5. Membrane shall be fastened to nailers in accordance with the membrane manufacturer's instructions. Unless otherwise specified, nails shall be staggered on 4-inch centers maximum; screws for sheet metal shall be staggered on 8 inch centers maximum; and a row of fasteners shall be at least ½ inch from edges of sheet metal.
- 6. Contractor shall mechanically fasten the roof membrane at penetrations, at base of antenna and walls, and at all locations where the membrane turns and angles greater than 4 degrees (1:12). Space fasteners a maximum of 12 inches on center, except where more frequent attachment is required to meet specified wind resistance or where recommended by the roof membrane manufacturer. Hot-air-weld all seams of flashing material as recommended by the roof membrane manufacturer's printed data.
- 7. Contractor shall install new flashing around antenna tower foundation, 5-inch exhaust pipe, south roof edging, and existing ventilator pad. The seam shall be sealed a minimum of 3 inches beyond the fasteners which attach the membrane to nailers. The installed flashing's shall be secured at the top of the flashing a maximum of 12 inches on centers under the counterflashing or cap. Where possible, prefabricated components shall be used for pipe seals and flashing accessories.
- 8. Apply flashing to cleaned surfaces and as recommended by the roof membrane manufacturer. Utilize reinforced PVC membrane flashing and prefabricated accessory flashing's as recommended by the roof membrane manufacturer.
- 9. Sheet metal counter-flashing shall be installed over the termination bar in the completed work. Mechanically fasten top edge of base flashing for all other terminations in a manner recommended by the roof membrane manufacturer. Apply reinforced PVC flashing membrane over top of exposed nailers and blocking and to overlap top edge of base flashing installation where applicable.
- 10. Install new high quality PVC coated metal fascia to cover the area where the membrane is keyed into the south roof edge noted on Figure 4.

11. Contractor shall protect applied membrane roofing system from water intrusion at the end of each day's work and when precipitation is imminent.

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:




Figure 1 shows general location of the New Bedford Hurricane Project.




Figure 3 shows area of roof repair on Operating House #1, looking north.




Figure 4 shows plan view of roof repair area.




Figure 5 shows reference Drawing 1 for existing roof installed in 2010.




Figure 6 shows reference Drawing 2 for existing roof installed in 2010.




Figure 7 shows reference Drawing 3 for existing roof installed in 2010.




Figure 8 shows reference Drawing 4 for existing roof installed in 2010.




Figure 9 shows reference Drawing 5 for existing roof installed in 2010.




Figure 10 shows reference Drawing 6 for existing roof installed in 2010.




Photo 4: Shows temporary patch materials with existing PVC membrane, looking south.
