I. General

1. Scope of Work

Contractor shall furnish all labor, materials, and equipment necessary to deepen the existing potable water well, install a new well pump, install a new pressure tank, disconnect existing 8,000 gallon water storage tank from system, and connect all contracted work into existing restroom water system at Winhall Brook Camping Area.

2. Location

The Winhall Brook Camping Area is located at 919 Winhall Station Road in South Londonderry, Vermont. The Ball Mountain Lake Recreation Area and Project Office is located at 88 Ball Mountain Lane, Jamaica, Vermont.

3. Site Visit

4. Schedule

The Period of Performance will be sixty (60) days from contract award. The project area will be open to the contractor Monday through Friday 7:00AM to 3:30PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.

5. Safety Requirements:

5.1 General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable OSHA, federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be accessed at the project office or electronically at the following link:

Project staff reserve the right to cease work at any time should the safety of employees, contractors, and/or the public become jeopardized.

5.2 Accident Prevention Plan:

The Contractor shall prepare an Accident Prevention Plan (APP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable APP template is available upon request. However, the contractor is permitted

to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

5.3 Activity Hazard Analysis (AHA):

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

Note: As part of the APP and AHAs include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements:

- Procedures for periodic sanitation inspections.
- Procedures for disinfecting project sites in accordance with CDC guidelines.
- Site specific measures to practice social distancing while working on the project.
- Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines.

EXCAVATION AND TRENCHING

 - a) An onsite employee who has been designated in writing by the employer to be responsible for the immediate supervision, implementation and monitoring of the excavation/trenching program, who through training, knowledge and experience

in excavation/trenching is capable of identifying, evaluating and addressing existing and potential hazards and, who has the authority to take prompt corrective measures with regard to such hazards.

5.4 Emergency Response:

Emergency procedures shall be documented in the Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

5.5 Required Personnel:

The Contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site and report to the contractor's upper management. The CP is required to have related construction and/or service experience.

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, at least two (2) employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

5.6 Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the TPOC. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

The Contractor shall compile employee work hours (including subcontractors) and forward the total hours to the TPOC no later than close of business on the 10th calendar day of the following month. The method of transmission by the prime contractor to the TPOC shall be electronically.

6. Pre-Construction Conference:

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Pre-Construction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. 8. Environmental Protection:

The contractor shall prevent pollution or damage to the environment resulting from construction during this contract. The contractor will receive no additional payment for environmental protection work. Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor. Water, air and land resources shall not be adversely impacted during the course of the work. Storage, fueling and lubrication of equipment and motor vehicles shall be conducted in a manner that affords the maximum protection against spills and evaporation. Storage and usage of lubricants and daily fueling of machinery and equipment shall occur at least 50 feet from any drainage inlets, water bodies (rivers, streams, and lakes), environmentally sensitive areas (wetlands, vernal pools). Note: The state of Vermont requires that water samples be submitted after work is completed under the Vermont Well Source Permit. There is then a 30-day public comment period prior to issuance of the Well Construction Permit which allows further modification to the water system and its components.

11. Omissions:

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable and functional product.

12. Quality Assurance:

The Contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

13. Other Contracts:

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and Government employees. The Contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor or by Government employees.

14. Security:

The government reserves the right to request a modified per-service price for specified project areas in lieu of the price listed in the bidding schedule. The per-service price shall be negotiated between the Contractor and the Contracting Officer. After the flood conditions have ceased, the Contractor shall resume normal contract requirements.

16. Contractor Conduct:

The Contractor and Employees shall not use or be under the influence of drugs or alcohol at any time while performing the obligations under this contract or giving the public the appearance of same. The contractor shall furnish and install a deepened public potable water well, as approved by the Technical Point of Contact to meet the following requirements:

- 1. Contractor shall deepen the existing well until it yields a flow rate of 15 Gallons per Minute OR reaches a maximum total depth of 450 feet.
 - a. If a depth of 450 feet is reached and the flow rate is less than 15 gallons per minute, the Government has the ability to exercise the optional task of drilling to a depth of 600 feet.
- 2. Well yield will be determined via a 2 hour blow test.
- 3. A silt containment pit shall be utilized during drilling operations, with silt fencing as needed to contain drilling spoils.
- 4. Contractor shall install a watertight, locking cast iron well cap, and monitor screen air vent, which provides a sanitary seal. Cap shall have a locking removable inspection cover that does not affect sanitary seal.
- 5. Contractor shall install a 3 horsepower variable frequency drive, constant pressure, submersible pump capable of 15 gallons per minute minimum flow with the appropriate sized wire for electrical draw.
- 6. Contractor shall install two torque arrestors and cable guard set every 20 feet, in addition to a nylon support cable.
- 7. Contractor shall use 1.25in inner diameter HDPE piping rated to 250lbs working pressure for water lines.
- 8. Replace the existing pressure tank located in the restroom facility utility room with a 5 gallon minimum displacement flow-through pressure tank. Contractor shall remove the old pressure tank and properly dispose of off-site.
- 9. Contractor shall connect electrical and water supply lines from well into existing electrical and water supply system in the restroom facility utility room.
- 10. All plumbing shall be done in a manner in which it can be easily drained by gravity at the end of each recreation season to prevent freezing.
- 11. All construction material shall be new, un-used and be first quality material or products. In addition, construction material shall be produced domestically or manufactured domestically in accordance with the Buy American Act.
- 12. Contractor shall provide up to three (3) water quality reports showing the well meets Vermont drinking water standards. The first test will be submitted to the State of Vermont in accordance with the Vermont Well Source Permit, Second will be provided after installation, and third prior to final payment. Lead, radon, water

hardness, and bacteria tests shall be included.

Demolition

- 1. Contractor shall perform all work necessary to disconnect all electrical and water line connections between the 8,000 gallon water holding tank and associated components and the well, electrical service panel, and utility room water system.
- 2. Contractor shall backfill with clean fill material, approved by the TPOC, grade, seed, and mulch jobsite after completion of work to previous condition or better to the satisfaction of the TPOC.
- 3. The contractor shall remove and legally dispose of the existing material and equipment identified above in accordance with all federal, state and local laws and regulations. Demolition materials shall be reused/recycled if possible.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

- (1) An unmanufactured construction material mined or produced in the United States;
- (2) A construction material manufactured in the United States, if--
- (i) The cost of its components mined, produced, or manufactured in the United States exceeds 50 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic; or
- (ii) The construction material is a COTS item.

Foreign construction material means a construction material other than a domestic construction material.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the component test of the Buy American statute is waived for construction material that is a COTS item. (See FAR 12.505(a)(2)). - (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.
- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).
- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.
