1.0 Introduction and General Scope.

The contractor shall furnish all labor, materials and equipment necessary to perform physical and chemical analysis of 29 sediment samples, one equipment blank sample, and associated quality assurance/ quality control samples as outlined in Table 1 of this document. These samples shall be collected by the New England District (NAE) of the U.S. Army Corps of Engineers (USACE) and provided to the contractor. The results of analysis shall be provided to the NAE in a full laboratory report and in the Electronic Data Deliverable (EDD) format provided on the NAE website: https://www.nae.usace.army.mil/Missions/Disposal-Area-Monitoring-System-DAMOS/Electronic-Data-Deliverables.aspx. All deliverables shall be provided to NAE within 30 days from the date that the samples are received by the contractor's laboratory facility. The Contract Period of Performance will be Thirty (30) days from contract award.

2.0 Requirements

- **2.1 General.** The contractor's quote shall include pricing to complete the physical and chemical analysis of sediment samples as specified in Table 1 of this document within a standard 30-day turn-around time. Other requirements specific to laboratory qualifications and capabilities which shall be demonstrated in the quote are as follows:
 - 1. The Laboratory shall be located within the footprint of the New England District states in order to facilitate transport and minimize the risk of exceeding sample holding times.
 - 2.  - 3. The Laboratory must be able to meet the requirements specified in the Regional Implementation Manual for analytical reporting limits, sample handling protocols, quality assurance and quality control measures, and Electronic Data Deliverables (EDDs) (Details at https://www.nae.usace.army.mil/Missions/Regulatory/Dredged-Material-Program/Regional-Implementation-Manual/).
 - 4. - (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.
- "Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.
- "Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

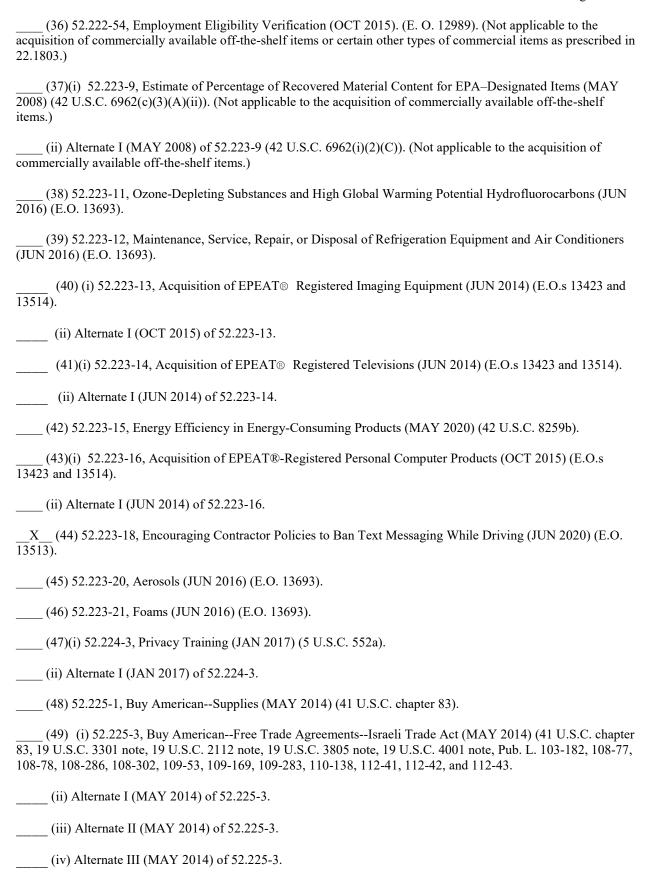

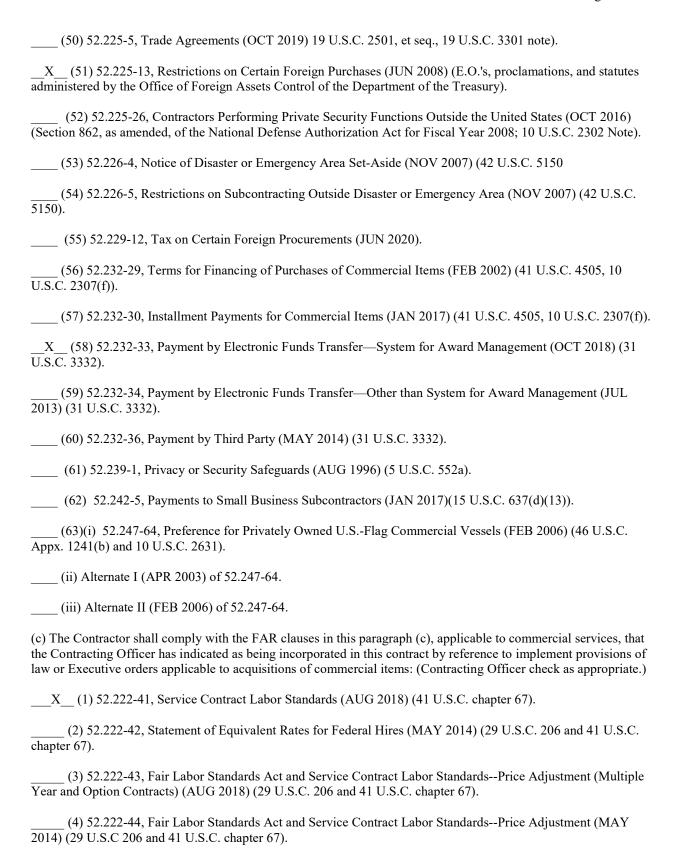

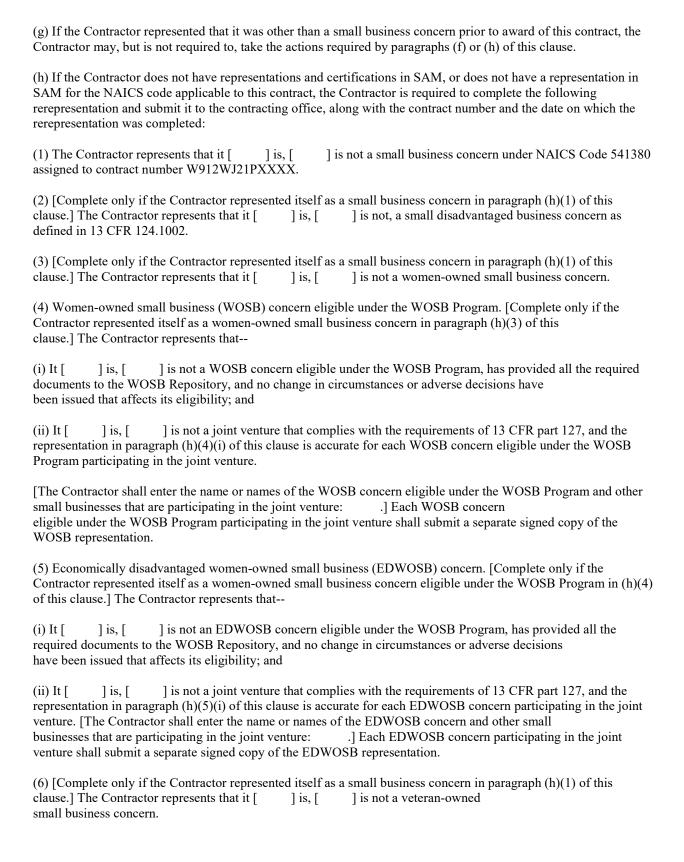
