Question 1: The solicitation document indicates:

NOTE: The US Army Corps of Engineers has two (2) boxes of textured double 4-inch vinyl siding the contractor may use if the contractor can supply additional siding that visually and functionally matches the Government owned siding. Site visits may be coordinated with the TPOC to review materials. Failure to verify this material prior to providing a quote shall not be a basis for modification of the awarded contract if the material is not suitable for use, or if it is later determined that the Contractor failed to provide a product that was both visually and functionally a match to the siding on site.

Can you provide the manufacturer's name and part number, so we can try to "match" the existing siding?

Answer 1: The manufacturer's name and part number will not be provided. Interested vendors are welcome to conduct a site visit and examine the product for information. It is the vendors responsibility to determine if this product meets the specifications as indicated in the Statement of Work for applicability of use of these materials. All products used must meet the requirements of the Statement of Work.
