Question 1: Can you provide which gates will need a flagger or police detail?

Answer 1: A police detail or flagger is only needed on high traffic main roads if the contractor closes part of the gate, impeding the regular flow of traffic. If the gate will remain open for the duration of work, parking a vehicle with flashers on the roadside before the gate with signage will satisfy the traffic safety requirement.
