- **B.** Typical year assessment(s): N/A a Typical Year Assessment was not performed for the site as there was no evidence of any surface water conveyances that could have provided adjacency for Wetlands 2 and 3 via reception of (a)(1) through (a)(3) waters in a Typical Year.
- C. Additional comments to support AJD: This Approved Jurisdictional Determination only addresses Wetlands 2 and 3 on the above referenced site and not any other wetlands and streams on this site. The "Request for AJD" submission included information and maps from USGS, NRCS SSURGO Soils and Soil Survey, FEMA, MADEP, acceptably-completed USACE Wetland Determination Data Forms (NCNE), aerial photographs, and ground photographs, so these resources were examined in completing this determination, but were not highlighted individually above. Wetland 2 and Wetland 3 are isolated wetlands that appear to have formed incidental to construction activities on the site in the 1990s and 2000s. They have no surface water connections to any (a)(1) through (a)(3) waters.
