SECURITY REQUIREMENTS

Performance Work Statement**

I. General:

- 1. Scope** – Furnish all transportation, labor, materials, and equipment necessary to perform offsite repair and routine maintenance on a 2011 Caterpillar D4K Bulldozer. Diagnosis and repair of a fuel leak, as well as an engine repair warning light are required. Glass for the two (2) cab doors and the windshield will also need to be replaced. General service of the machine and repairs are to be completed according to the technical specifications.
- 2. Location** – North Hartland Lake, 112 Clay Hill Rd. North Hartland, VT
- 3. Project Coordination** – Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for the project is Andrew White (978-318-8716) or via email at: Andrew.D.White@usace.army.mil
- 4. Schedule** – The work shall be completed no later than 60 days from the contract award date. Transportation of the machine shall be scheduled beforehand and shall occur Monday

through Friday 7:00 AM to 3:30 PM unless otherwise approved by the Technical Point of Contact. No transportation of the machine shall be done on weekends or Government holidays.

5. Safety Requirements

a. General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety, and health requirements. Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

- 6. Permits** – The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.
- 7. Payment** – After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. The invoice must also include the company letterhead, and this must match the data that is registered in the System for Award Management (SAM) registry. II. Technical Requirements:

Part 1 General:

- 1. Summary** – Furnish all transportation, labor, materials, and equipment necessary to perform offsite repair and routine maintenance on a 2011 Caterpillar D4K Bulldozer.

Diagnosis and repair of a fuel leak, as well as an engine repair warning light are required. Glass for the two cab doors and the windshield will also need to be replaced. A general service of the machine is also required as described in the technical specifications.

2. Warranties - The Contractor shall provide a warranty of repairs and workmanship.

3. Existing Conditions:

a. D4K Bulldozer Information:

- i. 2011 D4K Bulldozer SN# AMMM00602
- ii. Current hours on the machine are 300hrs
- iii. The Bulldozer currently runs and drives for loading & unloading.

b. Site Access and Equipment Location:

- i. The Bulldozer is located at:
North Hartland Lake
112 Clay Hill Rd.
North Hartland, VT 05052
- ii. The area will be open to the contractor M-F 7:00-3:30
- iii. Pickup and drop off are to be scheduled with the technical point of contact beforehand.

4. Environmental Protection – Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis when working onsite. Water, air and land resources shall not be adversely impacted during the course of the work. Storage, fueling and lubrication of equipment and motor vehicles shall be conducted in a manner that affords the maximum protection against spills and evaporation. Storage and usage of lubricants and daily fueling of machinery and equipment shall occur at least 50 feet from any drainage inlets, water bodies (rivers, streams, and lakes), environmentally sensitive areas (wetlands, vernal pools). While applying chemicals, the contractor shall take all precautions necessary for the protection of all persons, property, water courses, and natural resources, and will be held liable for any damages resulting from careless application of chemicals. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met.

5. Damage to Government and Private Property – The contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the contractor's operation. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the contractor's operation. The contractor shall notify the Project Manager immediately of damage to Government and private property and injury to any person resulting from the contractor's operation. Also, the Contractor shall notify the Technical Point of Contact of damage to Government facilities due to vandalism or other causes on the day such damage is first noticed. Trucks and/or trailers will be driven on existing roads only and not across or through park areas to facilities. The Contractor shall also restore landscape features

(shrubs, flowers, grasses, etc.), which are damaged or destroyed by the contractor's operation. Damaged or destroyed grass areas shall be re-planted as directed by the Technical Point of Contact, and shrubs and flowers which are damaged or destroyed shall be replaced from nursery stock of like size and kind.

6. **Omissions** – This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
7. **Quality Assurance** – The contractor is responsible for the quality control of the contract work. The contractor shall establish and maintain a quality control system to assure compliance with the contract requirements. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
8. **Other Contracts** – The Government may undertake or award other contracts for additional work not related to this contract, and the contractor shall fully cooperate with other contractors and Government employees. The contractor shall not commit or permit any act which will interfere with the performance of work by another contractor or by Government employees.

Part 2 Service Products:

1. All repair parts & fluids provided shall be new factory parts that meet or exceed original manufacturer's requirement, and shall be installed according to manufacturer's service, maintenance, and repair standards.

Part 3 Service Requirements:

1. Bulldozer Transportation:

- a. The Contractor shall transport the D4K bulldozer to and from an offsite repair facility using an appropriately sized truck & trailer. Approximate weight of the machine is 20,000 lbs. Length, width, and height of the machine are:
14'x 7'-9"x 9'

2. General Machine Service & Glass Replacement:

- a. Perform a general service and inspection to the machine. Service is to include: engine oil and filter change, hydraulic oil filter(s) change, fuel filter change, ether injection canister change, air filter(s) change, grease machine and track adjustment.
- b. Provide all labor and materials required to replace the window glass on the windshield and two (2) cab doors.

3. Engine Warning light & Fuel Leak Diagnosis:

- a. Engine Diagnosis – The Contractor shall provide labor to perform a diagnosis on the cause of the engine warning light displayed on the instrument panel of the machine..
- b. Fuel Leak Diagnosis – The Contractor shall provide labor to determine the cause of the fuel leak on the machine.
- c. Estimate – The Contractor shall provide to the technical point of contact an itemized list of parts and labor (including hourly rate) required to repair the findings of each of the diagnoses under 3a. & b. above. The technical point of contact must approve any repairs provided on the itemized estimate. No repairs or ordering of parts shall be performed until approval is received.
- d. The Contractor should anticipate that diagnosis of the engine warning light, fuel leak, and estimate preparation will not exceed a total of five (5) hours. If the Contractor has exhausted all means of diagnosis at the end of five (5) hours, the Technical Point of Contact should be contacted. No work outside of five (5) hours will be reimbursed without a negotiated modification signed by the Contracting Officer.

4. Option - Additional Repairs:

- a. Any broken, missing, or damaged parts identified in the estimate from 3c. above shall be repaired according to manufacturer's original equipment specifications. The technical point of contact shall confirm the parts meet manufacturer's specifications, and confirm the pricing is fair and reasonable prior to exercising the optional task. The contractor shall assume that the cost of the replacement parts and labor will not exceed \$5,000 for this contract. No work on tasks identified under the option CLIN shall be performed until the Contractor receives a formal modification to the Purchase Order.

52.204-26 COVERED TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (OCT 2020)

(a) Definitions. As used in this provision, "covered telecommunications equipment or services" and "reasonable inquiry" have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for "covered telecommunications equipment or services".

(c) Representations.

(1) The Offeror represents that it [____] does, [____] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(2) After conducting a reasonable inquiry for purposes of this representation, the offeror represents that it [____] does, [____] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically in the System for Award Management (SAM) accessed through <https://www.sam.gov>. (a) *Definitions.* As used in this provision--

"Covered telecommunications equipment or services" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Economically disadvantaged women-owned small business (EDWOSB) concern" means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

"Highest-level owner" means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

"Immediate owner" means an entity, other than the offeror, that has direct control of the offeror.
