STATEMENT OF WORK

QUECHEE GORGE VISITOR CENTER – INTERIOR PAINTING U.S. ARMY CORPS OF ENGINEERS NORTH HARTLAND LAKE Statement of Work

I. General:

- 1. Scope Provide all materials, labor, and equipment necessary to paint the interior walls, ceilings, floors, wainscoting, stairs/railings, doors, and door frames of the Quechee Gorge Visitor Center in Quechee, VT. There is a total of 10 (ten) door frames, 2 (two) cased openings and 7(seven) man doors to be painted. In total there is approximately 5,600sqft of painted surface.
- **2.** Location The Quechee Gorge Visitor Center is located at 5966 Woodstock Road (Route 4) Quechee, VT 05059
- 3. Site Visit Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for the project is Scott Bockus (802-295-2855) or Scott.S.Bockus@usace.army.mil).
- 4. Schedule Upon award of the Contract the contractor will coordinate with the Technical Point of Contact to schedule the start date of work. Work shall be start within 14 days of the award. The entire work shall be completed no later than 45 days after the Contractor receives the award. The project area will be open to the contractor Monday through Friday 7:00 AM to 3:30 PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.
- 5. Safety Requirements All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable OSHA, federal, state, and local safety, and health requirements. a. Abbreviated Accident Prevention Plan:

The Contractor shall prepare an Abbreviated Accident Prevention Plan (AAPP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable Abbreviated APP template is available upon

request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the Abbreviated APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Note: As part of the APP and AHAs, the contractor shall include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements:

- Procedures for periodic sanitation inspections.
- Procedures for disinfecting project sites in accordance with Center for Disease Control and Prevention (CDC) guidelines.
- Site specific measures to practice social distancing while working on the project.
- Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines.
- A list of Personal Protective Equipment (PPE) to be used in accordance with CDC and state guidelines

b. Activity Hazard Analysis (AHA):

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

c. Emergency Response:

Emergency procedures shall be documented in the Abbreviated Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

d. Required Personnel:

The Contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site and report to the contractor's upper management. The CP is required to have related construction and/or service experience.

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, at least two (2) employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

e. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the TPOC. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

The Contractor shall compile employee work hours (including subcontractors) and forward the total hours to the TPOC no later than close of business on the 10th calendar day of the following month. The method of transmission by the prime contractor to the TPOC shall be electronically.

6. Pre-Construction Conference – Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Pre-Construction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-Construction conference the contractor shall provide the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Pre-Construction Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.
- ii. Contractor's Safety Program (including sub-contractors).
- iii. Abbreviated Accident Prevention Plan and Activity Hazard Analysis (Submitted & accepted prior to start of work on site)
- iv. Safety Meetings (Documented on NED Form 251)
- v. Accident Reporting (ENG Form 3394)
- vi. Safety Data Sheet (SDS) requirements
- vii. Contractor's Equipment
- viii. Correspondence, Communication, Security and Administrative Procedures.
 - ix. Invoice and payment.
 - x. COVID-19 Procedures
- 7. **Permits** The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

8. Security – The contractor will comply with all established security policies at the Quechee Gorge Visitors Center. Due to periods of heightened security that may affect the access to the areas covered under this contract, the Government reserves the right to close any property or portion of property and reschedule and/or cancel any subsequent service. The Contractor shall be given at least 24-hour notice of any such closure.

9. Contractors Personnel-

a. Minimum Personnel Requirements - The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.

Note: At least one of the Contractor employees on site shall be able to communicate effectively and efficiently with project staff.

b. Employee Conduct - The Contractor shall be responsible for seeing that the contractor's employees strictly comply withal Federal, State, and Municipal laws. Any personnel activity, which, in the opinion of the Government, is deemed detrimental to the performance of the contract may result in the removal of Contractor employee/employees.

Part 1. General:

- 1. Summary Provide all materials, labor, and equipment necessary to paint the interior walls, ceilings, floors, wainscoting, stairs/railings, doors, and door frames of the Quechee Gorge Visitor Center in Quechee, VT. There is a total of 10 (ten) door frames, 2 (two) cased openings and 7(seven) man doors to be painted. In total there is approximately 5,600 square feet of painted surface.
- 2. Submittals Although the Government technically reviews submissions required by this Statement of Work, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted to the Technical Point of Contact for review and accepted by the Government prior to the commencement of any field activities.
 - Abbreviated Accident Prevention Plan (AAPP) Prior to the start of field
 - Activity Hazard Analysis (AHA)– Prior to the start of field work
 - CPR and First aid Certification (if more than two people on site)
 - Safety Data Sheets for any products used onsite
 - Paint Samples for color
 - Material Specifications for materials and paints

Note: Paint samples will be approved by the TPOC prior to start of work

3. Existing Conditions:

a. Site Access:

The Quechee Gorge Visitor Center is a two-story structure that was built in 2005. The walls, ceilings, floors, wainscoting, steel stair structure doors and door trim are in generally good condition. In total, they equal approximately 5,600 square feet of painted surface.

Wall surfaces are predominantly gypsum board but also include masonry blocks and 5 (five) wooden slat walls. Floors in the main entry area, lower foyer and stair treads are comprised of concrete.

There is a total of 10 (ten) door frames, 2 (two) cased openings and 7(seven) man doors to be painted.

The downstairs wooden office door, 4(four) sets of green double doors and all windows **shall not** be painted.

NOTE: See attached informational photos and drawings

- 4. Clean Up and Waste Disposal The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any designated storage areas free from accumulation of waste materials. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the Government. Any and all disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the Technical Point of Contact. All waste material will be disposed of offsite in accordance with all Federal, State, and Local regulations.
- 5. Environmental Protection Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis when working onsite. Water, air, and land resources shall not be adversely impacted during the course of the work. - 6. - 2. Bio Preferred Includes air fresheners, cleaners, floor protectors, and more. - 7. **Building Protection** Any involved building or structure, and all of its contents shall be protected from the elements during the duration of this contract. The contractor shall keep on site the means to quickly cover and protect all areas open to the elements during an unforeseen weather related event that could cause damage to the building and or any of its contents during all phases of this contract.
- **8. Personal Protective Equipment** It is the contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.
- 9. Government Resources The government will supply any electricity necessary for the project work from points of existing outlets when available. The contractor shall carefully conserve the use of electricity provided. The contractor shall supply his own means of communication (telephone). There is a restroom available at the contract site, and there is access to potable water at the contract site.
- 10. Damage to Government and Private Property The contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the contractor's operation.  - 2.2.5 Coverage: up to 450sqft per gallon

- 2.2.6 Dry film thickness of 1.5 2mils
- 2.2.7 Dry to touch in 30 minutes
- 2.2.8 Backed by a lifetime limited warranty
- **2.3** Contractor shall use clear semi-gloss oil-based polyurethane for the wainscoting that meets the following requirements:
 - 2.3.1 Interior oil-based polyurethane
 - 2.3.2 High durability
 - 2.3.3 Fast Drying
 - 2.3.4 Coverage: up to 125sqft per quart
 - 2.3.5 Backed by a lifetime limited warranty
- **2.4** Contractor shall use semi-gloss acrylic enamel for the steel stair structure and railings that meets the following requirements:

3.1.1 Move all shelving units, cabinets, pictures and displays and place items back to their original positions after paint has dried.

Note: Sliding display in lower hallway shall not be moved.


3.1.2 All surfaces must be clean, free of dust, grease, wax, polish, mold and mildew stains, loose and peeling paint, and all other foreign substances.

- 3.1.3 Any existing imperfections such as cracks or holes in the walls and ceilings shall be repaired prior to painting.
- 3.1.4 Wainscoting shall be sanded to obtain a smooth uniform surface prior to poly-urethane application.
- 3.2 <u>Installation:</u> Contractor shall provide all labor, tools, hardware, and materials to install products to manufacturer's recommendations in conformance with state and local building codes and the following requirements:
 - 3.2.1. Color of the new paints will be selected by the Technical Point of Contact from samples provided by the Contractor.
 - 3.2.2. Apply two coats of interior satin acrylic latex on approximately 2,750sqft (two thousand seven hundred fifty square feet) of wall surface in the entry way, welcome area, men's and women's bathrooms, brochure room, lower foyer, and lower hallway.
 - 3.2.3. Apply two coats of interior satin acrylic latex on approximately 1,000sqft (one thousand square feet) of vaulted ceiling in the welcome area.
 - 3.2.4. Apply two coats of semi-gloss acrylic styrene on approximately 300sqft (three hundred square feet) of doors, door frames and casings.
 *There are 10 (ten) door frames, 2 (two) cased openings and 7(seven) man doors to be painted
 - 3.2.5. Apply two coats of semi-gloss acrylic water-based paint on approximately 900sqft (nine hundred square feet) of concrete floor surfaces and stair treads.
 - 3.2.6. Apply two coats of clear semi-gloss polyurethane on 350sqft (three hundred square feet) of wooden wainscoting.
 - * Wooden display case along stairs, display shelves in main entry and the sliding display in the lower hallway shall not be treated.
 - * Only lower two boards of the circulation desk in the main entry way shall be treated.
 - 3.2.7. Apply two coats of acrylic semi-gloss enamel on approximately 300sqft (three hundred square feet) of steel stair structure.
 - 3.2.8. All piping along the ceiling in the welcome area shall be painted the same color as walls and ceiling.
 - * Emergency sprinkler heads are not to be painted.

3.2.9. All product applications and drying time between coats shall follow manufacturer's recommendations.













Small business concern--

- (1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR part 121 and the size standard in paragraph (d) of this clause. Such a concern is "not dominant in its field of operation" when it does not exercise a controlling or major influence on a national basis in a kind of business activity in which a number of business concerns are primarily engaged. Commercially available off-the-shelf (COTS) item—

- (1) Means any item of supply (including construction material) that is--
- (i) A commercial item (as defined in paragraph (1) of the definition at Federal Acquisition Regulation (FAR) 2.101);
- (ii) Sold in substantial quantities in the commercial marketplace; and
- (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and

(2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-
- (i) An unmanufactured construction material mined or produced in the United States; or
- (ii) A construction material manufactured in the United States, if--
- (A) The cost of its components mined, produced, or manufactured in the United States exceeds 55 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
- (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial

melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.
- (2) This requirement does not apply to information technology that is a commercial item or to the construction materials or components listed by the Government as follows:

- (c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--
- (A) A description of the foreign and domestic construction materials;
- (B) Unit of measure;
- (C) Quantity;
- (D) Price;
- (E) Time of delivery or availability;

- (F) Location of the construction project;
- (G) Name and address of the proposed supplier; and
- (H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.
- (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.
- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).
- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.
- (3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.
- (d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
