STATEMENT OF WORK

**ASPHALT PAVING
U.S. ARMY CORPS OF ENGINEERS
UNION VILLAGE DAM
EAST THETFORD, VT
Statement of Work**

I. General**1. Scope of work**

Provide all materials, labor, testing, and equipment for performing all operations necessary to complete the following work:

- Provide and install a total of approximately 45 cubic yards of crushed gravel for a 3-inch compacted sub-base on access road 12 feet wide and approximately 85 feet long and parking lot expansion 38 feet wide and 75 feet long for new equipment garage.
- Provide and install approximately 430 square yards of new hot mix bituminous concrete pavement (hereinafter “asphalt pavement”) on compacted gravel sub-base on the access road and parking lot expansion. Finished surface of asphalt pavement shall match existing drainage patterns. Pavement will mate up with concrete aprons, approximately 3 feet, on equipment garage. The garage sits approximately 4” above grade in the front and back of the building allowing for proper pitch of new pavement away from the building.
- Any excess material not used in this project shall be removed and disposed of offsite by the contractor.

2. Location

The Union Village Dam is located at 2 Main Street East Thetford, Vermont. The garage is located behind the park ranger office.

3. Site Visit

4. Schedule

The entire work shall be completed and ready for use no later than 90 days after award. The project area will be open to the Contractor Monday through Friday 7:00 AM to 3:30 PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.

5. Safety Requirements

All work shall be conducted in accordance with the APP, the U.S. Army Corps of Engineers Safety and Health requirements Manual (EM 385-1-1, most recent edition), and all applicable federal, state, and local safety and health requirements. A copy of EM 385-1-1

can be accessed electronically at Headquarters USACE website under publications using the following link:

Project Staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or public become jeopardized.

a. **Accident Prevention Plan:**

The Contractor shall prepare an Accident Prevention Plan (APP) specific to the activities being performed. It shall include an Activity Hazard Analysis (AHA) as described below. A non-mandatory, fillable APP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Note: As part of the APP and AHAs, the contractor shall include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements:

- Procedures for periodic sanitation inspections.
- Procedures for disinfecting project sites in accordance with Center for Disease Control and Prevention (CDC) guidelines.
- Site specific measures to practice social distancing while working on the project.
- Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines.
- A list of Personal Protective Equipment (PPE) to be used in accordance with CDC and state guidelines

b. **AHA:**

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. Work shall not proceed on a phase of work until the AHAs have been accepted by the TPOC. A preparatory meeting shall be conducted by the prime contractor to discuss the AHAs contents with all effected onsite employees. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

c. **Required Personnel:**

The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property. The Contractor shall employ a minimum of one Competent Person (CP) at each project site to function as the Site Safety and Health Officer (SSHO). The SSHO shall be present at the project site and report to the contractor's upper management. The SSHO is required to have related construction experience and have completed a 10 Hour OSHA training (or more).

In addition, when emergency medical services are not accessible within 5 minutes of the work location and there are 2 or more workers onsite, at least 2 employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

Note: Other Competent or Qualified Persons may be required per EM 385-1-1 and other sections of this Scope of Work, based on the characteristics of the project

d. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC within 4 hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the TPOC. ENG Form 3394 shall be completed and submitted to the TPOC within five working days of the incident.

The Contractor shall complete the attached "USACE Contractor Monthly Summary Record of Injuries/Illness and Work Hour Exposure" (for prime and its subcontractors) and forward the completed form to the TPOC no later than close of business on the 5th calendar day of the following month. The method of transmission by the prime contractor to the TPOC shall be electronically.

6. Pre-Construction Conference

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Pre-construction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-construction conference the contractor shall provide the Technical Point of Contact the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Pre-work Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors
- ii. Contractor's Safety Program (including sub-contractors)
- iii. Accident Prevention Plan (Submitted & accepted prior to start of work on site)
- iv. Weekly Safety Meetings (Documented on NED Form 251)
- v. Accident Reporting (ENG Form 3394)
- vi. Safety Data Sheet (SDS) requirements
- vii. Correspondence, Communication and Administrative Procedures
- viii. Invoice and payment
- ix. COVID-19 procedures

7. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

8. Security

The Contractor shall comply with all established security policies at Union Village Dam. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least a 24-hour notice of any such closure.

9. Contractors Personnel

- a. Minimum Personnel Requirements** - The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.

Note: At least one of the Contractor employees on site shall be able to communicate effectively and efficiently with project staff.

- b. Employee Conduct** - The Contractor shall be responsible for seeing that the contractor's employees strictly comply withal Federal, State, and Municipal laws. Any personnel activity, which, in the opinion of the Government, is deemed detrimental to the performance of the contract may result in the removal of Contractor employee/employees.

Examples of unbecoming actions or conduct include but are not limited to the following:

- i. Cursing, harassment, or discrimination of and/or unwarranted physical contact with visitors, USACE personnel, or other contractors
- ii. Recurring written and/or verbal complaints from visitors, USACE personnel, or other contractors.
- iii. Unsafe operation of vehicles while on US Army Corps of Engineers property.

c. **Removal of Contractor's Employees** - The Technical Point of Contact may require the Contractor to immediately remove from the work site any employee of the Contractor or subcontractor, who, in the opinion of the Technical Point of Contact, who endangers persons or property, or whose physical or mental condition is such that it would impair the employee's ability to satisfactorily perform assigned work. Notification to the Contractor shall be promptly made in writing if time and circumstances permit. Otherwise, notification shall be verbal or by telephone, and shall be confirmed in writing as soon as possible. No such removal, however, will reduce the Contractor's obligation to perform all work required under this contract, and immediate replacement will be made as required. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.

10. Payment

Payment will be made on a per job basis. After final inspection and acceptance by the Government, the Contractor shall submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. For jobs greater than 30 days the Contractor may request multiple payments.

II. Technical Requirements:

Part 1 General:

1. **Existing Conditions:**

Refer to the attached Figure 1 (informational plan) and informational photos. The current surface is gravel and grass covered that is fairly level. New garage sits approximately 4" above grade.

2. **Submittals:**

Although the Government technically reviews submissions required by this scope of work, it is emphasized that the Contractor's work must be prosecuted using proper internal controls and review procedures. The documents identified below must be prepared in

accordance with the applicable standards, submitted for review and accepted by the Government prior to the commencement of any field activities.

- 1.2.1. Accident Prevention Plan (APP)
- 1.2.2. Activity Hazard Analysis (AHA)
- 1.2.3. Product Data: Submit product information and job mix formula. Submit for approval 4 copies of the supplier's job mix formula at least 10 working days prior to commencing any paving work.
- 1.2.4. Installer Qualifications
- 1.2.5. Manufacturer Qualifications
- 1.2.6. Material Certification: Certify products are produced at a plant approved by Vermont Agency of Transportation (VT AOT) and that products meet or exceed specified requirements.
- 1.2.7. Waybills and Delivery Tickets: Submit certified waybills and certified delivery tickets for all aggregates and asphalt materials used in the actual work. Final payment will not be made to the Contractor until all waybills and delivery tickets have been received by the Technical Point of Contact.
- 1.2.8. Submit the results of all laboratory and field tests.
- 1.2.9. SDS (Safety Data Sheets) for all chemicals used on the project.
- 1.2.10. CPR & First Aid Certifications

3. **Clean Up:**

The Contractor shall practice good housekeeping to maintain a safe job site. The Contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area, the Contractor shall remove any tools, equipment, and materials that are not the property of the Government. Upon completion of work, the Contractor shall clean up the job site to the satisfaction of the Government.

4. **Government Resources:**

The Contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, water, electricity, telephone services, or other resources.

5. **Environmental Protection:**

The Contractor is responsible for sediment control during any earth-disturbing activities. Select and maintain temporary sediment controls such that water quality standards are not violated as a result of construction activities. Areas of bare soil shall be kept to a minimum during construction operations. Prevent sediment laden runoff from entering waterbodies, drainage inlets, and environmentally sensitive areas. Sediment controls may include, but are not limited to, entrenched staked straw bales, entrenched sediment (silt) fence, compost filter socks, or wattles. Remove all temporary sediment controls during final clean-up and prior to demobilization.

Storage, fueling and lubrication of equipment and motor vehicles shall be conducted in a manner that affords the maximum protection against spills and evaporation. Storage and

usage of lubricants and daily fueling of machinery and equipment shall occur at least 50 feet from any drainage inlets, water bodies (rivers, streams, and lakes), environmentally sensitive areas (wetlands, vernal pools). Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met.

6. **Omissions:**

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable and functional product.

7. **Quality Assurance:**

The Contractor is responsible for the quality control of the contract work. The Government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

8. **Other Contracts:**

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other contractors and Government employees. The Contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by Government employees.

9. **Receiving and Storing Materials:**

The Contractor is responsible for protecting any stored material until it is placed in service. The Contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the Contractor and will not be responsible for damage to Contractor equipment or material.

10. **Traffic Control:**

The contractor is responsible for safely controlling and protecting traffic on affected roads during the construction period to the satisfaction of the Technical Point of Contact.

Part 2 Products:

2.1. **References:**

2.1.1. VT AOT State Standard: The Vermont Agency of Transportation's Standard Specifications for the Construction Book (2018), to include supplemental specifications, and special provisions and attentions.

2.1.2. ASTM and AASHTO references as specified herein.

2.2. **Asphalt Pavement:**

Asphalt pavement materials and mixtures for the binder and wearing (top) courses, and tack coat shall be obtained from a supplier regularly producing bituminous concrete that is in accordance with and meets the requirements of sections 406 and 702 of the VT AOT State Standard. Approval of the asphalt materials and mixtures shall be contingent upon

the conformance of the completed asphalt pavement mix to the specification requirements, including adherence to the supplier's current job mix formulas within specific tolerance limits.

- 2.2.1. Binder Course - The binder course shall be designed in conformance with the design criteria of the VT AOT State Standard, Table 406.03A, Type II, and Table 406.03B for Bituminous Concrete Pavement.
- 2.2.2. Wearing Course - The wearing (top) course shall be designed in conformance with the design criteria of the VT AOT State Standard, Table 406.03A, Types III, and Table 406.03B for Bituminous Concrete Pavement.
- 2.2.3. Asphalt Binder - The asphalt binder shall be Performance-Graded (PG) PG 58-28 and conform to the applicable requirements of section 702.02 of the VT AOT State Standard.
- 2.2.4. Tack Coat - The tack coat shall be emulsified asphalt conforming to ASTM D 977 grade RS-1.
- 2.2.5. Mix Design: The Marshall Method of Mix Design shall be used to develop a mix to meet the specified design criteria. A copy of all test data, including graphs, used in developing the mix may be required with the submittal of the mix design.
- 2.2.6. The job-mix formula for each mixture shall establish a single percentage of aggregate passing each sieve and a single percentage of bituminous material shall be added to the aggregate. No change in the job-mix formula may be made without written approval of the Contracting Officer. The job-mix formula shall fall within the master range specified in Table 406.03A of the VT AOT State Standard. Prior to the start of construction, the Contractor shall submit to the Contracting Officer for approval a mix design to include the following : cold feed and hot bin grading; mixing times; the percentage of each ingredient including bitumen; the job-mix formula from such a combination; and the optimum mixing and compaction temperatures as required in the Marshall Method of Mix Design.

Part 3 Execution:

3.1. Quality Assurance:

- 3.1.1. Manufacturer and Installer Qualifications
 - 3.1.1.1. Manufacturer Qualifications: Engage a firm experienced in manufacturing asphalt pavement like that indicated for this Project and with a record of successful in-service performance.
 - 3.1.1.2. Installer Qualifications: Engage an experienced installer who has completed hot-mix asphalt paving similar in material, design, and extent to that indicated for this Project and with a record of successful in-service performance.

3.2. **Crushed Gravel Subbase:**

3.2.1. Subbase

The existing crushed gravel subbase shall be shaped and compacted to maintain specified lines and grades and to provide a subbase that is in a smooth condition free of holes and ruts. A 3" compacted base of crushed gravel or approximately 45 cubic yards shall be added to ensure proper grading and drainage. If the hauling equipment causes ruts in the subbase the equipment shall be operated only on the course being placed behind the spreading equipment.

3.2.2. Placement

3.2.2.1. Prior to placement, the Contractor shall walk with the Technical Point of Contact and mark the limits of work.

3.2.2.2. Place, spread, and compact crushed gravel subbase material in conformance with the requirements of section 301 of the VT AOT State Standard. New crushed gravel shall be placed on a surface that is unfrozen, free from snow and ice. In no case shall the relative density be less than 95% when tested in accordance with the requirements of section 301.

3.2.2.3. After the installation and compaction of the subbase material, there shall be no hauling over the subbase other than the delivery of material for the asphalt binder course.

3.3. **Bituminous Concrete Pavement:**

3.3.1. General

3.3.1.1. Do not apply asphalt materials if compacted subbase material is wet or excessively damp.

3.3.1.2. The asphalt paving equipment, weather limitations, job mix formula, mixing, construction methods, compaction, finishing, tolerance, and protection shall conform to the requirements of the appropriate sections of the VT AOT State Standard for the type of material specified.

3.3.1.3. Temperature of the asphalt material leaving the plant and at the time of placing shall be within the temperature ranges as specified in section 406 of the VT AOT State Standard.

3.3.2. Placing Asphalt Pavement

3.3.2.1. Verify the following: Subbase is prepared and compacted to the density specified herein and is dry and ready to support paving; and that the gradients and elevations of the subbase are correct.

3.3.2.2. Unless otherwise directed, asphalt pavement shall not be placed when the temperature of the subbase material or when the ambient air temperature is

below 40 degrees F.

- 3.3.2.3. Install asphalt pavement in accordance with sections 406 of the VT AOT State Standard.
- 3.3.2.4. Place the binder course in one 2-inch compacted thick layer and wearing (top) course in one 1-inch compacted thick layer. The thicknesses shall not be less than indicated after compaction.
- 3.3.2.5. Prior to placing the wearing (top) course, verify that the binder course is compacted to the specified thickness and density.
- 3.3.2.6. Prior to placement of wearing (top) course a tack coat shall be applied to the surface of the new binder course. The tack coat shall be applied at a uniform rate as specified in section 406.12 of the VT AOT State Standard. The binder course shall be cleaned of all foreign matter and loose material and shall be dry prior to placing the tack coat. The temperature of the tack coat shall range between 75 degrees F and 130 degrees F at the time of application. The application shall be made just prior to placement of the wearing (top) course, but not more than 24 hours after placement of binder course and shall progress sufficiently ahead of the paving so that the surface of the binder course remains "tacky." Tack coat shall not be applied when weather conditions would prevent the proper application and curing of the tack coat. The tack coat shall be uniformly applied with an approved applicator.
- 3.3.2.7. Clean surface of binder course and apply tack coat within 2 hours of placing wearing (top) course. Wearing (top) course shall be placed within 24 hours of placing and compacting binder course.
- 3.3.2.8. Where new asphalt pavement meets the existing asphalt pavement, the transition from the existing asphalt pavement to new asphalt pavement shall be smooth and gradual.
- 3.3.2.9. Compact each course by rolling to specified density and thickness in accordance with section 406 of the VT AOT State Standard. Do not displace or extrude pavement from position. Hand compact in areas inaccessible to rolling equipment.
- 3.3.2.10. Perform rolling with consecutive passes to achieve even and smooth finish without roller marks.
- 3.3.2.11. Finish asphalt pavement shall conform to surface tolerances as specified in section 406.16 of the VT AOT State Standard.

3.3.3. Joints

Joints shall conform to section 406.15 of the VT AOT State Standard.

3.3.4. Correcting Deficient Areas

Mixtures that become contaminated or are defective shall be removed to the full thickness of the course. Edges of the area to be removed shall be cut so that sides are perpendicular and parallel to the direction of traffic and so that the edges are vertical. Edges shall be sprayed with tack coat. Fresh paving mixture shall be placed in the excavated areas in sufficient quantity so that the finished surface will conform to the lines and grade, and smoothness requirements. Asphalt paving mixture shall be compacted to the density specified herein. Skin patching of an area that has been rolled is not permitted.

3.4. **Field Sampling and Quality Control Testing:**

3.4.1. General:

3.4.1.1. Field sampling and quality control testing shall be the responsibility of the Contractor and shall be performed at no additional cost to the Government. Sampling and testing shall be performed by an approved commercial testing laboratory, or by the Contractor subject to approval of the Technical Point of Contact.

3.4.1.2. Field sampling and testing shall be repeated as necessary or as directed by the Technical Point of Contact to ensure the required thicknesses and compaction are being achieved and that the materials are in compliance with the specifications. Materials not properly placed or areas not properly compacted, or not meeting grade and smoothness requirements shall be removed and replaced at no additional cost to the Government.

3.4.2. Bituminous Concrete Pavement:

3.4.2.1. Grade and Surface Smoothness Tests: Comply with the requirements of divisions 400 and 700 of the VT AOT State Standards.

3.4.2.2. Laboratory and Field Density Tests: Comply with the requirements of divisions 400 and 700 of the VT AOT State Standards.

3.4.2.3. Reporting Test Results:

Copies of all laboratory and field tests shall be submitted to the Contracting Officer within 24 hours of completion of the test. The recording forms shall include all data collected, calculations, final test results, compaction equipment, number of passes, layer thicknesses, recommendations and changes made in the field based on the test results, the weather conditions, type and number of tests, test instrument calibration data, and any other pertinent data. The Contractor shall maintain current copies of the test reports at the project field office for the duration of the project.

(c) Representations.

(1) The Offeror represents that it [____] does, [____] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(2) After conducting a reasonable inquiry for purposes of this representation, the offeror represents that it [____] does, [____] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

(End of provision)

52.211-10 COMMENCEMENT, PROSECUTION, AND COMPLETION OF WORK (APR 1984)

The Contractor shall be required to (a) commence work under this contract within **14** calendar days after the date the Contractor receives contract award, (b) prosecute the work diligently, and (c) complete the entire work ready for use not later than **90 days after notice of award**. The time stated for completion shall include final cleanup of the premises.

(1) Within 30 days after execution of a novation agreement or within 30 days after modification of the contract to include this clause, if the novation agreement was executed prior to inclusion of this clause in the contract.

(2) Within 30 days after a merger or acquisition that does not require a novation or within 30 days after modification of the contract to include this clause, if the merger or acquisition occurred prior to inclusion of this clause in the contract.

(3) For long-term contracts--

(i) Within 60 to 120 days prior to the end of the fifth year of the contract; and

(ii) Within 60 to 120 days prior to the date specified in the contract for exercising any option thereafter.

(c) If the Contractor represented that it was any of the small business concerns identified in 19.000(a)(3) prior to award of this contract, the Contractor shall rerepresent its size and socioeconomic status according to paragraph (f) of this clause or, if applicable, paragraph (h) of this clause, when the Contracting Officer explicitly requires it for an order issued under a multiple-award contract.

(d) The Contractor shall rerepresent its size status in accordance with the size standard in effect at the time of this rerepresentation that corresponds to the North American Industry Classification System (NAICS) code(s) assigned to this contract. (e) The small business size standard for a Contractor providing a product which it does not manufacture itself, for a contract other than a construction or service contract, is 500 employees.

(f) Except as provided in paragraph (h) of this clause, the Contractor shall make the representation(s) required by paragraph (b) and (c) of this clause by validating or updating all its representations in the Representations and Certifications section of the System for Award Management (SAM) and its other data in SAM, as necessary, to ensure that they reflect the Contractor's current status. Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both--
 - (i) An unmanufactured construction material mined or produced in the United States; or
 - (ii) A construction material manufactured in the United States, if--
 - (A) The cost of its components mined, produced, or manufactured in the United States exceeds 55 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
 - (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material.
