PERFORMANCE WORK STATEMENT**

Subject: Repair of INFICON HAPSITE ER® Portable Gas Chromatograph / Mass Spectrometer HSER-211COAA S/N#: 70044297 (H2059). The HAPSITE ER® is Government property, and currently used by a US Army Corps of Engineers Contractor (Wood PLC) to monitor trichloroethene (TCE) daily from vapor intrusion from the sub-surface and indoor air sources at a site the Cold Regions Research and Engineering Laboratory (CRREL) in Hanover, New Hampshire.

Place of Performance:

HAPSITE ER® H2059 is currently located at INFICON, Two Technology Place East Syracuse, NY 13057, where it was sent for evaluation after ceasing to work properly. The instrument H2059 is used daily by USACE contractor, Wood, to monitor TCE concentrations at a site in New Hampshire.

Failure Description: The following is a summary of the troubleshooting of Hapsite #2059. The contractor reported experiencing a problem with the Mass Spectroscopy (MS) controller five times over a few weeks period. Each time the Hapsite would make an audible chirping noise and then 10-15 seconds later the Contractor would receive a message on both the Hapsite and the laptop which stated, "Lost Communication with MS Controller" and it would then give an option to reboot, restart or turn off the Hapsite. Sometimes the operator was able to reboot or restart the Hapsite and continue sampling. Sometimes the operator was able to restart the Hapsite and

continue sampling, other times the Hapsite would shut off before the operator could make a selection or it would attempt to restart but the start-up process would stop part way through. In those instances, the operator would unplug the Hapsite, remove the battery and let everything discharge and then start H2059 again. The operator would resume sampling after it went through start-up again. This occurred using battery power with new batteries with 93-97% power remaining. In the past, similar problems were attributed to a bad board or a loose connection.

Repair Description: The instrument was sent in to Inficon for evaluation as intermittent failures are difficult to diagnose remotely. HAPSITE ER[®] H2059 (serial number 70044297) will require repair as follows with the compatible parts to those listed and described. Replacement parts must be compatible with the Hapsite ER model number HSER-211COAA and reason for replacement:

1. Current installed part number 934-419-P1 6-port Valve. Replacement part must be compatible with the Hapsite ER model number HSER-211COAA. (Sample flow through this valve is partially blocked by about 1/2 causing diminished peak response).
2. Current installed part number 930-290-G1 DSC Board. Replacement part must be compatible with the Hapsite ER model number HSER-211COAA (The sample pump on this part has a worn diaphragm causing almost no sample pump flow (4 ml/min with normal being around 150 ml/min).
3. Current installed part number 930-703-G1 Ion Pump. Replacement part must be compatible with the Hapsite ER model number HSER-211COAA (This part is beyond its recommended replacement hours 1258 hours and will not start even while pumping on the service module).
4. Current installed part number 930-425-P1 Neg Pump. Replacement part must be compatible with the Hapsite ER model number HSER-211COAA. (This part is beyond its recommended replacement hours 455 hours and activations 3 and will no longer maintain MS pressure).
5. Current installed part number 934-297-G1 Membrane Valve. Replacement part must be compatible with the Hapsite ER model number HSER-211COAA. (The sample coming off the column passing through the membrane is partially restricted causing poor chromatography in the form of broader than normal peaks).

The repair should include parts and labor for replacement. Once repairs are made the instrument needs to be tested adequately to verify the issues described above are resolved. Also perform all mandatory updates as needed to include any updates generated by INFICON since the previous repairs to this instrument on February 5, 2020. Perform a final test to ensure unit passes factory specs.

Assumptions: USACE will pay for the shipping of the Hapsite to the awarded Contractor's location designated for repairs. The awarded Contractor will be responsible for the shipping of the HAPSITE ER[®] H2059 back to CRREL at the address listed below.

CLAUSES INCORPORATED BY FULL TEXT

52.204-26 COVERED TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (OCT 2020)

(a) Definitions. As used in this provision, “covered telecommunications equipment or services” and "reasonable inquiry" have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

(c) Representations.

(1) The Offeror represents that it [___] does, [___] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(2) After conducting a reasonable inquiry for purposes of this representation, the offeror represents that it [___] does, [___] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (FEB 2021)
ALTERNATE I (OCT 2014)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically in the System for Award Management (SAM) accessed through <https://www.sam.gov>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (v) of this provision.

(a) *Definitions.* As used in this provision--

"Covered telecommunications equipment or services" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Economically disadvantaged women-owned small business (EDWOSB) concern" means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

"Highest-level owner" means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

"Immediate owner" means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

"Inverted domestic corporation," means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

"Manufactured end product" means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

"Sensitive technology"—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

"Service-disabled veteran-owned small business concern"—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

"Small business concern"—
