Performance Work Statement**

Part A

1. GENERAL

New England District's Safety and Occupational Health Office (SOHO) oversees the use of Automated External Defibrillators (AED) throughout the District. It is the SOHO's responsibility to develop and implement a formal AED Program. This program requires medical direction and program management be provided by an outside source. The contractor shall furnish all labor and equipment needed to perform the duties detailed below for all AEDs within the New England District:

- Develop site-specific AED protocols
- Register AED with local EMS and 911 call centers
- Provide online maintenance tracking/notifications
- Provide post event procedures

## 2. Locations

The U.S. Army Corps of Engineers, New England District (NAE) currently has 40 AEDs deployed throughout the New England states. The location and number of AED units at each location are detailed in Attachment 1.

## 3. Schedule

The period of performance is one year from 20 September 2021 to 19 September 2022 with two, one-year options.

## 4. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification necessary for the performance of this contract. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

## 5. Payment

The contractor shall furnish the Technical Point of Contact with one invoice per quarter, identifying the contract number, dates of service to which invoice applies, and stating the services completed during the quarter. Payment shall be made quarterly for the actual services performed at the applicable contract unit price.

## Part B

### 1. Technical Items

The vendor will ensure that all AEDs are kept serviceable and in compliance with all governing AED laws, regulations, and best practices. Any deficiencies noted will be reported to the Technical Point of Contact. The contractor must provide the following services:

- a. Medical Direction and Program Management
  - Write prescriptions required for AED purchases, and complete registration/application process, as required by state or local law.
  - Provide medical direction and oversight utilizing a Licensed Physician.

- Provide a program point of contact (POC) to answer questions and address programmatic issues.
- b. Site-Specific AED Protocols
    - Develop, review; and update site-specific AED protocols and procedures.
  - c. Registration with Local EMS and 911 Call Centers
    - Register each unit with local EMS and 911 call centers.
  - d. Online Maintenance Tracking and Notifications
    - Maintain an online system capable of providing the Technical Point of Contact with the state of readiness and compliance for each AED in the program; site-specific AED administrator and AED unit information (make/model/serial number); equipment expiration dates; personnel training records; and electronic notifications/alerts for upcoming actions.
  - e. Post Event Procedures
    - Maintain the ability to collect data from all the AEDs in the program.
    - Offer an on-line event reporting system.
    - Provide loaner equipment if an AED must be sent offsite for data collection after an event.

## 2. Service Locations

The list of AEDs by location is provided in Attachment 1.

## 3. Administrative

- a. Government Resources: The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.
- b. Omissions: This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
- c. Quality Assurance: The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

#### CLAUSES INCORPORATED BY FULL TEXT

52.204-26 COVERED TELECOMMUNICATIONS EQUIPMENT OR SERVICES--REPRESENTATION (OCT 2020)

(a) Definitions. As used in this provision, "covered telecommunications equipment or services" and "reasonable inquiry" have the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.



(b) Procedures. The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services”.

(c) Representations.

(1) The Offeror represents that it [ \_\_\_ ] does, [ \_\_\_ ] does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument.

(2) After conducting a reasonable inquiry for purposes of this representation, the offeror represents that it [ \_\_\_ ] does, [ \_\_\_ ] does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services.

52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (FEB 2021)

(a) *Definitions.* As used in this provision--

"Economically disadvantaged women-owned small business (EDWOSB) concern" means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

"Forced or indentured child labor" means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

"Highest-level owner" means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

"Immediate owner" means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

"Inverted domestic corporation," means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

"Manufactured end product" means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;

(4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;

(5) Consist of providing goods or services that are used only to promote health or education; or

(6) Have been voluntarily suspended.

"Sensitive technology"—
