#### b. Accident Prevention Plan:

The Contractor shall prepare an Accident Prevention Plan (APP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable APP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A.

A preparatory meeting shall be conducted by the prime contractor to discuss the APP contents with all effected onsite employees. The Prime Contractor is responsible for informing the subcontractors of the safety provisions under the terms of the contract, thepenalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

Weekly safety meetings shall be held and documented. Records shall be available to the Technical Point of Contact upon request.

# c. Activity Hazard Analysis:

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

#### d. Emergency Response:

Emergency procedures shall be documented in the Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, andonsite First Aid/CPR responders.

# e. Required Personnel:

The Contractor shall employ a minimum of one Competent Person (CP) at each project site to function as the Site Safety and Health Officer (SSHO). The SSHO shall be presentat the project site and report to the contractor's upper management.

The SSHO is required to have related construction experience and have at a minimum completed a <u>10 Hour OSHA training</u>.

In addition, when emergency medical services are not accessible within 5 minutes of the work location and there are 2 or more workers onsite, <u>at least 2 employees shall have (inperson) training in First Aid and CPR</u>. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

# f. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the Technical Point of Contact within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the Technical Point of Contact. ENG Form 3394 shall be completed and submitted to the Technical Point of Contact within five (5) working days of the incident.

The Contractor shall compile employee work hours (including subcontractors) and forward the total hours to the Technical Point of Contact no later than close of business on the 10<sup>th</sup> calendar day of the following month. Prior to the start of any work, the Technical Point of Contact will schedule and conduct a Pre-work Conference. No work may be performed under this contract prior to this conference. # **II. Technical Requirements**

# Part 1: General

1. Other Contracts: The Government may undertake or award other contracts for

additional work not related to this contract, and the Contractor shall fully cooperate with other Contractors and Government employees. The Contractor shall not commit or permit any act, which will interfere with the performance of work by another Contractor, or by Government employees.

- 2. Preferred Sequence for Work Schedules: The Technical Point of Contact shall provide the Contractor with a preferred sequence, or order, of work. (Note: The Contractor must provide sufficient personnel and equipment to accomplish this contract.) The Contractor will then be required to submit a work schedule and approximate times for beginning and ending. Any proposed change to an approved schedule must be submitted in writing, coordinated, and approved by the Technical Point of Contact in advance of actual schedule changes.
- 3. Damage to Government and Private Property: The Contractor shall be responsible for restoring any Government facilities or structures damaged as a result of the Contractor's actions. # 5. Inspections

- a) Contractor Quality Control The Contractor is responsible for establishing and maintaining an adequate quality control system to satisfactorily inspect and ensure that all work performed by the Contractor's organization in each separate service is in full compliance with this contract and the instructions, provisions, specifications, herein.
- b) General Inspection Upon the completion of work the Contractor will inspect all areas under this contract to ensure compliance with the scope of work. The Contractor or his representative must be able to commit personnel, equipment, and resources to correct deficiencies. A Government representative may accompany the Contractor on an inspection of completed work and will identify any contract deficiencies. Any deficiencies noted will be corrected within original contract time frames or appropriate deductions in payment will be made.
- c) Equipment/Supplies Inspections The Technical Point of Contact may inspect required equipment and, supplies at any time when in use on Government property. Equipment found deficient shall be removed from service immediately until faulty conditions have been corrected and passed by the Technical Point of Contact. # II. SCOPE OF WORK

#### 1. General:

All onsite work shall be coordinated with the Technical Point of Contact prior to start. Work shall be performed in a safe manner that protects both workers and the public from hazards. *NOTE: Existing cement parking blocks will be removed by USACE prior to the start of work and should not be factored into estimates for this contract.* Work shall be performed in a manner that prevents the release of any contaminants to the environment. The area of the area shall be left neat and free of any debris caused by the installation of the guardrails.

# 2. Work Zone Safety & Traffic Control

Contractor shall maintain work zone safety standards in accordance with current OSHA and USACE standards. The maintenance of traffic shall be included in prices quote. Total road closures on local streets will be considered on a case-by-case basis.

#### 3. Installation:

The Contractor shall install the new standard steel beam highway guardrail Type SS (Approximately 170 LF between 3 locations), single faced, galvanized, galvanized steelposts, and associated galvanized hardware. All work shall be square, level, accurate to spacing and free from distortions or defects detrimental to appearance or performance and satisfy the requirements of the CTDOT Standard Specifications and Details referenced.

- a. The Contractor shall install the new guardrail system in approximately the samelocation as the existing cable guardrail system, and in the area without current system.
- b. The Contractor shall coordinate the new guardrail system installation location with the Technical Point of Contact prior to the start of installation.
- c. Install radius panels as required to maintain original configuration/layout.
- d. Install wrap-around terminal ends at the beginning and ends of each of the replacement sect
- Install W-beam guardrail system in accordance with Section 621 titled "Traffic Barriers," Drawing Standard G-1 titled "Steel Beam Guardrail with Steel Posts," Drawing Standard G-1D titled "Steel Beam Guardrail Approach End Terminal, Steel Beam Guardrail Trailing End Terminal, Anchor for Steel Beam Guardrail, Steel Beam Median Barrier, and as specified herein. Height of rail above finished grade and offset from top of slope shall be as shown on Drawing Standard G-1.

  Store all galvanized rail elements, end sections and accessories to prevent galvanic action. Do not store in direct contact with the soil. The material may be stored in the open, provided it is properly separated, stacked, and drained. Protect galvanized surfaces which have been abraded exposing the base metal, threaded portions of all fittings and fasteners and cut ends of bolts from moisture, soil, or other damaging elements. The Contractor is responsible for the condition of the material in storage.

  At each location where an electric transmission, distribution, or secondary line crosses the steel guardrail rail system covered by these specifications, the guardrail shall be

grounded as required by the electric utility company.

# Steel Posts

The steel posts shall be set in accordance with the drawings. Posts may be set in holes, or they may be driven if suitable caps and driving equipment are used to prevent damageto the posts. Distorted posts will not be accepted. The installed posts shall be plumb, accurately aligned and spaced, and to the full depth as shown on Drawing. When holes are used the bottom of the hole shall be thoroughly tamped to grade. The space around the posts shall be backfilled with suitable material in 6-inch layers and tamped thoroughly compacted with air or mechanical tampers.

#### Rail Elements

Rail elements shall be erected in a manner resulting in a smooth, continuous installation. All bolts, except adjustment bolts, shall be drawn tight. Bolts shall be of sufficient lengthto extend beyond the nuts. At each splice the exposed end of each element shall be lapped in the direction away from approaching traffic. All metal work shall be prefabricated in a fabrication shop. Field punching, cutting, or welding shall be prohibited. Holes may be drilled or cutting made for special details onlyand as approved by the Technical Point of Contact. Warped or deformed rail elements will be rejected. Rail elements to be erected on a radius of 150 feet or less shall be shop curved to the approximate curvature of the installation.

Damage galvanized surfaces, threaded portions of all fittings and fasteners, and cut ends of bolts after assembly shall be repaired by thoroughly wire brushing the damaged or cutareas and painting the areas with two coats of zinc-rich primer, 708-NH 1.60.

# • Terminals:

Guardrail terminals shall be constructed and installed as shown on DrawingStandard G-1d.

The guardrail systems shall begin and end with terminals. Terminals consist of posts, rail elements, hardware, and anchorage assembly necessary to construct

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (FEB 2021)
(a) Definitions. As used in this clause
Commercially available off-the-shelf (COTS) item—
(1) Means any item of supply (including construction material) that is-

(i) A commercial item (as defined in paragraph (1) of the definition at Federal Acquisition Regulation (FAR) 2.101);

- (ii) Sold in substantial quantities in the commercial marketplace; and
- (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

#### Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

- (1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-
- (i) An unmanufactured construction material mined or produced in the United States; or
- (ii) A construction material manufactured in the United States, if--
- (A) The cost of its components mined, produced, or manufactured in the United States exceeds 55 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or
- (B) The construction material is a COTS item; or
- (2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

- (b) Domestic preference.
- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.
- (2) This requirement does not apply to information technology that is a commercial item or to the construction materials or components listed by the Government as follows:

- (3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that
- (i) The cost of domestic construction material would be unreasonable. The cost of a particular domestic construction material subject to the requirements of the Buy American Act is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;
- (ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or
- (iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.
- (c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--
- (A) A description of the foreign and domestic construction materials;
- (B) Unit of measure;

(C) Quantity;
(D) Price;
(E) Time of delivery or availability;
(F) Location of the construction project;
(G) Name and address of the proposed supplier; and

- (H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.
- (ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.
- (iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).
- (iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.
- (2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.
- (3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.
- (d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
