The following have been modified:

REQUEST FOR INFORMATION

1. The delivery date is end of May. Are you open to taking the wire rope sooner if I can deliver beforehand?

Answer: The wire rope shall be delivered no later than May 31, 2022. Delivery prior to that date is acceptable. Delivery shall be coordinated with the Technical Point of Contact.

2. Also, the request is for 6X19 construction. Is 6X36 acceptable?

Answer: 6x19 construction wire rope is the only acceptable product.

3. What is the rope used for?

Answer: The rope is used to secure booms across the inlet channel on the dam. Rope supplied shall be in accordance with the specifications listed in the Supply Requirement.

4. Is there a loading dock at the facility?

Answer: No, there is not a loading dock at the facility. Contractor is responsible for providing suitable equipment, i.e. pallet jack or forklift, to unload supplies from the delivery truck and place in the area identified by the Technical Point of Contact.

5. Is there a forklift available?

Answer: The Technical Point of Contact will not provide a means to unload supplies. Contractor is responsible for providing suitable equipment to upload supplies from the delivery vehicle.

6. Does the wire rope have to be manufactured domestically?

Answer: The Buy American Act applies to this solicitation. All supplies must be in accordance with the specifications, see II. Supply Requirements. Vendors offering materials not in compliance with the Buy American Act will be considered non-responsive.
