Performance Work Statement**

**A. GENERAL**

**1. Scope of Work**

Furnish all labor, materials, equipment, and transportation necessary for the removal of approximately 200 square feet asbestos-containing linoleum & mastic kitchen flooring located at the operator's quarters of Mansfield Hollow Dam. The contractor shall dispose of all asbestos containing material (ACM) in accordance with all applicable federal, state, and local laws and regulations.

Project consists of the following:

- Acquire all necessary asbestos permits and paperwork notifications
- Remove and containerize the approximately 200 square feet of asbestos-containing flooring
- All work will be performed by Connecticut asbestos-certified handlers
- All work will be completed in accordance with proper federal, state, and local regulations
- A post abatement inspection performed by an independent licensed industrial hygienist as per regulatory requirements

Specific work practices include:

- All necessary precautions to optimize air quality levels within and around the work area (i.e., thoroughly applying amended liquids, timely containing waste, and

- proper worker hygiene/changing practices)
- Disposal at an EPA certified disposal waste site
- Provide a copy of the Hazardous Waste Manifest to the Project Office

## 2. Location

Mansfield Hollow Dam, 141 Mansfield Hollow Road, Mansfield, CT 06250. The ACM flooring is located inside the operator's quarters building on site.

## 3. Site Visit

## 4. Schedule

The work will be completed 90 days from contract award. The project area will be open to the contractor Monday through Friday 7:30 AM to 3:00 PM and all work must be done during those hours unless additional hours are approved by the Technical Point of Contact. No work shall be done on weekends or Government holidays.

## 5. Safety Requirements

- a. All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable OSHA, federal, state, and local safety, and health requirements. A copy of EM 385-1-1 can be accessed at the project office or electronically at the following link:  
[http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM\\_385-1-1.pdf](http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf) Project staff reserve the right to cease work at any time should the safety of employees, contractors, and/or the public become jeopardized.
- b. Abbreviated Accident Prevention Plan -The contractor shall prepare an Abbreviated Accident Prevention Plan (APP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described in paragraph below. A non-mandatory, fillable Abbreviated APP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the Abbreviated APP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

- c. Activity Hazard Analysis (AHA) - An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all

activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

- d. Emergency Response - Emergency procedures shall be documented in the Abbreviated Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.
- e. Required Personnel - The contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site and report to the contractor's upper management. The CP is required to have related construction and/or service experience.

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, at least two (2) employees shall be trained in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

- f. Accident Reporting - All accidents and near misses shall be investigated by the contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the TPOC. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

The contractor shall compile employee work hours (including subcontractors) and forward the total hours to the TPOC within 10 days of the completion of the contract. The method of transmission by the prime contractor to the TPOC shall be electronically.

## **6. Specific Safety Section – Asbestos Abatement**

- a. General: The requirements of this section are applicable to contracts involving activities that disturb Asbestos-Containing Materials (ACM). All ACM activities, training, and submittals shall comply with OSHA Class II work practices, the EM 385-1-1, Section 06.C; 29 CFR 1910.1001; 29 CFR 1926.1101; CFR 61, Subpart A and M; as well as State, and local requirements.
- b. Submittals: A site-specific **Asbestos Abatement Plan** is required to be submitted and accepted by the Technical Point of Contact (TPOC) prior to initiating asbestos abatement tasks. This plan shall be developed as an appendix to the APP and describe procedures to be followed to protect employees and the environment from asbestos hazards while performing

work that will disturb ACM. Specifically, the Asbestos Abatement Plan shall address the following:

- i. A description of each activity where asbestos will be disturbed, including OSHA class of work, equipment required, controls to be used, crew size, job responsibilities, maintenance practices, and locations keyed to project drawings;
  - ii. The method of notification of other employers at the worksite;
  - iii. A description of regulated areas, types of containment, decontamination unit plan, and engineering controls;
  - iv. Air monitoring plan – Perform air sampling for personal, area and clearance monitoring in accordance with 29 CFR 1910.1101 and EM 385-1-1 Section 06.C. The plan shall include the number of samples to be collected, analytical method to be used, and sample turnaround time. Submit the name, address, and telephone number of the testing laboratory selected for the analysis and reporting of airborne concentrations for asbestos fibers along with documentation of the American Industrial Hygiene Association (AIHA) accredited laboratory. Breathing zone air samples must be taken for at least 25% of the workers in each shift, or a minimum of two, whichever is greater. Air sampling must be representative of the 8-hour time weighted average (TWA) and 30-minute short term exposure of each employee. Employees must be notified of the sample results no later than 5 working days after the beginning of abatement activities. The testing laboratory must be independent of the asbestos contractor and must have no employee or employer relationship which could constitute a conflict of interest.
  - v. PPE, including respirators and clothing;
  - vi. Housekeeping procedures to prevent the spread of contamination and dust, both in and beyond the regulated area;
  - vii. Hygiene facilities and practices;
  - viii. Competent Persons and employee training required;
  - ix. Medical surveillance, as required, to assess exposure and to monitor employee fitness to perform work tasks while wearing PPE (to include respiratory protection devices);
  - x. Waste generation, containerization, transportation, and disposal (including recordkeeping); and
  - xi. Security, fire, and medical emergency response procedures.
- c. Required Certifications and Licenses:
- i. The contractor must hold a current asbestos abatement license, for the applicable state where the work will be completed.
  - ii. At least one onsite employee will be designated as the Asbestos Competent Person and hold a current Asbestos Abatement Supervisor Certification, for the applicable state where the work will be completed.
  - iii. At a minimum, site workers must hold a current Asbestos Abatement Worker Certificates, for the applicable state where the work will be completed.
  - iv. Copies of certificates and licenses shall be kept on site and available for review if requested by the technical point of contact.

## **7. Specific Safety Section – COVID-19**

**General:** As part of the APP and AHAs include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements:

- Procedures for periodic sanitation inspections.
- Procedures for disinfecting project sites in accordance with Centers for Disease Control and Prevention (CDC) guidelines.
- Site specific measures to practice social distancing while working on the project.
- Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines.
- A list of Personal Protective Equipment (PPE) to be used in accordance with CDC and state guidelines.

## **8. Pre-Work Conference**

Prior to the start of any work, the Technical POC will schedule and conduct a 'Pre-work Conference'. The contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the TPOC to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the contractor. This conference will allow the contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-work conference the contractor shall provide to the name of the project superintendent with a telephone number for project coordination. The following is a general list of items for discussion during this Pre-work Conference:

- a. Authority of the TPOC and Quality Assurance Inspectors
- b. Contractor's Safety Program
- c. Abbreviated Accident Prevention Plan
- d. Activity Hazard Analysis
- e. COVID-19
- f. Accident Reporting (ENG Form 3394)
- g. Contractor's Quality Control Plan
- h. Contractor's Equipment (including a current written safety inspection)
- i. Correspondence Procedure
- j. Communications
- k. Administrative Procedures
- l. Invoice and payment

## **9. Submittals**

Although the Government technically reviews submissions required by this Statement of Work, it is emphasized that the contractor's work must be completed using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted to the Technical Point of Contact for review and accepted by the Government prior to the commencement of any field activities.



- Abbreviated Accident Prevention Plan (AAPP)
- Activity Hazard Analysis
- Asbestos Abatement Plan EM 385-1-1, Sections 06.C and 06.L
- License and Certifications for Asbestos Abatement
- State of Connecticut Asbestos Waste Shipment Record (Completed in full to include signatures from Disposal Site and submitted when complete)

#### **10. Permits**

The contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The contractor shall comply with any applicable federal, state, county, and municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

#### **11. Security**

The contractor will comply with all established security policies at Mansfield Hollow Dam. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The contractor shall be given at least 24 hour notice of any such closure.

#### **12. Contractor Conduct**

Contractor and employees must comply with CFR Title 36 Rules and Regulations.

#### **13. Damage to Government Property**

The contractor shall be responsible for restoring any Government facilities or structures damaged as a result of the contractor's actions. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the firm's operations. The contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person resulting from the contractors' operation. Also, the contractor shall notify the Technical Point of Contact of damage to Government facilities due to vandalism or other causes on the day such damage is first noticed. Trucks and/or trailers will be driven on existing roads and trails only and not across or through park areas to facilities.

#### **14. Payment**

Payment shall be made on a per job basis. After final inspection and acceptance by the Government, the contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item.

## **B. TECHNICAL**

### **1. Existing Conditions**

#### **a. Site Access:**

- i. The approximately 200 square feet of ACM flooring is located in the kitchen of the Mansfield Hollow operators' quarters. The TPOC will be on site to grant the contractor access to the site.

#### **b. Sampling and Asbestos Inspection:**

- i. An asbestos survey was conducted on 04 November 2021 by Mystic Air Quality Consultants, Inc to confirm the presence of asbestos. A number of samples were tested throughout the building, and it was confirmed that the flooring has 20% asbestos present.

### **2. Execution**

- Acquire all necessary asbestos permits and paperwork notifications.
- Remove and containerize the approximately 200 square feet of ACM flooring.
- Visually sweep the surrounding area to collect any fragments from the surface of the floor and counters.
- Transport ACM flooring and fragments to an EPA certified disposal site.
- Responsible for a post abatement inspection performed by an independent licensed industrial hygienist as per regulatory requirements.
- Provide the Project Office with a copy of the Hazardous Waste Manifest showing proper disposal at an EPA certified disposal waste site.

### **3. Asbestos Disposal:**

- a. All waste materials will be disposed of offsite in accordance with all federal, state, and local regulations, all hazardous wastes properly labeled, and proof of proper disposal provided to the Technical Point of Contact.
- b. Asbestos waste disposal and transportation requirements;
  - i. Package and label Asbestos waste as specified in 40 CFR 61.150(a)(1)(iii)-(v), as applicable.
  - ii. Remove all Asbestos containing packages on the same day as completion of the remediation work.
  - iii. Transport and dispose of Asbestos waste as specified in 40 CFR 61.150, specifically including 40 CFR 61.150(d), as incorporated by reference with amendments in Env-A 1808.01 and Env-Sw 901.04.
  - iv. All disposal shipments shall include a State of Connecticut Asbestos Waste Shipment Record.

### **4. References – All work shall be in conformance with:**

- a. Occupational Safety and Health Administration (OSHA)
  - i. 29 CFR 1910.1001 – General Standard (Asbestos)

- ii. 29 CFR 1926.1101 – Standard for Construction (Asbestos)
- b. Department of Transportation (DOT)
  - i. 49 CFR Parts 171, 172 & 173 – Transportation of Hazardous Materials and Wastes
- c. National Emissions Standards for Hazardous Air Pollutants (NESHAP)
  - i. 40 CFR Parts 61, subpart M – Standards for Demolition, Renovation and Disposal
- d. State of Connecticut
  - i. CT Standards for Asbestos Abatement (19a-332a)
- e. Other appropriate federal, state, and local laws, regulations, and codes for such abatement

## **5. Clean up**

The contractor shall practice good housekeeping to maintain a safe job site. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the government. Upon completion of work, the contractor shall clean up the job site to the satisfaction of the Government. The contractor is responsible for providing all equipment and tools to complete the project.

## **6. Environmental Protection**

Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/cleaned daily. No burning is permissible. Water, air, and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met.

## **7. Omissions**

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

## **8. Other Contracts**

The Government may undertake or award other contracts for additional work not related to this contract, and the contractor shall fully cooperate with other contractors and Government employees. The contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor or by Government employees.

## **9. Quality Assurance**

The contractor is responsible for the quality control of the contract work. The Government has the right to inspect all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

## 52.219-28 POST-AWARD SMALL BUSINESS PROGRAM REREPRESENTATION (SEP 2021)

- (a) Definitions. As used in this clause--

Long-term contract means a contract of more than five years in duration, including options. However, the term does not include contracts that exceed five years in duration because the period of performance has been extended for a cumulative period not to exceed six months under the clause at 52.217-8, Option to Extend Services, or other appropriate authority.

Small business concern--

(1) Means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR part 121 and the size standard in paragraph (d) of this clause. Such a concern is "not dominant in its field of operation" when it does not exercise a controlling or major influence on a national basis in a kind of business activity in which a number of business concerns are primarily engaged. In determining whether dominance exists, consideration shall be given to all appropriate factors, including volume of business, number of employees, financial resources, competitive status or position, ownership or control of materials, processes, patents, license agreements, facilities, sales territory, and nature of business activity.

(2) Affiliates, as used in this definition, means business concerns, one of whom directly or indirectly controls or has the power to control the others, or a third party or parties control or have the power to control the others. In determining whether affiliation exists, consideration is given to all appropriate factors including common ownership, common management, and contractual relationships. SBA determines affiliation based on the factors set forth at 13 CFR 121.103.

(b) If the Contractor represented that it was any of the small business concerns identified in 19.000(a)(3) prior to award of this contract, the Contractor shall rerepresent its size and socioeconomic status according to paragraph (f) of this clause or, if applicable, paragraph (h) of this clause, upon occurrence of any of the following:

(1) Within 30 days after execution of a novation agreement or within 30 days after modification of the contract to include this clause, if the novation agreement was executed prior to inclusion of this clause in the contract.

(2) Within 30 days after a merger or acquisition that does not require a novation or within 30 days after modification of the contract to include this clause, if the merger or acquisition occurred prior to inclusion of this clause in the contract.

(3) For long-term contracts--

(i) Within 60 to 120 days prior to the end of the fifth year of the contract; and

(ii) Within 60 to 120 days prior to the date specified in the contract for exercising any option thereafter.

(c) If the Contractor represented that it was any of the small business concerns identified in 19.000(a)(3) prior to award of this contract, the Contractor shall rerepresent its size and socioeconomic status according to paragraph (f) of this clause or, if applicable, paragraph (h) of this clause, when the Contracting Officer explicitly requires it for an order issued under a multiple-award contract.

(d) The Contractor shall rerepresent its size status in accordance with the size standard in effect at the time of this rerepresentation that corresponds to the North American Industry Classification System (NAICS) code(s) assigned to this contract. The small business size standard corresponding to this NAICS code(s) can be found at <https://www.sba.gov/document/support--table-size-standards>.

(e) The small business size standard for a Contractor providing an end item that it does not manufacture, process, or produce itself, for a contract other than a construction or service contract, is 500 employees if the acquisition--

(1) Was set aside for small business and has a value above the simplified acquisition threshold;

(2) Used the HUBZone price evaluation preference regardless of dollar value, unless the Contractor waived the price evaluation preference; or

(3) Was an 8(a), HUBZone, service-disabled veteran-owned, economically disadvantaged women-owned, or women-owned small business set-aside or sole-source award regardless of dollar value.

HEALTH & WELFARE: \$4.60 per hour up to 40 hours per week or \$184.00 per week or \$797.33 per month

HEALTH & WELFARE EO 13706: \$4.23 per hour up to 40 hours per week or \$169.20 per week or \$733.20 per month\*

\*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706 Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor; 3 weeks after 5 years 4 weeks after 15 years and 5 weeks after 25 years.

Length of service includes the whole span of continuous service with the present contractor or successor wherever employed and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of twelve paid holidays per year: New Year's Day Martin Luther King Jr's Birthday Washington's Birthday Good Friday Memorial Day Juneteenth National Independence Day Independence Day Labor Day Columbus Day Veterans' Day Thanksgiving Day and Christmas Day. A contractor may substitute

for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: Under the SCA at section 8(b) this wage determination does not apply to any employee who individually qualifies as a bona fide executive administrative or professional employee as defined in 29 C.F.R. Part 541. Because most Computer System Analysts and Computer Programmers who are compensated at a rate not less than \$27.63 (or on a salary or fee basis at a rate not less than \$455 per week) an hour would likely qualify as exempt computer professionals (29 C.F.R. 541.400) wage rates may not be listed on this wage determination for all occupations within those job families. In addition because this wage determination may not list a wage rate for some or all occupations within those job families if the survey data indicates that the prevailing wage rate for the occupation equals or exceeds \$27.63 per hour conformances may be necessary for certain nonexempt employees. For example if an individual employee is nonexempt but nevertheless performs duties within the scope of one of the Computer Systems Analyst or Computer Programmer occupations for which this wage determination does not specify an SCA wage rate then the wage rate for that employee must be conformed in accordance with the conformance procedures described in the conformance note included on this wage determination.

Additionally because job titles vary widely and change quickly in the computer industry job titles are not determinative of the application of the computer professional exemption. Therefore the exemption applies only to computer employees who satisfy the compensation requirements and whose primary duty consists of:

- (1) The application of systems analysis techniques and procedures including consulting with users to determine hardware software or system functional specifications;
- (2) The design development documentation analysis creation testing or modification of computer systems or programs including prototypes based on and related to user or system design specifications;
- (3) The design documentation testing creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties the performance of which requires the same level of skills. (29 C.F.R. 541.400).

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you work at night as part of a regular tour of duty you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am.

If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

### **\*\* HAZARDOUS PAY DIFFERENTIAL \*\***

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance explosives and incendiary materials. This includes work such as screening blending dying mixing and pressing of sensitive ordnance explosives and pyrotechnic compositions such as lead azide black powder and photoflash powder.

All dry-house activities involving propellants or explosives. Demilitarization modification renovation demolition and maintenance operations on sensitive ordnance explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with or in close proximity to ordnance (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands face or arms of the employee engaged in the operation irritation of the skin minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving unloading storage and hauling of ordnance explosive and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance explosives and incendiary material differential pay.

### **\*\* UNIFORM ALLOWANCE \*\***

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract by the employer by the state or local law etc.) the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition where uniform cleaning and maintenance is made the responsibility of the employee all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount or the furnishing of contrary affirmative proof as to the actual cost) reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However in those instances where the uniforms furnished are made of ""wash and wear"" materials may be routinely washed and dried with other personal garments and do not require any special treatment such as dry cleaning daily washing or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract by the contractor by law or by the nature of the work there is no requirement that employees be reimbursed for uniform maintenance costs.

**\*\* REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE Standard Form 1444 (SF-1444) \*\***

**Conformance Process:**

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e. the work to be performed is not performed by any classification listed in the wage determination) be classified by the contractor so as to provide a reasonable relationship (i.e. appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification wage rate and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award the contractor prepares a written report listing in order the proposed classification title(s) a Federal grade equivalency (FGE) for each proposed classification(s) job description(s) and rationale for proposed wage rate(s) including information regarding the agreement or disagreement of the authorized representative of the employees involved or where there is no authorized representative the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action together with the agency's recommendations and pertinent information including the position of the contractor and the employees to the U.S. Department of Labor Wage and Hour Division for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt the Wage and Hour Division approves modifies or disapproves the action via transmittal to the agency contracting officer or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request the ""Service Contract Act Directory of Occupations"" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage

determination. Remember it is not the job title but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split combine or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1))."
