PERFORMANCE WORK STATEMENT

BOUNDARY LINE INSPECTION AND MAINTENANCE U.S. ARMY CORPS OF ENGINEERS FRANKLIN FALLS DAM AND BLACKWATER DAM Performance Work Statement

I. General:

- Scope Furnish all materials, equipment, and labor to perform boundary line inspection, boundary line clearing, boundary line paint marking, as well as documentation and reporting of conditions for sections of the administrative boundary lines at the Blackwater Dam. The portion of boundary line requiring service at the Blackwater Dam project is approximately 1.3 miles in length. In addition, the Government may exercise an optional task for Franklin Falls Dam boundary line inspection and maintenance. The portion of boundary line requiring service at the Franklin Falls Dam project is approximately 4.6 miles in length.
- Location The Franklin Falls and Blackwater Dams are flood control projects which are both managed out of the Franklin Falls Project Office located in Franklin, New Hampshire: Franklin Falls Dam 46 Granite Drive Franklin, New Hampshire, 03235

- 4. Schedule The period of performance shall be from Contract Award to December 30, 2022. The Pre-Work Conference shall be completed within 14 days of Contract Award. All submittals to include safety and product submittals shall be submitted, reviewed, and accepted within 30 days of Contract Award. Work shall be performed Monday through Friday 7:00 AM to 4:30 PM unless otherwise approved in advance by the TPOC. No work shall be done on weekends or Government holidays, unless otherwise approved in advance by the TPOC.

NOTE: Blackwater Dam will be awarded as BASE Franklin Falls Dam will only be included if the OPTION is exercised

5. Safety Requirements – All work shall be conducted in accordance with the U.S. Army Corps of Engineers (USACE) Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be

Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

a. Abbreviated Accident Prevention Plan:

The Contractor shall prepare an Abbreviated Accident Prevention Plan (AAPP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable AAPP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the AAPP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

b. Activity Hazard Analysis:

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

<u>COVID-19 NOTE</u>: As part of the AAPP and AHA's, include site specific COVID-19 monitoring procedures which address, at a minimum, the following elements:

- Procedures for periodic sanitation inspections.
- Procedures for disinfecting project sites in accordance with Centers for Disease Control and Prevention (CDC) guidelines.
- Site specific measures to practice social distancing while working on the project.
- Employee training on the signs, symptoms, and protection measures in accordance with CDC guidelines.
- A list of Personal Protective Equipment to be used in accordance with CDC and state guidelines.

c. <u>Emergency Response:</u>

Emergency procedures shall be documented in the AAPP and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

d. <u>Required Personnel:</u>

The Contractor shall designate one employee as the site's Competent Person (CP) who is responsible for ensuring a safe environment for all employees. The CP shall be present at the project site and report to the contractor's upper management. The CP is required to have related construction and/or service experience.

When emergency medical services are not accessible within five (5) minutes of the work location and there are two (2) or more workers onsite, <u>at least two (2) employees shall be</u> <u>trained in First Aid and CPR</u>. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

e. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the TPOC within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the TPOC. ENG Form 3394 shall be completed and submitted to the TPOC within five (5) working days of the incident.

The Contractor shall compile employee work hours (including subcontractors) and forward the total hours to the TPOC no later than close of business on the 10th calendar day of the following month. The method of transmission by the prime contractor to the TPOC shall be electronically.

- 6. Flooding Both Franklin Falls and Blackwater Dams are primarily Flood Risk Management Projects. Occasional retention of floodwaters may inundate portions of the dam property or access roads in the areas covered by this contract. The TPOC will notify the Contractor as areas are closed as a result of floodwaters. When flooding ends and waters recede, the TPOC will notify the Contractor as areas reopen and services may resume.
- 7. Pre-Work Conference Prior to the start of any work, the TPOC will schedule and conduct a "Pre-Work Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the TPOC to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Pre-Work Conference the contractor shall provide the name of the project superintendent with a telephone number for project coordination.

- 8. **Permits** The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The portion of boundary line requiring service at the Blackwater Dam project is approximately 1.3 miles in length. Franklin Falls Dam boundary line inspection and maintenance (OPTION); this portion of boundary line requiring service at the Franklin Falls Dam project is approximately 4.6 miles in length.
- 2. Submittals Although the Government reviews submissions for technical data/information required by this Performance Work Statement, it is emphasized that the Contractor's work must be completed using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted to the TPOC for review and must be accepted by the Government prior to the commencement of any field activities.
 - Abbreviated Accident Prevention Plan Prior to the start of field work; submitted and approved within 2 weeks of contract award
 - Activity Hazard Analysis Prior to the start of field work; submitted and approved within 2 weeks of contract award
 - **Product Data Sheet(s)**: For Blue Marking paint type and color
 - Safety Data Sheets (SDS) For all chemicals and/or products used on-site.
 - **Documentation and Reporting (Photographs and associated field data)** Photographs with details to potential encroachments, monument conditions and field notes.
- 3. References All work shall be in conformance with:
 - **a.** U.S Army Corps of Engineers
 - i. EP 1130-2-540 Environmental Stewardship and Maintenance Guidance and Procedures, Chap 2.
 - ii. EM-385-1-1 Safety and Health Requirements Manual, U.S. Army Engineering Manual.
 - **b.** Code of Federal Regulations
 - i. Title 36 Parks, Forests, and Public Property; Chapter III, Part 327 Corps of Engineers, Department of the Army.
 - c. Other appropriate federal, state, and local codes and regulations.
- 4. Other Contracts The Government may undertake or award other contracts for additional work not related to this contract, and the contractor shall fully cooperate with other contractors and Government employees. The contractor shall not commit or permit any act which will interfere with the performance of work by another contractor or by Government employees.

- 5. Preferred Sequence for Work Schedules The TPOC shall provide the Contractor with a preferred sequence, or order, of work. (Note: The Contractor must provide sufficient personnel and equipment to accomplish services stated in the contract). The Contractor will then be required to submit a work schedule for each service, and approximate times for beginning and ending of each required service listed. Any proposed change to an accepted schedule must be submitted in writing, coordinated, and accepted by the TPOC in advance of actual schedule changes.
- 6. Clean Up and Waste Disposal The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any designated storage areas free from accumulation of waste materials. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the Government. All disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the TPOC. All waste material will be disposed of offsite in accordance with all federal, state, and local regulations.
- 7. Environmental Protection Containers for excess and/ or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis when working onsite. Water, air, and land resources shall not be adversely impacted during the course of the work. The contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met at no additional cost to the Government. Assurance of compliance with this section by subcontractors shall be the responsibility of the contractor.
- 8. Sustainability The United States Department of Agriculture (USDA) designates certain bio-based products for federal procurement and specifies minimum bio-based content levels for those products. - **9. Personal Protective Equipment** It is the contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.
- **10. Government Resources** –The contractor shall supply his own means of communication (telephone). There is not a restroom available at the contract site, and there is no access to potable water at the contract site. The contractor would have to provide these resources or have an acceptable alternative plan for these resources. The Government shall supply the following to the Contractor for use during the performance of this work:
 - **a.** Boundary Surveyed Maps with monument bearings and distances.
 - **b.** Any Key Control to provide vehicle access to service roads and authorized trails if needed to facilitate access for work locations.

NOTE: All Government provided materials, including access controls (keys), any hard copies of maps/data, and any digital data provided on external storage media shall be returned, to the TPOC at the completion of the contract and prior to submitting Final Payment.

11. Damage to Government and Private Property – The contractor shall be responsible for restoring all Government facilities or structures damaged as a result of the contractor's operation. The contractor shall also be responsible for any damage to private property or injury to any person as a result of the contractor's operation. The contractor shall notify the TPOC immediately of damage to Government and private property and injury to any person resulting from the contractor's operation. Also, the Contractor shall notify the TPOC of damage to Government facilities due to vandalism or other causes on the day such damage is first noticed. Trucks and/or trailers will be driven on existing roads only and not across or through park areas to facilities. 12. Contractor's Personnel -

a. Minimum Personnel Requirements - The Contractor shall provide an adequate number of fully qualified personnel to perform the specified service properly and efficiently within the time limits specified. The Contractor shall provide a list of the names and contact phone numbers for all employees prior to them working on Government Property.

b. Employee Conduct - The Contractor shall be responsible for seeing that the contractor's employees strictly comply with Code of Federal Regulations Title 36, Chapter III, Part 327, and all federal, state, and municipal laws. Any personnel activity, which, in the opinion of the Government, is deemed detrimental to the performance of the contract may result in the removal of Contractor employee/employees.

Examples of unbecoming actions or conduct include but are not limited to the following:

- i. Cursing, harassment, or discrimination of and/or unwarranted physical contact with visitors, USACE personnel, or other contractors
- **ii.** Recurring written and/or verbal complaints from visitors, USACE personnel, or other contractors.
- iii. Unsafe operation of vehicles while on USACE property.
- **c. Removal of Contractor's Employees** The TPOC may require the Contractor to immediately remove from the work site any employee of the Contractor or

subcontractor, who, in the opinion of the TPOC, who endangers persons or property, or whose physical or mental condition is such that it would impair the employee's ability to satisfactorily perform assigned work. Notification to the Contractor shall be promptly made in writing if time and circumstances permit. Otherwise, notification shall be verbal or by telephone, and shall be confirmed in writing as soon as possible. No such removal, however, will reduce the Contractor's obligation to perform all work required under this contract, and immediate replacement will be made as required. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.

13. Quality Assurance – The contractor is responsible for the quality control of the contract work. The contractor shall establish and maintain a quality control system to assure compliance with the contract requirements. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

14. Inspections-

- **a.** Contractor Quality Control The Contractor is responsible for establishing and maintaining an adequate quality control system to satisfactorily inspect and ensure that all work performed by the Contractor's organization in each separate service is in full compliance with this contract and the instructions, provisions, specifications, drawings, and maps herein.
- b. General Inspection Upon the completion of each service requirement, the Contractor will perform an inspection of all areas under this contract to ensure compliance with the Performance Work Statement. The Contractor or their representative must be able to commit personnel, equipment, and resources to correct deficiencies. A Government representative may accompany the contractor on an inspection of completed work and will identify any contract deficiencies. Any deficiencies noted will be corrected within original contract time frames or appropriate deductions in payment will be made.
- c. Equipment/Supplies Inspections The TPOC may inspect required equipment and, supplies at any time when in use on Government property. Any equipment found deficient shall be removed from service immediately until faulty conditions have been corrected and passed by the TPOC. No such removal will reduce the Contractor's obligation to perform all work required within the time scheduled under this contract. This requirement shall not be made the basis of any claim for compensation or damages against the United States or any of its officers or agents.
- **d. Government Inspections** The Government will monitor the Contractor's service performance and make deductions accordingly.
- **15. Receiving and Storing Materials** The contractor is responsible for protecting any stored material until it is placed in service. The contractor is responsible for receiving and unloading

of delivered goods. Government employees will not receive materials or supplies for the contractor and will not be responsible for damage to the contractor's equipment or materials.

- **16. Omissions** This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
- **17. Equipment Storage** No Government space or facilities shall be provided under this contract.

Part 2 Equipment:

1. Condition of Equipment– All equipment used to perform work under this contract must be in good operating and mechanical condition and comply with EM 385-1-1, Army Corps of Engineers Safety and Health Requirements. A regular schedule of preventive maintenance must be followed on all equipment. All vehicles utilized under this contract will be presentable, serviceable, and shall comply with safety standards.

2. Type of Equipment –

- **a. Boundary Clearing and Monument Locating:** Navigational tools and equipment may be necessary to locate bearings and distances within the boundary line. A forester's staff compass, or a sighting compass will be the lowest grade of instrument allowed to identify the boundary line. Brush clearing tools such as machetes, pruning saws, axes, loppers, and powered brush cutters are types of equipment that may be used to clear the boundary line. Motorized all-terrain vehicles are **NOT** authorized for use to accomplish the work specified in this contract. Metal detectors may be required to locate monuments that are not readily visible.
- **b.** Boundary Marking: Boundary marking may be accomplished by use of paint brush, forestry marking paint gun, aerosol paint can, or approved method by the TPOC.
- **c. Documenting:** Equipment used for documenting shall include a digital camera, GPS unit, field notebook and writing implements.

Part 3 Materials and Supplies:

1. Provided by Government –

- **a.** Boundary Maps and Data. Boundary survey maps showing distances and bearings between monuments.
- **b.** Government furnished supplies are the property of USACE and shall be returned in full upon the completion of work.

2. Provided by Contractor –

a. Boundary Marking Paint: The boundary marking paint shall be a blue oil-based paint designed to provide a 6-year service life visible at a minimum of 20 feet when applied to live tree bark. The Contractor shall provide submittals of the paint type and color to the TPOC for review prior to ordering.

- **b.** Approved paint application materials and supplies.
- **c.** Documentation and Reporting materials needed based on the requirements listed in Part 4 Service Requirements.

Part 4 Service Requirements:

1. General: Boundary lines are maintained lines of site to ensure abutters and visitors are aware of federal boundary lines on USACE projects. Maintenance of these lines requires routine clearing, painting, signing, reporting broken or missing monuments, and reporting encroachments (documenting via digital photographs). Services performed under this contract shall be based on boundary surveyed data as indicated on maps provided to the Contractor by USACE.

<u>NOTE</u>: Some boundary lines may proceed on a curved line with a specified radius between corner monuments. Some boundary corner monuments may be indicated as "Tie" lines or monuments, and the Contractor shall be familiar with properly reading survey maps and coordinates to properly maintain and mark these unique features of the boundary line.

a. Boundary Line Clearing:

- i. The Contractor shall clear and maintain a four-foot (4') wide by six-foot (6') high line of sight by cutting all branches and trees three inches or less in diameter at breast height (DBH), and any brush intruding into this "line of sight" zone.
- **ii.** All stumps shall be cut as close to the ground as conditions allow and no higher than three inches (3") above the ground.
- **iii.** Branches shall be cut back to the branch collar of the tree or shrub. To avoid tearing the bark on the main stem of the tree or shrub, branches may require starting the cut from the underside of the branch.
- iv. Clearing is not required where the boundary is defined by roads, streams, or bodies of water.
- **v.** Clearing is required along fencing and stone walls that define the boundary line.
- vi. All cuttings shall be disposed onto USACE property and not left on abutters property, in trees, or piled on the ground within the "line of sight" zone.
- vii. Cuttings will be spread out into the wooded area on USACE property at a minimum of ten-feet (10') from the "line of sight" zone and shall not be piled higher than two-feet (2') in height above the ground.
- viii. A forester's staff compass, or a sighting compass shall be the lowest order of instrumentation allowed for running the bounds between monuments.

b. Boundary Line Marking:

- i. Paint markings shall be approximately five feet (5') above the ground, with a blue spot at least four inches (4") wide and six inches (6") tall. See Exhibit 1.
- **ii.** Paint Markings shall be made on USACE property and face the adjacent property unless the line goes directly through a tree where a "Center Blaze" marking shall be applied. **See Exhibits 1 and 2**.

- iii. Paint and all supplies will be supplied by the Contractor.
- iv. Painted trees shall be on USACE property. The painted tress may be on the boundary line (Line Trees = Center Blaze) or no more than four feet (4') from the boundary line (Face Blaze). See Exhibit 1.
- v. Line trees receiving a "Center Blaze" shall be marked on each side of the tree to represent the boundary line proceeding through the tree. See Exhibits 1 and 2.
- vi. Where possible up to three (3) trees (Corner Trees) at each boundary corner (monument) will receive three (3) markings (Tri-Blaze), each one at least four inches (4") wide and six inches (6") tall. These markings shall be arranged vertically along the tree stem (See Exhibit 1).
- vii. Paint markings for trees less than four inches (4") DBH, shall coincide with tree diameter at DBH.
- **viii.** Trees shall be painted as necessary to provide a blaze visible from each to the next at an interval not to exceed seventy-five feet (75').
- ix. Boundary monuments (some metal, some concrete, some PVC, some on rocks, and all with bronze or metal survey discs) will receive a blue paint marking around the monument if room allows. The blue paint SHALL NOT cover the bronze or metal survey disc. See Exhibit 1.

c. Documentation and Reporting:

- i. Fallen Trees: The Contractor shall document and report the location (latitude and longitude) and between which monuments, and size of any fallen trees on the boundary line that cannot be removed by hand.
- ii. Encroachments: Any encroachment or suspected encroachment and any missing or broken boundary monuments observed shall be **immediately** reported to the Project Manager or TPOC. The Contractor shall also document and record the location (latitude and longitude) and between which monuments of any suspected encroachment and provide digital photos in .jpeg format that document the extent of the potential encroachment. An encroachment is defined the USACE Real Estate Encroachment Action Handbook as: any "unauthorized placement of improvements on (USACE) property by a non-Army party. An encroachment has occurred when the structure or improvement extends over, across, in, or upon lands in which the Government owns a real estate interest which would prohibit such, and the structure or improvement has not been approved. Structure or improvement means a permanent or semi-permanent facility, such as a habitable dwelling, building, fence, deck, porch, barn, outhouse, permanent storage building, road, pond, leach field and septic tank, utility line, levee, excavation, placement of fill material, oil, and gas well, mine entrance and tunnel. Also, unauthorized removal of government-owned real property components of economic value such as timber, sand, gravel, or embedded stone" is considered an encroachment. Any damage or disturbed USACE boundary lines such as to tree markings, fencing, stonewalls, or monuments, and any erosion caused by an abutter's activity, or other form of destruction of

Government property is considered an encroachment. All data collected for any encroachment shall be submitted to the TPOC.

iii. Monuments: The Contractor shall take digital photos in .jpeg format of existing monuments and provide the TPOC a list of conditions of all monuments on site along with the corresponding photographs. The Contractor shall make note of any missing or damaged monuments. Notes about the monument shall be written to include the physical condition of the monument itself (i.e., condition of disc, presence of monument, condition of any fiberglass posts, blue paint etc.) and submitted to the TPOC electronically by email.

<u>NOTE</u>: The Contractor shall be responsible for locating each monument, which may require the use of a metal detector for those monuments not immediately visible.

2. Restrictions:

- **a.** Contractors **SHALL NOT** enter private property to access boundary locations without written permissions from the TPOC and landowner. All ingress and egress to and from the specified area(s) shall be through USACE property.
- **b.** The Contractor **SHALL NOT** attempt to resolve any encroachments.
- c. Maps and data provided are for official use only and may not be shared.

3. Qualified Personnel:

- **a. Boundary Line Maintenance Work** To produce reliable results, the field crew must be composed by personnel who have the experience to properly implement a boundary line maintenance plan.
 - i. The Contractor must be familiar with boundary line inspections.
 - **ii.** The Contractor personnel must be familiar with reading and navigating from a survey map to properly conduct a boundary line inspection and services described herein.
 - **iii.** The personnel conducting the field work shall have three (3) years prior experience in conducting boundary line inspections and be able to locate and identify project monuments and potential encroachments.

4. Service Tasks:

- a. Task 1 Blackwater Dam (BASE):
 - i. The service area is located between monument numbers BWD-007 to BWD-212 (See Attached BWD Boundary and Monument MAP 3).
 - a. Service Requirements:
 - Boundary Line Clearing approximately 6,962.7 feet.
 - Boundary Line Marking approximately 6,962.7 feet (same as above).
 - Documentation and Reporting Approximately 24 Monuments.
- b. Task 2 Franklin Falls Dam (OPTION 1):
 - **ii.** The service area is located between monument numbers FFD-188 to FFD-231 and FFD-386 to FFD-391 (See Attached FFD Boundary and Monument MAP 4).
 - **a.** Service Requirements:
 - Boundary Line Clearing approximately 24,188 feet.

- Boundary Line Marking approximately 24,188 feet (same as above).
- Documentation and Reporting Approximately 58 Monuments.

(7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

"Reasonable inquiry" has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

"Restricted business operations" means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: This wage determination does not apply to any individual employed in a bona fide executive administrative or professional capacity as defined in 29 C.F.R. Part 541. (See 41 C.F.R. 6701(3)). Because most Computer Systems Analysts and Computer Programmers who are paid at least \$27.63 per hour (or at least \$684 per week if paid on a salary or fee basis) likely qualify as exempt computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 213(a)(17) this wage determination may not include wage rates for all occupations within those job families. In such instances a conformance will be necessary if there are nonexempt employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industry and are not determinative of whether an employee is an exempt computer professional. To be exempt computer employees who satisfy the compensation requirements must also have a primary duty that consists of:

(1) The application of systems analysis techniques and procedures including consulting with users to determine hardware software or system functional specifications;

(2) The design development documentation analysis creation testing or modification of computer systems or programs including prototypes based on and related to user or system design specifications;

(3) The design documentation testing creation or modification of computer programs related to machine operating systems; or

(4) A combination of the aforementioned duties the performance of which requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation requirements and the above duties test qualifies as an exempt computer professional under both section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (Field Assistance Bulletin No. 2006-3 (Dec. 14 2006)). Accordingly this wage determination will not apply to any exempt computer employee regardless of which of these two exemptions is utilized.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you

work at night as part of a regular tour of duty you will earn a night differential

and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

** HAZARDOUS PAY DIFFERENTIAL **

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance explosives and incendiary materials. This includes work such as screening blending dying mixing and pressing of sensitive ordnance explosives and pyrotechnic compositions such as lead azide black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization modification renovation demolition and maintenance operations on sensitive ordnance explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with or in close proximity to ordnance (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands face or arms of the employee engaged in the operation irritation of the skin minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving unloading storage and hauling of ordnance explosive and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance explosives and incendiary material differential pay.

** UNIFORM ALLOWANCE **

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract by the employer by the state or local law etc.) the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition where uniform cleaning and maintenance is made the responsibility of the employee all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount or the furnishing of contrary affirmative proof as to the actual cost) reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However in those instances where the uniforms furnished are made of ""wash and wear""

materials may be routinely washed and dried with other personal garments and do not require any special treatment such as dry cleaning daily washing or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract by the contractor by law or by the nature of the work there is no requirement that employees be reimbursed for uniform maintenance costs.

** SERVICE CONTRACT ACT DIRECTORY OF OCCUPATIONS **

The duties of employees under job titles listed are those described in the ""Service Contract Act Directory of Occupations"" Fifth Edition (Revision 1) dated September 2015 unless otherwise indicated.

** REQUEST FOR AUTHORIZATION OF ADDITIONAL CLASSIFICATION AND WAGE RATE Standard Form 1444 (SF-1444) **

Conformance Process:

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e. the work to be performed is not performed by any classification listed in the wage determination) be classified by the contractor so as to provide a reasonable relationship (i.e. appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification wage rate and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

1) When preparing the bid the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).

2) After contract award the contractor prepares a written report listing in order the proposed classification title(s) a Federal grade equivalency (FGE) for each proposed classification(s) job description(s) and rationale for proposed wage rate(s) including information regarding the agreement or disagreement of the authorized representative of the employees involved or where there is no authorized representative the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.

3) The contracting officer reviews the proposed action and promptly submits a report of the action together with the agency's recommendations and pertinent information including the position of the contractor and the employees to the U.S. Department of Labor Wage and Hour Division for review (See 29 CFR 4.6(b)(2)(ii)).

4) Within 30 days of receipt the Wage and Hour Division approves modifies or disapproves the action via transmittal to the agency contracting officer or notifies the contracting officer that additional time will be required to process the request.

5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.

6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request the ""Service Contract Act Directory of Occupations"" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember it is not the job title but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split combine or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1)).
