STATEMENT OF WORK

**WATER SUPPLY LINE REPAIR
U.S. ARMY CORPS OF ENGINEERS
STAMFORD HURRICANE BARRIER
STATEMENT OF WORK**

I. General**1. Scope**

Furnish all labor, materials, and equipment to identify location of water leak and repair service water supply line at Stamford Hurricane Barrier. Contractor will be responsible for excavation, removing all damaged pipe, and installing new “in-kind” piping; ensuring connection to existing un-damaged piping is functional and secure, and re-asphalting the roadway in accordance with the Scope of Work.

The service water supply line is located within the Woodland Cemetery in Stamford, CT which is adjacent to the Stamford Hurricane Barrier within an existing easement. The contractor will coordinate with all applicable agencies, to include Woodland Cemetery, Aquarian Water Services (Area’s Water Provider), and US Army Corps of Engineers (USACE). All work must meet all applicable industry standards and shall comply with any applicable federal, state, and municipal laws, codes, and regulations. Work shall be performed in a timely manner and to the satisfaction of the Technical Point of Contact (TPOC).

2. Locations

Work location is within the Woodland Cemetery, which is located at 63 Woodland Place, Stamford Connecticut, 06902. The responsible agency is the U. S. Army Corps of Engineers, Stamford Hurricane Barrier- East Branch located at 230 Elmcroft Road, Stamford Connecticut, 06902.

Attached overhead photographs show location of existing water line.

3. Site Visit

4. Schedule

The period of performance is 120 days from contract award. The Preconstruction Conference shall be completed within 14 days of contract award, and safety paperwork shall be submitted, reviewed, and accepted within 30 days of contract award. Field work shall begin no later than 30 days after contract award. The project area will be open to the contractor Monday through Friday 7:00 AM to 3:30 PM and all work must be done during those hours, unless additional hours and days are approved by the Technical Point of Contact. Work will

not be permitted on Saturdays, Sundays or Government holidays unless approved in advance by the Technical Point of Contact.

5. Safety Requirements

a. General:

All work shall be conducted in accordance with the U.S. Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, most recent edition), and all applicable Occupational Safety and Health Administration (OSHA), federal, state, and local safety and health requirements. A copy of EM 385-1-1 can be accessed at the project office or electronically at Headquarters USACE website under publications using the following link: http://www.publications.usace.army.mil/Portals/76/Publications/EngineerManuals/EM_385-1-1.pdf

Project staff reserve the right to cease work at any time should the safety of employees, Contractors, and/or the public become jeopardized.

b. Accident Prevention Plan:

The Contractor shall prepare an Accident Prevention Plan (APP) specific to the activities being performed. It shall include Activity Hazard Analyses (AHAs) as described below. A non-mandatory, fillable AAPP template is available upon request. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements of EM 385-1-1, Appendix A, Section K.

A preparatory meeting shall be conducted by the prime contractor to discuss the AAPP contents with all effected onsite employees. The Prime Contractor is responsible for informing their subcontractors of the safety provisions under the terms of the contract, the penalties for noncompliance, and inspecting subcontractor operations to ensure that accident prevention responsibilities are being carried out.

c. Activity Hazard Analysis:

An AHA shall be submitted for each major phase of work. A major phase of work is defined as an operation involving a type of work presenting hazards not experienced in previous operations or where a new subcontractor or work crew is to perform the work. The analysis shall define all activities to be performed, identify the sequence of work, the specific hazards anticipated, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level. The AHA shall be continuously reviewed and revised to address changing site conditions as appropriate.

d. Emergency Response:

Emergency procedures shall be documented in the Abbreviated Accident Prevention Plan and will include a map with directions to the nearest hospital, emergency contact numbers, and onsite First Aid/CPR responders.

e. Required Personnel:

The Contractor shall employ a minimum of one Competent Person (CP) at each project site to function as the Site Safety and Health Officer (SSHO). The SSHO shall be present at the project site and report to the contractor's upper management. The SSHO is required to have related construction experience and have at a minimum completed a 10-Hour OSHA Course (or equivalent).

In addition, when emergency medical services are not accessible within 5 minutes of the work location and there are 2 or more workers onsite, at least 2 employees shall have (in-person) training in First Aid and CPR. Minimum qualifications are listed in EM 385-1-1, Section 03.A.02.c.

Note: Other Competent or Qualified Persons may be required per EM 385-1-1 and/or other sections of this Scope of Work, based on the definable features of work for this project*

f. Accident Reporting:

All accidents and near misses shall be investigated by the Contractor. All work-related recordable injuries, illnesses, and property damage accidents (excluding on-the-road vehicle accidents), in which the property damage exceeds \$5,000.00, shall be verbally reported to the Technical Point of Contact within four (4) hours of the incident. Serious accidents as described in EM 385-1-1 Section 01.D shall be immediately reported to the Technical Point of Contact. ENG Form 3394 shall be completed and submitted to the Technical Point of Contact within five (5) working days of the incident.

The Contractor shall compile employee work hours (including subcontractors) and forward the total hours to the Technical Point of Contact no later than close of business on the 10th calendar day of the following month. The method of transmission by the prime contractor to the Technical Point of Contact shall be electronically.

6. Specific Safety Section Excavation and Trenching

- a. **General:** All excavating and trenching activities are required to be completed in accordance with EM 385-1-1, Section 25.
- b. **Submittals:** An Activity Hazard Analysis is required for all excavations and trenches. In addition, for excavations or trenches greater than 5 feet in depth an Excavation and Trenching Plan will need to be submitted for review by the Technical Point of Contact. USACE will provide a non-mandatory, fillable template plan. However, the contractor is permitted to submit their own plan, at a minimum it must meet the requirements listed in EM 385-1-1, Section 25.A.01.c.
- c. **Required Personnel:** All projects that involve excavation and trenching activities are required to have a Competent Person in excavation and trenching onsite. This person is typically (but not limited to) the Site Safety Health Officer (SSHO), Superintendent, or site foreman and is defined as:
 - i. An onsite employee who has been designated in writing by the employer to be responsible for the immediate supervision, implementation, and monitoring of the excavation/trenching program, who through training, knowledge and experience in excavation/trenching is capable of identifying, evaluating, and addressing existing and potential hazards and, who has the authority to take prompt corrective measures with regard to such hazards.

7. Traffic Control.

Provide and erect temporary safety fencing and/or barricades at areas as needed to prohibit access by unauthorized vehicles and public.

8. Preconstruction Conference

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Preconstruction Conference". The Contractor's Project Manager and Quality Control Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Preconstruction conference the contractor shall provide the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Preconstruction Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.
- ii. Contractor's Safety Program (including sub-contractors).
- iii. Accident Prevention Plan (Submitted & accepted prior to start of work on site)
- iv. Weekly Safety Meetings (Documented on NED Form 251)
- v. Accident Reporting (ENG Form 3394)
- vi. Safety Data Sheet (SDS) requirements
- vii. Correspondence, Communication and Administrative Procedures.
- viii. Invoice and payment.

9. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable federal, state, and municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

10. Security

The Contractor shall comply with all established security policies at each Project Location identified. If applicable, Contractor shall comply with Projects Key Control Management Program. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least a 24-hour notice of any such closure.

11. Contractor Conduct

Alcohol, illegal substances and firearms are prohibited on project grounds. Contractor and employees must comply with CFR 36 Rules and Regulations.

12. Payment

Payment shall be made on a per job basis. After final inspection and acceptance by the Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. For jobs greater than 30 days the contractor may request -multiple payments.

II. Technical Requirements:

Part 1 General:

1. Summary

Contractor will be responsible for excavation, removing all damaged pipe, and installing new “in-kind” piping; ensuring connection to existing un-damaged piping is functional and secure. Contractor will re-asphalt roadway.

Contractor will need to coordinate water service interruption/shut off with Aquarian Water Company, notify potentially affected end users, and the Technical Point of Contact prior to beginning project work.

2. Existing Conditions

The water line that supplies the Stamford Hurricane Barrier Project Facility runs through the adjacent property (Woodland Cemetery). The water leak in the service supply line for Stamford Hurricane Barrier has been detected in the adjacent property (Woodlawn Cemetery). Woodland Cemetery is where the project repair site is located.

Detection has indicated that the leak is under an asphalt roadway. Exposing the damaged pipe will require cutting, removal of asphalt and trench excavation. Aquarian Water Company has noted the pipe to be a cast iron, 6-inch service water supply line and at approximately 4-5 feet depth. U.S. Army Corps of Engineers drawing STA-1 Sheet 023 (Stamford Hurricane Barrier Utilities East Branch Plans) indicates that the waterline pipe is 6 inches in diameter. Due to its age, no record of prior pipe replacement, and the fact that the material of the pipe at the curb stop shut-off being cast iron, it is an educated assumption that the material of the waterline to be cast iron.

Leak is not affecting water pressure beyond the leak site but is causing groundwater retainment/minor flooding within the Woodland Cemetery. Leak point has been

identified by a leak detection service. The attached photos show aerial location map and leak location. In the event that the markings fade, the leak point is located directly in front of the headstone marked "Bella" and roughly 30 feet from the 90 degrees turn in the road.

4. Submittals

Although the Government technically reviews submissions required by this scope of work, it is emphasized that the Contractor's work must be prosecuted using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted for review and accepted by the government within 30 days of Contract Award. Submittals must be accepted before the commencement of any field activities.

- Copy of contractor's Accident Prevention Plan (APP) and be in compliance with all regulatory safety items to include EM 385-1-1 Section 25.A.01 (a).
- Copy of contractor's Excavation and Trenching Plan for trenches greater than 5 feet in depth.
- Copy of contractor's Activity Hazard Analysis (AHA).
- Copy of 10-hour OSHA Construction Safety Training Certificate.
- Copies of all products Safety Data Sheets (SDS).

5. Clean Up and Waste Disposal

The contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any designated storage areas free from accumulation of waste materials. Upon completing work in an area, the contractor shall remove any tools, equipment, and materials that are not the property of the Government. Any and all disturbed areas resulting from contractor activities shall be restored by the contractor to the satisfaction of the Technical Point of Contact. All waste material will be disposed of offsite in accordance with all federal, state, and local regulations.

6. Government Resources

The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources. The contractor may use the restroom at the office.

7. Environmental Protection

Containers for waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected and cleaned daily when working onsite. Water, air, and land resources shall not be adversely impacted during the course of the work. The contractor will take necessary steps to ensure all Federal, State, and Local environmental

regulatory requirements are met at no additional cost to the Government. Assurance of compliance with this section by subcontractors shall be the responsibility of the contractor.

8. Personal Protective Equipment

It is the contractor's responsibility to furnish and supply personnel with the proper personal protective equipment necessary for performing the work.

9. Damage to Government and Private Property

The Contractor shall exercise caution and follow sound industry practices in the conduct of the work to avoid Contractor related damage to any Government and Woodland Cemetery facilities or features. The contractor shall be responsible for restoring all Government and Woodland Cemetery facilities or structures damaged as a result of the contractor's operation.

The contractor shall also be responsible for any damage to private property or injury to any person as a result of the contractor's operation. The contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person resulting from the contractor's operation.

Trucks, trailers, and equipment will be driven on existing roads only. The Contractor shall also restore landscape features (example: shrubs, flowers, grasses), which are damaged or destroyed by the contractor's operation. Damaged or destroyed grass areas shall be re-planted as directed by the Technical Point of Contact, and shrubs and flowers which are damaged or destroyed shall be replaced from nursery stock of like size and kind.

Any Government and Woodland Cemetery property damaged as a result of the services performed under this contract shall be repaired or replaced at no additional cost to the Government and to the satisfaction of the Technical Point of Contact.

10. Omissions

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

11. Quality Assurance

The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

12. Other Contracts

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other Contractors and Government employees. The contractor shall not commit or permit any act, which will

interfere with the performance of work by another contractor, or by Government employees.

13. Staging and Storage Area.

A designated staging and storage area shall be used by the Contractor for staging work, storage of equipment, materials, and trailers during the life of this contract. The site-specific location of the staging and storage area will be in the Woodland Cemetery and will require coordination with TPOC and Woodland Cemetery prior to start of work. Coordination between all parties will be discussed at the Preconstruction Conference. The Contractor shall confine its storage and staging area to the limits as designated or approved by the TPOC and shall be responsible for the security of the area. Upon completion of the contract, all equipment, and materials, shall be removed, and the site must be restored to its original condition as approved by the TPOC.

Contractor shall not stockpile materials outside the staging and storage area in preparation for the next day's work.

14. Receiving and Storing Materials:

The contractor is responsible for protecting any stored material until it is placed in service. The contractor is responsible for receiving and unloading all delivered goods. Government employees will not receive materials or supplies for the contractor and will not be responsible for damage to contractor equipment or material.

Part 2 Products:

1. Sustainability

Part 3 Execution:

1. General

- a. Prior to starting any work, the contractor must contact “Call Before You Dig” at 1-800-322-4844. Notification shall not be earlier than 30 days prior, or later than 3 days prior to planned excavation.
- b. Contractor must repair 10 feet or less of a portion of the water line where a leak has been identified by a water line detection service. Any damage to the water line requiring more than 10 ft of piping will be considered an additional option for up to an additional 15 feet length of pipe.
- c. Work shall include - the following work activities:
 - i. Excavation
 - ii. Trenching
 - iii. Bedding
 - iv. Filling/Backfilling
 - v. Compacting
 - vi. Removing damage piping
 - vii. Installing new piping
 - viii. Re-asphalting roadway
 - ix. Disposal of excess materials and waste products
- d. Contractor will need to coordinate water service interruption/shut off with Aquarian Water Company, potentially affected end users, and TPOC prior to beginning project.
- e. Existing paved, unpaved areas, all surrounding structures, water supply line and all surrounding landscaping vegetation to include but not be limited to trees, shrubs, flowers, plantings, grass areas, and shoreline areas shall be protected during the duration of this contract.
- f. Activities including excavation, demolition, and installation, shall be scheduled to minimize impacts of weather-related events to structures and any of their contents.
- g. The contractor shall keep on site the means to quickly cover and protect all areas open to the elements during an unforeseen weather-related event that could cause damage to the structures and any of their contents.
- h. The contractor is required to construct a “safe zone” around excavated/trenched areas using temporary safety fencing and/or barricades to prohibit access by unauthorized vehicles and foot traffic. Temporary fencing and/or barricades must be maintained throughout duration of project.
- i. Any hole or trench must be covered when work is not being performed. In accordance with EM385-1-1 Section 21 G.01-03, covers must be capable of supporting, without failure, at least twice the weight of the worker, equipment and material combined. Covers must also be properly labeled.

- j. Once the repair is completed, the contractor shall coordinate with Aquarian Water Company to restore water service to supply line and notify end users of service status.

2. Excavation

- a. Cutting of asphalt along roadway at leak point will be necessary for excavation.
- b. Removed asphalt shall be properly disposed at an approved off-site facility at no additional cost to the government. This includes any excavated materials.
- c. The contractor shall recycle all waste and demolition materials to the fullest extent possible.
- d. Contractor will excavate trench to the required depth, alignment, and grade at the location of leak to expose the necessary length of water supply line to properly repair the leak. Reference EM 385-1-1 Section 25.A.01 (a).
- e. Existing structures, and other water supply line piping within the work area shall be protected.
- f. Erosion control material, if needed by the Contractor's construction methods, shall be installed in accordance with the manufacturer's instructions.

3. Installation

- a. The appropriate length of exposed compromised water supply pipe will be cut out. The removed damaged/compromised section of water supply piping will be replaced with the necessary length of new "in-kind" piping.
- b. The Contractor will install transition couplings as necessary, and bed underneath as needed to ensure proper support of the pipe. in accordance with the manufacturer's specifications.
- c. Contractor will coordinate with the Aquarian Water Company and leak test the new section of pipe and couplings before backfilling. Test will be completed in accordance with the Aquarian Water Company specifications.
- d. Contractor will bed and cover the water supply pipe with necessary material and backfill. Material will be installed and compacted to the subgrade of the pavement per the following recommendations provided by Aquarian Water Company. Backfilling material for at least one (1) foot above the top of the pipe shall consist of selected fine material containing no stones larger than one-half inch in size. Backfill of the fine selected material shall be carefully and thoroughly tamped with approved tools in such a manner as to prevent settlement. Special care shall be taken to place sand or stone dust material under the pipe to solidly furnish a hard bedding for the entire new section of piping.

The required backfill above the one-foot layer of fine selected material can be 4 inch or less processed stone and may be placed in one layer provided it is compacted by means of a hoe-pack to achieve a 95% modified proctor density. If a hoe-pack is not used, the backfill shall be spread in layers not exceeding twelve (12) inches in depth prior to compaction. Each layer shall be carefully and thoroughly tamped with approved tools in such a manner as to prevent settlement after the backfill has been completed and to achieve a 95% modified proctor density. All settlement in backfill shall be repaired by the Contractor at his expense. The use of frozen material will not be permitted. The excavated paving, either bituminous or other, shall not be placed in the trench as backfill.

Blue marking tape reading "Caution - Water Line Below" shall be placed a minimum of 24 inches above the top of the water main.

- e. In the area where the excavation and repair took place the removed asphalt will be replaced with new asphalt pavement to the grade of the existing pavement. Pavement shall be installed and compacted to the state of Connecticut Department of Transportation (CTDOT) State Standards.

Asphalt pavement materials and mixtures shall be obtained from a supplier regularly producing asphalt pavement that is in accordance with and meets the requirements of CTDOT State Standards.

- f. (Option) Additional Length of Pipe - If it is found that any damage to the water line requiring more than 10 feet of piping will be considered an additional option. This option may be exercised for up to an additional 15 feet of pipe length. No work identified under the optional task shall be performed until the Contractor receives a formal modification to the Purchase Order signed by the Contracting Officer.

4. Final Cleanup and Restoration

- a. At the Contractor's expense, any areas deemed by the Technical Point of Contact to be outside of the designated work area, which are damaged during construction operations, will be restored to their original conditions. This includes paved or unpaved areas, all surrounding structures, water supply line and all surrounding landscaping vegetation.
- b. Remove all construction debris, waste, surplus materials, and rubbish from work area to off-site location at the completion of installation.
- c. Temporary storage area(s) used by the Contractor shall be cleaned and restored in accordance with this statement of work.

- d. Upon the completion of all work, the Contractor shall leave the work area in the condition in which it was found just prior to work.
- e. All paved areas used or disturbed during construction shall be swept clean. Surplus material or other not required or suitable for the work, such as fills and backfills, pipe and fittings, brush, refuse, stumps, roots, and timber shall be removed from Government and Woodland Cemetery property.

Hazardous waste removal work receives additional \$1.25 per hour.

a. PAID HOLIDAYS: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day and Good Friday, provided the employee has at least 31 calendar days of service and works the last scheduled day before and the

first scheduled day after the holiday, unless excused.

WELDERS - Receive rate prescribed for craft performing operation to which welding is incidental.

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year.

Employees must be permitted to use paid sick leave for their own illness, injury or other health-related needs, including preventive care; to assist a family member (or person who is like family to the employee) who is ill, injured, or has other health-related needs, including preventive care; or for reasons resulting from, or to assist a family member (or person who is like family to the employee) who is a victim of, domestic violence, sexual assault, or stalking. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (ii)).

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010

08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

(i) October 31 of each year during contract performance; and

(ii) At the end of contract performance.

52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (OCT 2022)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

(1) Means any item of supply (including construction material) that is--

(i) A commercial product (as defined in paragraph (1) of the definition of "commercial product" at Federal Acquisition Regulation (FAR) 2.101);

(ii) Sold in substantial quantities in the commercial marketplace; and

(iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and

(2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

(1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or

(2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Critical component means a component that is mined, produced, or manufactured in the United States and deemed critical to the U.S. supply chain. The list of critical components is at FAR 25.105.

Critical item means a domestic construction material or domestic end product that is deemed critical to U.S. supply chain resiliency. The list of critical items is at FAR 25.105.

Domestic construction material means--

(1) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both-

(i) An unmanufactured construction material mined or produced in the United States; or

(ii) A construction material manufactured in the United States, if--

(A) The cost of its components mined, produced, or manufactured in the United States exceeds 60 percent of the cost of all its components, except that the percentage will be 65 percent for items delivered in calendar years 2024 through 2028 and 75 percent for items delivered starting in calendar year 2029. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic. Components of unknown origin are treated as foreign; or

(B) The construction material is a COTS item; or

(2) For construction material that consists wholly or predominantly of iron or steel or a combination of both, a construction material manufactured in the United States if the cost of foreign iron and steel constitutes less than 5 percent of the cost of all components used in such construction material. The cost of foreign iron and steel includes but is not limited to the cost of foreign iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the construction material and a good faith estimate of the cost of all foreign iron or steel components excluding COTS fasteners. Iron or steel components of unknown origin are

treated as foreign. If the construction material contains multiple components, the cost of all the materials used in such construction material is calculated in accordance with the definition of "cost of components".

Fastener means a hardware device that mechanically joins or affixes two or more objects together. Examples of fasteners are nuts, bolts, pins, rivets, nails, clips, and screws.

Foreign construction material means a construction material other than a domestic construction material.

Foreign iron and steel means iron or steel products not produced in the United States. Produced in the United States means that all manufacturing processes of the iron or steel must take place in the United States, from the initial melting stage through the application of coatings, except metallurgical processes involving refinement of steel additives. The origin of the elements of the iron or steel is not relevant to the determination of whether it is domestic or foreign.

Predominantly of iron or steel or a combination of both means that the cost of the iron and steel content exceeds 50 percent of the total cost of all its components. The cost of iron and steel is the cost of the iron or steel mill products (such as bar, billet, slab, wire, plate, or sheet), castings, or forgings utilized in the manufacture of the product and a good faith estimate of the cost of iron or steel components excluding COTS fasteners.

Steel means an alloy that includes at least 50 percent iron, between 0.02 and 2 percent carbon, and may include other elements.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

(1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the domestic content test of the Buy American statute is waived for construction material that is a COTS item, except that for construction material that consists wholly or predominantly of iron or steel or a combination of both, the domestic content test is applied only to the iron and steel content of the construction materials, excluding COTS fasteners. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(2) This requirement does not apply to information technology that is a commercial product or to the construction materials or components listed by the Government as follows:

(3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that

(i) The cost of domestic construction material would be unreasonable.

(A) For domestic construction material that is not a critical item or does not contain critical components.

(1) The cost of a particular domestic construction material subject to the requirements of the Buy American statute is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent;

(2) For construction material that is not a COTS item and does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that is manufactured in the United States and does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest offer of foreign construction material that exceeds 55 percent domestic content as a domestic offer and determine

whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(A)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(A)(2) of this clause will no longer apply as of January 1, 2030.

(B) For domestic construction material that is a critical item or contains critical components.

(1) The cost of a particular domestic construction material that is a critical item or contains critical components, subject to the requirements of the Buy American statute, is unreasonable when the cost of such material exceeds the cost of foreign material by more than 20 percent plus the additional preference factor identified for the critical item or construction material containing critical components listed at FAR 25.105.

(2) For construction material that does not consist wholly or predominantly of iron or steel or a combination of both, if the cost of a particular domestic construction material is determined to be unreasonable or there is no domestic offer received, and the low offer is for foreign construction material that does not exceed 55 percent domestic content, the Contracting Officer will treat the lowest foreign offer of construction material that is manufactured in the United States and exceeds 55 percent domestic content as a domestic offer, and determine whether the cost of that offer is unreasonable by applying the evaluation factor listed in paragraph (b)(3)(i)(B)(1) of this clause.

(3) The procedures in paragraph (b)(3)(i)(B)(2) of this clause will no longer apply as of January 1, 2030.

(ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or

(iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.

(c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--

(A) A description of the foreign and domestic construction materials;

(B) Unit of measure;

(C) Quantity;

(D) Price;

(E) Time of delivery or availability;

(F) Location of the construction project;

(G) Name and address of the proposed supplier; and

(H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.

(d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:
