Performance Work Statement
September 2018**

1. **Scope** – Purchase Order request for laboratory services that analyze both potable water and non- potable (beach) at designated Corps owned reservoirs and project offices located within Connecticut and Massachusetts that meet State and Federal regulations for each state the samples are collected from to protect public health as described below. Services include provision of appropriate sampling containers and analysis of water samples. Bacterial samples may not be subcontracted.
2. **Sample Location** – Sample locations at Corps of Engineers (COE) reservoirs and project offices throughout Connecticut and Massachusetts.
3. **Laboratory Location** – The laboratory must be located in Central Massachusetts and meet the following automobile transportation specification: no further than 40 miles via primary roads from Sturbridge, Massachusetts. This drive specification is the maximum distance that meets the turnaround requirements and logistical limitations for sample locations located in western and eastern Connecticut, western and central Massachusetts, and COE field office in Barre, Massachusetts. *Transport of bacteria samples by courier service or mail from a location within the stated driving range to another location is not permitted.* To ensure that the most accurate data are generated, all *E. coli* and total coliform samples should always be analyzed within the recommended holding time. Per EPA 5.11 Fecal Bacteria, “Samples for bacteria must be analyzed within 6 hours of collection. Keep the samples on ice and take them to the lab or drop-off point as soon as possible”.
4. **Certifications** – State of Connecticut and State of Massachusetts Certification for the specific method/analysis per Safe Drinking Water Act. The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

5. **Payment** – After completion of laboratory services and analytical results are submitted as described below under Technical Requirements, the Contractor must submit an invoice to the COE Program Manager, Heather Rausch, within 30 days of sample acceptance. **Lab reports must include a job number, job date, the issued contract number, description of work, quantities, and process. Invoices must reference the job number, date of service, quantities, unit price and total price due. When laboratory services are used multiple times over a two-week period, the contractor shall consolidate jobs into one invoice with a total payment cost to reduce the number of payments to be processed.**

B. Technical Requirements:
General Requirement

1. **Summary** – Furnish laboratory services to analyze water samples from Corps of Engineers reservoirs and project offices located in Connecticut and Massachusetts for parameters noted below under section “Service Requirements”. Services include provision of appropriate sampling containers and analysis of water samples.
2. **Government Resources** – The contractor is responsible for providing all laboratory equipment. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources.
3. **Omissions** – This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.
4. **Quality Assurance** – The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.
5. **Workmanship** – The contractor shall establish and maintain a quality control system to assure compliance with the contract requirements.
6. **Receiving and Storing Samples** – The contractor is responsible for protecting any stored samples within the EPA holding times and temperature requirements. Government employees will not receive material for supplies for the contractor and will not be responsible for damage to the contractor’s equipment or materials.

8. **Reporting Requirements** - Notify the Corps of Engineers Water Quality Program representative, Nancy McNally by telephone 978-508-9247 (cell) with coliform and E Coli results as soon as they become available and no later than noon the day following sample collection to meet the State and Federal notification timeframe. Failure to comply with the Submittal Part 1 reporting timeframe as stated will result in contract termination.
9. **Submittals Part 1** –The laboratory must notify the Corps of Engineers Water Quality Technical Point of Contact, Nancy McNally, by phone (978) 508-9247, with coliform and E Coli results as soon as they become available and no later than noon the day following sample collection to meet the State and Federal notification timeframe. Failure to comply with the Submittal Part 1 reporting timeframe as stated will result in contract termination.
10. **Submittals Part 2** - Written submittals shall be made on a per job basis within 30 days of sample acceptance. The written submittal shall include the data type, sample location, initial of analyst, reviewer signature, sample date and time, acceptance date and time, analytical method

utilized, quantities, unit of measure, contract number, dates of service, and description of work, as applicable and required by State and EPA guidelines.

10. Service Requirements:

A. Description: Purchase Order request for laboratory services that provide both potable water and non-potable water analyses at designated Corps owned reservoirs and facilities within Connecticut and Massachusetts that meet State and Federal regulations for each state the samples are collected from to protect public health.

1. Certifications:

- State of Connecticut Certification for the specific method/analysis per Safe Drinking Water Act.
- State of Massachusetts Certification for the specific method/analysis per Safe Drinking Water Act.

2. Sample acceptance, Monday - Thursday, occasionally on Friday.

3. Potable Water Samples:

Potable water samples will be collected and hand-delivered to the lab year round. Laboratory analysis of potable water samples will be performed in accordance with State approved analytical methods. Samples will come from Connecticut and Massachusetts. Bacterial samples are to be analyzed as soon as is possible. Maximum sample holding times must be met (6-hrs for source samples).

Unless otherwise directed, all coliform samples must be analyzed using the 18-hour method. Coliform samples must be processed within 2 hours of receipt; sooner if transport time exceeded 6 hours. Coliform results must be verbally reported within 21 hours of sample receipt.

Most Probable Number (MPN) Colony counts must be reported to the Water Quality Program representative, Nancy McNally. This reporting time is essential to optimal public safety and allows for timely management of postings, closures and reopening of systems and to meet State reporting requirements (notification must be received before the end of their workday). In order to achieve this, samples must be hand delivered to the lab no later than 2:00pm of the day sampled since the bacteriological tests take 18-hours plus setup beforehand and reading the results afterwards. Written reports and invoices will be provided to the Water Quality Program Manager within 30 days of sample collection. Bacteriological work must be performed on the premises. *Bacterial work may not be subcontracted.*

Routine analytes include Total Coliform, Escherichia coli (E. Coli) and Nitrates. Occasional analytes could additionally include, but are not limited to, nitrites, arsenic, sodium, iron, lead, manganese, uranium and radon. Presence/Absence coliform methods are unacceptable.

4. Non-Potable (Beach) Samples

Non-potable (beach) water samples will be collected and hand-delivered to the lab during the summer recreation season. Laboratory analyses of surface waters (beach samples) for E.Coli must be performed in accordance with State approved analytical methods. Samples will come from Massachusetts. Bacterial samples are to be analyzed as soon as is possible. Maximum sample holding times must be met (6-hrs for source samples).

Unless otherwise directed, all coliform samples must be analyzed using the 18-hour method. Coliform samples must be processed within 2 hours of receipt; sooner if transport time exceeded 6 hours. Coliform results must be verbally reported within 21 hours of sample receipt.

Most Probable Number (MPN) Colony counts must be reported to the Water Quality Program representative, Nancy McNally. This reporting time is essential to optimal public safety and allows for timely management of postings, closures and reopening of beaches and to meet State reporting requirements. In order to achieve this, samples must be hand delivered to the lab no later than 2:00pm of the day sampled since the bacteriological tests take 18-hours plus setup beforehand and reading the results afterwards. Written reports and invoices will be provided to the Water Quality Program Manager within 30 days of sample collection. Bacteriological work must be performed on the premises. *Bacterial work may not be subcontracted.* Routine beach monitoring is performed from mid-May through mid-September. Samples are generally collected weekly.

Routine Analyte: Escherichia Coli (E. Coli) by approved rapid enumeration method.

SECURITY REQUIREMENTS

The contractor and all associated sub-contractors shall receive a brief/training (provided by the RA) on the local suspicious activity reporting program. This locally developed training will be used to inform employees of the types of behavior to watch for and instruct employees to report suspicious activity to the project manager, security representative or law enforcement entity. This training shall be completed within 30 calendar days of contract award and within 30 calendar days of new employees commencing performance with the results reported to the Technical Point of Contact not later than 5 calendar days after the completion of the training.

The Contractor must pre-screen Candidates using the E-verify Program (<http://www.uscis.gov/everify>) website to meet the established employment eligibility requirements. 52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (NOV 2017)

The Offeror shall complete only paragraph (b) of this provision if the Offeror has completed the annual representations and certification electronically via the System for Award Management (SAM) Web site located at <https://www.sam.gov/portal>. If the Offeror has not completed the annual representations and certifications electronically, the Offeror shall complete only paragraphs (c) through (u) of this provision.

“Immediate owner” means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

“Inverted domestic corporation” means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except--

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate--

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;

“Sensitive technology”--

(i) To restrict the free flow of unbiased information in Iran; or

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

“Service-disabled veteran-owned small business concern”--

(1) Means a small business concern--

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

“Small business concern” means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.
