0750: Ludlow is pulling up erosion control netting at the 95R Maple Avenue property and placing see on bare spots of the lawn that were disturbed during the installation of a 1" copper water service line.

0757: Ludlow has excavated a trench along the west side of Maple Avenue from Station 936+88 to Station 936+67 and is now excavating westwards approximately 10' from 936+67.

0813: Ludlow has connected new 1" copper water service line to existing curb stop located at Station 936+88 and have bent the line 90° to the south towards Station 936+67. The new pipe was then run west for approximately 9' at Station 936+67.

0915: Ludlow has finished moving the curb stop from Station 936+88 to Station 936+67 on the west side of Maple Avenue.

Daily Activities - Well decommissioning activities, Durham

Grela Well Drilling, Inc. (Grela) removed well pumps from the properties located at 186, 227, 233, 235, 242, 297, 312 and 316 Main Street, Durham, as part of well decommissioning activities.

0840: Grela is mobilizing to the 316 Main Street, Durham, residence to remove the well pump as part of well decommissioning activities.

0848: Grela locates the pump at the 316 Main Street residence, which is on the north side of the house.

0904: Grela has pulled the pump at the 316 Main Street residence and is preparing to send the black poly well line back down the well.

0914: Grela is mobilizing to the 297 Main Street, Durham, residence to remove the well pump as part of well decommissioning activities.

920: Grela has mobilized to the 297 Main Street residence to remove the pump from the property's well as part of well decommissioning activities. The well is buried: Grela is using a spud bar to locate the top of the well tile.

0936: Grela locates the well tile at the 297 Main Street property (directly north of the residence's northwest corner and approximately 2' south of the driveway) and has removed the cement cover to daylight the well.

0950: Grela is preparing to pull the well pump at the 297 Main Street property.

1021: Grela has mobilized to the 242 Main Street, Durham, residence to remove the pump from the well located on the south side of the property (next to the southeast corner of the home). The well is located below surface grade; the top of the tile is located about 2" below the surface grade.

1127: Grela has just finished removing the pump shared by the 233 and 235, Durham, residences. They are currently putting the black poly waterline back down the well so they can use it in the future to tremie grout when they decommission the well.

1131: Ludlow continues to work on straightening the hydrant at on the north side of Talcott Lane.

1136: Ludlow has finished straightening the hydrant located at Station 305+41 and are backfilling around it.
