A discussion ensued about the test pressure being 150 versus 200 psi. Mike P. stated the Butterfly valves are only rated to 150 psi. Rich B. agreed to follow up on the max pressure to be tested after this meeting.
- Kurt M. mentioned that one of the hydrants on Watch Hill Drive appears that the bottom flange is set too high. Mike P. and Rich B. explained the correct setting of the bottom flange so they break off when hit by a vehicle.
- Ed. H. Brought up the weekly inspection of trenches over the winter. Doug H. asked who would be contacted if there is a problem. It was determined that Lisa B. would be the first contact followed by Mike P. in that order.
