- Lisa B. asked Steve Wright (DOT) if their Holiday State Road requirements involved the Friday before the Holiday or the Tuesday after the Holiday, Steve responded the Tuesday after the Holiday. Steve did ask Ludlow to be aware that the traffic could pick up on Friday before the Holiday and try to limit the work on the State Roads accordingly. He indicated no work following the State Holiday on Tuesday.

- Lisa asked Steve D., how long does this take to be in final approval. Steve D. responded it is already sent as approved.
- JC00029 Maiden Lane Fire Hydrant Relocation (Negotiations)
- Need Ludlow revisions.

### **Anticipated Events/Major Deliveries:**

- Lisa B. brought up a request she received from Ludlow Construction, asking for approval from the USACE and EPA to start early, 5:00 am. on Wednesday, August 2th. This is being requested due to the amount of the pour, as DN Tanks will be pouring the floor of the tank in Middletown. Carl N. and Lisa B. do not have a problem with this. Ed H. asked that the abutters at the tank site and Talcott Ridge and Watch Hill Drive owners be notified. Joe Fazzino asked to get Cc'd: on the email to the tank abutters informing them of the early start. Mike C. will take care of notifying Joe Fazzino and Brian Robillard along with the tank abutters, and E. Hathaway will take care of notifying the residents on Talcott Ridge Drive and Watch Hill Drive.
- ED H. asked if we could let Steve Wight (DOT) bring up his concerns before we move on to the Other Items to be discussed.
- Steve W. asked Ludlow Construction to shim coat all area's in need of pavement before the Holiday Weekend (Labor Day). He asked for Thursday or Friday before the Holiday.
- Steve mentioned an area on Rte. 68, Wallingford Road at the end of our trench just west of Maple Avenue needs to be shim coated as well.
- Steve W. asked what the time frame is for full depth restoration? Steve is looking to give his Management/Office a date. Lisa responded that we have the funding now we have to go through the modification process with the USACE. Mike P. said they will begin this work in the middle of September. Mike P. also stated that the saw cutting for this full depth restoration may begin before the middle of September.
- Steve W. mentioned that some places will require more than a one- foot cutback. Lisa responded saying the Sliver Slab will cover these areas. Steve W. will forward this schedule information to his office.
- Mike P. asked Steve W. how long does he expect the DOT crew to be working on Rte. 17 (Main Street) in Durham? Steve said a week to a week and a half.

### Other Items to be discussed:

- 227 Main Street Water Service.
- Mike C. said this resident contacted him about getting a second meter as this is a two-family residence. Mike told the owner of the property only one service is proposed to be installed and that you could not install 2 meters on one service line. If they wanted two meters to be installed, they would need two individual service lines installed. Mike C. said he instructed them to contact either Bill Milardo or Laura Francis.
- Bill M. asked Joe Fazzino from Middletown Water and Sewer how they handle these cases. Joe F. said similar to what Mike C. had told the customer, Middletown would install one service under the property owners name.



- 119 Maple Avenue Water Service.
- Mike C. brought up a phone call he received for Christina and Alex Muro form # 119 Maple Avenue questioning the proposed location of their water line. The proposed location runs next to a tree that the "homeowners were concerned with", a large bush and a tree would require removal. Mike Pio said he would take a look and get back as to the best route to install. Mike C. said the south side of the house looked clear. Cindy M, AECOM said the leaching field is located there and this would not be an option. Cindy M. will forward diagrams of the leaching field.
- Ed H. asked about the status of # 13 Maple Avenue? Paul Paris, (USACE) talked with the resident this morning. Would now like to wait for the meter installation. The local plumber the town suggested using is unable to do the job per the Spec's. Mike P. is in the process of obtaining a plumber.
- Brian Robillard mentioned that Schools are re-opening on September 3, 2020 in Middletown.
- Cindy M. asked if there was a schedule for the stream crossing on Maiden Lane? At this time this has not been scheduled. Mike P. needs to revisit the maps for the wetlands. Specifications call for "May need" wood matting for the machines. Jing Chen from DEEP was asked if someone in their office can give a definite answer, yes or no. Jing C. will look into through her office. Mike P said he has until the end of September to complete this crossing this calendar year.
