

In Lieu Fee Program Annual Report Fiscal 2017 July 1, 2016 – June 30, 2017

I. Introduction

The Audubon Connecticut In Lieu Fee Program (ACT ILF) is an option for compensatory mitigation for unavoidable impacts to waters of the United States in the State of Connecticut. Permits are required by the U.S. Army Corps of Engineers ("Corps") through the Clean Water Act ("CWA") Section 404 for discharge of dredge or fill materials within "waters of the U.S." and through the Rivers and Harbors Act Section 10 for structures or work in or affecting navigable water of the U.S. The Army Corps of Engineers requires that aquatic resource functions and services lost due to the effects of any regulated activity be replaced through compensatory mitigation, after addressing avoidance and minimization of impacts.

The ACT ILF program contains six (6) service areas that cover the entire state of Connecticut (See Appendix B for a Service Area Map). This report outlines the ACT ILF program activities from July 1, 2016 to June 30, 2017.

2. Impacts & Fees Received

During the period of July 1, 2016–June 30, 2017, 1.6 compensatory mitigation credits were sold to ten applicants for 2.7 acres of wetland impacts, for a total of \$511,880.23. The impacted acreage was in the Connecticut River, Housatonic River, South-Central Coast, and Southwest Coast Service Areas. There were no credit sales in the Southeast Coast Service Area during Fiscal 2017.

The tables that follow provide information on ILF payments, impact types and amounts, and funds available for future ILF projects.

Table I provides a full list of all of the permitted impacts that have generated ILF payments. Included in this table is the applicant, date the payment was received, permit numbers, town of impact, habitat type impacted, required amount of compensatory mitigation and the amount of the payment. This table is sorted by service area.

Table 2 shows the financial account ledger for the ACT ILF program. Included in this table is the starting balance, payments received, administration fees collected, interest earned, disbursements made and the remaining account balance. This table is broken down by service area.

Table 3 is the credit ledger for the ACT ILF program. This table shows the authorized advance credits, advance credits sold, credits released, released credits sold (in excess of satisfied advance credits), and the total credits available, broken down by service area.

3. **Project Implementation**

Update on 2016 Project Round

Subsequent to the end of the Fiscal 2016 reporting period, the IRT met to review projects in July 2016 and selected finalists by July 30th. Of the seven full proposals evaluated by the IRT, two were not approved. The remaining five projects were approved for full funding. Subsequent Notification Letters were sent to finalists by August 15th, 2016.

In December 2016, five Project Agreements were entered into with the cooperating entities whose proposals had been approved, in the Connecticut River, Housatonic River, South Central Coast, and Thames River Service Areas. \$680,825 in project expenditures was authorized during Fiscal 2017 for the 2016 project round, \$502,725 of which had been disbursed by June 30, 2017.

4.4 credits were released during Fiscal 2017 in the Thames River Service Area as a result of the completion of the Lukaszek Preservation project in Thompson, CT.

A summary of 2016 project statuses is provided in Appendix C.

2017 Project Round

ACT announced the availability of funds for five out of six service areas in a formal Request for Letters of Intent (RFLOI) issued in March, 2017. The RFLOI was posted on the ACT website, and in the electronic newsletters of the following organizations: The RFLOI was posted on the ACT website, and in the electronic newsletters of the following organizations: ACT, Connecticut Land Conservation Council, and the Connecticut Association of Wetland Scientists.

Additional outreach activities were undertaken in 2017 as follows:

A postcard was developed that we could hand out or email directly to anyone interested. ACT and FHI brought stacks to distribute at the following conferences:

- Connecticut Association of Wetland Scientists Annual Meeting on March 9th (at this conference ACT and FHI also presented on the results of the 2016 CT ILF Program and a look ahead for 2017).
- Connecticut Natural Resources Conference at UCONN on March 13th
- Connecticut Land Conservation Council Annual Meeting on March 18th (ACT and FHI also conducted a workshop at this conference on how to apply for a CT ILF Grant)
- Society of Wetland Scientists New England Chapter (FHI presented on the CT ILF Program on May 5th).

The information advertising the availability of funding was also Posted by Mike Beauchene, Supervising Fisheries Biologist CT Aquatic Resources Education (CARE) & Fisheries Program Support Fisheries

Division, Connecticut Department of Energy and Environmental Protection to the CARE Facebook Page.

FHI also did an email blast of the postcard on Feb. 28th to over 300 recipients including mostly land trusts but also to other non-profit organizations, wetland consultants, town IWC and Conservation Commissions, academics, and lawyers that represent land trusts. The Letter of Intent Deadline was April 17th, 2017.

Seventeen LOIs were submitted by responding applicants to ACT. No LOIs were received by ACT for projects proposed in the Southeast Coast Service Area at that time, likely due to due to the lack of available funds.

An LOI review committee was formed consisting of three members of ACT (S. Hudson, L. Kane, and P. Comins) and Ruth Ladd of the ACOE. The LOI review committee met on April 25th, 2017, and screened each LOI for consistency with the ILF program. Feedback was provided to all applicants after review of the LOIs. Out of the original 17 submissions, all were notified that they were welcome to submit full proposals. However, two applicants were informed that they did not have strong projects in comparison to other projects in the same service area competing for the same funds. Out of the 17 original applicants invited to submit full proposals, only thirteen chose to do so. The full proposals were received by Audubon on June 7th, 2017.

A PAC Meeting was held to select finalists on June 22nd, 2017. which resulted in the recommendation of ten projects to the IRT.

Note: Subsequent to the end of Fiscal 2017, the PAC formally recommended ten projects to the IRT on July 27th, 2017. In September 2017, the ACOE approved nine of the ten projects. At the time of this publication, project agreements for the nine approved projects were underway.


