C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is depicted on the enclosed attachments as land area associated with 156 Fresh Meadow Road and 140 Fresh Meadow Road. The reason for the small review area was to address the property owner's request to obtain an approved jurisdictional determination for a small water feature behind the 156 Fresh Meadow Road property. The feature of interest is geologically isolated within the materials processing yard. It does not coincide with other wetland areas historically delineated on the parcels (which are depicted on a historical site delineation survey) and it does not possess hydric soils. Hydrological function appears to be driven from seasonal precipitation and surface-driven runoff. As a portion of the depression may have been created from excavation, it is possible that it could intercept a high water table on a seasonal basis. It is delineated by Ordinary High Water Mark (OHWM) but does possess a small amount of *Phragmites australis* (common reed) as contiguous wetland completely encompassed within the OHWM. Plans dated August 14, 2018 provided by the consultant depict a culvert installed to provide positive drainage to eliminate concerns regarding inundation, poor drainage and mosquito breeding. The culvert is improperly pitched and does not intercept with any other wetlands or waters at the site.

Review of historical topographic maps reveal that the perennial Cove River was diverted through the feature identified as a red maple swamp sometime between 1944 and 1947. The intermittent tributary, identified on project plans as a drainage ditch, also appears on the 1947 USGS topographic map as a "blue line" stream. The 1934 aerial photographs from the Connecticut State Library depict that the three parcels associated with the GC Realty parcels and the majority of the area currently identified as the red maple swamp were manipulated and functioning as agricultural fields. The topographic map from 1957 clearly depicts this use and the agricultural fields and drainage ditches within the resource area. The 1985 topographic maps depict piping and channelization of various features associated with industrial development commencing at the site.
