C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other information (please specify): This Approved Jurisdictional Determination only addresses Wetland-3 (also called the "Farm Pond") on the above referenced site and not any other wetlands and streams on this site. The "Request for AJD" submission included information and maps from USGS, acceptably-completed USACE Wetland Determination Data Forms (NCNE), aerial photographs, and ground photographs, so these resources were examined in completing this determination. In this case, the identified Wetland-3 was excavated in an upland area sometime between 1934 and 1952 and remains within an agricultural setting. Furthermore, Wetland-3 does not receive or convey tributary flows to or from a WOUS. Therefore, Wetland-3 is not considered WOUS.
