primary source of hydrology. Any hydrologic connection to Fort Hill Brook appears to be restricted due to the failing catch basin and tile drainage system that originally connected to the Brook. Due to the small catchment area, Wetland B's ability to affect the conditions of Fort Hill Brook through storing storm water during heavy precipitation events is likely negligible. It also lacks a hydrologic or geologic connection to downstream waters. Though wetland B is approximately 425 feet from Fort Hill Brook and is close enough to be considered for ecological adjacency, the ecologic functions provided to Fort Hill Brook would be considered minimal due to the small size of Wetland B's drainage area. Wetland B does not possess any discernible ecological link to Fort Hill Brook or a nexus to interstate commerce, and is therefore isolated and nonjurisdictional..

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The "Request for AJD" submission included information and maps, acceptably-completed USACE Wetland Determination Data Forms (NCNE), aerial photographs, and ground photographs. Wetland B is a depressional feature on the landscape that collects stormwater runoff and exhibits the characteristics of an emergent wetland with forested and scrub-shrub. Wetland B has no nexus to navigation or interstate commerce. The other wetland resource area that will be



altered by the project is identified as Wetland A. The potential for this feature to be a WOTUS has been addressed through a Preliminary Jurisdictional Determination.
